To the California Assembly & Senate Redistricting Committee:

As a resident of **Lompoc, Santa Barbara County**, I am absolute opposed to the proposed State Assembly and Senate redistricting that has just been released for public comment.

The proposal calls for dividing our city of Lompoc in half, putting half our community in a district that is geographically divided by a mountain range, where there are little common interests south of us. You may not be aware but there was a movement a couple years ago to split Santa Barbara County, to make the northern half a new county. That is how diverse, and different our interests are from the southern half of Santa Barbara County and Ventura County.

The incorporated city of Lompoc has about 43,000 people, and the Valley region including unincorporated areas brings the total to 59,000. The Federal prison that is located on the outskirts of our community has inmates with no voting rights, and to count these people as part of the voting block/or active community members of Lompoc is at best irresponsible, and totally harmful to our city.

The proposed Senate and Assembly districts are drawn right through the middle of our city. Why?? Why cut half of Lompoc off from the northern part of Santa Barbara County. where there are mutual interests and concerns about the welfare of our people, businesses and land (we are agriculturally based, the same as San Luis Obispo County)? Our current representation from Assembly and Senate people is terrible. We had hoped for better with the new redistricting.

PLEASE RECONSIDER THE DISTRICT BOUNDARIES and the best interests of the City of Lompoc, and do not divide our City.
