down forestry, mining, and whatever else they have to complain about?

The enviromentalists complain about a co-ho salmon, which they say has always been here, LIE, the salmon took 3 tries for this fish to take and it is not going to increase because this is not its regular habitat, even the Kuruk Indians admitted that.

I recently heard a telephone interview by Corky Small, news director for KSYC radio in YREKA, of one of your commissioners, Mr. Forbes.

He was asked why there had not been any public hearings conducted in Yreka. His response was, "We did not have any hearings in "Eureka" because of the expense of time and travel for the commission." I hope the rest of the Commissioners know we are "Yreka" and not "Eureka."

If it is too much for the commission to come here then what will it be like for us and our Representatives to travel long distances? It will leave us with little contact thus no "fair or effective representation."

Please tell me how that is "Democracy in Action"? (We live in a Republic not a democracy)

Secondly, he also stated that the commission had not heard much from Siskiyou County. I personally read every letter/email that was sent to the commission. There were 10 letter/emails in April and 41 in May. I find that significant for a county of 44,000.

Thirdly, Mr. Forbes stated that the West Siskiyou County has significant American Native Population, who fish so that is why West Siskiyou was put with the Coastal Communities.

Did the commission look at the census records?

The total American Native population in all of Siskiyou County is only 4% (US Census website), much of which lives in the county seat of Yreka in the Karuk Housing. Fort Jones has 3.2 percent American Natives (US Census Website).

I have no stats for Happy Camp or Siead as they were not listed on the census report. I hope that Mr. Forbes and the rest of the commission will revisit their reasons for putting west Siskiyou County with the Coastal communities based on correct information.

This apparent total disregard for all the facts is both disappointing and appalling.

Regarding Mr Forbes interview heard on our local radio station, KSYC, I would dispute his comment that the significant portion of western Siskiyou county is comprised of Native Americans with a rich fishing tradition, thus having ties to coastal influence. While indeed, we do have a Native American population, you forgot to mention the Quartz Valley Tribe, the Shastas, and the Modocs, all of whom are interwoven throughout our population and land base, in particular, central and eastern Siskiyou county. They all have a cultural and historical tie to the Klamath River fishery having migrated in the past to the closest portions of the Klamath River, Shasta River, and their tributaries to harvest salmon during the season. By your logic, you should then include the entire Siskiyou county and the western half of Modoc county.

I cannot DISAGREE more with Mr Forbes' rationalization! The only Native American fishing tradition that takes place in Siskiyou county happens at Ishi Pishi Falls, located across the highway, Highway 96, from Somes Bar, which happens to only be **one mile** inside Siskiyou county from the Humboldt county line!! This is not only a tradition of harvesting salmon, it is a rite of passage into manhood for young Karuks. I'm certain you know very little, if anything, of our rich Native American population, it's quite apparant when you make comments like those above. Again, the only traditional fishing for local Native Americans that takes place in Siskiyou county is on the **western border** with Humboldt county.

I would also repeat the point I made in my first comment to this board two weeks ago that this proposed line location smells "fishy". You have drawn lines that suspiciously reek of environmental concerns and not local concerns. The line you have drawn seems to include all our watersheds that "could", but don't necessarily, support Coho salmon, a federally listed endangered species. I can only draw one conclusion, and that would be you're being influenced more by coastal environmental concerns/issues rather than the "real life" concerns/issues of those of us who live in western Siskiyou county.

We have **NOTHING IN COMMON** with those who live in the coastal region and please don't insult me by suggesting your reasoning for the proposed line location is because of the rich cultural fishing traditional of our Native Americans in western Siskiyou county! It's quite apparant you know very little of our Native American population and their history or culture.

I would also point out that having been raised in Yreka, we have often been confused with Eureka. I have often had to remind folks - I live in YREKA, not EUREKA - we're the town located 4.5 hours inland from the coast!! Please use a map the next time you make any reference to a geographical location inside Siskiyou county.

Being that the 2010 U.S. Census demographic information for Native American occupancy in Siskiyou County is difficult for me to find, the 2000 U.S. Census demographic information by the Area-Codes .com for the Yreka, Siskiyou County area was used to evaluate Native American occupancy in Siskiyou County to ascertain the following conclusions:

Area-Codes.com for Yreka, Siskiyou County, California population is 45472 and the Native American population in all of Siskiyou County is 1,737, establishing the said Native American population at 3.82%, which is not a very significant ratio for all of the Siskiyou County population.

The Scott River Watershed Drainage area is a much lesser population ratio, with a Native American population of 230, a 0.51% of Siskiyou County representation in the western proposed partitioning of said Siskiyou County by the CRC.

The California Karuk Tribe have a historical fishing right to take anadromous fish out of the Klamath River locate at Ishi Pishi Falls near Somes Bar, California, about 0.1 of a mile upstream from the Siskiyou County - Humboldt County Line.

Said Ishi Pishi Falls locate is the only dominant area of influence legally for the Siskiyou County Native American People (Exclusive only to Karuk Tribal Members) that have a common fisheries association with the coastal Tribes.

The Ishi Pishi fisheries area of dominant influence is less than a 0.5 mile radius, which is not a very significant ratio to the area of Siskiyou County!

The communities population of 383, a 0.85% of Siskiyou County representation in the western proposed partition of said County by the CRC is within a 30 mile radius of Ishi Pishi Falls, which is not very significant at all in ratio to the Siskiyou County population.

The communities of Yreka in Shasta Valley and Fort Jones in Scott Valley have a common farming and ranching lifestyle with ancillary services within a twenty minute drive to each other.

There is no common lifestyle and or services that benefit the Scotty Valley people between any of the coastal communities that are nearer than a three or four hour drive with many road closures in the winter months.

Please CRC do not create anymore hardships for the Scott Valley communities, they have to many now. I reiterate, the Scott Valley socioeconomic welfare patterns do not have any beneficial requirements by being handicapped with a political association with the coastal communities!

I therefore say, that the CRC do due diligence as stewards of we citizens and correct there proposed demarcation boundary to the following geographic location that I do reiterate by my previous correspondence with the CRC:

Subject: Redistricting of my county

Message Body:

I am a voting resident of Callahan in western Siskiyou County and I OPPOSE the 1st draft redistricting boundaries that splits Siskiyou County. The communities of Scott Valley (Fort Jones, Etna, Greenview, Quartz Valley, Callahan) share common social and economic interests with eastern Siskiyou County and the rest of the MTCAP.

Scott Valley is a ranching community with a long history of partnering with Shasta Valley (Yreka) and Tulelake (eastern Siskiyou County) communities on social and economic issues, specifically natural resource issues related to water resources.

We DO NOT travel to the coast for shopping and culture as others have claimed. Coastal services are 4.5 hours away. I lived and worked in Humboldt County for several years and have only returned a few times in the 15 years since I moved away. There is nothing social, economic, or political that my community shares with the coastal communities. We spend our time and money locally, or travel to Redding or Medford, OR for services.

One mission of the CTC is to ensure the fair representation of voters and to improve the proximity of citizens and the legislators who represent them. A review of voting records will show that the majority vote in Scott Valley is consistently aligned with the elected officials. Based on this metric, voters in Scott Valley are ALREADY fairly represented. The 1st draft redistricting boundary would significantly reduce the proximity of our representative by replacing the 2 hr drive to Redding with a 4.5 hr drive to Eureka.

Voters in Humboldt County are afraid of being absorbed by urban interests if a southern boundary is used for DELMENDO. They say they are rural agriculture and share our interests. Please listen to voters in Scott Valley who say this is not true. There is no record of any coastal communities partnering with us on shared common interests. In fact, many in the fishing industry have conflicts of interest with the ranching community.

Please do what is best for California (not special interests) and meet the goals of the redistricting committee to ensure fair and effective representation by keeping Scott Valley communities in the MTCAP district.

To Whom It May Concern:

I am opposed to the proposed split of Siskiyou County into separate Assembly, Senate and Congressional Districts. Your Commission's proposal for Siskiyou County will result in splits of Supervisorial Districts 5 including the incorporated cities of Fort Jones and Etna, Supervisorial District 3, Siskiyou County Board of Education Areas 3, 6, and 7, Siskiyou Community College District Areas 3 and 7, Yreka Union High School District Areas 3 and 7, Siskiyou Union High School District, Scott Valley Unified School District Area 1 and 2, Hornbrook Elementary School District, Gazelle Elementary School District, Scott Valley Fire Protection District and Gazelle Fire Protection District. I believe that a county united under the same elected representatives promotes more effective and comprehensive government, public health, and safety. I believe that the proposed split will adversely affect several communities in the county.

There are numerous negative impacts to Siskiyou County due to this proposed split. Siskiyou County supervisors, law enforcement, and citizens have a good relationship with our current representatives: Assemblyman Nielsen, Senator LaMalfa and Congressmen Herger. These elected representatives know our county and our interests are a top priority. Placing us in the coastal districts will greatly reduce our ability to attend key events and meetings on a regular basis due to distance, weather and travel expense. I believe the coastal elected representatives have different law enforcement priorities and critical issues such as agriculture, water rights, dam removal, endangered species, foresting, mining, recreation, and general land use topics are prioritized significantly different in the coastal areas than in Siskiyou County. Siskiyou County already has tremendous budget challenges and has seen a significant decline in the economy and a divided political approach to our problems will be potentially disastrous. Most people I have talked to view this proposed split as a deliberate political ploy to reduce the voice and freedoms of county citizens, especially in the critical areas of land and water use issues.

Again, the purpose of this letter is to express my strong opposition to the proposed redistricting of Siskiyou County. As resident of Siskiyou County, I feel that this division of assembly, senate and congressional boundaries will adversely impact the economic and social fabric of our county. I am very alarmed by the first draft of maps proposed by the Commission and can see absolutely no benefits to this plan.

Maybe then you will see how close Scott Valley and Shasta Valley are in economics and how very different they are from the coastal communities that you plan to merge.
