I would like to tell you about an experience I had in Coachella, Calif. While I was taking a class at Coachella Adult School, I occasionally went out to lunch with my fellow students. On one occasion we went to a local Chinese restaurant. When I was handed a menu I found it was in Spanish and Chinese. There was no English menu.

Situations like this occur all over the Coachella Valley. Parts of the Valley are English speaking; parts of the Valley are Spanish speaking. There are major divides in the Coachella Valley based on language and ethnicity.

It has become apparent to me that there is a real continuation of people and language between Riverside County and Imperial County. I hope you keep this in mind when you draw the next Reapportionment maps.

As you become familiar with areas such as Coachella, Mecca, and Thermal you will see their similarity to the towns of Brawley, El Centro, and Imperial. In terms of language and ethnicity of the population they are one area and should be considered as such.

nDear Commissioners,

I spoke before your Committee in Palm Springs on May 12 and in San Diego on June 20 representing the City of Coachella.

After seeing the overwhelming testimony at the Palm Springs hearing in favor of linking the Coachella Valley with the Imperial Valley, I was a concerned when your first map did not link our two valleys.

I am now grateful to see that as a result of what are very clear community of interest matters between the Eastern Coachella Valley and the Imperial Valley that your visualization has kept our two Valleys together in the Assembly.

There are also great arguments for keeping our communities combined in the same Senate District and Congressional Districts as well.

The population of our two Valleys is predominantly lower income, young, unemployed and Latino. In agriculture, we share a major economic sector, as well as the currently emerging green energy sector. In fact, just days ago the US Secretary of Interior approved a 152 mile line that will bring large scale energy from both the Coachella and Imperial County. In addition, both Riverside and Imperial County have approved large scale energy projects that will produce thousand of megawatts'. Other transmission lines and large scale energy projects are also planned.

The full development of the Renewable Energy Sector and the maintaining of the agriculture sector is key to both of our valleys future success. In fact, because of the attraction and make up of the Baby Boomer population in the Coachella Valley, there is a big drive amongst regional leaders to diversify the CV economy. Baby boomer are working longer and have less disposable income than generations before them. No longer can "hospitality and tourism" be the only economic sector in the Coachella Valley. Economic diversification is key. Agriculture has been the sector that has remained constant in the Coachella and Imperial Valley. The unemployment rate in some areas of the Imperial valley has hovered around 30percent. There are areas in the Coachella Valley that have unemployment rates as has high as 24percent. Many economist have eluded that ag has keep the unemployment rate from growing. Ag is still the second largest employer and revenue generator in the Coachella Valley and number one in Imperial.

The Salton Sea, one of the biggest environmental hazards in the Western United States, is not only in the Coachella Valley but in Imperial Valley. Most importantly, the Sea is the home land of the Torres Martinez Desert Cahuilla Indians. The TM have anseterial land between the Coachella and Imperial Valleys. In fact, the majority of the Natives Americans living within both counties are Cahuilla Indians. In my city alone, three Indian tribes are represented: the Cabazon band of Mission Indians, The Augustine Band of Mission Indians and the 29palms Band of Mission Indians. The Torres Martinez also have land rights in Coachella. These tribes would be better served with one legislator in each level of government.

The Imperial Irrigation District serves the Imperial Valley and the Coachella Valley, and the Coachella Valley Unified School District serves residents of the Imperial Valley as well. Water History and water future are things the commission should ponder as well.

Again, thank you for keeping the Coachella Valley and Imperial Valley linked in the Assembly. I hope you strongly consider linking the two in the Senate and Congress as well.

Dear Commissioners,

It was with great feelings that i write this letter to get the commission to consider adding the Coachella and Imperial Counties into one Senate and Congressional District.

I have read the testimonials of several elected officials expressing that the Coachella Valley should retain all state and federal representation because of tourism serving as the community of interest. My view is that that argument is not good enough.

i will offer a counter proposal based on one argument also. Native American Tribes. I ask the commission to strongly consider the Native American link between the Coachella and Imperial Counties. Cahuilla Indians is the ethnic make up of the majority of tribes that live in both Imperial and Coachella Valley. In fact, the Torres Martinez Band of Cahuilla Indians has their reservations between both Valleys. The Torres Martinez future is linked to the success of both the Imperial and Coachella Valley. The Torres Martinez has been a leader in the Salton Sea restoration efforts and is a one of five member in the Salton Sea Commission. Their is currently a master planned development in the work on Torres Martinez reservation that hinges on the successful restoration of the salton sea.

Many of the other Cahuilla tribes such as the Augustine Band of Mission Indians and Cabazon Band of Mission indians used the San Jacinto and Mecca Hills mountains as hunting grounds and have ceremonial lands within them. The San Jacinto and Mecca Hills are between Imperial and Coachella Valley and have linked both valleys. There is also great economic diversification endeavors going on as tribes are looking at the emerging renewable energy sector and making investing within it such as the Agua Caliente Band of Cahuilla Indians located in the Coachella Valley.

Again, i ask that you link the Imperial and Coachella Valley in one Senate and Congressional District.

Dear Commissioners: I am a 27-year resident of the Coachella Valley in Riverside County and have been active in the community for all of those years. I wish to commend and thank the Commission for responding to citizen input on the drawing of legislative districts. I write in support of the most recent visualizations for COACH and BBCOH Assembly Districts that cover eastern Riverside County, Imperial County and portions of San Bernardino Valley covering Morongo and Yucca Valleys.

In addition to working in various nonprofits which provide medical care and affordable housing in the Coachella Valley, the Palo Verde Valley and Imperial County, I also teach American Government at the local Community College--College of the Desert. In my opinion, the current Assembly District visualizations recognize the community of interest resulting from the social, economic, geographic and community service integration of this region. Many of our local nonprofits provide services throughout this region and we recognize that families and commerce move about this desert region. COACH and BBCOH properly recognize the growth of the Latino community, respect their political strength and best serve the region.

I have also been an elected official in the region. I was elected to the non-partisan office of Community College Trustee in 1989 in the Desert Community College District. At that time, the district included the San Bernardino area of Morongo, Yucca Valley and Joshua Tree--as proposed in BBCOH. (It has since been split by the Legislature into a separate district). We found many students who lived in one county and worked in the other. Students took classes at both the Copper Mountain Campus in Joshua Tree and College of the Desert in Palm Desert. While the population demographics are different and the weather somewhat different, both regions have a retirement, desert community life.

I was elected to partisan office in the Assembly in 1992. The 80th District at that time (and ever since) couples Imperial County with eastern Riverside County. This district is truly a well-designed district of rural, agricultural economies, large elements of tourism and many retired "snow-birds". The entire area has no city larger than 80,000. The entire region is part of the SCAG planning and transportation Council of Governments.

I commend you for your recognition of the similarities of Imperial County and the Riverside County desert. I urge you to formalize the visualization maps for COACH and BBCOH (Assembly Districts) in your final redistricting efforts.

Dear Ms. / Sirs,

Recently our newspaper printed the map of the Proposed Congressional Visualizations 2011.07.08. This map does not reflect the new city of Jurupa Valley. On the map it shows our city area chopped up into the areas of: Mira Loma, Glen Avon, Pedley and Rubidoux. The map divides our city in two different Congressional districts and 2 different counties!

For as long as I have lived here our area has been split up although we considered ourselves 1 community. Our valley was divided into pieces and we were represented by state representatives from other counties, neither of which who ever came to visit in our area or acknowledged our issues. We became a city July 1, 2011 to have better representation as a city than we did as an unincorporated county area. This does not appear to be the case on your current proposal. Geographically our area is separated from Fontana and Crestmore Heights by mountains and county lines. The San Bernadino side of the mountains has different needs and issues than we do. We would be better served by having representatives that at least reside in the same county as we do.

Our new city needs to be treated as a city and kept intact with a representative who represents both our city, Jurupa Valley, and our county, Riverside. Putting our city with Norco, Eastvale, Riverside, and/or Moreno Valley which are in the same county and same geographic area would make more sense. Our city needs fair representation, putting part of our city, or our entire city into a San Bernadino County District does not give us fair representation. Please remap the city of Jurupa Valley so we receive fair representation.
