Message Body:

I have lived in Fair Oaks for 30 years, and spent 10 years as a regional planner in Sacramento, so I have a good picture of how Sacramento County works. The most recent district maps under consideration, as reported in today's Sacramento Bee (Thursday July 21), show Sacramento's eastern suburbs split among three districts that each reach far outward into surrounding rural areas. I ask you to reconsider a district that would put Rancho Cordova, Carmichael, Fair Oaks, Orangevale, Folsom, Citrus Heights, and Antelope, (and maybe El Dorado Hills and/or Roseville if you need more population) together in one suburban Sacramento district. Those communities are all interconnected for housing, jobs, shopping, and services, and it would make sense to connect them for political representation too. You can then divide the remaining areas in Sutter, Yuba, Placer, El Dorado, Amador, Southeastern Sacramento, and San Joaquin Counties into other districts, based on adjacent area, common!

interests, and economic interactions (for example, Yuba City and Marysville belong together, Placer and El Dorado share water and common foothill growth interests, and Amador County connects to San Joaquin for many economic interactions). It seems to me that such a configuration would make more sense in terms of common interests and good representative government. I think urban Sacramento, comprising 3.5% of the state by population, should have at least two internally-based Assembly members (2.5% of the Assembly) without diluting that representation with rural areas. I expect rural areas might feel the same way about being attached to a large urban population with different concerns. Incidentally, on the same map in today's Bee I think you have gotten the district covering Natomas-Sacramento downtown-Arden Arcade-South Sac-Elk Grove substantially right. Thank you...
