On behalf of the Asian Pacific American Legal Center (APALC), I respectfully ask the Commission to consider holding hearings on the final maps that we understand will be posted on July 29, 2011.

In connection with this request, we note that section 8253(a)(7) of the Government Code provides that,

The commission shall establish and implement an open hearing process for public input and deliberation that shall be subject to public notice and promoted through an outreach program to solicit broad public participation

in the redistricting public review process. *The hearing process shall include hearings to receive public input before the commission draws any maps and hearings following the drawing and display of any commission maps.* In addition, hearings shall be supplemented with other activities as appropriate to further increase opportunities for the public to observe and participate in the review process. The commission shall display the maps for public comment in a manner designed to achieve the widest public access reasonably possible. Public comment shall be taken for at least 14 days from the date of public display of any map.

(emphasis added).

Our review of the meeting schedule posted on the Commission's website indicates that for the month of August, meeting notices are posted for meetings to held on August 7 through August 12, 2011. Because the 14-day meeting notice requirement set forth in section 8253(a)(1) of the Government Code would appear to preclude the holding of meetings prior to August 7, we suggest that hearings on the final maps be held during the period of August 7 through August 12.
