Re: Citizens Redistricting Commission

Dear Governor Brown:

I am writing in my capacity as Chair of the Citizens Redistricting Commission (CRC) to request your assistance in assuring the CRC is able to successfully complete its responsibilities to approve new legislative, congressional and board of equalization districts by August 15, 2011. The challenge of creating a new state commission with adequate staff for this task is proving to be extraordinarily difficult, largely because of the complex web of bureaucracy that often prevents the simplest of tasks, such as acquiring working telephones and computers, from occurring.

The full Commission did not have their first meeting until mid-January of this year and the Executive Director has only been in place a little over a month. It has not been possible to establish a fully functional office to serve the state's citizens, and the impediments of expeditiously completing the task of contracting with the necessary consultants to propose draft districts places the CRC at risk of missing its statutory deadline.

In order to assure that this work goes forward in the manner and on the schedule mandated by the voters, we are requesting you to: (1) identify a senior member or your staff with the authority to not only navigate the bureaucracy, but to cause it to actively support the CRC's work and (2) grant a hiring exemption pursuant to paragraph 3 of Executive Order B-3-11. This will permit the CRC to fulfill its "core statutory mission" by hiring a very modest staff and the consultants necessary to draw the districts


