09:57:28 8 of you and your input of what you think we need

09:57:31 9 and you're hearing from people and what is the

09:57:37 10 best way that we can be communicating.

09:57:40 11 But we're going to be starting from

09:57:42 12 scratch here. I know that, number one, the

09:57:45 13 website is going to need to be totally reorganized

09:57:49 14 and retooled, and it needs to be done overnight.

09:57:52 15 We don't have any time.

09:57:54 16 So right now there are challenges

09:57:58 17 with -- because the -- as you all know, the

09:58:02 18 Secretary of State is the one that's handling

09:58:04 19 this, and now we're trying to get -- take over and

09:58:07 20 get our own I.T. people.

09:58:12 21 I mean, we're relying on Google

09:58:15 22 mail, as you know, and don't have our own I.T.

09:58:18 23 systems. So we're going to be designing a web

09:58:20 24 that's going to be -- a website that's going to

09:58:23 25 be, this is an overused word, but user friendly

09:58:27 1 and the fact that people can go and feel that  
09:58:31 2 their input is wanted and that it's easy to find  
09:58:37 3 the kind of information that you need.

09:58:41 4 We're up on Twitter, just that I  
09:58:44 5 put an account together. The name of the account  
09:58:46 6 is -- and here was the challenge, because in the  
09:58:49 7 name you only have a few characters to put up  
09:58:52 8 there. So it's C.A. underscore line redistrict.

09:59:04 9 Now, if you do a search in Twitter  
09:59:08 10 and you put California redistricting, it'll still  
09:59:11 11 come up, because there's other ways to search in  
09:59:13 12 the profile and things of that nature.

09:59:14 13 The vision for Twitter is to get  
09:59:18 14 information out on a very timely basis as it  
09:59:22 15 happens and when we have something to communicate  
09:59:25 16 and news that already in establishing an  
09:59:30 17 audience -- and of course we'll put the Twitter,  
09:59:33 18 follow Twitter bug up on the website and  
09:59:36 19 communicate that also to the list of people who  
09:59:40 20 have signed up.

09:59:41 21 But also I've started following  
09:59:45 22 the, many of the media. And then once you follow  
09:59:50 23 them and then they see that you're up, and then  
09:59:52 24 they've already started to follow us. So that's  
09:59:56 25 in the initial stages.

09:59:58 1 Part of the overall media relations  
10:00:02 2 and communications plan will be to piggyback, of  
10:00:06 3 course, on the public meetings and then the  
10:00:09 4 outreach hearings that are going to be held up and  
10:00:14 5 down the state.

10:00:15 6 First of all, I must say we're not  
10:00:18 7 going to have a paid advertising budget. We're  
10:00:21 8 going to be relying on free media and -- because,  
10:00:26 9 of course, we don't have -- it would be a drop in  
10:00:30 10 the bucket whatever we would be able to have to  
10:00:33 11 advertise in this state.

10:00:36 12 However, and I've been doing this  
10:00:38 13 for a few years, relying always, I never had a  
10:00:39 14 paid media budget jobs in the that I had.

10:00:43 15 And this is a hot-button issue  
10:00:45 16 that's important. The media is paying attention.  
10:00:49 17 And there are many, many news outlets, and  
10:00:53 18 especially now with the advent of the internet and  
10:00:57 19 the blogs, so many opportunities there.

10:00:59 20 But newspapers, you hear a lot  
10:01:02 21 about newspapers dying. Newspapers are still  
10:01:04 22 there. They're dying for content. And so much  
10:01:08 23 since they don't have the kinds of resources that  
10:01:10 24 they used to have, that's where we need to bring  
10:01:15 25 the story to help write the story for them.

10:01:18 1 I'm going to be relying on  
10:01:21 2 commissioners to be our voice out there, to be in  
10:01:24 3 the communities, to help in talking to radio and  
10:01:31 4 television and newspapers and community groups, in  
10:01:36 5 addition to and above what the outreach folks are  
10:01:40 6 going to be doing;

10:01:42 7 And editorial boards of newspapers  
10:01:47 8 where you come in, sit around the table like this  
10:01:50 9 and you meet with the editorial writers, the  
10:01:53 10 editor, maybe the publisher sometimes;

10:01:55 11 And then the beat reporters, the  
10:01:57 12 actual journalists. And I think that's very  
10:02:00 13 important to do and to set that in the coming  
10:02:05 14 weeks/early months.

10:02:07 15 Because to have the support, first  
10:02:11 16 of all, to let them know -- to let them know you  
10:02:13 17 and to also let them know what the process is  
10:02:16 18 early on, because they're going to be key.

10:02:20 19 The end goal here is that, when you  
10:02:23 20 come out with these lines, first of all that the  
10:02:28 21 public feels that they were included, that they  
10:02:30 22 were listened to, and the opinion leaders, and  
10:02:34 23 when you're talking about newspapers, that they're  
10:02:36 24 going to be coming out and they're going to say,  
10:02:39 25 you know, we were aware of this process, we had a

10:02:41 1 conversation, we know, we support the work that

10:03:39 20 question. There was a Twitter account that, you  
10:03:41 21 know, has been used for redistricting.

10:03:46 24 question is: Why wouldn't we just take that over?

10:04:02 9 Draw the Line" site.

10:04:02 10 MR. WILCOX: Okay. I didn't see

10:04:03 11 that. So.

10:04:03 12 COMMISSIONER DAI: So there's a --

10:04:03 13 there is a Twitter feed that is on the "We Draw

10:04:03 14 the Line" site.

10:04:03 15 MR. WILCOX: Okay.

10:04:07 16 COMMISSIONER DAI: I actually don't

10:04:08 17 know the ownership of it.

10:04:08 18 MR. WILCOX: Okay.

10:04:10 19 COMMISSIONER DAI: But I think the

10:04:11 20 Bureau of State Audits had it, is my guess.

10:04:14 21 MR. WILCOX: All right. I didn't

10:04:16 22 actually see that. I was -- okay. So I'll make

10:04:17 23 sure that they're together.

10:04:18 24 COMMISSIONER DAI: Yeah.

10:04:20 25 MR. WILCOX: Great. Thank you for

10:04:21 1 that.

10:04:21 2 COMMISSIONER DAI: That's the first

10:04:23 3 thing. Because it's okay to have two.

10:04:23 4 MR. WILCOX: No.

10:04:25 5 COMMISSIONER DAI: That's great,

10:04:26 6 but.

10:04:26 7 MR. WILCOX: No. It's -- we want

10:04:27 8 one.

10:04:28 9 COMMISSIONER WARD: Yeah. Exactly.

10:04:28 10 COMMISSIONER DAI: We want to take

10:04:32 11 it over is what we want to do.

10:04:32 12 MR. WILCOX: Well, we certainly

10:04:32 13 don't want a competitive one.

10:04:36 14 COMMISSIONER RAYA: But the fact

10:04:37 15 that you didn't see it on there, I do not

10:04:40 16 personally tweet --

10:04:43 17 MR. WILCOX: Yes.

10:04:43 18 COMMISSIONER DAI: We're going to

10:04:44 19 fix that.

10:04:46 20 COMMISSIONER RAYA: But you know,

10:04:49 21 it's -- I mean, I have seen it and I have kind of

10:04:51 22 looked at some of the things just out of

10:04:54 23 curiosity.

10:04:54 24 MR. WILCOX: Uh-huh.

10:04:55 25 COMMISSIONER RAYA: So that says to

10:04:56 1 me, you know, the gentleman who was saying what,  
10:05:00 2 you know, it's hard to find things, and I do think  
10:05:02 3 it is for, you know, for anybody.  
10:05:03 4 And you're -- I know you're looking  
10:05:05 5 at things and trying to --  
10:05:08 6 COMMISSIONER DAI: "We Draw the  
10:05:11 7 Line."  
10:05:11 8 COMMISSIONER FORBES: Well, you  
10:05:11 9 know, on the "We Draw the Lines" -- this is the  
10:05:13 10 first time. Commissioner Forbes.  
10:05:17 11 COMMISSIONER WARD: Good memory.  
10:05:20 12 MR. WILCOX: Okay. What is that?  
10:05:20 13 That's not -- that doesn't say it's Twitter,  
10:05:20 14 though.  
10:05:20 15 COMMISSIONER DAI: It is, though.  
10:05:23 16 That's the Twitter stream.  
10:05:23 17 MR. WILCOX: Okay. So we need the  
10:05:26 18 Twitter bug --  
10:05:26 19 COMMISSIONER DAI: Right.  
10:05:26 20 MR. WILCOX: -- on there --  
10:05:26 21 COMMISSIONER FORBES: But it --  
10:05:27 22 MR. WILCOX: -- so that people  
10:05:27 23 know --  
10:05:28 24 COMMISSIONER FORBES: It tell -- I  
10:05:29 25 mean, looking at maps as of today, that's why I'm

10:05:32 4 is a lot --

10:05:32 5 COMMISSIONER DAI: Of stuff.

10:05:34 7 information.

10:05:34 8 MR. WILCOX: Oh, yeah.

10:05:34 9 COMMISSIONER FORBES: I mean, if it

10:05:35 10 doesn't count, it should be gone or it could be

10:05:36 11 archived so I won't have to look at it, but

10:05:38 12 assuming we should be just what's current.

10:05:41 13 MR. WILCOX: So the process here is

10:05:42 14 going to be we're going to work with what we've

10:06:17 6 perfect thing to tweet.

10:06:17 7 MR. WILCOX: Perfect to tweet,  
10:06:17 8 uh-huh.

10:06:19 9 COMMISSIONER DAI: Yeah. Like  
10:06:19 10 coming back in now, you know, join us in room X or  
10:06:23 11 whatever. So I mean, that stuff is --

10:06:25 12 COMMISSIONER FORBES: And I was --  
10:06:26 13 just in terms of laying it out, some years ago I  
10:06:29 14 took a class in political brochure writing. And  
10:06:33 15 there are three kinds of people who are going to  
10:06:35 16 read this stuff.

10:06:36 17 I mean, there's always going to be,  
10:06:38 18 you know, the wonky types who are going to read  
10:06:38 19 everything we say.

10:06:38 20 MR. WILCOX: Right.

10:06:40 21 COMMISSIONER FORBES: But that's  
10:06:41 22 not what the ordinary people are going to look at.  
10:06:43 23 And there are -- as I read, there are three kinds  
10:06:44 24 of readers. There's the two-second reader.

10:06:46 25 MR. WILCOX: Is everyone supposed

10:06:48 1 to introduce themselves when we talk?

10:06:49 2 COMMISSIONER FORBES: I did.

10:06:52 3 MR. WILCOX: Oh, you did?

10:06:52 4 COMMISSIONER FORBES: I did.

10:06:52 5 MR. WILCOX: I didn't hear it.

10:06:52 6 COMMISSIONER FORBES: I did.

10:06:52 7 MR. WILCOX: Okay. Sorry about

10:06:55 8 that. Good for you.

10:06:55 9 COMMISSIONER FORBES: All right.

10:06:55 10 There's the 30-second reader and

10:06:58 11 there's the two-minute reader. And there's no --

10:06:58 12 MR. WILCOX: Okay.

10:07:00 13 COMMISSIONER FORBES: Nobody reads

10:07:01 14 beyond two minutes.

10:07:01 15 MR. WILCOX: No. No.

10:07:02 16 COMMISSIONER FORBES: It doesn't

10:07:02 17 happen.

10:07:02 18 MR. WILCOX: No.

10:07:03 19 COMMISSIONER FORBES: So it needs

10:07:04 20 to be structured --

10:07:05 21 COMMISSIONER DAI: Unless you're a

10:07:06 22 student.

10:07:06 23 COMMISSIONER FORBES: What we do

10:07:07 24 needs to be structured to sort of address those

10:07:09 25 kinds of readers.

10:07:10 1                   Something else I think we should  
10:07:12 2 do, and probably it's not every meeting, but in  
10:07:14 3 every session, because I think we need to have --  
10:07:17 4 we've written it before, here what we did.

10:07:17 5                   COMMISSIONER DAI: Yes.

10:07:20 6                   COMMISSIONER FORBES: Here's what  
10:07:21 7 happened. If you didn't tune in the last few  
10:07:23 8 days, here's what happened --

10:07:23 9                   COMMISSIONER DAI: Here's the  
10:07:24 10 synopsis.

10:07:25 11                   COMMISSIONER FORBES: -- and here's  
10:07:25 12 what we're going to do. And that should be --  
10:07:26 13 that should go up on Friday night or Saturday  
10:07:29 14 morning, go right up so it's an executive summary.

10:07:33 15                   MR. WILCOX: Uh-huh.

10:07:33 16                   COMMISSIONER DAI: And we want you  
10:07:34 17 to do that, just to be clear. I did it for  
10:07:37 18 January --

10:07:37 19                   COMMISSIONER FORBES: Right.

10:07:38 20                   COMMISSIONER DAI: -- but I want  
10:07:38 21 you to do it moving forward.

10:07:40 22                   COMMISSIONER FORBES: At the risk  
10:07:41 23 of -- because I have my list here and I'll just go  
10:07:43 24 through it.

10:07:44 25                   I think that the meetings, that we

10:07:47 1 are the -- when we make presentations, they should  
10:07:48 2 be timed to go along with when we're going to have  
10:07:51 3 our public meetings.

10:07:52 4 So the two weeks before we have our  
10:07:53 5 public meeting in Claremont --

10:07:53 6 MR. WILCOX: Uh-huh.

10:07:55 7 COMMISSIONER FORBES: -- that's our  
10:07:56 8 chance to have something in the paper, to be on  
10:07:58 9 the radio.

10:07:58 10 MR. WILCOX: Absolutely.

10:07:58 11 COMMISSIONER FORBES: I mean,  
10:07:59 12 there's no point, if we're going to be six months  
10:08:01 13 here, to do it today, because it'll be forgotten.

10:08:01 14 MR. WILCOX: Right.

10:08:05 15 COMMISSIONER FORBES: Personally,  
10:08:05 16 I'm happy to go every day and maybe talk to  
10:08:07 17 somebody. It doesn't matter to me.

10:08:09 18 But I'd like you to contact them  
10:08:10 19 and have them then contact -- don't make me  
10:08:13 20 contact them. I just want to be sure. Just want  
10:08:15 21 to be sure.

10:08:16 22 MR. WILCOX: I'll speak with them.

10:08:19 23 COMMISSIONER FORBES: Let's see.

10:08:19 24 What else? I guess those are the subjects of  
10:08:23 25 conversation I just wanted to make an issue of.



10:08:27 1 COMMISSIONER WARD: Okay. Before

10:08:27 2 we --

10:08:27 3 COMMISSIONER DAI: Commissioner

10:08:27 4 Ward.

10:08:29 5 COMMISSIONER WARD: Commissioner

10:08:30 6 Ward. Yeah. Thanks.

10:08:32 7 Before we get off the website

10:08:35 8 there, and I'll try to keep it -- there's so

10:08:36 9 much --

10:08:36 10 MR. WILCOX: Uh-huh.

10:08:37 11 COMMISSIONER WARD: -- I don't want

10:08:38 12 to get lost. What's the plan to make that happen?

10:08:41 13 We don't have a tech guy. We don't have any

10:08:44 14 D.G.S. funds.

10:08:44 15 MR. WILCOX: That's right.

10:08:45 16 COMMISSIONER WARD: We need this

10:08:46 17 now. So how are we going to do it?

10:08:47 18 MR. WILCOX: Well, how we're going

10:08:48 19 to do it is we're going to work with what we've

10:08:49 20 got now and retool that site as we're waiting for

10:08:54 21 this other.

10:08:55 22 COMMISSIONER WARD: Who's going --

10:08:55 23 MR. WILCOX: What we're --

10:08:56 24 COMMISSIONER WARD: -- to do that?

10:08:57 25 Oh, sorry.

10:08:57 1 MR. WILCOX: Well, I will working  
10:08:59 2 with --

10:08:59 3 COMMISSIONER WARD: You're going  
10:08:59 4 to?

10:08:59 5 MR. WILCOX: -- yeah, working with  
10:08:59 6 the folks at the Secretary of State now just to  
10:09:03 7 get this --

10:09:05 8 COMMISSIONER WARD: Thank you.

10:09:06 9 MR. WILCOX: You know, we have to  
10:09:06 10 do that. And so you'll see changes next week.

10:09:09 11 However, as far as the retooling of

10:09:30 18 within the state, the chief information officer  
10:09:34 19 who does the -- all the departments and agencies,

10:09:41 21 because it's ease -- we have no problem  
10:09:44 22 contracting with a state agency.

10:09:44 23 COMMISSIONER DAI: Right.

10:09:46 24 MR. WILCOX: So the problems that  
10:09:47 25 we're having in procurement and getting going we

10:09:50 1 don't have. So. And I've worked very closely  
10:09:54 2 with those folks before.

10:09:55 3 So my answer is sooner rather than  
10:09:57 4 later. I would love to see this in a very, very  
10:10:00 5 quick turn-around. I know we don't have any time.  
10:10:03 6 So that's the plan.

10:10:05 7 COMMISSIONER DAI: One thing to  
10:10:09 8 consider also --

10:10:09 9 MR. WILCOX: Commissioner...

10:10:11 10 COMMISSIONER DAI: -- Dai, yes, is  
10:10:11 11 borrowing employees.

10:10:11 12 MR. WILCOX: Uh-huh.

10:10:13 13 COMMISSIONER DAI: So I think that  
10:10:16 14 that was something that Ditas Katague mentioned,  
10:10:19 15 that she borrowed employees. So other agencies  
10:10:23 16 lent her her Web person.

10:10:23 17 MR. WILCOX: Uh-huh.

10:10:26 18 COMMISSIONER DAI: So then we don't  
10:10:27 19 have to pay for it. And it's very fast.

10:10:32 20 And I have to believe -- I know  
10:10:33 21 that Dan mentioned there was a good guy at B.S.A.,  
10:10:37 22 too. So maybe the --

10:10:38 23 COMMISSIONER WARD: Maybe put the  
10:10:39 24 one together.

10:10:40 25 COMMISSIONER DAI: Yeah. Maybe we

10:10:41 1 can borrow someone --

10:10:41 2 MR. WILCOX: Okay.

10:10:42 3 COMMISSIONER DAI: -- and get that  
10:10:43 4 person on even faster.

10:10:46 5 COMMISSIONER WARD: That's exactly  
10:10:47 6 where I was headed to. I was wondering if -- I  
10:10:49 7 know one of the things that, you know, impressed  
10:10:51 8 as a commission with your resume was your contacts  
10:10:56 9 in the private side.

10:10:58 10 You know, is there any community  
10:11:01 11 groups or private support that you know might be  
10:11:04 12 available to get this done?

10:11:06 13 MR. WILCOX: Yes. I mean, I  
10:11:09 14 believe that there's -- and especially with the  
10:11:11 15 different partners and -- that are -- already  
10:11:14 16 exist and out there, that that's going to be  
10:11:16 17 something I'm going to be doing next week to reach  
10:11:18 18 out and say, hey, you know, you supported Prop 11,  
10:11:23 19 you were out there --

10:11:23 20 COMMISSIONER DAI: Yeah.

10:11:24 21 MR. WILCOX: -- and we need help  
10:11:25 22 and we need to get this rolling.

10:11:28 23 So I -- that is. And I'm glad that  
10:11:29 24 you mentioned that, because that is part of --  
10:11:31 25 that we're reaching out and we're going to ask for

10:11:34 1 volunteers and help and, you know.

10:11:36 2 COMMISSIONER DAI: Students will be

10:11:37 3 all over this.

10:11:37 4 MR. WILCOX: Absolutely.

10:11:37 5 COMMISSIONER DAI: I mean, they can

10:11:39 6 redesign a website --

10:11:39 7 MR. WILCOX: Right.

10:11:40 8 COMMISSIONER DAI: -- in an hour.

10:11:43 9 So.

10:11:46 10 COMMISSIONER WARD: Okay. So for

10:11:47 11 website retooling, which we all agree needs -- is

10:11:49 12 in dire need, our plan is we're going to contact a

10:11:52 13 public and -- public groups, private group and

10:11:56 14 government agencies --

10:27:41 13 able to give interviews in languages other than

10:27:46 15 COMMISSIONER DAI: Absolutely.

10:27:46 16 COMMISSIONER FORBES: It might also  
10:27:47 17 be useful, then, if we let you know some strengths  
10:27:51 18 we might have or that you might not have picked up

10:34:55 4 So yeah, I thought it was really  
10:34:57 5 well done. I looked through the whole thing and  
10:34:59 6 it's -- yeah, kind of hits the high points.

10:37:12 23 said, philosophical.

10:37:16 24 COMMISSIONER FORBES: I mean, it's  
10:37:16 25 a --

10:37:16 1 COMMISSIONER DAI: What does it  
10:37:16 2 mean?

10:37:16 3 COMMISSIONER FORBES: Yeah. What  
10:37:16 4 does it mean? I mean, what does it mean  
10:37:17 5 practically speaking?

10:37:18 6 The fact is in -- you know, in  
10:37:21 7 pre-Voting Rights Act, there would be -- we might  
10:37:23 8 have a 40 percent African-American population and  
10:37:25 9 no African Americans --

10:37:25 10 COMMISSIONER DAI: Right.

10:37:26 12 elected because of the way the stuff was drawn.

10:37:31 15 Rights Act was designed to correct that by -- you  
10:37:34 16 know.

10:37:34 17 COMMISSIONER DAI: Right.

10:37:34 18 MR. WILCOX: That's right.

10:37:35 19 COMMISSIONER DAI: I mean, I  
10:37:36 20 actually think the whole packing and cracking  
10:37:38 21 thing is -- those are good terms.

10:38:30 15 COMMISSIONER DAI: Why should  
10:38:31 16 people engage? I think this would be an excellent  
10:38:36 17 assignment for, you know, young interns.

10:39:25 14 COMMISSIONER DAI: I try.

10:39:26 15 COMMISSIONER WARD: I'm just trying

10:39:27 16 to make sure we have some definite direction for

10:39:29 17 Rob so that he can cook away. So we have a number

10:39:35 18 of items.

10:39:36 19 I was wondering if, in that media

10:39:38 20 products option, is there any, with your

10:39:41 21 experience in media, is there any guest speakers

10:39:45 22 that you think would be helpful in coming and

10:39:50 23 presenting to the group on media relations or how

10:39:53 24 to rather -- further than just the one-on-one

10:43:20 1 on their site that it was in Spanish.

10:43:22 2 COMMISSIONER FORBES: But I mean,

10:43:22 3 and perhaps we want to have that voluntarily --

10:43:24 4 COMMISSIONER DAI: Yeah.

10:43:25 5 COMMISSIONER FORBES: -- for

10:43:26 6 free --

10:43:51 25 COMMISSIONER DAI: An audio

10:43:53 1 version.

10:43:53 2 COMMISSIONER FORBES: Well, it  
10:43:54 3 could be an audio version or, I don't know, a  
10:43:54 4 Braille version. I don't know.

10:43:56 5 I mean, I don't know what, you  
10:43:56 6 know, what is most convenient --

10:43:56 7 COMMISSIONER DAI: Uh-huh.

10:43:56 8 COMMISSIONER FORBES: -- you know,  
10:43:58 9 both to generate and be used, but.

10:44:07 10 COMMISSIONER DAI: Yeah. That's a  
10:44:08 11 good point.

10:44:19 12 COMMISSIONER FORBES: And along  
10:44:20 13 those lines, I was thinking, as we're live  
10:44:24 14 streaming our video, you've seen where, I've seen  
10:44:29 15 it basing it on T.V., you know, where what's said

10:44:35 18 COMMISSIONER DAI: Teletype.

10:44:38 20 feasible? I don't know if it is or not. I have

10:44:43 22 COMMISSIONER DAI: Yeah. They're  
10:44:44 23 actually services on the Web to basically  
10:44:50 24 automatically transcribe --

10:44:50 25 COMMISSIONER FORBES: Yeah.

10:44:53 1 COMMISSIONER DAI: -- video.

10:44:53 2 COMMISSIONER FORBES: So is there

10:44:54 3 a -- I mean, can we? Is it useful? I mean, is

10:44:55 4 there enough of a deaf community that we would --

10:44:58 5 that's a useful thing to do, that it could be done

10:45:01 6 inexpensively or at no cost?

10:49:59 19 COMMISSIONER FORBES: Huh?  
10:50:00 20 YouTube. I know. I mean, you know, all over the  
10:50:00 21 place. Because D.V.D.'s cost nothing to reproduce  
10:50:06 22 once you've got it.

10:50:06 23 MR. WILCOX: Uh-huh.

10:50:06 24 COMMISSIONER WARD: So if you  
10:50:07 25 haven't noticed, Rob, sorry, I'm just trying to

10:50:08 1 make a master list of things --

10:50:08 2 MR. WILCOX: Right.

10:50:11 3 COMMISSIONER WARD: -- for you to  
10:50:11 4 dig your teeth into and go to town so we have  
10:50:14 5 something to --

10:50:15 6 COMMISSIONER FORBES: Like herding  
10:50:17 7 chickens.

10:50:17 8 COMMISSIONER WARD: -- map our --  
10:50:18 9 no, no, no, no. You're doing great. Great ideas.  
10:50:18 10 I just want to make sure I -- yeah.

10:50:20 11 So if there's anything else you can  
10:50:23 12 think of in regards to specifically, you know,  
10:50:26 13 products or presentations that we need to have for  
10:50:30 14 commission meetings, outreach or awareness.

10:50:35 15 COMMISSIONER DAI: So one of the  
10:50:36 16 things at the top of the list here is the public  
10:50:39 17 education plan.

10:50:40 18 And we had a discussion about this  
10:50:42 19 in our meetings in January, about kind of how much  
10:50:45 20 do we want to do this and how much do we want to  
10:50:48 21 kind of want to delegate to all the other partners  
10:50:50 22 who are already doing a lot of work on that.

10:50:52 23 So I mean, I think the answer is  
10:50:54 24 that, when we have a meeting, there is an  
10:50:58 25 opportunity to do it.

10:50:58 1 It doesn't have to be long. It  
10:51:00 2 could be a, you know, a short multi-media  
10:51:02 3 presentation the beginning of all of our meetings.

10:51:04 4 But you know, beyond that, I think  
10:51:07 5 the consensus was that we weren't going to do  
10:51:10 6 special kind of, you know, education sessions,  
10:51:12 7 that we can leave to everybody else, but whenever  
10:51:14 8 we have a meeting, that there's always a section  
10:51:17 9 of the meeting that's going to be just about  
10:51:20 10 educating and making sure people know what is the  
10:51:22 11 significance of an independent redistricting  
10:51:23 12 commission and that the legislatures actually --

10:51:23 13 MR. WILCOX: Right.

10:51:26 14 COMMISSIONER DAI: -- you know,  
10:51:26 15 that we're not advisory, for example, and get  
10:51:29 16 that, you know -- so there's some basic facts that  
10:51:32 17 we want to make sure we get out

10:51:32 18 MR. WILCOX: Basic core --

10:51:32 19 COMMISSIONER DAI: Core facts.

10:51:34 20 MR. WILCOX: -- short message.

10:51:35 21 COMMISSIONER DAI: Yeah. At the  
10:51:36 22 beginning.

10:51:37 23 And it could play, like we said,  
10:51:37 24 the beginning of the meeting every meeting. And  
10:51:41 25 it's short so that, you know, people who are going

10:51:43 1 to multiple meetings don't get bored.

10:51:46 2 But it's informative --

10:51:46 3 MR. WILCOX: Right.

10:51:46 4 COMMISSIONER DAI: -- you know.

10:51:46 5 MR. WILCOX: Right.

10:51:48 6 COMMISSIONER DAI: And then leave,

10:51:49 7 like I said, the detailed kind of education to

10:51:52 8 that organization.

10:51:53 9 MR. WILCOX: Right.

10:51:54 10 And it's important to remember,

10:51:57 11 even though Californians voted on this issue twice

10:52:04 12 in Prop 11 and Prop 20, that we're not assuming

10:52:08 13 that that may be more than a few percentage of the

10:52:12 14 populus know that this is going on.

10:52:12 15 COMMISSIONER DAI: Right.

10:52:12 16 COMMISSIONER FORBES: Yeah.

10:52:12 17 Exactly.

10:52:12 18 COMMISSIONER DAI: Right.

10:52:16 19 MR. WILCOX: Or what redistricting

10:52:18 20 is.

10:52:18 21 COMMISSIONER FORBES: Uh-huh.

10:52:18 22 MR. WILCOX: And that's going to be

10:52:19 23 the challenge. Because we want to -- there's so

10:52:22 24 many Californians that are disenfranchised and

10:52:25 25 that have just dropped out that we want to make

10:52:27 1 this a real and open process.

10:52:29 2 And that is the core of our  
10:52:30 3 communications and media strategy is to get as  
10:52:34 4 many people as we can involved.

10:52:36 5 And that's where that key message  
10:52:38 6 comes in, to educate, to bring them in and say why  
10:52:42 7 you should care, why it matters.

10:52:47 8 COMMISSIONER DAI: Right. And I  
10:52:48 9 think that's really key. I mean --

10:52:48 10 MR. WILCOX: That's the key, yeah.

10:52:48 11 COMMISSIONER DAI: You know, I  
10:52:52 12 mean, yeah, because all this is great all this  
10:52:52 13 stuff's happening, but why should you care. What  
10:52:55 14 is --

10:52:55 15 COMMISSIONER FORBES: Because I  
10:52:55 16 went back and I reread Prop 11 several times, and  
10:52:59 17 it's interesting to see clearly one of the  
10:53:02 18 motivations that people put this on was their  
10:53:05 19 cities were sliced and diced.

20 COMMISSIONER DAI: Yeah.

21 COMMISSIONER FORBES: And --

22 COMMISSIONER DAI: We heard that  
23 today.

24 COMMISSIONER FORBES: I mean, and  
10:53:09 25 so that is --



10:53:09 1 MR. WILCOX: That's going to be a  
10:53:10 2 reoccurring thing you're going to hear.

10:53:12 3 COMMISSIONER FORBES: I mean, but  
10:53:12 4 that's the reason that they ought to care.

10:53:12 5 MR. WILCOX: Right.

10:53:14 6 COMMISSIONER FORBES: We can show  
10:53:15 7 examples.

10:53:16 8 COMMISSIONER DAI: Yeah. And they  
10:53:17 9 have representatives who've never visited them.

10:53:20 10 COMMISSIONER FORBES: Exactly. And  
10:53:20 11 so that's -- I mean, those kinds of examples are,  
10:53:22 12 I think, very effective in, you know, saying don't  
10:53:26 13 you think that Stockton should have its own  
10:53:29 14 representative rather than being sliced up among  
10:53:29 15 five districts?

10:53:32 16 You know, I'm not saying that's the  
10:53:33 17 case, but.

10:53:33 18 MR. WILCOX: Right.

10:53:33 19 COMMISSIONER FORBES: I mean, you  
10:53:35 20 know, that to me is a compelling argument to  
10:53:38 21 participate in this.

10:53:39 22 COMMISSIONER WARD: Which is  
10:53:40 23 actually a great point, because that's very true  
10:53:42 24 with these presentations. And all of our examples  
10:53:45 25 would have to be out of state, correct.

10:53:46 1 We wouldn't be able to use  
10:53:49 2 California examples of instances of -- because  
10:53:51 3 we'd be rendering opinions about those districts,  
10:53:53 4 and that's not something that we'd want to do as  
10:53:57 5 a --

10:53:57 6 COMMISSIONER FORBES: Except Prop  
10:53:58 7 11 specifically names some cities.

10:53:59 8 COMMISSIONER DAI: They did, yeah.  
10:53:59 9 It's true. We can cite the act.

10:54:01 10 COMMISSIONER FORBES: So I mean,  
10:54:02 11 that's --

10:54:02 12 COMMISSIONER DAI: We can cite the  
10:54:03 13 act.

10:54:04 14 MR. WILCOX: Why don't I say this  
10:54:06 15 before we do anything like that and before we do  
10:54:08 16 anything.

10:54:10 17 COMMISSIONER DAI: Legal review.

10:54:12 18 MR. WILCOX: Don't worry. That's  
10:54:13 19 right.

10:54:14 20 COMMISSIONER DAI: But you're  
10:54:15 21 right. In the preamble --

10:54:15 22 COMMISSIONER FORBES: Right.  
10:54:15 23 Uh-huh.

10:54:16 24 COMMISSIONER DAI: -- it  
10:54:16 25 specifically mentions certain ones. So I think

10:54:19 1 we'd certainly be within our legal right to go  
10:54:23 2 back to the Act.

10:54:24 3 COMMISSIONER FORBES: And then just  
10:54:24 4 quote the Act and then show the map of what that  
10:54:25 5 meant anyway.

10:54:28 6 MR. WILCOX: Okay.

10:54:28 7 COMMISSIONER RAYA: If we could go  
10:54:30 8 back for a moment to -- I have a connection here  
10:54:33 9 to make, I think the education part and further  
10:54:36 10 outlets for doing so.

10:54:37 11 I've been talking to a lot of --  
10:54:39 12 one of my employees is getting her A.A. this  
10:54:43 13 spring. So she talks a lot. She's not the  
10:54:46 14 average, you know, 18-year-old student, but  
10:54:49 15 nevertheless she talks about them a lot and talks  
10:54:51 16 about the classes that she has taken --

10:54:51 17 MR. WILCOX: Right.

10:54:53 18 COMMISSIONER RAYA: -- and has  
10:54:54 19 developed a great interest, of course, in this

10:54:57 21 But I was thinking even to, you  
10:55:00 22 know, coming out here, I was hoping we would see a  
10:55:03 23 lot of students.

10:55:04 24 COMMISSIONER DAI: Me, too. Yeah.

10:55:06 25 COMMISSIONER RAYA: I was really

10:55:07 1 hoping, and I -- some of you may be students, some  
10:55:11 2 of the members of the public who are here.

10:55:12 3 But I was really hoping that, it  
10:55:14 4 was too soon to do it now, but for future outreach  
10:55:17 5 that we might really try to develop relationships  
10:55:21 6 with community colleges, high schools --

10:55:21 7 COMMISSIONER DAI: Uh-huh.

10:55:24 8 COMMISSIONER RAYA: -- whatever  
10:55:25 9 to -- however big umbrellas there might be to  
10:55:27 10 reach these people.

10:55:29 11 I don't think people really have  
10:55:31 12 government classes anymore, but.

10:55:34 13 COMMISSIONER DAI: They do.

10:55:34 14 COMMISSIONER RAYA: Do they?

10:55:34 15 COMMISSIONER DAI: They're high  
10:55:35 16 school classes.

10:55:35 17 MR. WILCOX: Oh, yeah.

10:55:35 18 COMMISSIONER RAYA: They'll have  
10:55:35 19 classes?

10:55:36 20 COMMISSIONER DAI: Absolutely.

10:55:36 21 COMMISSIONER RAYA: Okay. Well,  
10:55:37 22 that's good to know.

10:55:37 23 COMMISSIONER DAI: Yeah.

10:55:39 24 COMMISSIONER RAYA: But those, you  
10:55:39 25 know, professors, we have a professor from

10:55:42 1 Santa Monica City College who has tracked us up  
10:55:45 2 and down the state.

10:55:45 3 MR. WILCOX: Yes.

10:55:45 4 COMMISSIONER RAYA: And undoubtedly  
10:55:47 5 he has a tremendous forum and students who are  
10:55:52 6 interested in this subject, the young man who  
10:55:57 7 addressed us this morning.

10:55:57 8 COMMISSIONER DAI: Uh-huh.

10:55:58 9 COMMISSIONER RAYA: So I just think  
10:55:58 10 there is an opportunity there to maybe build an  
10:56:01 11 enthusiastic audience, maybe recruit some  
10:56:04 12 volunteers, you know, a lot of ways to connect.

10:56:06 13 These are the people we talked  
10:56:07 14 about valuing as, you know, the future.

10:56:11 15 COMMISSIONER DAI: The next  
10:56:11 16 generation.

10:56:11 17 COMMISSIONER RAYA: The future of  
10:56:11 18 the work we're doing. So.

10:56:11 19 MR. WILCOX: We need to --

10:56:11 20 COMMISSIONER RAYA: Bear that out  
10:56:13 21 as members.

10:56:13 22 MR. WILCOX: I agree totally with  
10:56:17 23 that. And I'll just give a little bit of an  
10:56:19 24 example.

10:56:19 25 I fielded a call from the U.C.

10:56:23 1 Davis newspaper called the Aggie. Right? Is that  
10:56:25 2 correct?

10:56:25 3 COMMISSIONER DAI: Uh-huh.

10:56:27 4 MR. WILCOX: And Commissioner  
10:56:29 5 Forbes was kind enough to talk with him yesterday.  
10:56:31 6 Now, that's something that we fielded that they  
10:56:35 7 were interested in doing this.

10:56:39 8 But when we're talking about these  
10:56:40 9 campuses and you're talking about getting to the  
10:56:43 10 right classes or whatever, there's that -- a great  
10:56:46 11 opportunity.

10:56:46 12 And all of these campuses --

10:56:46 13 COMMISSIONER DAI: Uh-huh.

10:56:49 14 MR. WILCOX: -- universities and  
10:56:50 15 colleges that have their own media --

10:56:50 16 COMMISSIONER FORBES: Uh-huh.

10:56:50 17 COMMISSIONER DAI: Yes.

10:56:53 18 MR. WILCOX: -- and that, you know,  
10:56:53 19 we're not going to wait for the media, any of the  
10:56:57 20 media to call us, we're going to be very  
10:57:00 21 proactive.

10:57:00 22 COMMISSIONER DAI: Uh-huh.

10:57:00 23 MR. WILCOX: And that's another  
10:57:01 24 part of the in general outreach in that we can  
10:57:05 25 reach -- and you're absolutely right that we need

10:57:07 1 to reach the young people.

10:57:07 2 COMMISSIONER DAI: Yeah.

10:57:09 3 MR. WILCOX: Because this is the

10:57:11 4 future.

10:57:12 5 COMMISSIONER DAI: I think we need

10:57:13 6 a youth engagement strategy for sure.

10:57:15 7 COMMISSIONER FORBES: Right. And

10:57:16 8 like, for example, whether it be the student

10:57:18 9 government or whatever body --

10:57:18 10 COMMISSIONER DAI: Yeah.

10:57:19 11 COMMISSIONER FORBES: -- on campus,

10:57:19 12 the Young Democrats or Young Republicans or

10:57:21 13 whatever, if they want to --

10:57:24 14 COMMISSIONER DAI: Divide the

10:57:25 15 state?

10:57:25 16 COMMISSIONER FORBES: I'm afraid

10:57:26 17 those might be the youngest ones. I don't know.

10:57:29 18 So but to get them, you know, if they want to put

10:57:32 19 on an event, you know, we can come give a speech,

10:57:34 20 you know, if they can generate an audience...

10:57:37 21 COMMISSIONER RAYA: Yeah. Or make

10:57:38 22 it a field trip to come to --

10:57:39 23 COMMISSIONER DAI: Come to the

10:57:40 24 capital. Right?

10:57:42 25 COMMISSIONER RAYA: Yeah.

10:57:43 1 Something, you know. Come to one of our outreach  
10:57:47 2 sessions --  
10:57:47 3 COMMISSIONER FORBES: Uh-huh.  
10:57:47 4 COMMISSIONER RAYA: -- or whatever  
10:57:47 5 it might be.  
10:57:47 6 COMMISSIONER WARD: If I can jump  
10:57:48 7 in just with a personal experience over the last  
10:57:49 8 two weeks that I've had in working with some of  
10:57:52 9 that, not the high school, but the college  
10:57:54 10 level --  
10:57:54 11 COMMISSIONER FORBES: Uh-huh.  
10:57:55 12 COMMISSIONER WARD: -- trying to  
10:57:55 13 get some of that involved, is working with some of  
10:58:00 14 the political groups, you know, the college --  
10:58:00 15 COMMISSIONER FORBES: Right.  
10:58:02 16 COMMISSIONER WARD: -- ones, those  
10:58:03 17 tend to be smaller, you know what I mean --  
10:58:03 18 COMMISSIONER FORBES: Right.  
10:58:05 19 COMMISSIONER WARD: -- and poorly  
10:58:06 20 resourced.  
10:58:06 21 COMMISSIONER FORBES: Uh-huh.  
10:58:06 22 COMMISSIONER WARD: But the  
10:58:07 23 communications departments --  
10:58:07 24 COMMISSIONER FORBES: Uh-huh.  
10:58:08 25 COMMISSIONER WARD: -- public



10:58:09 1 relations --

10:58:09 2 COMMISSIONER FORBES: Uh-huh.

10:58:09 3 COMMISSIONER WARD: -- things like  
10:58:10 4 that are well, well funded and have a lot of  
10:58:13 5 resources available to them.

10:58:15 6 Graduating from Cal State Fullerton  
10:58:18 7 with a public relations degree, I went to them  
10:58:22 8 naturally and tried to -- there was an  
10:58:24 9 association, Public Relations Society of  
10:58:25 10 America -- Student Society of America, and tried  
10:58:28 11 to see about getting them engaged already --

10:58:28 12 COMMISSIONER FORBES: Uh-huh.

10:58:31 13 COMMISSIONER WARD: -- and things  
10:58:31 14 like that. And the first thing that was asked  
10:58:33 15 was, how much can you donate?

10:58:34 16 So I'm finding that even these  
10:58:36 17 resources in, putting out requests and things like  
10:58:40 18 that, there's been no student -- I mean, I'm being  
10:58:43 19 real. The reality of it is --

10:58:43 20 COMMISSIONER FORBES: Right.

10:58:45 21 COMMISSIONER WARD: -- there's been  
10:58:46 22 postings and there's been -- for I can say three  
10:58:48 23 and a half weeks now --

10:58:48 24 COMMISSIONER FORBES: Uh-huh.

10:58:49 25 COMMISSIONER WARD: -- and there's

10:58:50 1 not been one interest.

10:58:51 2 But there has been asked that we  
10:58:52 3 can put our group into motion about can we make  
10:58:55 4 donations to our group.

10:58:56 5 So that's something, you know, we  
10:58:58 6 need to think about is I think that they're a  
10:59:01 7 great resource, but we need to look at the reality  
10:59:04 8 and figure out, you know, how much can we do  
10:59:06 9 that --

10:59:06 10 COMMISSIONER DAI: It's not going  
10:59:06 11 to --

10:59:06 12 COMMISSIONER WARD: -- what's going  
10:59:07 13 to be available.

10:59:08 14 COMMISSIONER DAI: It's not going  
10:59:09 15 to be a P.R. of students. It's going to be the  
10:59:11 16 students who are engaged in political science.

10:59:11 17 COMMISSIONER WARD: Maybe that's  
10:59:11 18 it, then.

10:59:11 19 COMMISSIONER DAI: I mean, the  
10:59:18 20 wrong --

10:59:18 21 COMMISSIONER WARD: Direct our  
10:59:18 22 share?

10:59:18 23 COMMISSIONER DAI: Uh-huh.

10:59:19 24 COMMISSIONER WARD: Do they have  
10:59:19 25 awareness vehicles and public --

10:59:21 1 COMMISSIONER FORBES: Maybe we  
10:59:23 2 should be going to the president's and the  
10:59:23 3 chancellor's --  
10:59:23 4 COMMISSIONER DAI: Yeah.  
10:59:23 5 COMMISSIONER FORBES: -- office,  
10:59:25 6 from the top down. Because they can push more  
10:59:27 7 buttons.  
10:59:28 8 COMMISSIONER DAI: They can push  
10:59:29 9 more buttons, exactly.  
10:59:31 10 COMMISSIONER FORBES: Right.  
10:59:31 11 COMMISSIONER WARD: And again,  
10:59:31 12 yeah, it's -- we'll have to have a message in  
10:59:33 13 that's relevant to them.  
10:59:33 14 COMMISSIONER FORBES: Uh-huh.  
10:59:34 15 COMMISSIONER WARD: Because I'll  
10:59:35 16 tell you --  
10:59:36 17 COMMISSIONER DAI: But I do  
10:59:36 18 think --  
10:59:36 19 COMMISSIONER WARD: It's a  
10:59:36 20 bureaucracy that was --  
10:59:36 21 COMMISSIONER FORBES: Hard going.  
10:59:36 22 COMMISSIONER WARD: -- that was  
10:59:40 23 hard going, yeah. Yeah.  
10:59:40 24 COMMISSIONER DAI: Well, I mean, I

10:59:50 4 COMMISSIONER WARD: Uh-huh.

10:59:51 5 COMMISSIONER DAI: So I think we  
10:59:53 6 really need to think about, as you said, there are  
10:59:55 7 a lot of Californians, as you pointed out, who  
10:59:57 8 have been disenfranchised or have opted out and  
11:00:00 9 just are not engaged anymore.

11:00:01 10 So obviously, certain ethnic groups  
11:00:03 11 fall into that category, hard-to-reach voters, the  
11:00:07 12 young, the youth.

11:00:09 13 I think we need to just think about  
11:00:11 14 the general philosophy of how do we, you know,  
11:00:15 15 reach people who don't know this is important.

11:00:20 16 You know, I mean, this is the  
11:00:20 17 education piece --

11:00:20 18 MR. WILCOX: That's right.

11:00:23 19 COMMISSIONER DAI: -- of it that I  
11:00:23 20 think is important that we're involved in.

11:00:25 21 The Rotary Club probably, I mean,  
11:00:28 22 they know --

11:00:28 23 MR. WILCOX: They're engaged, yes.

11:00:29 24 COMMISSIONER DAI: They're already  
11:00:29 25 engaged; right?

11:00:29 1 COMMISSIONER FORBES: Right.

11:00:30 2 COMMISSIONER DAI: So I think it's

11:00:31 3 important that we do this --

11:00:31 4 MR. WILCOX: Right.

11:00:31 5 COMMISSIONER DAI: -- because we,

11:00:32 6 of course, want to encourage them to stay engaged,

11:00:34 7 but there's a whole kind of cohort of people who

11:00:37 8 are not.

11:00:37 9 MR. WILCOX: Yes.

11:00:38 10 COMMISSIONER DAI: And that's the

11:00:38 11 part where I think --

11:00:40 12 COMMISSIONER FORBES: Yeah. Look

11:00:41 13 who votes.

11:00:41 14 COMMISSIONER DAI: Yeah. Exactly.

11:00:42 15 COMMISSIONER FORBES: I mean, it's

11:00:42 16 not the under 20, I mean. I know, for example --

11:00:45 17 COMMISSIONER DAI: That's why the

11:00:46 18 youth --

11:00:46 19 COMMISSIONER FORBES: For example,

11:00:46 20 we have --

11:00:47 21 COMMISSIONER DAI: -- engagement is

11:00:48 22 very important.

11:00:50 23 COMMISSIONER FORBES: This is a

11:00:50 24 Davis. It's just a pretty politically --

11:00:50 25 MR. WILCOX: Yes.

11:00:52 1 COMMISSIONER FORBES: -- active  
11:00:53 2 town.  
11:00:53 3 COMMISSIONER DAI: Uh-huh.  
11:00:53 4 COMMISSIONER FORBES: We found that  
11:00:54 5 we didn't even advertise to the under 25s. We did  
11:00:58 6 mailings. We took them off the mailing lists.  
11:01:00 7 Because their turn-out was --  
11:01:00 8 COMMISSIONER DAI: So low.  
11:01:02 9 MR. WILCOX: And the school board  
11:01:02 10 election we didn't also.  
11:01:04 11 But the turn-out for that age group  
11:01:06 12 was 2 percent.  
11:01:08 13 COMMISSIONER DAI: Wow.  
11:01:08 14 MR. WILCOX: Oh, wow. That hurts.  
11:01:09 15 COMMISSIONER DAI: Now, how much of  
11:01:10 16 that is because the college-age population is very  
11:01:15 17 mobile and they're voting out of town?  
11:01:15 18 COMMISSIONER FORBES: They're not  
11:01:15 19 voting, no. This is the people that are  
11:01:15 20 registered in Davis.  
11:01:18 21 COMMISSIONER DAI: Oh.  
11:01:18 22 MR. WILCOX: I mean, of the  
11:01:18 23 registered --  
11:01:18 24 COMMISSIONER FORBES: We have --  
11:01:18 25 MR. WILCOX: -- 2 percent of the

11:01:20 1 registered.

11:01:20 2 COMMISSIONER FORBES: 2 percent of  
11:01:20 3 student -- and there're like ten students  
11:01:24 4 precincts where the student housing was. And  
11:01:25 5 we -- 2 percent turned out.

11:01:25 6 COMMISSIONER WARD: Wow.

11:01:27 7 COMMISSIONER FORBES: So we said  
11:01:28 8 there's no point in doing that. So it's really

11:29:00 18 And the last thing for the comment  
11:29:01 19 section, because I took up the time of giving 12,  
11:29:05 20 maybe it would be helpful, and I know it's -- you  
11:29:07 21 don't want it to get too unruly, but perhaps when  
11:29:10 22 you have a meeting agenda, after you finish each  
11:29:12 23 topic, maybe give, like, a minute of time, the  
11:29:15 24 comments that section of the agenda.

11:29:18 25 COMMISSIONER WARD: Thank you.

11:29:19 1 MR. BEAMER: My name's Dave Beamer.

11:29:23 2 I'm observing for the League of Women Voters,

11:29:23 3 which is a strong supporter of this --

11:29:23 4 COMMISSIONER DAI: Yes.

11:29:26 5 MR. BEAMER: -- this whole

11:29:27 6 operation and, you know, pushed Proposition 11 to

11:29:30 7 begin with.

11:29:30 8 And also, I've lived in Claremont

11:29:31 9 for 37 years, and which means I'm a resident of

11:29:35 10 the 59th Assembly District.

11:29:37 11 So if you -- you know, that map

11:29:38 12 could be a poster child for the whole thing, it's

11:29:42 13 just so bizarre.

11:29:42 14 COMMISSIONER FORBES: I feel the

11:29:42 15 same way.

11:29:43 16 MR. BEAMER: So I agree with what,

11:29:45 17 you know, Commissioner Forbes was saying about

11:29:46 18 getting some of those pictures out there, even

11:29:48 19 though some will still end up looking kind of like

11:29:51 20 that.

11:29:51 21 This doesn't connect to any --

11:29:53 22 anything in any way at all, nothing conceptual, no

11:29:56 23 case you can make for this district.

11:29:58 24 But I have a question: Can you, in

11:30:01 25 explaining why the redistricting is important, why

11:30:05 1 people should care about it, can you say that the  
11:30:07 2 current districting is a major reason why  
11:30:10 3 California government has become so dysfunctional?

11:30:13 4 And try to make that big point,  
11:30:16 5 which is more than just, you know, your local  
11:30:19 6 community has been messed up.

11:30:19 7 COMMISSIONER DAI: Uh-huh.

11:30:21 8 MR. BEAMER: And everyone knows the  
11:30:22 9 government's become dysfunctional. And that's --  
11:30:24 10 you can make a pretty strong case that this is one  
11:30:27 11 of the reasons for it. And that might get  
11:30:31 12 people's attention.

11:30:32 13 And just as a general comment about  
11:30:33 14 tone and style, you know, there's sort of a  
11:30:36 15 continuum between, on the one end of it is  
11:30:39 16 dignified, stilted, boring, you know.

11:30:44 17 Maybe the other extreme would be  
11:30:45 18 populist and sensationalist. And I would just  
11:30:49 19 encourage -- don't be too afraid of edging toward  
11:30:54 20 that populist sensationalist.

11:30:56 21 And there can be villains, you  
11:30:57 22 know, in just the way the incumbents are  
11:31:01 23 entrenched in protecting their own little  
11:31:02 24 fiefdoms. That gets people's attention.

11:31:04 25 COMMISSIONER FORBES: Called the

11:31:04 1 California Enquirer.

11:31:07 2 MR. BEAMER: Something with

11:31:08 3 villains. And a little anger seems to go a long

11:31:11 4 way. And that's -- oh, and also just confirming,

11:31:18 5 it's not advisory?

11:31:20 6 COMMISSIONER FORBES: No.

11:31:22 7 COMMISSIONER DAI: No.

8 MR. BEAMER: Okay. Because that

9 was --

10 COMMISSIONER DAI: No.

11 MR. BEAMER: Because that was --

12 COMMISSIONER FORBES: Rudy was

13 wrong.

14 MR. BEAMER: -- scary what she said

15 earlier.

11:31:23 16 COMMISSIONER DAI: No. We

11:31:23 17 corrected her.

11:31:23 18 COMMISSIONER FORBES: I corrected

11:31:23 19 her.

11:31:24 20 COMMISSIONER DAI: It is not.

11:31:25 21 COMMISSIONER FORBES: We whispered

11:31:28 22 in her ear.

11:31:29 23 MR. BEAMER: That's good to know.

11:31:29 24 COMMISSIONER DAI: Yes. No.

11:31:29 25 It's -- I said we took their jobs. This is our

11:31:32 1 mandate.

11:31:33 2 MR. BEAMER: You are drawing the

11:31:35 3 line, so yeah.

11:31:35 4 COMMISSIONER DAI: Yeah. We are

11:31:36 5 drawing the line. So yeah, that -- I was

11:31:38 6 concerned when I heard that.

11:31:39 7 COMMISSIONER FORBES: Yeah. Me,

11:31:40 8 too.

11:31:41 9 COMMISSIONER DAI: Yeah. So it was

11:31:42 10 good that you let us do what we --

11:31:44 11 COMMISSIONER FORBES: She's

11:31:45 12 quasi-politically sophisticated, you'd think, from

11:31:50 13 her situation.

11:31:50 14 COMMISSIONER DAI: That's why we

11:31:50 15 have media education.

11:31:51 16 COMMISSIONER FORBES: But she's

11:31:51 17 dead wrong.

11:31:52 18 MR. WILCOX: Even those in the

11:31:54 19 know --

11:31:54 20 COMMISSIONER FORBES: Don't know.

11:31:54 21 MR. WILCOX: -- don't know.

11:31:58 22 MR. BEAMER: That's all.

11:31:58 23 COMMISSIONER WARD: Thank you.

11:32:00 24 MS. SMITH: I'm Linda Akers Smith.

11:32:03 25 I work with the U.S. Census Bureau in the



11:32:04 1 Los Angeles regional office.

11:32:05 2 And we're just here observing both  
11:32:06 3 this committee and the technical committee to see  
11:32:09 4 what our role may be in the future.

11:32:12 5 And I have no comment.

11:32:14 6 COMMISSIONER DAI: Great.

11:32:14 7 COMMISSIONER WARD: Thank you.

11:32:14 8 COMMISSIONER DAI: Thank you.

11:32:15 9 MR. WESSEL: My name is Cameron  
11:32:17 10 Wessel. I'm a field representative for a state  
11:32:19 11 assemblyman, actually, the one that orders the  
11:32:23 12 59th district. It's the 63rd.

11:32:25 13 Which I don't know if you guys have  
11:32:26 14 taken a look at that one, we cover 12 different  
11:32:29 15 cities. So it's quite a big one.

11:32:31 16 So I just had one comment and one  
11:32:34 17 question. The first comment was that -- I'm  
11:32:41 18 sorry, the only comment is that I really like the  
11:32:43 19 idea about you guys reaching out to college  
11:32:45 20 students.

11:32:46 21 I think it's really important. As  
11:32:48 22 a college student myself, I'll tell you, we don't  
11:32:50 23 get a lot of exposure to, you know, redistricting  
11:32:54 24 and, you know, kind of where the district lines  
11:32:56 25 are drawn and that kind of thing.

11:32:58 1 So I think it'd be really important  
11:33:00 2 to let them know why there's such a strong support  
11:33:05 3 for a volunteer commission and, you know, kind of  
11:33:07 4 give them the history on why some of these  
11:33:10 5 districts are so, you know, ridiculously drawn and  
11:33:13 6 what the point is of coming in and redistricting  
11:33:16 7 them.

11:33:17 8 So yeah, I think, you know,  
11:33:18 9 reaching out to college students would be a really  
11:33:21 10 great thing to do.

11:33:22 11 And then I just had one question.  
11:33:26 12 I've talked to a lot of constituents in our  
11:33:30 13 district, and a lot of them, when I tell them that  
11:33:31 14 we cover 12 separate cities -- and I think we only  
11:33:35 15 cover, like, a mile of one city.

11:33:37 16 So you know, it's just some of them  
11:33:39 17 are like, you know, why is -- why do you guys  
11:33:41 18 cover such a huge district?

11:33:43 19 So I was just curious if you guys  
11:33:46 20 know, is there, like, a maximum amount of cities  
11:33:50 21 that you guys are trying to reach or is it more on  
11:33:54 22 just population?

11:33:56 23 How are the new districts going to  
11:33:58 24 be kind of consolidated, do you guys know?

11:34:01 25 COMMISSIONER FORBES: Well, let me

11:34:01 1 make a reference. There's -- I mean, they have to  
11:34:03 2 be roughly the same population.

11:34:03 3 MR. WESSEL: Yeah.

11:34:06 4 COMMISSIONER FORBES: But also,  
11:34:08 5 Prop 11 gives them specific criteria that we're  
11:34:10 6 supposed to consider, and I would -- I don't  
11:34:12 7 remember them all.

11:34:12 8 I mean, they're supposed to be, you  
11:34:14 9 know, compact and so forth and so on. But we have  
11:34:18 10 to comply with the Voting Rights Act.

11:34:20 11 But there is a list of the criteria  
11:34:22 12 in the Prop 11 that we are to, you know, try to  
11:34:25 13 adhere to best we can.

11:34:28 14 COMMISSIONER DAI: And in order of  
11:34:30 15 precedence.

11:34:30 16 COMMISSIONER FORBES: In order of  
11:34:30 17 precedence, right.

11:34:30 18 COMMISSIONER DAI: And the main  
11:34:32 19 thing is to maintain communities of interest.

11:34:32 20 COMMISSIONER FORBES: Right.  
11:34:32 21 That's the drive.

11:34:34 22 COMMISSIONER DAI: And there is a  
11:34:35 23 stipulation in the voters first act that we try to  
11:34:38 24 respect political boundaries, cities, counties.

11:34:38 25 MR. WESSEL: Okay.

11:34:42 1 COMMISSIONER DAI: So that is part  
11:34:44 2 of our charter is to try to respect that.

11:34:50 3 COMMISSIONER WARD: Chris; right?

11:34:52 4 MR. WESSEL: Cameron.

11:34:53 5 COMMISSIONER WARD: Cameron. Thank  
11:34:53 6 you. Sorry about that.

11:34:53 7 MR. WESSEL: Yeah.

11:34:55 8 COMMISSIONER WARD: Great comment  
11:34:55 9 about the college students. I'm wondering,  
11:34:58 10 though, since you're here and attending the  
11:35:00 11 meeting, can you give us what would -- how's the  
11:35:00 12 best way to do that?

11:35:05 13 What's the best message to send to  
11:35:06 14 college students to get their attention?

11:35:08 15 MR. WESSEL: I think one of the  
11:35:10 16 best ways to do it would be trying to get to all  
11:35:13 17 the government classes. That'd be a great way to  
11:35:18 18 start, you know, just the political science  
11:35:20 19 classes.

11:35:20 20 Inform teachers. Because a lot  
11:35:22 21 of -- you know, a lot of teachers tend to kind of  
11:35:26 22 press their ideals on the students from my own  
11:35:30 23 personal experience.

11:35:31 24 So you know, just making sure that  
11:35:33 25 they're informed of what's going on and making

11:35:35 1 sure that they make it a point to just kind of  
11:35:39 2 take a nonpartisan stance on it and be like, you  
11:35:43 3 know, this is what's going on, this is why there's  
11:35:46 4 a need to restrict, you know, that kind of thing.

11:35:48 5 And then, I mean, even putting it  
11:35:51 6 out in, colleges have, like, the college paper.  
11:35:55 7 You know, there's, like, newsletters, e-mails, you  
11:35:57 8 know, e-mail lists, you know, just all kind of  
11:36:01 9 stuff.

11:36:01 10 And in our office, in our assembly  
11:36:05 11 office, we actually send out a, this is just an  
11:36:07 12 example, we send out a mass e-mail to all of the  
11:36:10 13 PolySci professors in all of our surrounding  
11:36:15 14 areas.

11:36:17 15 And they -- it was basically just  
11:36:19 16 to see if we could get them to forward that out to  
11:36:20 17 their students for an internship possibility. And  
11:36:24 18 I'll tell you, we got I think, like, 20 responses  
11:36:26 19 back within five or six hours of getting that out.

11:36:30 20 So PolySci teachers are interested  
11:36:33 21 in what's going on, and they do like to, you know,  
11:36:36 22 try to get their students more involved and let  
11:36:38 23 them know what's going on.

11:36:40 24 So I think, you know, those would  
11:36:41 25 be some -- probably some pretty good possibilities

11:36:45 1 on how to actually, you know, implement that, you  
11:36:47 2 know.

11:36:47 3 COMMISSIONER WARD: Thanks,  
11:36:48 4 Cameron. Appreciate it. Thank you.

11:36:50 5 MR. KOPP: My name is John Kopp.  
11:36:51 6 It's K-o-p-p. I live in East Vale, which is the  
11:36:55 7 northwest corner of Riverside County cheek and  
11:36:59 8 jowl with San Bernardino County, which wraps  
11:37:02 9 around.

11:37:03 10 And I'm also -- I didn't disclose  
11:37:05 11 it in the first meeting, but I'm a member of the  
11:37:08 12 Riverside County Democratic Central Committee. I  
11:37:11 13 applied to be on the commission, I submitted my  
11:37:16 14 supplemental, and then I got axed.

11:37:19 15 So to follow up on --

11:37:19 16 COMMISSIONER FORBES: No hard  
11:37:19 17 feelings.

11:37:24 18 MR. KOPP: I wasn't a member of the  
11:37:26 19 central committee when I applied, so I was still  
11:37:27 20 eligible. That was a later event.

11:37:29 21 About voters versus youthful  
11:37:34 22 voters, the general voters versus youthful voters,  
11:37:35 23 a friend of mine, Bill Hedrick, who ran for  
11:37:39 24 Congress in the 44th District, he was ruminating  
11:37:42 25 one afternoon saying that they were trying to

11:37:46 1 contact youthful voters all through the campaign,  
11:37:46 2 all through the campaign.

11:37:50 3 And what he finally determined was  
11:37:53 4 that they really didn't get a rise, didn't get a  
11:37:56 5 response out of the youth vote until they started  
11:38:00 6 pressing a message on a single issue. And it  
11:38:02 7 happened to be immigration. That's just the  
11:38:04 8 example from his district.

11:38:06 9 So you've got -- you may have a lot  
11:38:09 10 of trouble contacting youthful voters. They move  
11:38:12 11 a lot. They're going to school. They're new in  
11:38:14 12 their jobs. They get a promotion, they have to  
11:38:17 13 move from Sacramento to Marin County or something  
11:38:20 14 like that. So they're very transient.

11:38:22 15 But now, in terms of my general  
11:38:24 16 comments, I think your website really needs to be  
11:38:26 17 clearer. For example, for this February 12th  
11:38:31 18 through 13th meeting hand-outs page that you could  
11:38:34 19 go to, the fifth item was the Voting Rights Act  
11:38:37 20 and the conscientious redistricter by Paul  
11:38:41 21 McKaskle. And it said 12.50.

11:38:46 22 Now, I didn't spend 12.50 on the  
11:38:48 23 website because I was hoping that the commission  
11:38:51 24 would have popped for, you know, a bunch of copies  
11:38:54 25 and had them available for distribution.

11:38:56 1 So the website was unclear as to  
11:38:58 2 what I had to do. In other words, what does a  
11:39:02 3 citizen have to do when they're seeing something  
11:39:05 4 on the website if the -- you know, by the way, are  
11:39:06 5 you guys going to pop for that or do I have to  
11:39:09 6 spend 12.50 to get that?

11:39:10 7 COMMISSIONER WARD: We'll have to  
11:39:12 8 discuss it right now.

11:39:12 9 MR. KOPP: All right.

11:39:13 10 COMMISSIONER WARD: Right now we've  
11:39:14 11 got a hundred dollars total.

11:39:14 12 MR. KOPP: But anyway --

11:39:14 13 COMMISSIONER WARD: So.

11:39:16 14 MR. KOPP: -- in terms of whatever  
11:39:17 15 media you use, whether it's print or on-line or  
11:39:22 16 your website, when you archive your material, it  
11:39:25 17 has to be retrievable.

11:39:31 18 Okay. In terms of I.T. assistance,  
11:39:34 19 you mind fight colleges and university departments  
11:39:36 20 have, you know, the star pupil who's working on a  
11:39:38 21 master's degree that might be able to assist you,  
11:39:41 22 or laid-off state workers.

11:39:44 23 One of the things that's going to  
11:39:49 24 come up, and maybe can you help with this, when  
11:39:53 25 you start dealing with the census data, it's going



11:39:58 1 to be very confusing to the public. And your  
11:40:01 2 website or communications need to make clear what  
11:40:05 3 is happening.

11:40:08 4 You know, I pulled out the thing  
11:40:09 5 from the strength in numbers from -- is that the  
11:40:15 6 Census Bureau publication?

11:40:16 7 I read through it, you know. And I  
11:40:18 8 can see that I'm going to be very confused when we  
11:40:20 9 start getting to maps and populations and so  
11:40:23 10 forth.

11:40:26 11 When you reach out to ethnic and  
11:40:29 12 special groups, not just their media favorites,  
11:40:34 13 but you might want to contact things like black  
11:40:37 14 churches. It's a very concentrated center of a  
11:40:41 15 community. Or nonprofits such as the League of  
11:40:45 16 Women Voters, although they're already very  
11:40:48 17 actively involved.

11:40:49 18 But you know, the American  
11:40:50 19 Association of College Professors, American  
11:40:53 20 Association of University Women, Catholic Bishops,  
11:40:57 21 Lutheran Synods, the A.A.R.P., those sorts of  
11:41:00 22 things, that directly communicate with their own  
11:41:02 23 people.

11:41:03 24 You might even want to, you know,  
11:41:08 25 don't take too much input from them because

11:41:10 1 they're not too trustworthy, but you might want to  
11:41:14 2 pass information on to the central committees of  
11:41:16 3 the two primary parties, you know, and let them  
11:41:18 4 distribute it to their population. They may add  
11:41:21 5 comments, but you know, there are all sorts ever  
11:41:25 6 things.

11:41:26 7 I somewhat disagree with  
11:41:29 8 Commissioner Forbes that you want to use video  
11:41:32 9 versus PowerPoint. I usually find that videos  
11:41:37 10 obfuscate more than they help.

11:41:38 11 If you have a PowerPoint, you're  
11:41:39 12 trying to say this, this, this and this, therefore  
11:41:42 13 that, and it's usually pretty clear.

11:41:45 14 When I see a video done on a low  
11:41:47 15 budget, I'm usually concentrating on how bad the  
11:41:51 16 actors are.

11:41:51 17 COMMISSIONER DAI: And that would  
11:41:52 18 be us.

11:41:54 19 MR. KOPP: Well, and finally, some  
11:41:57 20 of the points, I think most sociologists and  
11:42:03 21 historians would conclude at the end of the 20th  
11:42:06 22 Century that we're a pretty tribal species.

11:42:10 23 We concentrate on what we like, the  
11:42:12 24 people who are similar to us, you know. We have a  
11:42:16 25 history of centuries of ethnic cleansing no matter

11:42:22 1 who it was that was doing it, whether it was the  
11:42:23 2 Nazis or, you know, the clean-up of Serbia.

11:42:29 3 And so when you get to the  
11:42:30 4 different criteria about numerical equality of  
11:42:35 5 population, territory contiguous and compact,  
11:42:38 6 counties with -- and cities within proposed  
11:42:40 7 districts maintained intact as far as practicable,  
11:42:44 8 you get down to criteria four and five, the  
11:42:46 9 integrity of California's basic geographical  
11:42:49 10 regions, and I know this is in Prop 11, but -- and  
11:42:51 11 then Number 5, the social and economic interests  
11:42:54 12 common to the population of an area, a so-called  
11:42:57 13 community of interest should be considered in  
11:42:59 14 determining whether the area should be included  
11:43:01 15 within or excluded from a district that you're  
11:43:05 16 proposing, you've got to be -- that's probably  
11:43:08 17 going to be your slipperiest slope, you know,  
11:43:13 18 determining what is a community of interest.

11:43:15 19 And I'm pretty sure you're not  
11:43:20 20 going to be able to find that from the population  
11:43:21 21 data, so you're going to have to take that from  
11:43:23 22 testimony.

11:43:24 23 But you could move so far that it  
11:43:25 24 would begin to look like ethnic cleansing, you're  
11:43:29 25 going to include this group and you're going to

11:43:30 1 exclude that group from a particular district.

11:43:34 2 So you better be real careful  
11:43:37 3 there.

11:43:37 4 MS. WOODS: Sorry. Do you mind if  
11:43:38 5 I just add something to his point?

11:43:38 6 COMMISSIONER WARD: Certainly.  
11:43:39 7 Just so we can make a statement, we  
11:43:39 8 have two minutes till we wrap up. So certainly.

11:43:42 9 MS. WOODS: Oh, just to his  
11:43:43 10 community of interest point, I think that's a good  
11:43:45 11 one that keeps on being raised is like, what is a  
11:43:47 12 community of interest.

11:43:47 13 So when you talk about doing these  
11:43:49 14 YouTubes or PowerPoint or something of that sort,  
11:43:52 15 I think if you had something as basic as here are  
11:43:55 16 five examples, if you want to make an argument for  
11:43:57 17 a community of interest, you can start with these  
11:43:59 18 five.

11:44:01 19 Because I think that's where you're  
11:44:02 20 going to lose a lot of people even if they can  
11:44:06 21 wrap their mind around what redistricting is.

11:44:07 22 MR. KOPP: One final point?

11:44:09 23 You know, I think you can use --  
11:44:12 24 you can speak as badly about a current district as  
11:44:17 25 you'd like. You individually and as a group

11:44:19 1 should have that freedom, and I think you do.

11:44:22 2 You may not want to get into the  
11:44:24 3 personalities of the people who occupy those  
11:44:27 4 districts, but -- or even the reason why they were  
11:44:29 5 created, but you can use them as demonstrations.

11:44:32 6 I in the public meeting pointed out  
11:44:34 7 Riverside has six assembly districts, I forget,  
11:44:41 8 it's so annoying, but numerous senatorial, state  
11:44:45 9 senatorial districts. And it's congressional  
11:44:49 10 districts are carved up between itself and several  
11:44:52 11 other counties.

11:44:52 12 The only congressional district  
11:44:54 13 that is entirely within Riverside County is Mary  
11:44:59 14 Bono Mack's 45th Congressional District. The 44th  
11:45:04 15 is heavily populated with Orange County and, you  
11:45:08 16 know.

11:45:08 17 So you can use those maps as  
11:45:09 18 examples of bad acting.

11:45:12 19 COMMISSIONER WARD: Thank you. I  
11:45:13 20 appreciate all your input. It's very helpful.

11:45:17 21 Okay. So tomorrow we have to -- or  
11:45:19 22 Saturday we have to give a presentation to the  
11:45:23 23 broad commission.

11:45:24 24 And do we have any volunteers that,  
11:45:27 25 I'd think the two would be appropriate, to take

11:45:31 1 that up and put together a -- it's each group is  
11:45:36 2 going to have about an hour and a half to be able  
11:45:39 3 to discuss the findings of their subcommittee,  
11:45:43 4 actions steps and then future plan.

11:45:47 5 And then Mr. Wilcox will also have  
11:45:50 6 a portion of that hour and a half to address the  
11:45:52 7 commission and give a vision as well.

11:45:56 8 Any commissioners want to take --  
11:45:57 9 volunteer to be part of the presentation.

11:45:58 10 COMMISSIONER DAI: I would think  
11:45:59 11 most of the time should actually go to Rob. I  
11:46:01 12 mean, I think a lot of this has been brainstorming  
11:46:04 13 and input into his plan, his strategy.

11:46:08 14 That's my personal take on it.

11:46:10 15 COMMISSIONER RAYA: You have, you  
11:46:10 16 know, you have a very good, Mike is so good at  
11:46:16 17 this, summarizing, you know, and bullet points.

11:46:18 18 COMMISSIONER WARD: Well, I'm happy  
11:46:19 19 to help, yeah.

11:46:20 20 COMMISSIONER RAYA: I mean, I think  
11:46:21 21 that could be just a good introduction for Rob to  
11:46:24 22 go forward with his --

11:46:25 23 MR. WILCOX: I think it would be  
11:46:27 24 great. Because you as the chair of this  
11:46:29 25 subcommittee and with your vision and your take of

11:46:33 1 this, that would be great for you to give an  
11:46:34 2 overview and an intro and then whatever you want  
11:46:37 3 me to do.  
11:46:40 4 COMMISSIONER WARD: I don't know  
11:46:41 5 that I'm chair of the subcommittee.  
11:46:41 6 COMMISSIONER DAI: Yeah. We don't  
11:46:41 7 have chairs.  
11:46:41 8 MR. WILCOX: Oh.  
11:46:45 9 COMMISSIONER WARD: But what do you  
11:46:45 10 know?  
11:46:46 11 MR. WILCOX: I'm sorry.  
11:46:48 12 COMMISSIONER DAI: No.  
11:46:48 13 MR. WILCOX: Okay. So what we'll
