Region IV Wrap-Up

Executive Summary originally delivered on May 4, 2011

The following is a summary of the major points that have been raised through public testimony about Region IV. It is not an exhaustive list of every public comment; those are available in a MS Access Database. Also, there are no recommendations in this document. It is merely a summary of what was communicated and proposed by the public and any technical notes related to those proposals of which the Commission should be aware.
