Subject: City Boundries in Riverside County - Eastvale and the New City of Jurupa Valley

Dear Commission Members, Staff, Voting Rights Counsel and Mapping Consultants:

My name is **John Kopp** and I was speaker #4 at last nights (05/05/2011) Public Input Meeting in Norco.

My e-mail address is [REDACTED].

While viewing the on-screen/projected maps of the Northwestern corner of Riverside County, I noticed **map errors in the boundaries** for the **City of Eastvale**, where I live, as well as the new **City of Jurupa Valley**, which has been voted into existence and will formally become a city on 07/01/2011.

I was told that in order to investigate the need for making a correction to your mapping software, the Commission would need for me to formally communicate (testify to) the need for same to you. This message is intended as that formal communication.

I.

The City of Eastvale was newly incorporated 10/01/2010, and the long "finger" that extends Northward from Remington / Belgrave Avenues ends short of the actual city's true northern border in your mapping software. That stretch of land follows the Riverside / San Bernardino county line (down the middle of Hamner Avenue) and goes all the way North, beyond State Hwy-60 and Mission Blvd. until it reaches Philadelphia Avenue. The city's Northern boundary then turns East at Philadelphia Ave. and continues to run Eastward until it intersects the mid point (median strip) of Interstate-15 where it turns Southward.

Attached below is a map copied and pasted over from the City of Eastvale's website (<http://www.eastvalecity.org/city-boundaries/>) showing the city boundaries. Please make the necessary correction to your mapping software. II.

I believe you ultimately received testimony last night in Norco about the proposed borders of the newly created City of Jurupa Valley, - but to make sure, here are the boundaries of this city which will come into existence 07/01/2011 and which should be considered a - Community of Interest, like any other city. -

The new city's Western boundary runs down the middle (median strip) of Interstate-15 until it reaches the Riverside / San Bernardino County line. From there it runs Eastward until it reaches the Santa Ana River, which river, running first South, then Southwest and then West, forms the Eastern & Southern border of the city. A copy of the map that was include by the Riverside County Registrar of Voters' Sample Ballot In English for the 03/08/2011 Special Incorporation Election can be found on page 10 of that document by going to the Riverside County Registrar of Voters' web site: http://www.election.co.riverside.ca.us/docs/3-8-11_English%20Ballot.pdf.

While in that .pdf document, you'll see at the bottom of page there, you'll see the Registrar's comment "**If you desire a copy of the Legal Description of the boundaries, please call the Registrar of Voters' office at (951) 486-7200, and a copy will be mailed at no cost to you.**"
