Dear Members of the Citizen Redistricting Commission:

Thank you once again for the opportunity to testify before you in Santa Rosa this past Friday. My name is Denise Rushing and i am the District 3 Supervisor for Lake County. I testified both as a board member and as a citizen. It was my desire to emphasize our Board's position --I believe that I was the only Lake County resident to testify before you at the hearing and I am certain that my position represents the desire of the majority (if not all) of Lake County residents. Our Board of Supervisors recently submitted a resolution to you that states our unanimous position.

Lake County STRONGLY supports staying grouped with the other premium wine counties of Napa, Mendocino and Northern Sonoma Counties. On a federal level, we have Geothermal industry interests in common, and this issue is quite important to our respective counties. I would go on to say it would be a tragedy for Lake County to be separated from these counties in a new congressional district with others to the east or north of our small county. In addition, Lake has watershed ties with Yolo County and thus will continue to work closely with them going forward.

I further testified that, as a board, we do not have any affinity with Colusa or Glenn Counties as our respective counties are separated by a mountain range and many miles of wilderness and we do not have any significant community or economic ties. Further, we just successfully received the recommendation from the State workforce investment board to join with Napa county on workforce and economic development issues. In fact, 150 years ago this week, we were part of Napa County and thus share a common history. We are acknowledging our 150th anniversary of the formation of Lake County: in 1861 we were formed from the northern "hot springs" portion of Napa County.

It is our boards desire, and my own individual hope, that we (a) remain intact as a county in any redistricting and (b) we remain in a substantially similar congressional district as we are today.

Thank you once again for your hard work, your dedication and your consideration.
