On behalf of the Mendocino Coast Audubon Society, we would like to commend the commission on its efforts to re-draw the lines for Congressional, State Senate, and Assembly districts. While we appreciate your holding public hearings, the Region 9 hearings in Redding were not conducive to attendance from those of us on the North Coast.

Had we been able to attend, we would have expressed our concern with an east-west division of the northern part of the state. Those familiar with the inland versus coastal environments will be aware of the vast differences in topography, flora and fauna. While we share a concern for the environment with our inland neighbors, our environments are quite different.

Historically, these unique differences, and the coalitions that have developed have recognized the north-south corridors (Highway 101) that unite us. We are further united by our proximity to the ocean. We share watersheds and redwood forests. Our avian wildlife, particularly shore birds are north-south migrants. Decisions made at federal and state levels need to consider our unique ecology. We are best served by representatives who are able to visit our area and understand our needs.

Our Audubon society is engaged in citizen science projects that cover the northern California coast. In conjunction with other coastal Audubon societies, we conduct shore bird and sea bird research projects. We work with the California Coastal National Monument and BLM on these projects. We work with our State Parks to monitor the beaches and study shore bird migration. These projects are done in collaboration with state and federal agencies and other coastal groups. Recently a representative participated in the Marine Life Protection Act Stakeholders group. This project was unique to the coast of California and included our state representatives who have knowledge of coastal issues from all political sides.

Again, we thank you for your work and urge you to keep the north coast counties in the same Congressional, Assembly and State Senate Districts. The California coast, a national treasure, will be better served, as will the avian residents and migrants who depend upon it.
