Dear Commissioners,

As a resident of Mendocino County in Northern California, I urge you to consider a coastal community of interest that is glued together by our connection to land and water--and wildlife.

The attached handout is a bit of a different map. The source is California Audubon and it's a map of California's Important Bird Areas--literally a road map for birds that indicates areas where large or significant numbers of birds forage, rest, reproduce and raise their young. In a poetic way, this bird map defines our North Coast community of people. The green portions are Important Bird Areas--some 145 areas in the state described by Audubon and American Bird Conservancy scientists as so important to animals and plants that heroic efforts should be made to conserve that land.

In the northwest corner of the state, you'll see a string of green spots that stretches along the coast north to south. That area corresponds fairly closely to Del Norte, Humboldt, Mendocino and Trinity counties. And further south there are pockets in Lake, Napa and Sonoma Counties. Birds don't respect county lines, so they aren't drawn on this map. These counties are where we would like you to look for our Congressional, State Senate and Assembly districts because we feel we are tied together with people in these counties by our commitment to unique ecological and economic environments.

We love our ocean, our wildlife, our water and our land. In Mendocino County alone, more than 45 per cent of our 2.2 million total acres is in some form of conservation ownership or management. And we share concerns of sustainable forestry, fishing and recreation with people in neighboring counties. Recently, a representative of our Audubon chapter participated in the Marine Life Protection Act Stakeholders group. The project was unique to the coast of California and included participants who have knowledge of coastal issues from all political sides.

If an elected official serves the people in this area of the state, that official must know about our land, water and wildlife. And that human community more or less reflects migratory bird behavior. People I know travel just like birds--mostly north to south (in our case, we travel primarily along the Highway 101 corridor). In northernmost California, it wouldn't make sense to draw district lines west to east because there are big mountains between the North Coast and the east part of the state--and those mountains divide our worlds.

The birds know that and so should we.

What's so important about birds and what difference does all this make to us? A year ago, the U.S. Interior Secretary came out with a state of the birds report that indicates large bird populations are being wiped off the face of the earth. Shorebirds and seabirds, especially, are in deeply serious decline and they are some of the first indicators of environmental stress on our planet. If the birds are in trouble, so are we.

We on the Mendocino Coast are deeply involved in citizen science and university level research about our coastal birds. We conduct research with the Bureau of Land Management, the

California Coastal Monument and an on-going long-term shorebird research project with California State Parks. And that work puts us in contact with researchers up and down the Northern California coast and Sonoma State University.

Birds teach us something every day about how to take care of our world. The lessons we learn from them apply to sustainability in our agriculture, commercial and recreational fishing, hunting, timber production in the coastal redwood zone and the land conservation movement in this Northern Coastal community of interest.

Logic tells us that it is wise to respect county boundaries as much as possible when the lines are drawn up north. Del Norte, Trinity, Lake and Napa County clearly can be grouped together with Humboldt, Mendocino as as much of Sonoma county as possible. We'd like to see that reflected in our State Senate District and as much as possible in our Assembly and Congressional District. Currently, there are fingers of the State Senate District and Congressional District that meander into Solano and/or Yolo Counties and that's too far from our communities of interest. It takes our representatives too far away from home. And we'd like you to adjust those district boundaries so they make more sense.

Thank you for an opportunity to expand on these thoughts I shared with you as speaker #16 at your May 20 hearing at Santa Rosa City Hall.

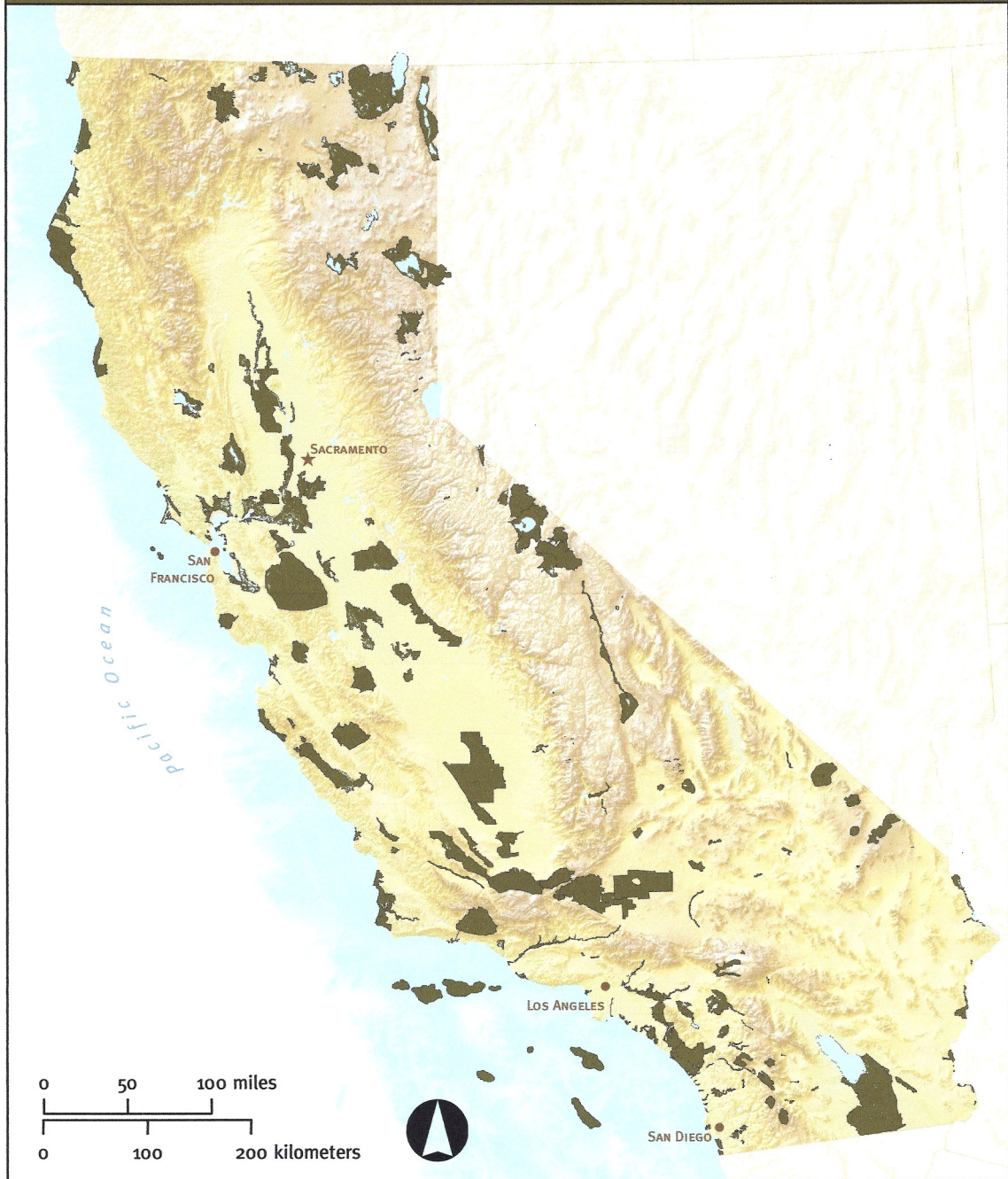

Dear Citizens Redistricting Commission:

As a resident and the retired Office of Emergency Services Coordinator (OES), Assistant Chief of Mendocino County Fire Warden and retired Fire Chief of the Hopland Fire Protection District I am voicing my opinion on the redrawing of Congressional and State Legislator Districts.

My particular focus is on Emergency Management as it relates to natural and man-made disasters throughout the North and Redwood Coastal Regions. Over my long public service career I served as a key Emergency Management Planner that developed Emergency Operational Plans for Mendocino, Humboldt, Del Norte and Lake Counties, including the 16 Incorporated cities throughout the region. Thought-out the late 1980's and 1990's I served as a key planner in developing emergency plans addressing response and preparedness to Off Shore Oil Spills related to shipping accidents from vessels traveling off our coastline from Alaska to Bay Area Refineries. Additionally during my active service I deployed to Wildland Urban Interface Fires, Floods, Tsunami, Earthquakes and Hazardous Materials spills throughout the region. With that I was task to coordinate response and recovery operations. As a major point, it has been a benefit for all the counties, cities, special districts, native American reservation governments and its citizens welfare to have the ability to work with our current Congressional District and State Legislator Districts following a Local Emergency Proclamation, Governors State of Emergency and Presidential Federal Declaration as key points in moving response and recovery efforts forward. The current Congressional and State Legislator Districts represent common interest in combating major contiguous disasters.

Our coastal counties and cities of Mendocino, Humboldt and Del Norte and neighboring counties of Lake, Napa and Yolo share common interest and address same issues related to emergency management programs. Message Body:

My comments are based on my occupation as a post-secondary school educator in a California Community College district and on my long term residency in a northern California seacoast town. I have experienced firsthand the economic, social, and civic common interests that are inherent in the north coast counties of Del Norte, Humboldt, Mendocino, and Sonoma. Geophysical features, such as the maritime western boundary and the coastal range of mountains, and human-engendered patterns, such as the generally widespread rural settlement of the area and its transportation corridors, firmly define this as one community. I strongly believe this community represents an integrated and interdependent area that is best unified in a single legislative district.

The college student population of this area tends to move to and study at institutions to the north and south. From my home town in Mendocino County, students matriculate at Santa Rosa area schools such as Sonoma State University and secondarily to Humboldt State University. This reflects the continuing importance of a natural resource economy in the region for traditional reasons, such as timber and fisheries, and newer enterprises in tourism and recreation, since these schools possess or are developing strong career programs in these areas.

The agricultural base seems to be centered at the southern end of the district and to extend eastward only there, to the Napa and Sonoma valleys. The viticulture and wine-producing districts are justly world-famous and are perhaps also a natural part of the Mendocino and northwestern Sonoma agricultural bloc.

In general, this comparatively sparsely-settled region of California could best contribute to the commonwealth of the state by being unified and integrated to mirror its existing characteristics. Public officials should be able to clearly act to promote its rational development. For example, many parts of the area do not have reliable access to contemporary internet service, a key infrastructure for the 21st century. I would think a single legislative district would be better able to effectively bring such services to the population.

The people of this area would be fairly and reasonably represented by districting that acknowledges the maritime border, population centers and transportation routes, common economic and agricultural factors, and the social/educational needs of Del Norte, Humboldt, Mendocino, Sonoma and Napa counties. My thanks to the Commission for their consideration and their work.
