I'm a concerned citizen of Yolo County and wish to express my cautionary views and concern about the redetermination of legislative districts. My husband and I have been residents of Yolo County for 45 years, 20 in Winters and 25 as residents of Davis.

In my professional work, my region covered 30 of California's 58 counties, from the Oregon border to the LA county line; from Sacramento to the Nevada state line. I know well the characteristics of the interior valley of California. In my view, the legislative district lines should follow along the I-80 corridor. With the I-80 corridor, there are a large number of community conditions such as education, transportation, water and air, to name a few, that must be addressed through the legislative process. These community conditions are more alike with their combined rural and urban characteristics than much of the rest of the state that is more rural in nature.

As an educator, the student needs and financial conditions of the school districts in Solano and Yolo counties are more similar and almost completely dissimilar to the rural school districts of neighboring counties. The surrounding industries that are supported by the economy of education are similar in need and dimension as well.

When considering the traffic/transportation and the transportation of goods and services and the prevailing conditions associated with these, and the legislative policies that guide them, none of the counties west of Sacramento and east of the Bay Area, compare to the traffic/transportation concerns of the I-80 corridor.
