Little Saigon Is A Community Of Interest That Has Been Split In The Past

I live in the Westminster/Garden Grove portion of Little Saigon. I'm here to ask you to keep Little Saigon together. We are currently split up between many Congressional, State Senate, and State Assembly districts, and this is not fair to us. It makes our voices less likely to be heard, and although we're part of the cities of Westminster, Garden Grove, southwest Santa Ana or north Fountain Valley; we deserve the same representation as any other group of citizens in Orange County.

The Vietnamese community has a unique perspective on small business, international affairs, trade and human rights to name a few, that is missing in the public debate because the community is "cracked" in half due to political district lines.

The Vietnamese community has a shared language and culture that is not represented in the current political districts.

Garden Grove, Westminster, SW Santa Ana and Fountain Valley all share a common school district: La Quinta, Bolsa Grande High School sits in Westminster but are part of GGUSD. Also Garden Grove Unified School District (GGUSD) has large portions of Fountain Valley (Monroe Elementary School in Fountain Valley for example) and portions of Santa Ana (Rosita Elementary School in Santa Ana for example.)

In the past, redistricting has been extremely self-serving and has greatly undermined public trust. This only serves to further divide many ethnic and cultural groups of the community.

You'll hear a great deal from people focused on maintaining the status quo which would ensure reelection. Money and power are an especially attractive aphrodisiac to many politicians. But I implore you to make Little Saigon whole again.

"Little Saigon" is a large Vietnamese business district that is recognized by GARDEN GROVE, Westminster, the State of CA and is marked by Caltrans on local freeway signs. The cities of GARDEN GROVE and Westminster share an annual TET Parade and Moon Festival recognizing and celebrating Vietnamese holidays. Located next to GARDEN GROVE's "Korean District," Little Saigon serves as a unique cultural experience to many of the tourists that visit Disneyland and Orange County's beaches.

The businesses of Little Saigon have well-recognized economic links to one another. This economic contiguity is most clearly evidenced by the mutual representation of Little Saigon by the "Vietnamese Chamber of Commerce."

The communities of Garden Grove, Westminster, FV and SW Santa Ana share the 22 Freeway and Harbor Blvd. as a primary means of transportation.

The Vietnamese community has a shared language and culture that is not represented in the current political districts.

The Voting Rights Act requires minority residents to be in one district. Orange County might have two Latino Assembly districts and at the same time, Asian voters to the west should be concentrated in a separate Assembly district. Our map respects these Latino seats but also respects the VRA implication of denying Orange County's Asian voters an Assembly District that gives the community a voice in the democratic process.

I proposed a Central Orange County Assembly District with the entire City of Orange, Entire City of Villa Park, and Santa Ana (minus 50,000 residents in Southwest Santa Ana that are a large Asian/Vietnamese population.) that should make up Assembly District#1.

The cities of Santa Ana and Orange (the city of Villa Park is an island inside the city of Orange) have a long history and many historic buildings that are fairly unique to Orange County. They also share transportation and water infrastructure.

The communities of Orange and Villa Park share a common means of communication. The masthead of the leading newspaper of the area, The Orange County Register has a regional section insert serving Orange and Villa Park. There is also a specially produced Santa Ana version of the same paper.

The communities of the Santa Ana and Orange share the 55 and 22 freeways as their primary means of transportation. If Santa Ana and Orange make up one Latino district, Little Saigon can remain whole and get the proper voice in government it deserves. The communities Westminster, Garden Grove, Fountain Valley, Southwest Santa Ana and South East Anaheim share the 22 and 405 freeways as their primary means of transportation.

I am a member of the Vietnamese community, and I can tell you that there's a large Vietnamese community, the largest in the world outside of Vietnam, in the Westminster, Garden Grove, SW Santa Ana and North Fountain Valley area known as Little Saigon. Please don't cut us up into many districts. Little Saigon is a "community of interest" and should be respected. Thank you.

Dear Commissioners:

I am writing to voice my strong opposition to the Citizens Redistricting Commission's proposed redistricting map for the cities of Santa Ana and Anaheim which if approved will substantially alter the socio-economic composition of the City of Santa Ana's legislative districts and profoundly impact the lives of our residents. Your June 10, 2011 proposal would divide the two cities into separate Assembly, Senate, and Congressional Districts and dilute the voice of this working class area and place our residents into more affluent areas that may not have similar interests.

Historically, Santa Ana and Anaheim flatlands have been identified as "Communities of Interest" through shared socio-economic demographics. The two cities are linked by a large blue collar working class-immigrant population. Both areas share significant populations that are primarily Spanish speaking, young median age, and have common health issues related to diabetes, obesity, and a lack of medical insurance. Additionally, Santa Ana and Anaheim have common interests related to a variety of regional transportation and important infrastructure projects. Both cities are pursuing fixed-guide way projects and are currently serving as major public transportation hubs and pursuing multi-modal transportation centers known as the Anaheim Regional Transportation Center, and the Santa Ana Regional Transportation Center. Santa Ana and Anaheim are older, more densely populated cities with common issues related to aging infrastructure, and along with Fullerton, Anaheim and Santa Ana are the only three cities with direct membership in both the Metropolitan Water District and the Orange County Water District, thus sharing common water resources and needs. Also, because of the common socio-economic demographics, Anaheim and Santa Ana's population tend to share similar transportation habits such as higher bus ridership, and similar recycling and disposal habits.

The Santa Ana and Anaheim Police Departments have also collaborated on numerous programs and projects throughout their respective histories. One important joint program is the Urban Areas Strategic Initiative (UASI) which was designed by the federal government to facilitate a county-wide strategy, training, and exercise program to increase homeland security and public safety. Through this collaborative effort the cities of Santa Ana and Anaheim have distributed over \$60 million dollars in Orange County to strengthen the County's ability to prevent and

respond to terrorist attacks and natural disasters. Other collaborative efforts with the City of Anaheim include the CAD2CAD project that when finalized will allow all fire dispatch centers in Orange County to automatically dispatch emergency units from other jurisdictions should additional assistance be required. Santa Ana and Anaheim are the lead cities partnering on this project, and also maintain mutual aid agreements for emergency response assistance.

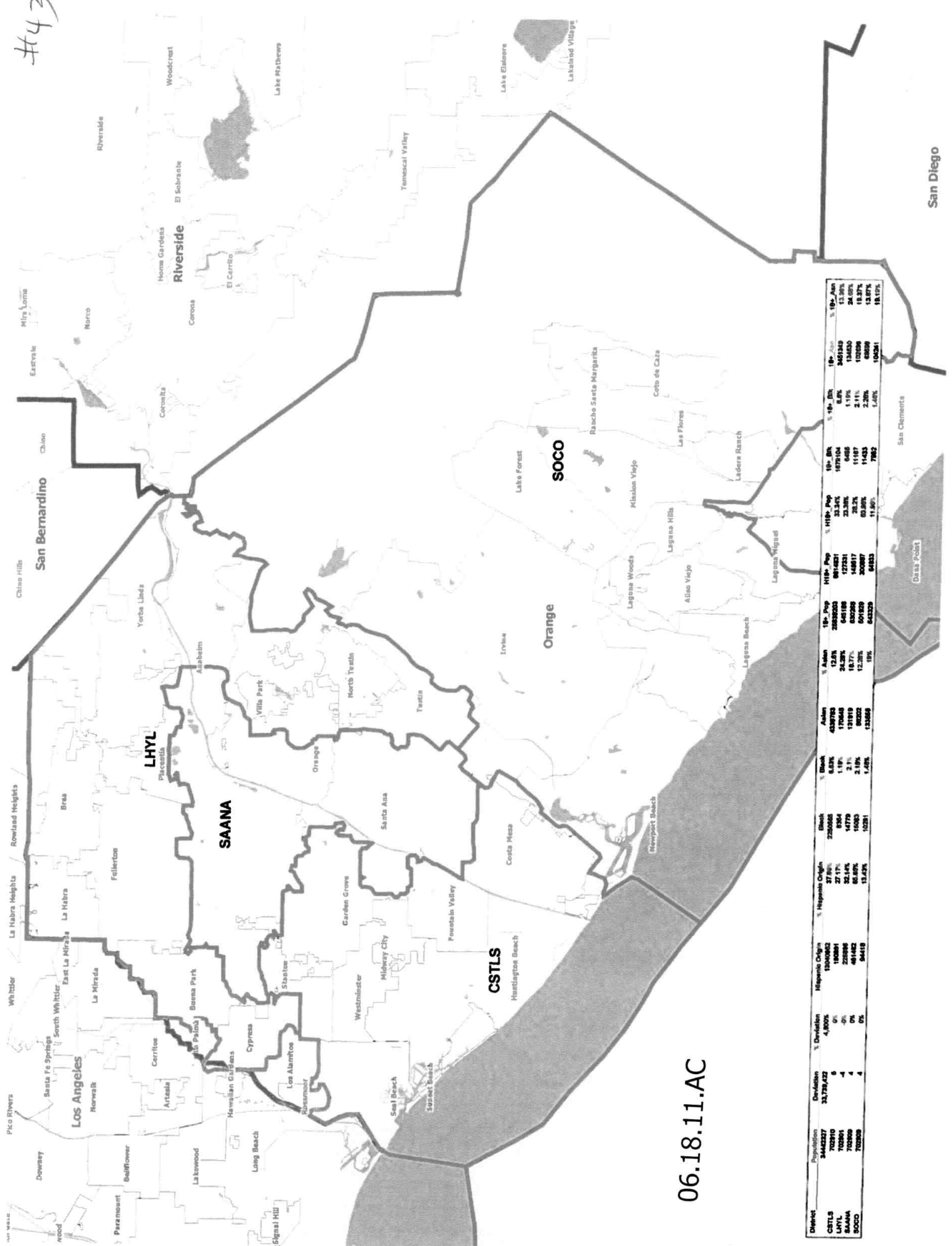
Dividing the state and federal legislative districts in Santa Ana and Anaheim will adversely impact the lives of our respective residents and potentially limit their ability to fully participate in the democratic process. I urge the Citizens Redistricting Commission's to reconsider the June 10th redistricting proposal for the cities of Santa Ana and Anaheim. It is imperative that Santa Ana and Anaheim flatlands remain in the same state and federal legislative districts to maximize our "Communities of Interest" and to ensure that our residents can continue to elect candidates of their choice who represent their common interests.

Commissioners, My name is Minerva Gomez Stone, I am a University student and member of Santa Ana LULAC #147.

Since 1990, our state's Latino population accounted for 90% of the growth in population. Orange County residents urge the Commission to walk down the path of understanding and respond to community input as you should - to the changes that are taking place in this county and throughout the state.

We urge you to draw district maps that reflect the growth of our communities that will provide fair opportunities for every voter eligible to cast a ballot.

We urge you to be bold and to "draw the line" against previous and potential discrimination in America's electoral process.

We urge the Commission to draw lines that will provide electoral opportunities for individuals who may wish to be "public servants" and also that each person who wishes to serve do so competing with others and being held accountable and responsible to their communities within their districts.

While many tend to believe that every city is unique, this is less true in Orange County. If one was to drive Beach Blvd., Lincoln Ave., or Main Street - it is very difficult to determine what city you are in.

But you can surely note where you might be by looking at the neighborhoods, types of businesses, and people who are taking walks in the street. People have chosen to live in certain parts of Orange County because of the natural tendency to retain a relationship with their culture and heritage.

Santa Ana LULAC implores upon the California Citizens Commission to respect the different communities of interest in the county; particularly its largest ethnic community constituting well over 44% of the county's population.

There has been a tremendous increase of Spanish-Speaking, Hispanic/Latino residents in Orange County - contrary to the age-old myth that "behind the Orange County Curtain" is a 1950's style of suburban white, middle-class, professional "Ozzie & Harriet" type of families.

Orange County is home to the largest number of Spanish-language newspapers, magazines, and periodicals in one region in the United States. These are listed within the narrative provided to you by Santa Ana LULAC.

Television stations and radio stations originating in Southern California area covers Orange County and recognizes the value of the county for entertainment viewers, listeners, advertising revenues, and Arbitron ratings audience. There are over seven television networks, and over 17 radio stations that program in the Spanish-language. These too are listed in the report by Santa Ana LULAC that you have received.

Santa Ana LULAC #147 believes that every city has its uniqueness with a realization that defined city lines do not stop communities of interest in crossing city boundaries to live day-to-day lives with family and friends. People live in neighborhoods and communities which in turn becomes the character of the city. The Latino community provides an excellent example of a cohesive and close community of interest that should be respected as the Commission draws its lines for future electoral elections.
