Course of study focuses on the history of European political thought, critical theory, American constitutional jurisprudence, the legalities surrounding and the rights of transnationalism, immigration, and citizenship, and theories of punishment, torture, and war. Coursework to date includes papers on the rhetoric of rights in the context of post-September 11th immigration, the Anglo-American liberal state's troubled relationship with religion and freedom of expression, utilitarianism and libertarianism in the thinking of John Rawls, and the discourse of civilization and barbarism accompanying the United States and the European Union's invasion of Iraq.
