I live on the West Side of Los Angeles. I sent a comment last week and have not seen it posted, so I will try again:

Since the meeting I have seen the "visioning" maps that propose putting Santa Monica, Venice & MDR into the same district as the area East of the 405.

These are not mutual communities of interest. In fact they ignore communities of interest that do exist with surrounding areas.

First of all, you split Malibu from Santa Monica despite the fact that they share a school district and the nearest hospital to Malibu is St John's in Santa Monica. The Santa Monica bay watershed also extends from Malibu to Santa Monica and many many people from Malibu and Pacific Palisades either shop or work in Santa Monica.

I also think Malibu and Santa Monica share the same Council of Government group the Las Virgines Malibu Council of Governments (Santa Monica is on both that one and the West Side Cities with Culver City, Beverly Hills, West Hollywood and LA).

I live east of the 405 and I never go west unless I absolutely have to because the north-south traffic from the Valley gets in the way.

Venice & Marina Del Rey deal more with the Bay cities and Santa Monica in terms of shopping & traffic flow.

Beverly Hills shares more in common with West Hollywood, Pico Robertson, Cheviot Hills & Hancock Park/Fairfax.

These areas all use the same hospitals like Cedars-Sinai or Olympia. They also are similar demographically with large Jewish, Persian and Armenian populations that don't exist in Santa Monica, Malibu, Venice or Marina Del Rey.

You are better off using the 405 as a dividing line or maybe Brentwood in the West and maybe Koreatown or East Hollywood in the East.

I hope this comment gets read.
