I would like to propose that the redistricting lines include the areas of Kagel Canyon, Lake View Terrace, Shadow Hills, La Tuna Canyon, Sunland, Tujunga, La Crescenta, Montrose, La Canada-Flintridge, Glendale and Burbank.

1. These communities, Kagel Canyon, Lake View Terrace, Shadow Hills and La Tuna Canyon are all located in the foothills of the San Gabriel and/or Verdugo Mountains and share the desire to retain low density housing, to protect environmental, wildlife, trees and flora of our open spaces with their many opportunities for passive recreation including equestrian interests, to protect the Angeles National Forest and Rim of the Valley Trail. The communities of Sunland-Tujunga, La Crescenta, La Canada-Flintridge and Montrose are low-density suburban and also located between the mountain ranges of the San Gabriels and Verdugos. Glendale and Burbank have a mix of rural and low-density suburban housing, are located at the base of the Verdugo Mountains and serve as our primary hub of shopping, business and entertainment interests.

2. These communities share the same watershed and have joined together to create natural water retention, purification and ground-water aquifer recharge facilities.

3. The 210 Freeway is the common connecting transportation corridor to these communities.

4. For a district to present few conflicting interests for its elected representatives would make it far easier for them to serve their constituents well. The current version of the redistrict map does reflect serious conflicting interests. The above-mentioned communities share many common bonds and would best reflect a unified mind-set.

I wish to point out two issues related to the proposed congressional district map for the communities near where I live. One concern is in regards to the San Gabriel Mountains-Foothill district. It was my impression that the former district boundaries (CA-26) carved a long, narrow swath and encompassed communities that were far distant from one another and had little in common. It appears as though instead of making logical adjustments, you've made that district even wider. Not only are Burbank and Upland an hour (or two in traffic) apart, their issues and concerns seem to be a mismatch. Burbank is more diverse demographically, and is home to large entertainment industry companies. Upland is a residential community located in a different county (San Bernadino) without a significant business base. I don't see how one person can effectively represent such a broad and diverse region.

My second concern is in regards to the placement of South Pasadena. Although I currently live in neighboring Arcadia, I have previously been a longtime S. Pasadena resident. It is a mismatch to include S. Pasadena, a middle-to-upper class, predominantly white and Asian community with the mostly Hispanic, working class communities to the south and west of it. If there is one issue that S. Pasadena residents fiercely defend, it is opposition to the 710 freeway extension. Past Congressional representatives have supported this cause. Under the draft district plan, the Representative would be answering to interests along the 710 corridor who are strongly in favor of completing the 710 extension. S. Pasadena relate to Pasadena, and I would urge you to keep the two sister cities united under the district map.

RE: Expand Ontario Congressional District North To Include the San Gabriel Mountains

Dear Citizens Redistricting Commission:

I would like to support a redistricting effort that would place the federal public lands in the San Gabriel Mountains in the same Congressional Districts as communities to their south,. Residents of these communities are the most frequent visitors to these public lands and they have the highest stake in the management of the San Gabriels, including fire and fuels management. I live in the proposed new Ontario Congressional district and regularly hike in the San Gabriel Mountains above Rancho Cucamonga.

Although 75% the San Gabriel Mountain range is in LA County, the other 25% is actually to the east in the San Bernardino National Forest. I live in Rancho Cucamonga and look north from my front window into this section of the San Gabriels every day, which forms the striking scenic backdrop for all the cities of the proposed Ontario Congressional District. . Like the Pasadena area to the west, Rancho Cucamonga is located near one of the major gateways to the San Gabriels. Mt. Baldy Road provides access to Mt. Baldy Village, its ski area, and many well used San Gabriel Mountain trails where I hike.

It doesn't make sense to have the San Gabriel Mountains in the same Congressional district as Mono and Inyo County rather than in the same district as Rancho Cucamonga and other cities in the proposed Ontario District which have extensive geographic, economic and recreational connections to the range. Please include the East San Gabriel Mountains in the Ontario Congressional district. This can readily be accomplished by extending the proposed Ontario Congressional District north from Rancho Cucamonga to include the San Bernardino Forest section of the San Gabriel Mountains. The expanded boundaries would be the LA County line on the west, the national forest boundary on the north, and I-15 on the east. With this adjustment, the San Gabriel Mountains will be in two logically designed Congressional Districts which connect highly populated foothill communities with their magnificent public lands to the north.

Gentlemen:

I presume to offer my comments about redistricting as I was selected to serve on your committee but a serious accident prevented my continuing with the procedure. I have been a resident of the area since 1964, served on many volunteer committees, was a member of the Planning Commission, South Pasadena, am a registered professional engineer (ret.) and emeritus, Cal Poly Pomona.

My remarks are directed at the proposed redistricting of the area including LaCanada-Flintridge, Western Pasadena, South Pasadena and San Marino.

These are contiguous bedroom communities of common social, ethnic, and economic interests. They often come together and act as one when common interests are involved. They have supported charities, social interests and athletics. Their schools compete in many common areas-their students are well known to each other. For many years San Marino and South Pasadena shared the same high school. They have been supporters of the Rose Parade from almost its inception.

Your guidelines state that the new boundaries would largely be based on "communities of interest," defined as "a contiguous population which share common social and economic interests that should be included within a single district for purposes of its effective and fair addressed. This is a district which sees itself as an entity and which would be diminished by representation." The area which I discuss could be used as an example of that definition.

I urge that you carefully reconsider the proposed redistricting of the area which I have addressed.
