Redistricting: The Trans-Sierra Assembly District: Isolated and Sparse Population COI

Good afternoon and thank you for the opportunity to speak for a Trans-Sierra Assembly District that would represent the unique isolated mountain communities located on both sides of the Sierra Nevada at the eastern edge of our geographically diverse state. Route 80 to the North and Route 49 to the West are our logical Transportation Corridor boundaries; it also allows for closely maintaining county lines in Placer, El Dorado, Amador, Calaveras, Tuolumne, Mariposa, Mono and Alpine Counties.

There are many economic and cultural similarities that tie these communities together; the anchor is the Sierra Nevada Mountains. The beauty and hardships of the mountains have forged a unique lifestyle in our communities of isolation. Many of our residents first came for the outdoor recreation but made the Western Foothills and Eastern Sierra Mountains home. The sparse population lends itself to smaller "mom and pop" enterprises, the backbone of our communities. Many businesses, retirees and volunteers who live or visit see themselves as guardians of the fragile environment, wilderness areas and national parks. We are committed to the seasonal rhythms of the mountains, the weather and the roads. Our livelihood and passions revolve around the tourist related economy, be it trout fishing, skiing, snowboarding, birding, biking or any level of a walk in the great outdoors. In the summer Yosemite, Sonora and the John Muir Trail are our calling cards for visitors from all over the world.

We believe our steadfast commitment to our mountain environment and its tenacious economy gives us a determined perspective to manage and preserve our autonomous region as an Assembly District.

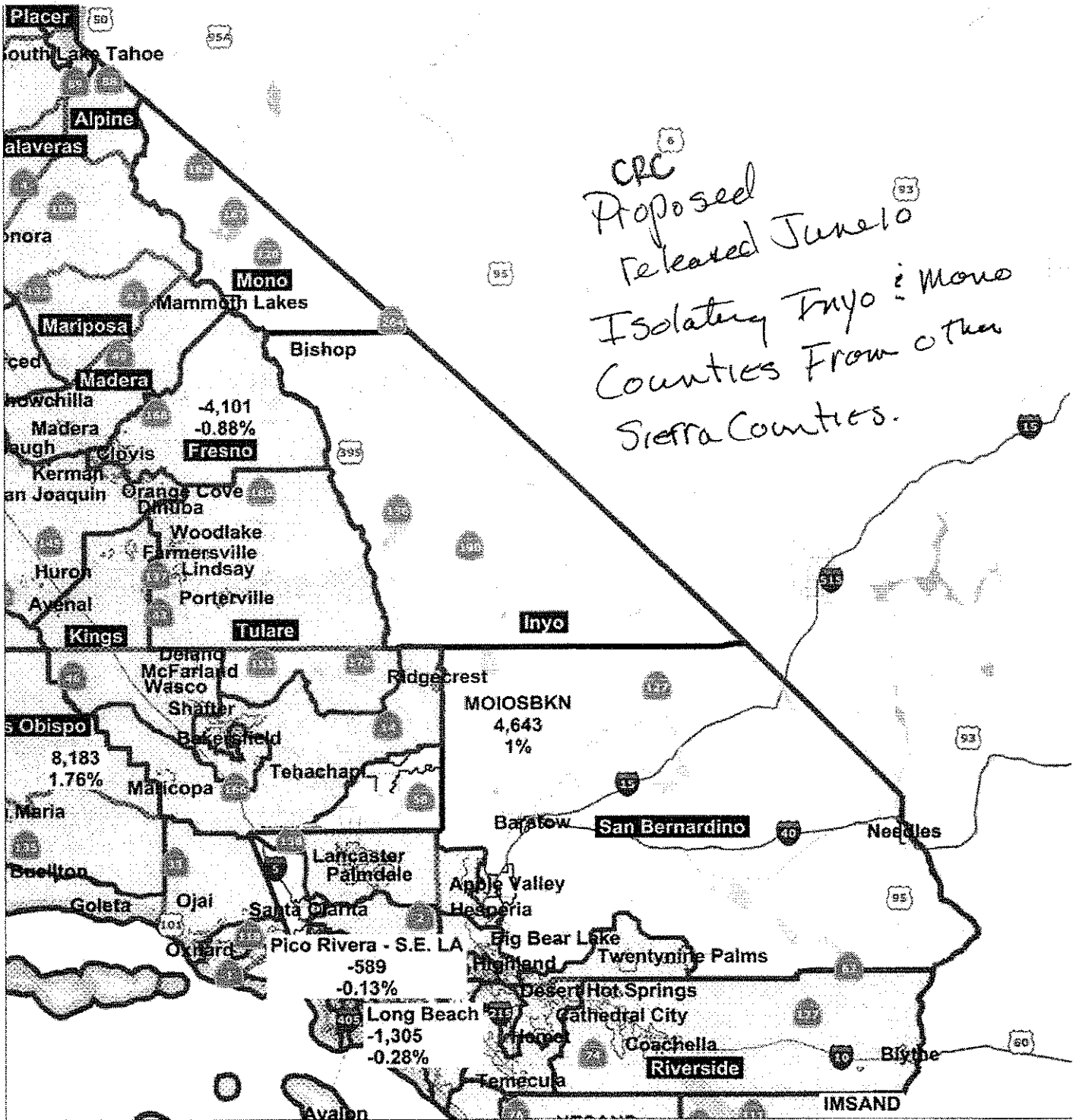

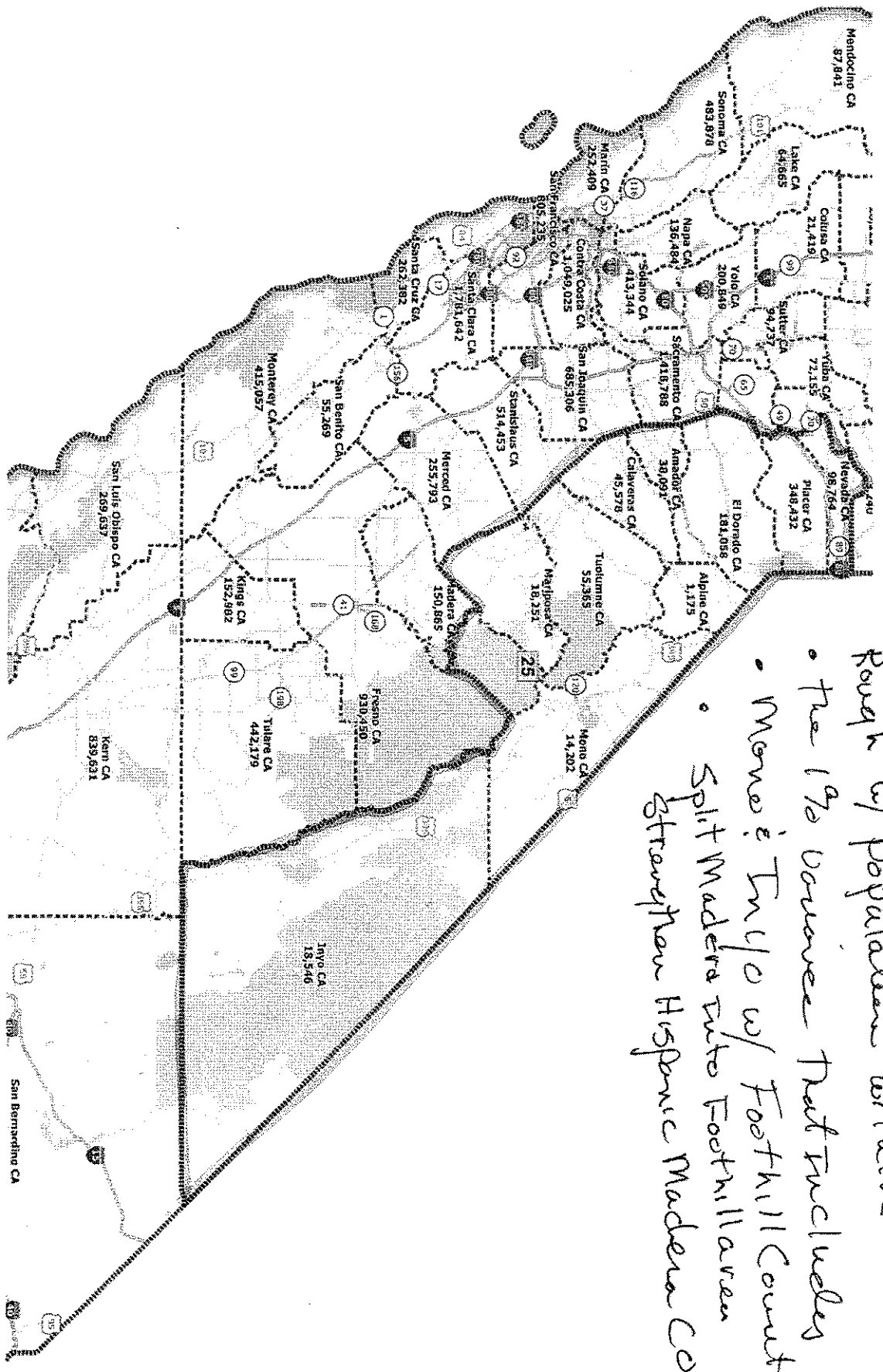
