I would like to take this opportunity to comment on your first draft of maps. Because your map splits Siskiyou County in half, I can only assume that you do not understand how our county as a community is tied together geographically, socially and economically. Perhaps you did not receive many comments from our community, but most of us were unaware of the redistricting. I understand that there was no public meeting held in Northern California except for one in Redding. No one that I have talked to even knew about the meeting until after the fact.

Siskiyou County is rural with agriculture and ranching as our main industry. The Endangered Species Act destroyed our timber industry and we are now fighting the removal of our dams on the Klamath River, the expansion of National Monuments and the moratorium on suction mining and preserving our water rights. We are being hit from all sides. The citizens of our community work hard to make a living and because of all the governmental issues we are facing it is becoming more and more difficult. If our county is split in half, it will only make matters worse.

The Coast and the Scott Valley area is separated by many miles of mountainous terrain. It is a very long twisty drive on secondary roads to get to the coast. The people in Etna, Fort Jones, Scott Valley and Happy Camp are tied to Yreka (District 2) for county services; our Sheriff, our community hospital, our library, our Court House, and our supervisors. We share the same access to media and communication relevant to the election process.

If the split of Siskiyou County takes place, election costs will increase because we will need different ballots for two districts. The split of Siskiyou County will also result in splits of Supervisorial districts, County Board of Education Areas, Siskiyou Community College District areas, High School District Areas, Elementary School District areas and Fire Protection Districts.

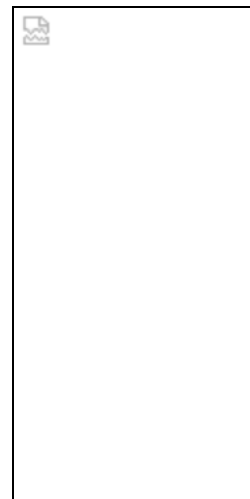

Yreka is the County Seat and all county business takes place there. The drive is approximately 20 minutes as compared to five hours to the coast.

I implore you to keep our county whole in the redistricting process, and ask that you hold a public hearing closer to Siskiyou County.

I am deeply opposed to the new redistricting lines which would cut off western Siskiyou County from the rest of the county and place it in the coastal jurisdiction.

I was born and raised in Scott Valley. In the early 90's I lived in Arcata for four years while completing my BA degree at Humboldt State. The values of western Siskiyou County residents are in no way similar to the values, culture or political interests of the coastal communities. If the proposed redistricting map is put through, western Siskiyou County residents will have no voice and no representation. Western Siskiyou County residents are farmers, ranchers and loggers, not fishermen. Current Siskiyou County representatives Wally Herger, Jim Nielsen and Doug Lamalfa represent the values and interests of the population.

Eureka is a four to five hour drive from Scott Valley. Not only is the drive a long one, but one must traverse very windy and narrow roads. These roads are extremely dangerous to drive in the winter and are often closed due to snow and rock slides in the fall and winter months. The only time that individuals from Scott Valley travel to the coast is during the summer for a vacation. NEVER have I heard of anyone from our valley taking the four plus hour-long drive just to go shopping!

I was extremely upset to learn that on your preliminary redistricting maps you have split Siskiyou County! The fact that the Commission voted 14-0 in favor indicates to me that there is no one on the Commission who is even vaguely familiar with Siskiyou County!

In Siskiyou County we are somewhat isolated from the rest of the state; we are an intimate community that shares economic, social, and cultural interests. By splitting Siskiyou County you are violating your own guideline of maintaining effective and fair representation by keeping communities intact that share common social, economic, and cultural interests.

A very large portion of the 7400 people you would be separating from the rest of Siskiyou County live in Etna, Ft. Jones, and the surrounding rural area of Scott Valley. These people shop in Yreka, many work in Yreka. They share the one community hospital, the library, the one local newspaper and local radio station. They come to Yreka for the County Fair and to the dirt track car races on Saturday night. Siskiyou County is an area where we wave at oncoming cars because that person is the one who checked your groceries at the grocery store or is your child's scout leader. Maybe it's someone your son worked for at harvest time or someone you know from one of the local organizations like the Tea Party, Grange or the Cattlemen's Association. If it's someone you don't know you wave anyway just to say "Howdy" to a stranger.

Contrary to the boldfaced lie Felice Pace of Klamath, CA wrote in his letter to you dated 20 June, 2011, the people of Western Siskiyou County DO NOT go to the coast to shop and for culture. There may be a few folks from the Somes Bar area that go to the coast. A few is being very generous. When looking at a map, the road going west from Etna towards the coast may look inviting. That road is very similar to the "Dangerous Journeys" program you see on cable TV! It is a far cry from getting in the hot lane on the freeway and setting your cruise control at 70. The best way of getting to the coast from Etna and Ft. Jones is either going north on I-5 to Grants Pass, OR and Hwy 199 to the coast, then south to Eureka, or going south on I-5 to Redding and across Hwy 299 to the coast. Either way, it takes most of a day to get there.

The economy of Siskiyou County is based on timber, mining, and agriculture/ranching. The timber and mining industries have already been destroyed, largely to the efforts of the environmentalists from the coastal region. The aforementioned Felice Pace is as responsible for the destruction of the timber and mining industry in Siskiyou County as any other one individual. In Siskiyou County we are involved in political battles for our very survival with the attempts to remove the dams on the Klamath River, to take our water and property rights, and to force National Monuments on us. With the meager amount of political clout Siskiyou County has you are taking 20% and placing them in a representative "No Man's Land". The people of Ft. Jones and Etna will never see a representative from the coastal region. It is too far, not enough votes to bother with, and our interests are opposing.

Please!! Keep Siskiyou County whole.


I would like to know the reasons why the CCRC split Siskiyou County?
