Dear Mike Klocke & Michael Fitzgerald,

I was surprised to see the leaked Redistricting maps in this morning's Record. It seems contrary to the Commission's posted agenda for tomorrow and Friday. I filed papers on 04/18/2011 with the FEC to run for Congress from San Joaquin County. I naturally assumed this County would be a single district since it is within 2.5% or 17,599 people of qualifying. Now I find parts of the South County joined with all of Stanislaus (with the line going through my house?). The only Prop. 20 requirement that would seem to bump community of interest is the federal Voting Rights Act compliance. Perhaps someone could explain to me how carving up this county into two slices and adding Antioch would be such compliance. Otherwise, see for instance <http://www.mjbarkl.com/sjcounty.htm>. In this county we are bound together by our County government, courts, Superintendent of Schools, transportation systems, special districts and their governance, political party councils, newspapers, and so on, and especially by flooding and water shortage problems, none of which we share with Stanislaus County. The foothill communities from Copperopolis and Stanislaus north of the river through Valley Springs and Lone would seem appropriate to flesh out the 17,599 people needed and share more with us than Antioch. I see from the Commission's web site that they have a meeting scheduled in Stockton on 06/24/2011. All 685,306 people in this County should show up at that meeting and demand to be our own Congressional District.
