I had the privilege of speaking before you at your Stockton appearance on June 24th.

I wish to reinforce the points touched upon in my presentation, on this the last day for submission of public comment.

By the efforts published to date, it is obvious that this Commission has attempted to identify "communities of interest" as described in Article XXI §2 of the California Constitution, but I believe insufficient emphasis has been placed on how these "communities of interest" can and will be served by their representative(s).

This Commission appears to ignore the criteria established in $\S(4)$, (5) and (6) of Article 21.

You cannot have "effective and fair representation" and "geographical compactness" that will promote efficient service by the Representative when you bundle Lodi with Sausalito or join Antioch and Brentwood with Stockton.

You can best comply with §(6) by placing a Congressional District over a State Senate District superimposed over two State Assembly Districts.

Compact, co-located Congressional, State Senate and State Assembly Districts in the greater San Joaquin County area would effect the most efficient, service oriented, redistricting scheme for this long neglected area.

It would also reduce unnecessary expense and improve efficient government.

State Senate:

This proposal I do not understand after the congressional map was so well done. 
