





Attention Please - California Redistricting Committee:

In the foothills and mountains above Los Angeles, there are several indivisible communities. They are equestrian in nature with a shared wholesome lifestyle. The youngsters of such people are, for example, way too busy working with their folks in the barn to keeping stalls clean and the building in good repair, or riding, training, grooming, feeding and watering horses and ponies to find much time for mischief.

By itself, this does not rise to the level of a mandate to keep the communities together. What does warrant keeping them as one is the shared objective to preserve the area from re-zoning and high density residential development that would deny Los Angeles of most of its last remaining available open space for riding and hiking by urban visitors. At present, the communities constitute a voting bloc that elects representatives sensitive to this lifestyle that churns out good citizens generation after generation. Please don't weaken a formula for productive living that works!

Many people up here tend toward historic preservation and environmental sensitivity. In fact, a several block area of CCC built modest stone houses just became an HPOZ area, thanks to citizen efforts. Because of our linked objectives, much of the Tujunga Wash water shed and Devil's Gate dam water shed remain almost pristine for us and our visitors. We are, in fact, the group you read about who take in livestock and wildlife during fires, floods and earthquakes. We remain actively involved in a many years project to create The Rim of the Valley Trail for countywide use by hikers and horses. Above all else, this multi-community, interwoven milieu stands firmly together to preserve LA's few remaining open space areas for us all.

The communities include Shadow Hills, La Tuna Canyon, Kagel Canyon, Lake View Terrace and Sunland/Tujunga to the west. La Crescenta, Montrose and La Canada Flintridge are more easterly. Glendale and Burbank with their large equestrian populations are to the south.

The Alliance for a Better Community (ABC) - a multi-strategic, community-based Los Angeles advocacy organization- urges the California Citizens Redistricting Commission to revise the newly-proposed map in order to ensure full and fair representation of Latino communities across Los Angeles County. ABC specifically requests that the Commission redraw the map in accordance with the Unity Maps submitted on June 28 by Latino, African American and Asian American advocacy groups such as MALDEF, NALEO, AARC, and APALC.

The maps as they are drawn now would violate the 1965 Voting Rights Act, which protects underrepresented communities from discrimination in the electoral process. In addition, a Gibson Dunn July 13 Memorandum clearly states that "if the commission does *not* create several Latino-majority districts in Los Angeles County, a court might find that the Commission's maps have resulted in Latinos having less opportunity than other members of the electorate to participate in the political process and elect representatives of their choice, in violation of Section 2." The Unity Maps of the Assembly, Southern California Senate and Congress, submitted on June 28, offer an alternative that complies with Section 2 of the Voters Rights Act.

Why is this important? Latinos represent 40% of the population in our state, and account for 90% of the state's population growth in the last decade. However, the current map fails to reflect this community's growing electoral influence. In fact, the new map disempowers minority and socio-economically disadvantaged communities.

For example, the map joins densely-populated cities and Latino immigrant hubs like South Gate with African American communities in Long Beach that do not share the same interests or needs. If the map remains unchanged, Latinos and African Americans will compete for equal representation at the expense of fair representation. These, two

South Gate with Long Beach would severely disrupt the political process in these areas.

More importantly, the maps as they are drawn now would violate the 1965 Voting Rights Act, which protects underrepresented communities from discrimination in the electoral process. The Gibson Dunn July 13 Memorandum clearly states that "if the commission does *not* create several Latino-majority districts in Los Angeles County, a court might find that the Commission's maps have resulted in Latinos having less opportunity than other members of the electorate to participate in the political process and elect representatives of their choice, in violation of Section 2." The Unity Maps of the Assembly, Southern California Senate and Congress submitted on June 28th offer such an alternative that complies with the Section 2 of the Voters Rights Act. There are several barriers that would be in place in two communities of interest are competing for one voice representing them in Congress.

ABC urges the commission to rectify this injustice by following the Unity Maps drafted by NALEO, MALDEF, APALC and AARC.

Dear Members of the California Citizens Redistricting Commission:

I am a resident of the community of Venice in the City of Los Angeles and live in the area known as the Marina Del Rey Peninsula. I'm a member of the Venice Neighborhood Council and am active within my community, working on projects and advocacy aimed at improving the quality of life in Venice. I'd like to comment on the maps that have been released showing proposed boundaries for our Assembly District. Note that I sent you testimony earlier, on June 27th, 2011; I'll now be commenting on the recently released Visualization Maps that cover Venice.

First, thank you again for your service. The redistricting process has required a huge investment from you on behalf of our state. That it's a job that has to be done doesn't make it easier.

District AD LAIHG from Visualization 2011-07-14 08:42AM assembly LA opt 1 and opt 2 is the district I now find myself in. I note that this district now encompasses the Ballona wetlands in their entirety, a huge improvement over earlier drafts which split the wetlands between two districts. I also note that the visualized district now includes the communities of Playa Vista and Westchester.

But these new visualizations split the community of Venice between three Assembly Districts. Should this visualization become the final map, it would be disastrous for our community. A letter detailing all of the reasons for this would go on for pages – let me make just 4 points and leave the extrapolation to you:

1. Venice is a small, compact community, wholly contained within the City of Los Angeles City Council District 11 and represented by a single Neighborhood Council. We have a rich history and feel connected to each other, taking great pride in living in Venice. The boundaries of the City Council and Neighborhood Councils should be respected in the redistricting process - indeed, Proposition 10, the state-wide initiative that established the redistricting process says: "The geographic integrity of any city, county, city and county, neighborhood, or community of interest shall be respected to the extent possible..."
2. The problems faced by Venice as the number one public tourist destination in Southern California require a common, unified approach to traffic, parking, law enforcement, community preservation, air & water quality, environmental concerns, tourism and business development that relies on cooperation between City, State and Federal representatives. The California Coastal Commission, with members in part appointed in the Assembly, is critical to maintaining coastal access and our environment. To have Venice represented by three different Assembly members will inevitably create roadblocks to cooperation and cracks that problems can fall into; our community must be represented by a single voice in the Assembly, a representative that is responsible for representing the unique needs of our community. A single representative will be more responsive to our input and can take ownership for addressing community concerns.
3. The problems of the homeless in Venice are intractable and often appear politically unsolvable, even in the current environment - splitting Venice into three Assembly Districts will make it much more difficult to develop common approaches to state involvement. The state sets requirements for including low income housing in new developments (considered somewhat controversial in Los Angeles), has been instrumental in requiring replacement housing in the Coastal Zone through the Mello Act and provides funding for medical services through MediCal and other programs. Our State Assembly Representative must be able to speak with authority to questions about how changes to these and other state programs and regulations will impact our community. New programs introduced

to deal with homelessness require an Assembly person that can speak for Venice's community of interest. Having three Assembly members will dilute our voice and make addressing these problems much more difficult.

4. Venice is a coastal plain and much of its land area lies within the state's defined tsunami inundation zone. Additionally, much of the community rests on reclaimed marshland that is subject to liquefaction in the event of an earthquake. Preparation for disaster requires community-wide awareness and planning; a single State Assembly person can engage with the community and other governmental representatives to address disaster planning and can help get our community state resources in case disaster does strike; 3 representatives trying to do the same would result in chaos.

Again, thank you for your service; it is greatly appreciated.

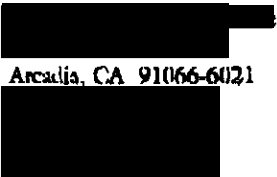

Dear Honorable Commissioners and Mr. Claypool:

While the Simi Valley Chamber of Commerce appreciates the difficult task that the Commission faces, the most recent visualizations of Congressional and Assembly Districts for the City of Simi Valley raise concerns regarding the maintenance of our county, city and communities of interest within the proposed boundaries. As district boundaries are currently drafted, Simi Valley is the sole Ventura County city excluded from a Ventura County Assembly or Congressional District. Instead, it is included in Congressional and Assembly Districts with Santa Clarita and the Antelope Valley.

The Simi Valley, Ventura County community of interest has been described in detail in our previous correspondence of March 22, 2011 and June 27, 2011 as well as in letters submitted by the City of Simi Valley, and oral comments to the Commission made by our mayor, Bob Huber and our councilwoman, Barbara Williamson. A few of the many Ventura County joint services/programs that the City of Simi Valley participates in include the Ventura Council of Governments, Ventura County Transportation Commission, Ventura County Judicial System, Ventura County Schools, Ventura County Social Services, and Economic Development Collaborative Ventura County.

Not only Ventura County city and county government agencies coordinate their activities to enhance the quality of life within the community; businesses across Ventura County also work together to achieve success for the county. Through the Chambers of Commerce Alliance, eight Ventura County Chambers of Commerce representing several thousand large and small Ventura County businesses work together to enhance the economy and quality of life in the region.

There are no similar business or government relationships between Simi Valley, and Santa Clarita or the Antelope Valley.


The City of Simi Valley and the businesses within its borders do not draw their employees or their business success from Santa Clarita or the Antelope Valley. Nor are the personal lives of our residents connected with Santa Clarita or the Antelope Valley; our lives are drawn from Ventura County. Our children's schools and sporting events, our places of worship, our social networks, our volunteer hours, and our physicians and hospitals are all in Ventura County. The open space mountain range that separates Simi Valley from Los Angeles County is not merely a topographical feature on a map. These mountains are a physical boundary that define the northeast border of Ventura County and the region within which Simi Valley citizens conduct the business of their lives.

The most recent Assembly and Congressional District map visualizations not only cut Simi Valley off from Ventura County, they split the city between two Congressional Districts. This draft boundary does not honor the letter or the spirit of the Voters First Act. At the very least, the City of Simi Valley should be whole within its new Assembly, Senate and Congressional Districts. Secondly, the lives of the residents and the businesses in Simi Valley are inextricably blended with the life of Ventura County. It is impossible to ignore this reality and create new voting districts that honor the intent of the Voter's First Act.

The City of Simi Valley recently proposed Congressional boundaries that will permit Simi Valley to remain whole and connected to Ventura County without violating neighboring communities of interest. We respectfully request that the Commission implement that proposal in the final district maps.

In your Assembly and Senate plans you are splitting the City of West Covina. As with every city we want to be kept whole. At this point we realize that is likely not going to happen.

However as a long time West Covina Resident and Business Owner I want to alert you that your current split is non-contiguous with two separate fingers extending into our city. While doing your "live line-drawing" I would ask that you rectify this by making the split of West Covina in the Assembly and Senate plans contiguous. As with your current lines the split should be identical in both plans to ensure continuity of representation.

With the help of the Los Angeles redistricting center I would suggest adding census tracts 407900, 408003 and 408004 to the Covina districts and census tract 408005 to the Walnut districts.

This would create only one finger into West Covina. It would also use a major road (Azusa Blvd) as a recognizable district boundary. It exchanges one heavily Asian neighbourhood for another so it does not impact your attempts to keep the Asian community of interest in the eastern San Gabriel Valley whole. Finally it would not affect the Section 2 status of the LACVN Assembly district.
