Dear Commissioners:

*Thank you for your dedication to completing this enormous redistricting task.*

My name is Barbara Robbin. I live in Studio City. My community of interest includes: Studio City, Sherman Oaks, Encino, Tarzana, Woodland Hills, Calabasas, Agoura Hills, Topanga, the communities along the Ventura Blvd. corridor and the 101 freeway corridor, and BOTH sides of the Santa Monica Mountains including Santa Monica, Brentwood, and Pacific Palisades. This mountains and coastal district is defined by key transportation corridors of PCH, the 405 and the 101. Cross mountain roads provide access for both our residents, commuters and the many people who come to visit the Santa Monica Mountains National Recreation Area and Santa Monica Bay.

All these cities and communities serve as gateways to the Santa Monica Mountains National Recreation Area and our beaches. Many locally elected officials and residents, homeowner and neighborhood council leaders have testified at your hearings and sent in letters in support of this united community of interest. The Supervisor who represents this area in LA County, Zev Yaroslavsky, also has sent letters restating this strong connection between the Westside, coast, mountain cities, and the SF Valley.

Several of the most recent maps on the Commission's website dramatically changed our community of interest. Please do NOT exclude Studio City and Sherman Oaks from the proposed Senate District called EVENT simply because Studio City and Sherman Oaks are east of the 405 freeway. We share the 101 freeway and Ventura Blvd. corridor with Tarzana, Encino, Woodland Hills, Agoura Hills, but have been placed in the district called LASFE with which we have no community of interest. We do not share the same roads, schools, religious institutions, County Supervisors, or cultural or civic organizations as do the other communities in the most recently drawn LASFE. Please recognize that these are two distinct areas by keeping them in separate districts so that an elected official can better represent their interests. The south San Fernando Valley communities should be in one Senate District.

My name is Clarisse Schlesinger. I live with my husband Fred and my children at 1165 South Rodeo Drive, LA, 90035. We have lived at this address for over 25 years. I would like to be included in the group of citizens respectfully requesting that our neighborhoods and community not be divided in half with the new re-districting.

I live in the Pico Robertson area and I frequent many of the establishments in this extended neighborhood. However, as a member of the orthodox Jewish community I have many ties to the Beverly-Fairfax, Hancock Park neighborhoods. I work on Third Street and Formosa and my son attends school in that neighborhood. I shop at the various kosher markets on 'both sides of town' as we colloquially refer to our neighborhoods. I use the libraries on Gardner, Robertson and the BHPL. I attempt to play tennis at all the parks and have given my children lessons at both Poinsettia Park as well as Roxbury and La Cienega Parks.

My married daughter lives on Poinsettia between Third and Beverly so in addition to everything else, I consider myself as part of both neighborhoods (hopefully my son in law agrees). My local hospital is Cedars and all my doctors are in that vicinity. My family and I frequent synagogues in both neighborhoods (we stay with our children when the Sabbath is involved although my daughter, son in law, and son have walked the five miles that separate us (Sabbath observers do not drive on Saturday).

I can state that I have groups of friends in both neighborhoods and have attended celebrations in synagogues, halls, and hotels on 'both sides of town'. In addition there are many occasions where I attend special lectures ranging from religion to community safety. These issues affect our community in both these neighborhoods.

In addition, I was hoping that the Beverlywood neighborhood also not be divided in half. Uniting our community will not have an adverse affect on any other group. Please place all of Pico-Robertson into the LAMWS district along with Beverly-Fairfax, Hancock Park and Beverly Hills.

As one who does scheduling for a school with 100 employees and approximately 375 students, I cannot even begin to imagine how daunting your task is to divide up an entire state with over 37 million people. Unbelievable!! We have a great state. I love it and I'm from NY.

As a resident and business owner in the City of La Habra, located in Orange County, I am strongly opposed to the Commission's plans to place La Habra in Senate and Assembly Districts comprised solely of Los Angeles County cities. La Habra does not share with Los Angeles County communities the same community identity, history, characteristics and relationships, which directly correlate to our vision for the future of La Habra. Rather, is more closely aligned with north Orange County cities, which rely on Orange County-based educational institutions, the Orange County Transportation Authority, the Municipal Water District of Orange County and many other organizations.

Specifically, the City of La Habra should be placed in the DB-YL (Diamond Bar-Yorba Linda) Senate District and either the DBRYL (Diamond Bar Yorba Linda) or ANAFULL (Anaheim Fullerton) Assembly District. The present map visualizations place La Habra in the Los Angeles-Covina Senate District and the Whittier-Norwalk Assembly District. To be the only Orange County city in districts with all Los Angeles County cities is unacceptable as it will compromise La Habra's representation in public affairs at the State Legislative level.

La Habra needs to be represented by elected officials that understand and share our local vision, goals and objectives. Our success and future is tied to the north Orange County region, and collectively, we need to be represented in Sacramento, not as an afterthought or island at the tail end of a Los Angeles County-dominated district.

I urge you to reconsider the placement of La Habra in the proposed district and realign the City with its other north Orange County communities of interest.

For the past eleven years, I have lived in the Fairfax/Hancock Park neighborhood, near the intersection of Beverly Blvd and La Brea. Before that, I lived in the Pico-Robertson area for six years. I am intimately familiar with both areas. I am also familiar with the politics of these communities. For example, I was elected to the Mid-City West Community Council and served as Vice Chairman of the Board.

Although we live in one of these areas, we patronize kosher restaurants, kosher markets and Jewish bookstores in the other area. We sometimes attend religious services in the other area and have many friends there. The classmates of our children live in both areas.

Based on our knowledge and experience, it is clear that the Fairfax/Hancock Park neighborhood and Pico-Robertson/Beverlywood neighborhood constitute a single, integrated community-of-interest (COI) with many shared institutions. The only way that the Orthodox community will have a voice in the Assembly is if Fairfax/Hancock Park and Pico-Robertson/Beverlywood are all in the "LAMWS" district.
