Hello,

I just found out that the California Oak Creek community (where I live, 6298 Running Springs Road) is in the Milpitas district! I have to drive for 25 minutes just to get to Milpitas. Everyone in this community thinks of themselves as part of Evergreen, and more specifically part of the Silver Creek area. It makes no sense to put us in the Milpitas district--we don't care about Milpitas issues, and we care passionately about San Jose issues. Our community has, on multiple occasions, mobilized to participate in various planning meetings at San Jose city hall. We care about the quality of San Jose streets (101 south of 280 and other local streets in Evergreen), San Jose public services, San Jose schools, etc. San Felipe is not a reasonable boundary--the ridge to our east is the most sensible boundary, as this is what defines our community. Evergreen is the area that we drive through every day going to work and school, it is the area we shop in, it is the same police and!

fire department serving us, not Milpitas. By using San Felipe Road as the diving line, you are cutting us off from representation about our community. Please change this so that we are represented!
