We, the undersigned, submit these comments in response to the Commission's July 1, 2011 Assembly and Senate visualizations for Alameda County districts. We make the following three comments about the Commission's visualizations.

 The Assembly visualization shows Oakland in a district with Alameda and San Leandro. As indicated in testimony previously submitted to the Commission, we believe that an Assembly district that includes Oakland should be drawn to respect a community of interest residing in Oakland flats, Alameda, Emeryville and parts of Berkeley that shares common socioeconomic interests. Many residents of this area rely on services provided by both government and community-based institutions that provides services across city lines, and have shared policy interests that would be best-served by having a common representative at all levels of government.

- 2. Instead of being put with Oakland, San Leandro should be kept together with adjacent areas such as San Lorenzo, Cherryland, Ashland, Castro Valley, Hayward and Union City. The residents of this area have similarities including high rates of being foreign-born, lower rates of English proficiency and common social and cultural ties. These areas also have a shared history in that they were primarily agricultural 50 years ago and have since experienced similar patterns of development. These interests would be best-served if the residents of San Leandro, San Lorenzo, Cherryland, Ashland, Castro Valley, Hayward and Union City have a common representative at all levels of government.
- 3. The visualization shows that the City of Fremont continues to be split; as many members of the public have testified, Fremont should be united in one district. Fragmentation of Fremont means fragmentation of Fremont's large Asian American population.
