Message Body:

The California Redistricting Commission has been tasked with redrawing the district boundaries for State Senate and Assembly seats as well as congressional districts. The Commission's most recent proposed maps of State Senate districts, released on July 14, have the cities of Martinez and Pleasant Hill being taken out of the proposed senate district for Contra Costa (referred to as RAMON) and moved into a district which incorporates the counties of Yolo, Lake, Napa and Solano (WINE). Please voice your opposition to the proposed redistricting and support moving Pleasant Hill and Martinez back into the RAMON senate district with the rest of Contra Costa County.

In determining the various district boundaries, the commission must use a "community of interest" standard. This standard includes such factors as a contiguous population and geographic area; a population that shares common social and economic interests such as same transportation facilities, work opportunities, and the same media market. It is clear in our situation that these "community of interest" guidelines were not followed. Here are some bullet points that can be used in your online public comment to the commission:

1. Pleasant Hill and Martinez are NOT geographically part of the rest of this proposed district - that is, the counties of Napa, Yolo, Lake and Solano - as we are physically separated from them by Suisun Bay.
2. Our two cities are an integral part of the East Bay region as well as being major cities in central Contra Costa County. As such, we share no specific social or economic characteristics with the four northern counties mentioned above.
3. Our media market is completely different than these other counties.
4. The vast majority of our residents are employed in the East Bay or San Francisco. There is very little overlap between us and these other counties when it comes to employment.

To the Citizens Redistricting Commission:

I live in Martinez, and I work as one of the pastors at a church in Pleasant Hill. Our congregation consists mainly of people from Martinez, Pleasant Hill, Concord, and Walnut Creek. While we do not preach partisan politics from the pulpit, we do encourage our congregants to be involved in their communities and exercise our civic duty to vote.

Our people are deeply invested in Contra Costa County. Someone may live in Concord, but their children attend school in Pleasant Hill, or vice versa. Our church is known in the cities in which our congregants live, and there are plenty of places to serve the community without leaving this four or five-city area. We not only care about decisions affecting the cities in which we live but also about decisions affecting the cities in which we serve and have fellowship. Our business is spread across these cities, too. Neither Concord, Pleasant Hill, Martinez nor Walnut Creek individually have every amenity or service one could need, but these cities combined give our residents little reason to leave the county for shopping and services.

We have little investment in the cities north of the Suisun Bay. Steep tolls to cross the bridges into the cities to the north create an economic dissuasion to frequenting those communities. We do not share many media markets with the cities to the north of the bay, either.

From a government standpoint, separating the county seat, Martinez, from the rest of the county seems unwise. I am sure that residents in the cities of Concord, Walnut Creek, etc., would like to have some say in the decisions made in the city of their county's center of government--its facilities and employees.

I urge you to take all of these things into consideration as you draw the district boundaries for the State Assembly, Senate and Congress. Martinez and Pleasant Hill are intrinsically linked with their adjacent cities in the Mt. Diablo Valley. To separate them would be disruptive and divisive.

Dear Commission:

I am writing to you to express my strong opposition to the proposed State Senate District (WINE) which would result in the removal of Pleasant Hill and Martinez from current Senate District 07. There are many reasons why it makes no sense to include this portion of Contra Costa County with the Counties of Lake, Napa, Solano and Yolo, not least of which is the fact that there is no geographic contiguity between the two areas.

As outlined in Proposition 20, which passed in 2010, the commission is required to use the 'community of interest' guidelines or standards in considering districts. Specifically, community of interest is defined as "a contiguous population which shares common social & economic interests....examples of such interests are those common to areas in which the people share similar living standards, use the same transportation facilities, have similar work opportunities, or have access to the same media of communication...."

Clearly, these guidelines were not taken into consideration with the current redistricting proposal. Pleasant Hill and Martinez are an integral part of Contra Costa and the East Bay region in general. We share the same transportation modes such as BART, highway system and economic base. We are part of the same Bay Area media market which only partially reaches into the proposed 'WINE' district.

From a social, economic and cultural perspective, Pleasant Hill and Martinez share many common interests with neighboring cities and the entire East Bay community. Conversely, there is little or no connection with Solano, Napa, Lake and Yolo Counties, some of which is not considered as part of the Bay Area region.

I strongly urge you to reconsider this redistricting proposal by placing Pleasant Hill and Martinez where they should be - with the rest of Contra Costa in the proposed 'RAMON' district.

Dear Commissions:

I am writing to you to express my strong opposition to the proposed State Senate District (WINE) which would result in the removal of Pleasant Hill and Martinez from current Senate District 07. There are many reasons why it makes absolutely no sense whatsoever to include this portion of Contra Costa County with the Counties of Lake, Napa, Solano and Yolo, not least of which is the fact that there is no geographic contiguity between the two areas.

As outlined in Proposition 20, which passed in 2010, the commission is required to use the 'community of interest' guidelines or standards in considering districts. Specifically, community of interest is defined as "a contiguous population which shares common social & economic interests....examples of such interests are those common to areas in which the people share similar living standards, use the same transportation facilities, have similar work opportunities, or have access to the same media of communication...."

Clearly, these guidelines were not taken into consideration with the current redistricting proposal. Pleasant Hill and Martinez are an integral part of the central Contra Costa community and the East Bay region in general. We share the same transportation modes such as BART, County Connection Bus Services and many bicycling and pedestrian routes. We are part of the same Bay Area media market which only partially reaches into the proposed 'WINE' district. Both Cities are also active participants in the East Bay Economic Development Alliance incorporating all of the major cities in Contra Costa and Alameda.

From a social, economic and cultural perspective, Pleasant Hill and Martinez share many common interests with our neighboring cities and the entire East Bay community. Conversely, there is little or no connection with Solano, Napa, Lake and Yolo Counties, most of which is not considered as part of the Bay Area region. Pleasant Hill and Martinez are intertwined with efforts in Contra Costa county to develop transit centers and reduce the greenhouse effect caused by auto emissions in commuting to work places elsewhere in Contra Costa, Alameda, and San Francisco counties.

I strongly urge you to reconsider this redistricting proposal by placing our community where it should be - with the rest of Contra Costa in the proposed 'RAMON' district.
