As a citizen of Lake County, I was genuinely appalled to see the latest version of the draft Congressional District map prepared by the Commission. This map separates our county from our true geographic, economic, and social "community of interest," which is the North Coast/wine country/northern Coastal Range, and attaches us as an incongruent appendage to the Central Valley.

Please take a closer look at Lake County's characteristics and needs. True, we are a farming community, but our production is entirely in specialty crops, not commodity agriculture. The future prosperity of agriculture here depends on diversification, expansion of markets, and innovative value-added production: entirely different from the operative constraints in Colusa, Glenn, and other Sacramento Valley counties. Our growing identity as a premium wine-growing area is particularly important: signalling association with Napa County at the least, and preferably with Mendocino and parts of Sonoma Counties as well.

Lake County's future also requires the creative redevelopment of our attraction for visitors. Preservation of the natural beauty of the area, and maintenance of the health of our air and waters is essential to our well-being and prosperity. These considerations are of comparatively minor importance in the region to the east.

Furthermore the redistricting detaches Lake County from both of the urban centers (Santa Rosa and Ukiah) where most of our residents seek out goods and services that are not locally available.

We are anything but a natural fit in the region to which the Commission proposes to include us.

Redistricting along these lines would be particularly calamitous because as a small rural county our voice will always be of comparatively small account in any larger legislative district. Up to now we have been fortunate in this respect, not only by the happy accident of having elected leaders who are responsive to our needs, but -- much more important -- because our needs have coincided to a high degree with those of the larger district in which we have been included. Redistricting along the lines now proposed would completely abolish the congruence that is such a necessary component of true representation for our community.

My objections to the proposed Congressional redistricting also apply, to a diminished degree, to the proposed State Senatorial district, which does at least have the virtue of keeping us connected to Napa County.

The Commission's original recommendations were far far preferable to these revisions. I very strenuously recommend returning to them.
