Please move the town of Esparto (zip 95627) into one of two proposed neighboring Assembly districts (per my attached maps), and a proposed neighboring Congressional districts (per attached maps)

The town of Esparto is clearly not majority conservative. There are many many (more?) of us progressives. Currently we do not have representation while being part of the Sacramento Valley (Herger, Nielsen). I genuinely feel we belong with eastern/southern Yolo County, that tends to be part of the greater Sacramento region. Thus, I suggest placing Esparto in the WSAC district. If you cannot do that, then at the very least, place Esparto in the ECC district, although I suspect that is populated by conservatives.

Please please get Esparto out of a conservative district. We don't belong there. It is a dense area of rural Yolo, populated by the employees of landowners, businesses, and government.
