As a resident of Cypress (90630), I want to express my strong objection to the preliminary final draft Congressional district map which straddles both Orange County and Los Angeles County.

This preliminary final draft does not best satisfy the Commission criteria of "Districts must respect the boundaries of cities, counties, neighborhoods and communities of interest, and minimize their division, to the extent possible."

This district straddling both Orange County and Los Angeles County cannot best serve either county because of the following representative major differences:

- different court systems/jurisdictions
- police radio frequency issues (ability to "free talk")
- police funding differences
- police operations, protocols, pursuits, SWAT, etc. differences
- shared police resources within the county
- working relationships within the county (OC Traffic Officer's Association, OC Gang Investigator's Association, OC SWAT Commanders, etc. just for a few examples)
- Joint Power Authorities
- common community interests

I respectfully request that this Congressional district honor the OC/LA county boundary line and that the affected cities be assimilated within districts contained within their respective county.
