Dear Mr. Claypool,

On behalf of the Artesia City Council and the residents of Artesia, I respectfully request that the Citizens Redistricting Commission consider preserving federal and state legislative districts that keep Artesia with our fellow cities of the Gateway Cities Council of Governments (COG) in Los Angeles County, including Bellflower, Cerritos, Downey, Hawaiian Gardens, La Mirada, Lakewood, Long Beach, Norwalk, Paramount, Pico Rivera, Santa Fe Springs, and Whittier.

As part of the Gateway Cities COG, Artesia has worked collaboratively with our neighboring cities throughout Southeast Los Angeles County to develop and support

- high-tech manufacturing and entrepreneurial businesses;
- transportation infrastructure including an airport, marine terminals, freeway systems, rail networks including the Alameda Corridor Freight Rail System and expanding mass transit systems;
- economic partnerships at the local and regional level encourage redevelopment and business growth with an eye to the future, leaders from business, education and government work together to identify ways to improve the business environment;
- public and private educational institutions, including Biola University, La Mirada, California State University Long Beach, Whittier College, Whittier, and five community colleges, Cerritos College, Compton College, Long Beach City College, Rio Hondo College and East Los Angeles College, are a magnet for innovation and research; and
- housing opportunities that range from single-family homes apartments, condominiums and affordable housing close to the workplace.

Given Artesia's history of cooperation and collaboration among our neighboring cities through the Gateway Cities COG, I believe that grouping Artesia with the cities in Orange County, such as Cypress, Fountain Valley, Garden Grove, La Palma, Stanton, and Westminster will be disruptive and damaging. Artesia does not share the same level of relationship, history, and diversity with these cities, and, as a small city of 17,000 residents, we would find it difficult to represent our city's needs to Sacramento and Washington DC.

I appreciate the difficulty of the work of the Commission, so I thank you for your consideration.
