Subject: You Have Disenfranchised El Segundo Voters!

Message Body:

I do not have the time to download all of your maps to figure out which category of representation has had its boundaries re-drawn, affecting the City of El Segundo. Therefore, I will accept as fact the words of our City Council Members during a televised meeting on 8/2/11, that a disastrous change has occurred on at least one of the maps. Specifically, we have suddenly been assigned the same representation as some communities to our north and to the east, most objectionably, the cities of Inglewood, Hawthorne, and West Hollywood.

El Segundo is a small, independent beach town, which serves as a recreational area for Los Angeles area beachgoers, and as home to 17,000 residents and numerous Fortune 500 Corporations. For decades El Segundo has shared the same representatives as all of the other independent beach cities to our south. In fact, all of our cities lie in a contiguous line; have similar demographics and interests; share similar concerns; and cooperate with one another in many matters. By contrast we have little in common with our northern neighbors, Playa Del Rey and the tourist mecca of Marina Del Rey, both of which utilize L.A. City and County services; and nothing whatsoever in common with the inland areas of Inglewood, Hawthorne, and West Hollywood.

The number of registered voters in El Segundo is about 10,000. Inglewood alone on the other hand, is a city of about 120,000 people. Should a representative elected with Inglewood's "muscle" not be responsive to the concerns of El Segundo voters--which is entirely likely based on that City's history--we would have no chance whatsoever of replacing that representative in a subsequent election. Effectively, this redistricting completely disenfranchises the voters of El Segundo for a minimum of ten years!!!

At best these new boundaries have been drawn in the absence of adequate information or thought. At worst this has been a corrupt attempt to ensure that El Segundo's votes would be forever wiped out and not count. The action which has been taken is contrary to the original purpose of forming the new Commission, which was to prevent gerrymandering; to limit the influence of special interests; and to halt the guaranteed re-election of career politicians.

I hope that the Commission will look more deeply into this outrageous "sentence" that has been imposed on El Segundo and re-align us with the rest of the beach cities, with which we rightfully belong. Otherwise, I would certainly encourage our City leaders to pursue legal action.




