I'm pleased that the latest maps show my San Mateo County coast community of Montara in the same senate and congressional districts as our sister communities of Moss Beach, El Granada, Princeton and Half Moon Bay. However, I'm troubled by the latest assembly map that divorces Montara and Moss Beach from those same communities, with which we have much in common. The latest assembly map pairs us up with less comparable communities to the north. Montara and Moss Beach have much in common with the other coastal communities that lie to the south, with our mutual focus on agricultural lands, open space preservation and the ocean resource and tourism interests that fuel the San Mateo coast economy from Devil's Slide on south past Pescadero to the Santa Cruz County line. Montara and Moss Beach are less aligned with Pacific and other SF bedroom communities to the north, so it would serve us better to be included in the same assembly district as Half Moon Bay. This purpose is well accomplished with the current senate and congressional district maps. Please consider a modest modification to the assembly district map so as to keep Montara and Moss Beach in the same assembly district as Half Moon Bay and our similar, neighboring non-urban coastal communities of El Granada and Princeton.
