I have been closely following the redistricting process and was initially encouraged that districts drawn by an "independent" commission would produce fairer boundaries more reflective of cultural and community character than was the case with redistricting drawn by politicians.

As a 32 year resident of the Beach Cities (Manhattan Beach, Hermosa and Redondo) I'm both respectful of the authority vested in your commission yet appalled at the proposed new boundaries for subject 36<sup>th</sup> Congressional District.

The proposed boundaries eliminated traditional communities recognized as being part of the South Bay such as El Segundo, part of Torrance, all of Lomita as well as San Pedro, Hawthorne and Carson. This, coupled with replacing these traditional South Bay cities with parts of the Westside including bizarre narrow portions of Santa Monica, Venice, Malibu, Bel Air and Beverly Hills. Even part of Calabasas, Agoura and Los Angeles are now proposed for inclusion in the 36<sup>th</sup> District. This appears to be gerrymandering of the first order.

Many of my friends and neighbors feel these proposed boundaries will result in our being disenfranchised with a more severely gerrymandered district than we suffered with before. Uncompetitive districts promote the type of dysfunctional, polarized politics that are paralyzing our government and damaging the economy, both locally and nationally. You have the power to make a lasting impact by drawing a more balanced district where the communities share common priorities with in-district representation rather than sharing little in common except vulnerability to extreme, carpet-bagging career politicians who seldom represent genuine community interests.

I urge you to revisit these boundaries if for no other reason than to avoid costly litigation which is unfortunately being readied.

If this district is left as proposed, count me in as supporting the lawsuit, financially and otherwise.
