As 38-year residents of Westchester, we appeal to you to right the wrong of putting our Westchester, Playa del Rey and Playa Vista community (ZIP codes 90045, 90293 and 90094) in the incompatible congressional district with Inglewood and other areas to the east. Our community was split and parts were gerrymandered into our current district ten years ago.
