To determine each applicant's identity and qualifications to serve on the Commission and to track the demographic information of the applicant pool, this application seeks personal information about applicants that will be provided to the Applicant Review Panel, State Auditor's Office staff, and the public, including members of the press, the Legislature, and the Commission.

1. Please describe why you wish to serve on the Commission and why you think it's important\*:

I am applying to serve on the Citizens Redistricting Commission because I firmly believe that redistricting is key to ensuring public voice in democracy. Having voice in governance is an essential component of our democratic system. While there are many avenues for residents to make their voices heard, the concept of one person one vote is the hallmark of representative democracy in the United States. Unfortunately, the voices of underrepresented communities, are too often diluted and drowned out due to how district boundaries are drawn. In fact, recent research finds that participation of minority communities in elections decreases relative to the proportion of the community in a district (see Fraga 2016; Fraga 2018; and my own research currently under peer review). The CRC is a unique way of addressing these challenges to robust voter participation and I would be honored and excited to serve and advance its mission.

In most states, redistricting is left to the jurisdiction of state legislators, in which the majority party has the upper hand. In a recent report by the USC Schwarzenegger Institute that I co-authored, we identify the top ten gerrymandered state legislatures in the United States. We found that an astonishing number of Americans - more than 59 million - live under minority rule in a state where the party with fewer votes in the 2018 election controls the majority of seats. California was not a part of that list. The Citizens Redistricting Commission played an essential role in ensuring fair representation of all Californians by crafting district boundaries that met the needs of diverse communities.

I want to be a part of this process because I have a strong commitment to transparency and public involvement. As an advocate in the social justice community of California, I built a track record as a bridge builder working to bring communities across the state together. As a scholar, I have dedicated my career to researching the needs of historically underserved communities. To that end, my expertise lies in the analysis of census and voting data in California. I believe my extensive work with communities across the state, my analytic skills and training, and my deep commitment to upholding the values of representative democracy make me uniquely qualified for the California Citizens Redistricting Commission.

2. Please explain what it means to be *impartial* and describe your ability to exercise impartiality as set forth in <u>2CCR §60800</u>. Provide examples of times when you had to set aside your personal views in order to achieve a common goal. How will your ability to be impartial assist you if you are selected to be a commissioner? You may include with this description any occupational, academic, volunteer, or other life experiences you have had that demonstrate this ability\*:

Impartiality may be the most important quality needed in a redistricting commissioner, and yet may be the most difficult to establish. Each person has a wide portfolio of identities that will influence their outlook. One's profession, family, socio-economic status, the community with whom one self-identifies all influence an individual's values and may lead others to assume they are unable to put

aside their views and have an open mind. But to be impartial is to leave your pre-conceived notions at the door, to actively listen to others, and to make decisions that are fair to those impacted by them.

While much of my career has emphasized concerns for underserved communities, my husband and I are also small business owners, in which we have to consider both the rights of workers and the bottom line. To do so requires seeing beyond self-interest, including my own. More often than not, I've had to set aside my own personal views and deal with facts objectively and with an open mind.

As a professor of political science, I must practice impartiality every day. I work with a wide array of students of differing backgrounds, abilities and world views. As an educator, my goal is to ensure that students come away from my courses with a baseline level of conversant, factual knowledge about the substantive material and to impart a set of analytic skills intended to permit them to confront new academic and professional challenges encountered long after the course ends. To do this requires accepting students for who they are and the beliefs that they possess - not to spew my own views. For instance, in my courses we regularly discuss hot button political issues like same-sex bathrooms, abortion, second amendment rights, and immigration. Across the many institutions where I have taught, students have a wide range of personal opinions on these issues. My role requires impartiality and to instruct students in understanding the institutional opportunities and constraints for policy change regardless of its direction, as well as generalizable theories of human behavior while creating a classroom climate that safe for student exploration.

My intention in applying to serve as a Redistricting Commissioner is to serve all Californians for the good of our system of representational democracy.

3. All commissioners must demonstrate an appreciation for California's diverse demographics and geography as set forth in <u>2 CCR</u> <u>\$60805</u>. Please describe your appreciation for California's diversity and provide any occupational, academic, volunteer, or other life experiences you have had that demonstrate this appreciation\*:

California's vast diversity of cultures, viewpoints, opportunities and geography, is what leads millions to call the Golden State home. As a biracial American and the daughter of immigrants - an Indian father and an English mother - growing up in America's rustbelt I felt the isolation of never fully belonging - never being quite white; never being Indian enough. Through this experience, I have come to identify most with underrepresented communities, and that passion led me to become a part of California's diversity narrative and has fueled my professional and research pursuits.

During my years working in immigrant rights advocacy organizations, I worked to engage California's underrepresented communities in the democratic process. As a part of my work at both the Coalition for Humane Immigrant Rights of Los Angeles (CHIRLA) and Asian Americans Advancing Justice-Los Angeles (previously the Asian Pacific American Legal Center) I organized large scale naturalization drives, prepared and mobilized immigrants to speak with their legislators, and built coalitions among communities across the state. As a part of this work, I engaged and built coalitions with the Cambodian refugee community in Long Beach, with African immigrants in Oakland, agricultural workers in the Central Valley, Muslim Americans in San Diego and many more. I had the opportunity to spend a significant amount of time working in the Inland Empire with organizations striving to build resource capacity and representation for warehouse workers and day laborers. Through this work I came to know and love the vast diversity of our state.

As a scholar of voting behavior and electoral institutions, I view my research as advancing the public's understanding of diversity in our state. In a publication in the California Journal of Politics and Policy, my coauthor and I examine the voting behavior of Latino Democrats in elections in which the top two open primary system has resulted in two Republicans on the general election ballot. In research published in the news outlet Vox, I examine the competition between two Asian American congressional candidates in the San Jose area - the nation's only Asian American majority district outside of Hawaii. I find distinct divergence between Chinese, Vietnamese and Indian voters in their preference of Asian American candidates of different national origin backgrounds. This work is furthered by several research projects that disaggregate Asian Americans by national origin subgroups to further examine political behavior outcomes such as registration, turnout and policy preferences.

Beyond a personal appreciation, the richness of California's diversity and the policy and participatory challenges of a changing demographic is my area of professional expertise. My work as a scholar and previously as an advocate have all emphasized the great diversity of our state.

4. Please describe the relevant analytical skills (as described in <u>2 CCR §60827</u>) you possess that you believe make you a strong candidate for the Commission. You may include, but are not limited to, with this description any occupational, academic, volunteer, or other life experiences you have had that demonstrate those skills\*:

My vocation as a researcher and professor of political science as well as my former work as a policy advocate for community-based organizations has allowed me to build and possess a tool kit of analytic skills that I could bring to the Redistricting Commission.

In my research, I analyze voter registration and vote returns using the California Statewide Database held at the UC Berkeley School of Law - the official redistricting database for the state. This is a powerful dataset that includes surname matching identification of Latino and Jewish voters along with the six largest Asian American national origin subgroups in the state. In addition, my work includes the analysis of census data, public opinion survey analysis, experimental data and nationwide vote returns. My training includes the use of various relevant statistical and analytic software such as STATA, R and ArcGIS. Furthermore, my research emphasizes how electoral institutions like the Voting Rights Act, California's top two primary and citizen redistricting influence voter participation and representation. In a 2018 article in the peer-reviewed journal PS: Political Science and Policy my co-author and I

contend that how electoral institutions are designed - including how district lines are drawn - may create both constraints and opportunities for representational diversity. The article was profiled by the London School of Economics' United States Centre for Politics and Policy.

In my capacity as a professor at Cal Lutheran University in Ventura County, I teach courses on social science research methodology, introducing students to the fundamentals of research design and statistical procedures necessary for empirical research. Therefore, I would be well suited to not only use my knowledge in the assessment of district demographics, but also to assist other commissioners in building their own knowledge and understanding.

Finally, in my previous work in community-based organizations, I built a track record for being a bridge builder. For example, in 2011, in my position as the strategy director for the California Immigrant Policy Center, I worked closely with immigrant workers in the Inland Empire as well as with the California Chamber of Commerce to stop cities from mandating the use of the federal E-Verify program, which was fraught with errors that mis-identified workers and placed unnecessary burdens on small businesses.

My research and my track record of working within and between communities to build consensus is evidence that I have the requisite analytic skills necessary to serve on the commission. In addition, as a data scientist and instructor of research methodologies, I would be well poised to assist other commissioners throughout the process.

My name is Fernando Romero, I am the Executive Director for the Pomona Economic Opportunity Center (PEOC), a leading immigrant rights organization based in Pomona, CA. The PEOC is a nonprofit organization with a grassroots advocacy model focused on facilitating services and education to low-wage, immigrant workers in the Inland Empire region of California.

I write this letter on behalf of Professor Sara Sadhwani (Applicant #: 7164) in her candidature for California's Redistricting Commission and would like to give my highest commendation in her pursuit of this endeavor.

I've known Prof. Sadhwani since 2011 when she worked as the strategy director for the California Immigrant Policy Center (CIPC), a statewide immigrant rights organization focused on immigration policy. During her time with CIPC, she was diligent in her policy and advocacy work to educate and engage deeply with marginalized communities, particularly in regions like the Inland Empire. In April 2012, we worked closely to prevent the implementation of a measure being proposed by the San Bernardino County supervisors, which our organizations deemed detrimental to the rights of immigrants. The county-wide initiative aimed at creating a color-identifying system for businesses that chose not to use E-Verify when hiring employees. The measure was voted down in large part due to Sara's educational outreach and foresight in understanding that it would disproportionally affect immigrant community members in the IE.

Over the years, I've had the pleasure to work alongside Prof. Sadhwani in other ventures and she has brought her skills and talents to each. During her tenure on the Board of Directors with Liberty Hill Foundation, she brought her critical analysis skills and knowledge of the unique demographics in Los Angeles County to the Foundation. Through her position on the Liberty Hill Board she worked closely with organizations like ours to provide vital resources to empower marginalized low-wage and immigrant communities across the County.

I write to wholeheartedly endorse Sara Sadhwani for service as a member of the California Citizens Redistricting Commission. I can think of no other Californian more suited for this position. Sadhwani is analytical; impartial; intelligent; has superb communication skills; can work well with others across the partisan and ideological spectrum; has a commanding knowledge of the state's people, diversity, and geography; has the cognitive skills required to draw maps and carefully consider multiple evaluative criteria in constructing those maps; and can understand data, analysis, and GIS or other mapping software.

I have known Sadhwani for about seven years. I am a professor of political science and public policy at the University of Southern California. I know her as a collaborator on several analytical and impartial research projects, including one evaluating fair maps and the fairest distribution of votes-to-seats in legislative districting maps across the United States. I also served on her dissertation committee when she received her Ph.D., and I also worked with her directly as a colleague and coworker at the Institute at USC to which I am affiliated.

Sadhwani has excellent analytical and cognitive skills. She completed her Ph.D. in political science and international relations at the University of Southern California in Los Angeles. She is now a professor at California Lutheran University in Thousand Oaks. She is a teacher and a researcher, and in both of these capacities, she demonstrates the analytical abilities to make an excellent California Redistricting Commissioner.

Her area of expertise includes an understanding of the federal Voting Rights Act and the California Voting Rights Act. In her analytical research, she has analyzed the people and demography of California, and she has conducted extensive research on the voting rights of Asian American, Latinx, and African American people. This expertise in voting rights in California in particular will be an important skill brought to the Commission. She understands the law that the Commission must follow, and can objectively analyze what districts may protect the rights of minority voters. She also has an in-depth and analytical ability to quantitatively assess how various districting plans may impact people of color and voting rights. Her dissertation studied voting rights in California, and her skills as an objective scholar directly translate to her ability to serve on the Commission and evaluate fairness in maps.

Sadhwani also has a strong skill set in understanding quantitative data and analysis. Given that the Commission will need to use quantitative data and mapping software, and have expertise in analyzing data and various maps and criteria for drawing maps, Sadhwani's quantitative skill set will be extremely helpful to the Commission. Just as important, were she selected to serve as a Commissioner, she would also be able to communicate such data and quantitative analyses to a wide audience. Her cognitive skills are extremely high, and she has direct skills and capabilities in reading data, analyzing maps, analyzing data, and evaluating multiple criteria to create a redistricting plan. In most of her research, she uses statistical models to analyze data. This facility with statistics, as well as mapping, will serve her well on the Commission.

Sadhwani also is able to use fairness when making evaluations. As a Commissioner, she would do an excellent job of weighing multiple criteria, such as compactness, protecting communities of interest, protecting voting rights, equal population, and other relevant criteria. Because she has objectively studied this topic, she understands what criteria must be used to draw fair district lines. In her own research she has analyzed legislative districting maps across the United States, evaluating those that are the fairest districting plans and those that are some of the worst districting plans when it comes to fairness. She will bring this understanding of drawing fair maps to the table as a Commissioner. In fact, I think she will be a leader on the Commission, if she is chosen, given her unique ability to be able to objectively evaluate fair maps, analyze and understand statistics, and have the ability to draw maps using GIS software and other statistical or mapping software.

Sadhwani is also highly impartial, and can work well with a wide variety of people across the partisan and ideological spectrum. As already noted, she has conducted much research. However, this research is not opinion driven. It is objective and impartial, and simply analyzes and explains. She also teaches and is impartial in the classroom. Beyond that, she has worked in settings that require bipartisanship, compromise, and impartiality. While she is a registered Democrat and is applying for one of the five Democratic positions on the Commission, she has time and again demonstrated willingness to work with members of other parties. Even though

Sadhwani is a registered Democrat, she has worked as a fellow at the USC Schwarzenegger Institute studying fair districting maps. The Institute is a nonpartisan center affiliated with USC, where Sadhwani received her Ph.D. In this capacity, she has worked at a center created by the state's last Republican governor, who also was one of the key supporters in the passage of the ballot proposition creating the CCRC. Her work there was impartial, bipartisan, and analytical.

She has also worked with independent voters, and took part in a seminar two years ago of scholars and no-party-preference voters where she analyzed diversity in the California electorate. Other attendees in the audience at the event included the nation's top scholars, students, policy practitioners, and no-party-preference voters who were interested in expanding voter access to the polls for NPP voters. This demonstrates her ability to work with no-party-preference voters. I mention these examples (and there are several others) to show that Sadhwani, while a registered Democrat, is able to be impartial and to work with others whether they are Democrats, Republicans, members of other parties, or hold no party preference. Given the composition of the committee will be five Democrats, five Republicans, and four other/NPP commissioners, Sadhwani's demonstrated ability to work across partisan lines shows she will function well on such a commission with a diversity of people from different parties.

Her impartiality is not just about working with people from all parties, though. Her scholarship and published research objectively and impartially analyzes districting maps, demographics, and other data in California and beyond. Her research and teaching show she has the ability to be impartial. If you asked her students what her political party is, my guess is that none would know as she presents herself in the classroom as a rational expert. In today's polarized world, it is difficult to find such a person, but Sadhwani's dogged impartiality when it comes to data analysis, research, and teaching suggest she will be extremely impartial in her work on the California Citizens Redistricting Commission.

Sadhwani understands the people and diversity of California. She has lived in California for many years. She has worked with a wide variety of stakeholders that cover the vast diversity of the state. She has worked in the immigrant rights community on policy that affects a vast group of California's people. She has conducted research, including a nonpartisan and scholarly study funded by the Haynes Foundation called "Representation in a Multi-racial California" that analyzes the changing demography of the state. Finally, she herself is a woman of color, and will bring an important and diverse perspective to the Commission. She can work with any Californian, and she knows how to work with a diversity of people and stakeholders.

Finally, she is a skilled communicator. She is an excellent speaker, writer, and listener. As the Commission must hold hearings to seek input from the state's voters; and travel the state seeking such inputs, I am confident Sadhwani will do well in communicating and listening to citizens and stakeholders. She knows how to receive information and feedback from diverse voices across the partisan spectrum and incorporate it into the drawing of the fairest and most impartial maps possible. She is of extremely high character that is demonstrated in her work and interactions with others.

In sum, I highly recommend Sara Sadhwani to be one of the next California Citizens Redistricting Commissioners. I can think of no better citizen of California to serve in this capacity. She is truly perfect for this position, and possesses all the skills necessary for this incredibly important service to our state.
