The Act also requires the California State Auditor's Office (State Auditor's Office) to select 60 of the most qualified applicants based upon their voter affiliation; eligibility to serve pursuant to Article XXI of the California Constitution; the absence of any conflicts of interest; relevant analytical skills; ability to be impartial; appreciation for California's diverse demographics and geography; and racial, ethnic, geographic, gender, and economic diversity. To determine each applicant's identity and qualifications to serve on the Commission and to track the demographic information of the applicant pool, this application seeks personal information about applicants that will be provided to the Applicant Review Panel, State Auditor's Office staff, and the public, including members of the press, the Legislature, and the Commission.

1. Please describe why you wish to serve on the Commission and why you think it's important\*:

Initially, I wasn't certain I wanted to serve. It seemed as if there should be others 'out there' that would take on this weighty assignment. Surely, someone with more knowledge and experience than me should step up to this challenge. However, as I read and re-read the application, definitions, and selection process, it occurred to me that though there would certainly be others 'out there' that would do an amazing job, so would I. This assignment calls for a committee member with analytical skills, that is impartial, and embraces diversity. I am passionate about all of these areas therefore, I feel compelled to at least attempt appointment!

I desire to serve on the 2020 Citizens Redistricting Committee because I believe I will serve in excellence, with my whole heart and ability. The process seems complex and will require individuals that will listen for what's presented and for what may be missing. I enjoy the challenge of taking massive amounts information and organizing it in a manner that allows sequencing and logic to begin to take shape. I have worked with teams and organizations for the better part of my life. One of my strengths is the ability to work through difficult decisions, (those with potential to divide and alienate) and have outcomes that all parties understand and embrace. Also, embracing diversity comes easy for me. Not just diversity of culture, but also diversity of status, thought, and stated opinions. I truly believe that people with varied backgrounds and experiences adds flavor and dimension to an otherwise dull and flat society.

Fully embracing diversity is important because, I know who I am and where I come from; what my needs are. As I listen and am in relationship with others, I begin to learn and understand who they are, where they are coming from and what their needs are. We embrace diversity when we have a desire and capacity, with demonstrated actions, to learn from others, gaining a clearer picture of what our collective needs may be, in a way that brings value to all.

This understanding and value for all people provides the foundation, that I would like to build upon, as we begin the work of drawing lines and re-establishing boundaries. I am excited for opportunity to serve with other other individuals with varied experiences and backgrounds. I am hopeful that by some chance or miracle that I am selected to do my best to ensure equity for all Californians.

2. Please explain what it means to be *impartial* and describe your ability to exercise impartiality as set forth in [2CCR §60800](#). Provide examples of times when you had to set aside your personal views in order to achieve a common goal. How will your ability to be impartial assist you if you are selected to be a commissioner? In 2016, I was instrumental in merging five separate 501c3s into one legal entity - Faith in the Valley. Our founding convention, held in Fresno, California, brought 2000 people together, from various backgrounds and varied economic status, to the Fresno Convention Center to ratify the merger. Faith in the Valley's mission is to provide support, training, and assistance to community members, teaching them how to use their voice to enact change where inequities exist.

I chose to work with and support people in a multi-faith setting. The community of people that I work with range from those that would be considered marginalized to those with privilege or affluence; with different life experiences that inform their views. Everyone's voice is valued and powerful and deserves to be served with respect. We (I) truly believe in working towards a just society where every one belongs and is treated fairly. When working with community, I believe if I'm not fair in my dealings and consistent in how I serve, then I become no different from those that have set up systems that we work to change.

Impartiality is the ability to treat all people equitably with fairness, regardless to their character, actions, or beliefs. When planning our convention, the community leaders, Pastors, Priests, Imams, Rabbis, and Spiritual Leaders were expectantly diverse and opinionated in the role they would play and also vocal on what platform issues they could not or would not support; based on their religious beliefs or community standing. I ensured that each participating group leader had an opportunity to be represented. Then, and even now, I work very hard to ensure we find areas of agreement to focus on and not allow difference to destroy relationship. Even when an opinion is expressed and embraced that differ from my thought process or desired path forward, I provide the same level of support and access to resources.

This is one example of my willingness to serve and support those with different views from my own. I desired, from the beginning of our merger, to be impartial; my desire was (and is) to honor each person's beliefs and ensure all of the voices were represented. Our role at Faith in the Valley is to educate our community about the issues at hand; teach community (all community) how to get civically involved; do their own research and draw their best conclusions and path forward.

I also recognize that impartiality is not a one time event, it is a chosen lifestyle. I do not believe it is automatic nor do I believe it is consistently applied. I believe decisions, choices, verdicts all have to be checked and challenged because a simple desire to be impartial is rarely evidence that one is impartial. Impartiality is one of those things better spoken about by a third party. It is something best said about you rather than something you say about yourself. All in all, I do my best to be impartial, I listen to feedback from others, and as I learn better, I make adjustments when and where needed.

Faith in the Valley is a multi-faith, multi-cultural organization that fully supports and embraces of people from all ethnic and socio-economic backgrounds. My staff, intentionally, consists of individuals that are of Latino/Hispanic, Jewish, African American, Hmong, and Caucasian. My Board of Directors have the same representation with also a Muslim American. I work in coalition spaces fighting for justice with indigenous people, immigrants, returning citizens (previously incarcerated), and homeless individuals. Because we are a non-partisan organization, I serve on panels and work groups with people that would identify as Democrat, Republican and Independent, with policy makers and elected officials.

To ensure we are inclusive and ensure we represent as many diverse populations as possible, in our meetings and planning we ask, "Who is not at the decision-making table?" If we cannot invite the 'missing' into the space because of timing, space or proximity, we lift them in are hearts, minds, and in our learned experiences, to ensure we are providing the best possible path forward for all concerned.

Because I appreciate diversity and strongly believe in the value of all people I was honored and selected to participate in an 18 month non-profit accelerator cohort program, sponsored by the Latino Community Foundation. This program was curated by and for Latino people, to build the skills of leaders working with the Latino community. I was contacted several times and initially thought they were reaching out in error. They indicated they had selected me to be a part of this amazing program because of the work I do with the Latino community. I explained that though the program sounded amazing, I had to tell them I was African American. The program coordinator responded that they knew exactly who I was; based on my work with the Latino community they still wanted to offer me the opportunity to benefit from the program!

Through the Astraea Lesbian Foundation for Justice and the Borealis Foundation, I was selected to attend a Grantee Gathering, "Freedom from Violence and Criminalization" in San Juan, Puerto Rico. I was one of more than 60 organizers based in the U.S. that lead work in the community to fight back against the increased criminalization of communities of color, Lesbian, Gay, Bi, Trans, Gender Non-Conforming & Queer (LGBTGNCCQ), poor and working class folks, women, migrant communities and all of those that live at the intersections of these identities and experiences. This was a generative space where we were able to engage in political dialog and re-envision public safety in communities of color.

I truly appreciate California's diversity and the many, many people that make up our beautiful Golden State. I am so encouraged by this process that aims to include all voices in the conversation.

I have a Bachelor of Business Administration degree in Management. I graduated Summa Cum Laude, one of the top in my class. I am comfortable with math, analysis, statistical reports, and problems solving. I am comfortable with a computer and most software programs. I served on both the Civil Service Commission for the City of Stockton as well as the Salary Setting Commission. In each of these roles I was part of a group decision-making process and was required to assess the value of information to determine its weight in decision-making. I worked, in management for 20 of the 25 years that I worked for a telecommunications company. There, I interacted with two different unions - CWA and TIU and frequently had to receive expert and legal advice and apply the advice to decisions for the company.

I am a staff pastor for the Victory in Praise Church, where I serve as Executive Pastor. A good portion of my duties consists of report generating, letter writing, team facilitation and conflict resolution within membership and sometimes staff. We also operate a Community Development Center where there is multiple programs that run concurrently. When conflicts arise in programming, finances/budgeting, and or procedure, I serve as adjudicator or moderator to ensure the facts are louder than opinions so that we can move forward with the solution that is best alignment with the stated mission.

Working at Faith in the Valley, we train community members how to research issues, determining the root cause of why issues exist; the history or origin, who benefits, who put the policy in place, what structure upholds or is at odds with the law or policy and what steps are needed to change. This requires the ability to read and understand policy, some law, and parse through, sometimes massive amounts of information.

I have served in leadership within our church structure since my early teens (approximately 45 years). Within the church structure, I served as transportation coordinator, secretary, board representative, treasurer for a National organization, fund raiser coordinator, Sunday School teacher, youth pastor, young adult pastor, trainer, coach, facilitator, and now also, as executive pastor.

My husband and I host monthly marriage workshops that are open to all married couples. We believe healthy families are a necessary element of a strong and vibrant community. Having been married for 41 years, we facilitate discussions and activities designed to enrich and fortify couples for life. Because finances, or lack thereof causes added stress in relationships, we also offer financial counseling to adults of all ages; individuals and groups.

Within the community, I have worked with Californians for Safety and Justice in a community fair to pass Proposition 47. Facilitated leadership trainings for the Boys and Girls Club, First Five, other local congregations. Served for the Lincoln High School African American Parent Advisory Committee. Recruited 25 community members to participate in the annual Stockton Reads program. Served a term as Stockton Civil Service Commissioner and then as a member of the Salary Setting Commission, for the City of Stockton. I've received community honors from the NAACP and the Amelia Ann Adams Whole Life Center Bridge Award. I met Pastor Trena Turner through my work with the Faith in Action (FIA) network, formerly known as the PICO National Network. I have been with FIA for 38 years as a community organizer, an executive director of 2 affiliates, the Director of Organizational Development and, presently, the Director of Leader Development.

Faith in Action is the largest faith-based, grassroots community network in the country. Over its 47 year history, FIA affiliates in 23 states have developed tens of thousands of volunteer community leaders who have reached out and invited their neighbors, members of their congregations, and those living on the margins to join together to participate in public life. As a result, lives have been changed as people have the experience of coming together to improve their community, their city, their state and their country. It is democracy in action at its best.

I met Pastor Trena Turner a weeklong FIA National Leadership Training in 2013. She was a participant representing her local FIA affiliate in Stockton, California. What I noticed within the first 2 days is that Trena is someone who bridges across difference. She was surrounded by 120 multi-racial leaders and clergy from across the country who represented over 25 faith traditions and diverse political perspectives. Trena brought both curiosity and a generosity of spirit to each and every moment. There was one point in the training that participants were involved in an exercise about race, class and gender. Everyone was asked to sit on the seat that they thought the larger society has designated for them. By virtue of her professional work with the phone company, Trena seated herself in the middle of the 'pyramid.' She then proceeded to engage with her colleagues who raised questions about her decision. What was remarkable to watch was Trena's ability to articulate her own thinking behind where she chose to sit but also hold the tension of others who questioned her decision. She opened up and leaned into questions of how we explore issues of identity, class, race in a shared space where everyone's voice was heard. She led spontaneously, with respect, curiosity and generosity for those with whom she agreed and disagreed. At the end of the training, people named how deeply impacted they were by that moment in the training - they felt that it was a safe place to share and also a space of discomfort and inquiry.

Trena moved from a role as a volunteer leader in the local FIA affiliate to becoming the first Executive Director of Faith in the Valley - a merger of 5 independent organizations which spans the breadth of the Central Valley. She brought her management skills from her 30 years at the phone company to her new role along with a deep faith commitment. Her roots are deep with people and institutions. She has sat in hundreds of congregations and homes listening to the stories of families most deeply impacted by the issues affecting the quality of life in the central valley - air quality, skyrocketing costs of housing, gun violence, quality of schools, unemployment, etc. Those stories are a part of her and shape her understanding of who California needs to become and how it needs to be shaped (and for whom) to live out a future where everyone can thrive.

The third quality that I'd lift up about Pastor Trena is her sense of integrity. She lives in a region of political extremes - one of the most polarized regions in the state. I have observed her navigating through those extremes - listening to views very different from her own - and being clear about her thoughts without demonizing others. Where I have seen her (on occasion) lose her patience is with people who aren't interested in being a part of a team or thinking about the 'whole', but want to take up a lot of space to voice their own, individual opinions.

Trena is a leader - she is someone that people look to for guidance. During her 3 years as an Executive Director in Faith in Action, she has been invited to play a number of leadership roles within the state and national network - from leading national gatherings to examining how the network becomes a more equitable place for women of color. There are directors with 30 years tenure who pick up the phone and call Trena when they need a thought partner. The retired Roman Catholic Bishop of the Diocese of Stockton spoke of Trena as being the person who helped him understand more deeply about racial tensions in the region.

There is no one I can imagine better suited for the 2020 Citizens Redistricting Commission than Pastor Trena Turner. Her thoughtful discourse, love of people and ideas, bridging skills, her sense of integrity, her deep understanding of the diverse cultures and political divides across the state, and her clarity about who she is and what she believes will be a gift to the Commission.

I am writing to recommend Pastor Trena Turner for the 2020 Citizens Redistricting Commission. Since 2017, Pastor Trena has been the Executive Director of Faith in the Valley, a multi-faith, multi-race coalition of faith leaders and congregations from across the Central Valley, united around defending our most vulnerable neighbors and communities. I have known Pastor Trena since 2016 and, for the past three years, proudly served as her Communications Director and Regional Director. Before that, I was Director of Faith in the Valley's Fresno chapter (previously known as Faith in Community), working with Fresno congregations on campaigns including predatory lending, substandard housing, and gun violence prevention. I was born and raised in Fresno and believe deeply in the new rising leadership in the Central Valley, a region for far too long home to some of the nation's highest rates of poverty, pollution, and incarceration.

In her capacity as Executive Director of Faith in the Valley, Pastor Trena has led the founding and building of Faith in the Valley, merged from five previously separate organizations from Kern to San Joaquin Counties, into one that is developing a unified, regional vision for the role that leaders and congregations of various faiths can play together in partnership with other community-based organizations for dignity, opportunity and security for everyone in the Central Valley. Through Pastor Trena's leadership, we have seen our regional and local teams grow significantly, from a team of roughly 10 to now over 20 full-time community organizers and administrative staff. In large part because of that increased capacity and coordination across the five counties in which we currently operate, our county chapters have seen and begun scaling important campaign victories for health and safety housing inspections (in Fresno and now being scaled to Modesto), gun violence prevention programs (in Stockton and now being pursued in Fresno and elsewhere), and the turnout of thousands of new and infrequent Central Valley voters.

I believe likely in part because of her extensive career experience in both the corporate sector and co-leading a congregation with hundreds of members and multiple campuses, one of Pastor Trena's greatest strengths is in coaching. She has a unique ability to lead teams, but also work individually with a diverse range of experience levels and personalities to help build confidence in and clarity for everyone on her team. She inspires people - both those of us who know her well and those she meets for the very first time - with her belief in us and what is possible, her calming and confident presence, and her ability to turn seemingly distinct perspectives into

genuinely inclusive and coherent ideas. I have also seen firsthand Pastor Trena's commitment to "do the work" of learning from people and places where she has less experience, genuinely listening and taking the time to understand new issues, communities, faith traditions, and perspectives. Rarely will you see or hear her judge those with different viewpoints from her, and that model she sets has impacted me and across our team. While Pastor Trena has spent her entire life - growing up in the Bay Area and for the past several years in Stockton - experiencing, seeing firsthand, and working to address the needs and inequities in our state (whether that be as Pastor, Board member of Faith in the Valley's predecessor in Stockton - People and Congregations together for Stockton - or just in her personal life), I actually believe that her relatively more recent transition into non-profit leadership has also played a role in her humility and genuine openness to learn from others around her, rather than simply coming in to every room thinking that she has all the answers.

While Pastor Trena's executive and organizational leadership skills are clear, what draws people to her, I believe, is first and foremost a genuine heart and concern for her team members and our volunteer leaders and clergy as people and not just employees or volunteers. That means prioritizing (and modeling herself) personal and health needs, and modeling in our treatment of our team internally how we aspire to see everyone in all of our communities treated. Finally, Pastor Trena is incredibly even keeled and consistent. No matter what pressures we may be facing internally or externally, she is always present, patient, and thoughtful in hearing all perspectives before either making her own decision or seeing us through to a shared one.
