James Woodson is currently the Senior Policy and Strategic Projects Manager at California Calls. He manages California Calls' legislative endorsement strategy, as well as policy work around the 2020 census, redistricting, and the Voters Choice Act. James is also on the leadership team of the Black Census and Redistricting Hub, a project of California Calls. James began at California Calls in 2016 as an Organizing Coordinator on the African American Civic Engagement Project, coordinating civic engagement programs and providing support and assistance to the founding cohort. Previously, James served as the Director of Programs for the Boys & Girls Club of Newark, NJ and in a variety of capacities within the Obama For America, Organizing For America, and NJ Health Care for America Now campaigns.
