## **David Becker:**

David Becker, one of the foremost elections experts in the country, has over two decades of experience in the law of voting rights, election administration, and redistricting. In addition to his nationally recognized work at the nonpartisan nonprofit he founded to help serve election officials of both parties, he was as director of the elections program at the Pew Charitable Trusts, and served for seven years as a senior trial attorney in the Voting Section of the Department of Justice's Civil Rights Division. That service included a redistricting cycle, including DOJ preclearance review under the Voting Rights Act of redistricting plans in multiple jurisdictions, and litigation under the Voting Rights Act in federal court. In this role, he led investigations into dozens of potential federal voting rights wiolations in more than a dozen states, and served as lead trial counsel on voting rights matters for the United States in approximately a dozen federal cases.

In addition to this work, Mr. Becker has also served as counsel on various other litigation matters concerning anti-discrimination and civil rights.

<u>His redistricting litigation, including Voting Rights Act cases, includes:</u> *Georgia v. Ashcroft*, 195 F. Supp. 2d 25 (D.D.C. 2002), 539 U.S. 461 (2003), Case No. 02-182. Lead trial counsel for the United States as the defendant in a Voting Rights Act preclearance case for congressional and state legislative redistricting plans, including the adjudication of both an initial state Senate plan and a revised state Senate plan. The case was appealed to the U.S. Supreme Court, and the outcome in the Supreme Court led expressly to congressional amendment of the Voting Rights Act.

*United States v. Upper San Gabriel Valley Municipal Water District*, Case No. 2:00-cv-07903 (C.D. Cal.) (case settled Dec. 10, 2001). Counsel for the United States as plaintiff in a redistricting case under the Voting Rights Act, alleging dilution of the Latino vote with respect to the districts for electing the board of directors of a municipal water district.

*United States v. City of Santa Paula*, Case No. 2:00-cv-03691 (C.D. Cal.) (case settled Oct. 23, 2001). Counsel for the United States as plaintiff in a redistricting case under the Voting Rights Act, alleging that the at-large elections for city council diluted the Latino vote.

# **Conflict Disclosures for Mr. Becker:**

## Compliance with Government Code section 8252

Mr. Becker has no contributions to federal, state, or local candidates to disclose. Mr. Becker has in the past been registered as a state lobbyist in several states, but is not currently registered in any states. He has never been registered as a lobbyist in the State of California. He has done no lobbying in the State of California, although he has testified on one or two bills in the last for years at the request of various state legislative committees. Mr. Becker has no other disclosures under Government Code section 8252.

# Other Conflicts

Mr. Becker is not adverse to the State of California in any pending litigation. He has done no active volunteering, consulting, or paid work for any candidate or officeholder. Mr. Becker has disclosed the relevant legal work on redistricting that he has performed in the State of California, and does not believe that he has performed any work for a potential adverse party or witness that would impair his ability to serve the Commission under the California Rules of Professional Conduct.

# **Fee Arrangements:**

Mr. Becker would be billed at the same rate as Senior Counsel Fredric Woocher and Andrea Sheridan Ordin, which is \$575 per hour. All other fee arrangements from the Litigation Counsel proposal would remain as proposed.
