Under Government Code section 11123, subdivision (a), all meetings

However, pursuant to Executive Orders N-29-20 [17 March 2020] and N-35-20 [21 March 2020], certain provisions of the Bagley-Keene Open Meeting Act are currently suspended due to a State of Emergency in response to the COVID-19 pandemic.

Consistent with the Executive Orders, this meeting of the Commission will be conducted remotely (streamed live). Members of the public who wish to participate in the meeting may do so via livestream on our website at <u>www.WeDrawTheLinesCA.org</u> None of the locations from which the commissioners will participate will be open to the public.
