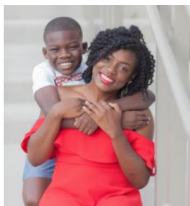

**IMPORTANT NOTES:**

Under Government Code section 11123, subdivision (a), **all meetings of a state body are open and public**, and all persons are permitted to





attend any meeting of a state body, except as otherwise provided in that article. However, pursuant to Executive Orders N-29-20 [17 March 2020] and N-35-20 [21 March 2020], **certain provisions of the Bagley-Keene Open Meeting Act are currently suspended due to a State of Emergency in response to the COVID-19 pandemic.**

**Consistent with the Executive Orders, this meeting of the Commission will be conducted remotely (streamed live).** Members of the public who wish to participate in the meeting may do so via livestream on our website at <https://WeDrawTheLinesCA.org>. **None of the locations from which the commissioners will participate will be open to the public.**
