**RE:** **Draft Letter Advocating for a Fair and Accurate Collection of Census Data**

On Wednesday August 26<sup>th</sup>, the 2020 California Citizens Redistricting Commission (CRC) received a briefing on the current status of the US Census Collection efforts and changes made by the U.S. Census Bureau in the dates and timeline for collection.

It was discussed and agreed upon by the CRC that:

- 1.) Census data is the only data that can be used in the redistricting process and therefore we hold a stake in ensuring the most accurate data be collected;
- 2.) The vast demographic and geographic diversity of the state makes census data collection a difficult process even under the best of circumstances;
- 3.) The COVID-19 pandemic has severely impacted efforts for broad outreach and census data collection;
- 4.) The state of California in the *Legislature v. Padilla* ruling has allowed the CRC an additional four months to complete our task of redistricting to allow greater time for census collection and to accommodate a delay in the release of census data;
- 5.) It is in the interest of the CRC to actively advocate for an accurate census count.

While a number of actions have been considered, including submitting an amicus curiae brief or even joining the litigation brought by the Urban League and others, our initial step would be to form a subcommittee and draft a letter or letters advocating the U.S. Census Bureau honor its April 13<sup>th</sup> memo, which extended the deadline of data collection due to the COVID-19 pandemic.

This document presents a draft letter for consideration to the CRC. **This letter is only a draft and should be edited with the feedback of the full commission as well as with public commentary.**

Draft letter was crafted by the appointed Census Letter Committee, including Commissioners Sara Sadhwani and Pedro Toledo and with the support of Interim Counsel Mariam Johnson.
