Welcome to the July edition of the California Citizen Redistricting Commission newsletter. Ten years ago, in July 2011, the first Commission had already received the 2010 Census data and had already issued its first draft maps. With the unprecedented six-month delay to the 2020 Census data, the present Commission still awaits the new population numbers needed to start its mapping work. Equal population is the first and most important criterion for drawing fair and equitable election districts.

Meanwhile, the Commission has been busy listening to Californians as they provide public input during Communities of Interest (COI) meetings. We have held six COI meetings to date and have approximately thirty more to go. That is thirty more opportunities for you to tell the Commission how you want us to keep your community together during redistricting. For a full list of meetings, [click here](#).

We have added two more key positions to the outreach team. Anne Marx will serve as our Outreach Manager and Ashleigh Howick will serve as Team Lead for Northern California, which includes Zones A-D. 8. Has your community come together to advocate for important services, better schools, roads, or health centers in your neighborhood?

We recently added two members to the CRC team. Anne Marx joins the Commission staff as Outreach Manager following a 12-year career in access to justice, with a focus on improving disability and language access with the California Judicial Council's Court Interpreters Program. She also brings supervisory experience working as a manager in a local business and as a Regional Political Director for a State Assemblywoman. Ashleigh was born and raised in the Bay Area and loves the vibrancy of all the cities and cultures. She also enjoys exploring State and National Parks, watching movies, and trying new foods.
