



## Redistricting Report | February 19, 2021

This week's big news is the resignation of Daniel Claypool from the Executive Director post at California's Citizens Redistricting Commission. The rationale for his decision to step down wasn't entirely clear. He hasn't offered any comments himself and the Commission didn't go beyond thanking him for his service in a [prepared statement](#). The Commission has tapped Deputy Director Alvaro E. Hernandez, a veteran of state service with the Franchise Tax Board, to fill in as the top staffer on an interim basis going forward.

Close watchers of the Commission were intrigued with Claypool's hiring last October, as he led the Commission's staff through the 2011 process. One big question for the current Commission is whether it will follow the inaugural Commission's lead and build upon that work for the 2021 cycle, \*or\* whether this Commission was more interested in charting its own course and start fresh. Claypool's hiring was as good a signal as anything that the Commission was interested in drawing upon those experiences from last cycle. With his departure four months in, the answer is again unclear.

Will Claypool's early exit put the Commission behind?

Readers from [last week's Redistricting Report](#) will remember that the ongoing Census delays are the primary driver of this redistricting timeline. Last Friday, the Census Bureau dropped the bombshell that [September 30 is the new deadline](#) being eyed by the Biden Administration for releasing the redistricting-level data file that the Commission and public agencies around the country will use to redraw their districts, meaning it's unlikely the Commission will produce draft maps before November 2021.

It's really too early to understand what other impacts the pushed-back Census might have on the next set of dominoes – the 2022 primary elections! Other states like [Oregon](#), [Maryland](#), [North Carolina](#), and [Virginia](#) are starting to eye alternate plans,

either to their redistricting process or their election schedule in 2022.

The current CA Commission deadline of [next year's Valentine's Day \(Feb. 14, 2022\)](#) will fall nearly two months after the signature-in-lieu process for candidates begins and five days after the deadline to turn in those signatures. We presume [this set of deadlines](#) is getting a serious look.

Finally, many of our readers know Redistricting Partners was a leading advocate for LGBTQ+ inclusion in the redistricting process in 2011 with partners like Equality California. This cycle the drumbeat is starting much earlier, with an article this week from the [Bay Area Reporter](#) and a podcast [with Out in the Bay](#) featuring commissioners who are already supporting a focus on LGBTQ+ communities of interest.
