The pollution of the Salton Sea affects the health of the inhabitants of the cities near the lagoon, but we also know that particles of poor air quality can run up to 200 miles, that is why the Imperial Valley and all its surroundings are affected, for this reason the request is made. Farmworker families in Imperial County and East Coachella face different challenges than West Coachella families. Most farmworker families do not have health insurance. Therefore, we rely on special clinics and other sources to address work related injuries or basic health care for our families. Many of our Spanish-speaking families have limitations in their English and require additional support to access the language when trying to access education, higher education and health. These are some of the situations that are happening and we ask for the consideration of the issues that are manifested in this petition.



CHIRLA was founded in 1986 to promote the human and civil rights of immigrants and refugees. In addition, we are members of the People's District Redistricting Alliance (PRA), a coalition of 16 community organizations established to promote a greater community voice in local and state redistricting processes here in Orange County.

#### My community is:

My community is made up of Spanish-speaking people, few Anglo-Saxons, and Chicanos. The common language in my community is Spanish. The people in my Santa Ana community are lower class compared to the upper middle class people living in Irvine neighborhoods. The largest employers in my community are bread factories, the Maruchan factory, supplements, and aircraft parts manufacturing. Other jobs my community has is in restaurants and cleaning houses. People in my community live in houses where more than 4 to 5 families live, Section 8, garages that the community turns into living areas where 7-8 people live, apartments, and you also see a lot of vacant land.

Rent is very high, and there is no rent control, the houses they rent are also uninhabitable because they have lead and are a health risk. Farmworkers are being exposed to pesticides and there is no help for them. There is no health safety for immigrants and field workers when they become ill from chemicals to which they are exposed to in the fields, back damage, and work stress. Also, in my community the abuse of the police is very much being seen, they have tried to remove the resources from the immigrant community to give them to the police. Often, police harasses the Latino community and communities in Santa Ana or fail to respond quickly to accidents. There is also abuse of authority in schools, where boys are blamed in order to get them into jail. Here in my community there are also hospital services, but there is also a problem in the kind of insurance you have. In my community we have non-profit organizations like Casa de la Familia, which helps with domestic violence cases and immigration resources. CHIRLA is another organization that helps the immigrant community. We also have city help and local representatives who offer food distribution to communities.

#### My community is located:

My community is east of Harbor Blvd in Santa Ana. The main streets in my community are: 1st, Main, 5th, Civic Center, Harbor, Edinger, Warner, McFadden. The main freeways are 5, 22, 55, and 57. In conclusion:

In conclusion, it is important that my community east of Harbor Blvd in Santa Ana stay together because we care about the following immigration issues, access to jobs, health insurance for all, rent control, job security, and health care, and housing."
