The Voters FIRST Act (Proposition 11, November 2008) calls for the creation of a 14-member Citizens Redistricting Commission (Commission). As prescribed by the Voters FIRST Act and its implementing regulations (Cal. Code Regs., tit. 2, § 60860 et seq.), the first eight commissioners select the final six commissioners no later than August 15, 2020. The only action that may be taken by the first eight commissioners will pertain to the selection of the final six commissioners and to related procedural matters, such as the selection of a chairperson and vice-chairperson to preside over the selection of the final six commissioners. No further action may be taken until the full 14-member Commission is selected and meets at an open, public meeting.

This will be the first meeting of the first eight commissioners for the 2020 Commission. Prior to performing the duties necessary to select the final six commissioners, the first eight commissioners must first be provided training in preparation. (Cal. Code Regs., tit. 2, § 60855.) This meeting will be devoted exclusively to housekeeping matters and orientation, and to providing the commissioners with necessary training. There will be no discussion nor action taken at this meeting related to the selection of the final six commissioners. There will be opportunity for public comments prior to the selection of chair and vice chair (action item) and, at the end of the multi-day meeting, for general comments.

6. Training relating to the process and procedures for selection of the final six commissioners, including discussion and possible action regarding additional information about the remaining applicants.
7. Training on Bagley-Keene Open Meeting Act requirements.

Under Government Code section 11123, subdivision (a), all meetings of a state body are open and public, and all persons are permitted to attend any meeting of a state body, except as otherwise provided in that article. Pursuant to Executive Orders N-29-20 and N-35-20, certain provisions of the Bagley-Keene Open Meeting Act are suspended due to a State of Emergency in response to the COVID-19 pandemic. Consistent with the Executive Orders, this meeting of the first eight commissioners will be conducted remotely (streamed live) and by teleconference only. None of the locations from which first eight commissioners will participate will be open to the public.
