Overview: November 30, 2021

Map Focus: Assembly

Regional Focus: South/East LA County working southward to OC, San Diego.

- Focus: What changes are PRIORITIES, what changes would be nice if possible?
 - **Focus first on VRA districts in LA County**, once confirmed and generally agreed upon these serve as “anchors” and we can start to address other priorities - mappers Jamie/Sivan could work on clean up of non-VRA areas on Wednesday offline and present options to us on Thursday when we come back to this area.
- Time allocations:

 - ~2 hours on OC, San Diego
 - Take public comment at 5:30pm

- West San Gabriel Valley/National Forest, particularly in congressional map (Kennedy, Taylor, Vazquez, Yee, Akutagawa, Sadhwani)
- **NELA** (Vazquez, Toledo, Sadhwani)
- **Lawndale/South LA** (Yee, Vazquez, Sadhwani)
- **Border between LA-OC** (Taylor, Vazquez, Toledo, Sadhwani)
- Simi Valley/Moorpark/San Fernando Valley (Taylor, Akutagawa, Yee)
- Long Beach (Toledo)
- Van Nuys/Sherman Oaks - POSO (Yee)
- Malibu - Council of Governments (Kennedy)
- Split in West Hollywood (Kennedy)
