Under Government Code section 11123, subdivision (a), all meetings of a state body are open and public, and all persons are permitted to attend any meeting of a state body, except as otherwise provided in that article. However, pursuant to Government Code section 11133, certain provisions of the Bagley-Keene Open Meeting Act are currently suspended. None of the locations from which the Commissioners will participate will be open to the public.

The Commissioners will periodically recess after no more than 90 minutes for the comfort of the participants and staff, without reference to agenda items.

Members of the public will be provided appropriate opportunities to comment on any issues before the Commission, but the Chair may, at his or her discretion, apportion available time among those who wish to speak. If public comment is not specifically requested, members of the public should feel free to request an opportunity to comment.
