15	Roll call is complete, Chair.
16	CHAIR SADHWANI: Great. Thanks so much, Alvaro.
17	I'll start by sharing a little bit about the
18	Commission. Every 10 years, after the Federal Government
19	publishes updated Census information, California must
20	redraw the boundaries of its Congressional, State Senate,
21	State Assembly, and State Board of Equalization districts
22	so that the districts correctly reflect the State's
23	population.
24	In 2008, California voters authorized the creation
25	of the Commission when they passed the Voters FIRST Act.



It authorized the Commission to draw the new district
 lines for the State Assembly, State Senate, and State
 Board of Equalization districts.
 In 2010, the Congressional Voters FIRST Act added

7

5 the responsibility of drawing congressional districts to the Commission. The fourteen-member Commission is made 6 7 up of five Republicans, five Democrats, and four not affiliated with either of those two parties. 8 The 9 Commission must draw the district lines in conformity 10 with strict, nonpartisan rules designed to create districts of relatively equal population that will 11 provide fair representation for all Californians. 12 13 When we receive the Census data, the Commission 14 begins drawing maps using six line-drawing criteria as 15 outlined in the California Constitution. One of these is 16 minimizing the division of counties, cities, 17 neighborhoods, and communities of interest to the extent 18 possible.

We can obtain the city and county information from those jurisdictions. But we need the neighborhood and community of interest information from Californians directly. That's why we have launched these communities of interest input sessions, to get that valuable information from you directly. We encourage all Californians to participate in this process.



1	If you would rather submit community of interest
2	input over the internet, you can do so from our website
3	or by visiting drawmycacommunity.org. Skip the line, go
4	online.
5	Now I will call on all Commissioners to introduce
6	themselves and to say hello. To see the biographies for

10	Please also follow the California Citizens

15	useful information about redistricting and updates from
16	the California Commission.
17	We'll begin with my co-Chair, Commissioner
18	Akutagawa.
19	COMMISSIONER AKUTAGAWA: All right. Thank you.
20	Welcome, California. We're glad that you're joining us.
21	We're looking forward to hearing more communities of
22	interest input from all of you, and particularly for
23	those of you from Orange County, my current hometown,
24	really definitely looking forward to hearing what you all
25	have to say about the county. So thank you, and we look



1	forward to hearing from you again.
2	CHAIR SADHWANI: Great, thank you.
3	And Commissioner Ahmad.
4	COMMISSIONER AHMAD: Good morning, everyone. I'm
5	very excited to hear about your communities down in
6	Orange County, and I look forward to a great meeting.
7	CHAIR SADHWANI: Thank you.
8	Commissioner Andersen. I think she is not here,
9	actually, today.
10	Commissioner Fernandez.
11	COMMISSIONER FERNANDEZ: (Introduction in Spanish
12	language.)
13	Good morning, California. I'm Alicia Fernandez from
14	Yolo County, and I'm very excited to hear about all of
15	your communities, especially those from Orange County.
16	CHAIR SADHWANI: Great, thank you.
17	Commissioner Kennedy.
18	COMMISSIONER KENNEDY: Good morning, California.
19	I'm Ray Kennedy, joining the meeting from my home in
20	Morongo Valley. We are one of the rural Joshua Tree
21	Gateway communities in southern San Bernadino County.
22	I'm happy to be here, and I look forward to hearing about
23	your community and what makes it special to you. Thank
24	you.
25	CHAIR SADHWANI: Thank you so much.



1 Commissioner Le Mons. I don't know if he is here 2 today. I think not. Okay. Commissioner Toledo. 3 COMMISSIONER TOLEDO: (Introduction in Spanish 4 5 language.) Good morning, California. I'm Pedro Toledo. 6 I'm 7 currently living in Petaluma, California, in Sonoma County, which is wine country. I'm looking forward to 8 9 hearing all of your community of interest testimony and 10 information, and learning all about your communities, and 11 sharing this lovely morning with you. Thank you. 12 CHAIR SADHWANI: Thank you. 13 Commissioner Sinay. 14 COMMISSIONER SINAY: Thank you, Chair. 15 (Introduction in Spanish language.) 16 Hi, hello from one of -- it's fun to say hello to 17 one of the four counties that I consider having been a 18 home here in California. It's an honor to serve you from 19 San Diego. I'm Patricia Sinay. 20 CHAIR SADHWANI: Thank you. 21 Commissioner Turner. Oh, Commissioner Turner is not 22 with us this morning. My apologies. 2.3 Commissioner Vazquez. Is she joining us today? We 24 have a lot of people that are either joining late or are 25 unable to be with us.

2	COMMISSIONER YEE: Good morning, California. Good
3	morning, Orange County. I'm Russell Yee, here in my
4	hometown of Oakland. And one ting Oakland lacks is a 99
5	Ranch Market, and it says that Orange County is the
6	birthplace of the 99 Ranch Market. Anyone connected to
7	that, please, please come to Oakland. I will shop there
8	all the time if you do. I'm looking forward to hearing
9	about your communities today. Thank you.
10	CHAIR SADHWANI: Perfect, thank you.
11	And myself, Sara Sadhwani. I'm calling in today
12	from my home in La Canada, right in the foothills of the
13	Angeles National Forest. And over the years I've spent a
14	lot of time in various parts of Orange County. So
15	looking forward to hearing more about your communities of
16	interest.
17	A few housekeeping rules. This meeting is primarily
18	for communities of interest testimony focused on Orange
19	County and surrounding areas. However, anyone in
20	California can call in to provide input. General public
21	comment will take place at the end of the meeting.
22	Although the Commission has divided up California
23	into 11 zones, that in no way is related to or reflective
24	of redistricting lines or boundaries. The Commission
25	created the zones to assist Commissioners and staff in



1	their outreach efforts only, not as an indication of any
2	planned boundaries.
3	Today we're joined by our Line Drawing Team, Haystaq
4	DNA, and Q2 Data & Research, LLC, who will be displaying
5	a map of the area that attendees describe.
6	Please start with the area you would like to
7	discuss, and be as specific as possible about the
8	boundaries of where your community is located. It's our
9	goal is to find the area on the map you would like to
10	discuss prior to your testimony. If you are within a
11	specific neighborhood of a large city, please mention it
12	by name. Once we are able to locate your area, your
13	three-minute timer will begin. Attendees will not be
14	able to share their screen.
15	We are also joined by Katy, our comment moderator,
16	who will be introducing attendees when it is their turn
17	to speak.
18	When you join the meeting, please use the Raise Hand
19	button at the bottom of your screen to enter the queue.
20	If you have registered for a timeslot, we encourage you
21	to call in during your appointment timeslot. When it's

16	CHAIR SADHWANI: Good morning.
17	COMMENT MODERATOR: Welcome to the public input
18	session. Please use the Raise your Hand button at the
19	bottom of your screen to enter the queue. When it is
20	your turn to speak, you will be identified by your
21	assigned unique ID number, which you were emailed
22	yesterday. You will be reconnected to the session with
23	the ability to enable your own video and/or audio. You

SPARKS: Okay. Can you hear me? 24 COMMENT MODERATOR: Yes, we can. 25 MS. SPARKS: Okay. Yeah, I think what you have up



1 there, Orange County, is perfect.


2	MR. MANOFF: Thank you. Go ahead please.
3	MS. SPARKS: Okay. So I'm Lisa Sparks. I'm the
4	founding Dean of the School of Communication at Chapman
5	University, which is in the heart of Orange County. And
6	I've lived in Irvine and Newport Beach for the past
7	fifteen years. I have a Ph.D. in communication with a
8	focus on healthcare communication and aging, with
9	particular foci on health disparities for underserved
10	populations. I'm here to talk about Orange County
11	healthcare.
12	For healthcare purposes, I'm going to divide the
13	county into two groups. First, those who typically have
14	employer-provided healthcare and have sufficient
15	resources to take care of their families. These folks
16	are those who care very deeply about their plans, but are
17	not reliant on the public healthcare system, other than
18	Medicare supplements. These citizens typically have
19	solid SES, socioeconomic status or incomes.
20	In Orange County they tend to live on the coast in
21	cities like Seal Beach, Huntington Beach, Newport, and
22	Laguna; or in places such as Yorba Linda, Anaheim Hills,
23	Lake Forest, Rancho Santa Margarita, and Mission Viejo,
24	in or near the foothills.
25	Residents of cities like Santa Ana, the flatlands



portion of Anaheim, south and western Fullerton, Buena
Park, and La Habra have very different needs. A higher
percentage of residents in these regions rely on Medicaid
and public healthcare. They often have inferior
preventative health programs, and this is critical and
obvious in terms of communication, as many are immigrants
whose families primarily speak Spanish.

8 For instance, sadly, Santa Ana and Anaheim accounted 9 for thirty-six percent of Orange County COVID cases, yet 10 had only twenty percent of the population. Many of these 11 people were essential workers. Others just had poor care 12 or were outside of our communication efforts for too 13 long.

14 Healthcare is perhaps the most critical human need, and if our representatives can't effectively communicate 15 16 with their constituents, then we can't address their 17 needs adequately, and disaster often strikes. COVID is only the latest example that we've all been dealing with, 18 19 of course. It's no secret that people with higher 20 incomes have greater access to care, and in Orange County 21 that means folks living near the coast or near the 22 foothills. 2.3 There, of course, are exceptions to that like Brea, 24 Placentia, and parts of Fullerton. And certainly Irvine





1	campus than residents in the foothill areas.
2	But for healthcare reasons I suggest you look at
3	Orange County as a giant, sort of V-shape. And what I
4	mean by that is, those living along the I-5 corridor,
5	north of Irvine, need representatives who focus on public
6	health access and care, while those on the coast and
7	foothills need representatives who are focused on
8	ensuring private
9	MR. MANOFF: Thirty seconds.
10	MS. SPARKS: work for their constituents.
11	And that is all I have. Thank you for your time.
12	CHAIR SADHWANI: Thank you so much.
13	COMMENT MODERATOR: Thank you.
14	And now we have $0-0-4$, and up next will be $0-0-1$.
15	0-0-4, I will be promoting you now. 0-0-4, your
16	speaker order number is number 2. If you'll please make
17	note of that for future reference. And if you'll please
18	remind the mapper what area you would like to discuss
19	today, the floor is yours.
20	MR. BRANDON: Thank you, and good morning. And
21	thank you to all the Commissioners for your service to
22	this important function that you're undertaking.
23	The map that is currently pictured is appropriate
24	for my comments. So I'll introduce myself. I'm Patrick
25	Brandon (ph.). I'm a former Huntington Beach City



1	Councilman, currently serving as the CEO for an
2	environmental organization that's dedicated to the
3	protection and restoration of coastal wetlands in Orange
4	County.
5	I believe that the 48th Congressional District
6	should include every coastal community from San Clemente
7	to Seal Beach. It makes no sense to exclude San
8	Clemente, San Juan Capistrano, and Dana Point from the
9	48th District.
10	Our coastal communities need to be unified so that
11	our congressional representative is able to focus on the
12	unique issues affecting coastal Orange County, such as
13	beach erosion, flood control, tourism, and coastal
14	property protection related to sea level rise. Our
15	Orange County coastal communities are dependent on
16	tourism, more so than many of our inland neighbors of the
17	current 48th Congressional District.
18	Unifying the coastal cities into a single district
19	will not only benefit the constituents of the 48th, but
20	it will equally benefit our inland neighbors, because
21	their representative will be able to focus on the unique
22	issues that they face, free from the distraction and
23	time-consuming burden of dealing with the dynamic,
24	everchanging, and urgent issues we face along the coast.
25	There is a long history of forming districts that

1	reflect common interests of the constituents within those
2	districts. And I believe there is no place where such
3	precedent is more important than along the coast of
4	Orange County.
5	For the benefit of the residents of coastal Orange
6	County and our inland neighbors, I urge you to redraw the
7	48th Congressional District to include all Orange County
8	coastal cities from Seal Beach to San Clemente.
9	Thank you for your time.
10	CHAIR SADHWANI: Thank you so much.
11	COMMENT MODERATOR: Thank you.
12	Right now we have $0-0-1$, and up next will be $0-0-2$.
13	0-0-1, I will be promoting you now. 0-0-1, your
14	speaker order number is number 3. If you'll please make
15	note of that for future reference. You can now enable
16	your audio and video, If you'll please remind the mapper
17	of what area you would like to discuss today, the floor
18	is yours.
19	MR. RAMNAY: Thank you very much. This is Art
20	Ramnay (ph.). I need Rossmoor, which is in the far
21	western part of the county. There we go, Rossmoor, Seal
22	Beach, Los Alamitos, that's the area that I'll be
23	addressing today.
24	Rossmoor, as you see there in the pink, is an
25	unincorporated area of Orange County. So that means that



1	we have no local government. Our government is really
2	the supervisorial districts. So we present a little bit
3	of a unique situation.
4	The Los Alamitos School District, which includes Los
5	Alamitos and Seal Beach, is our geographical
6	neighborhood, if you will. The school district has six
7	elementary schools, four of which are in Rossmoor. So
8	most all of the city's schools or most all of the
9	students in the three areas go to schools that are within
10	Rossmoor.
11	So geographically and representation wise we
12	function very much as one community. Our Congressional
13	District is actually mostly in Long Beach, so that's a
14	challenge for us in CD-47. We would be much better
15	represented, I guess, if we were part of the same
16	district as Seal Beach as well as Los Alamitos. The same
17	goes for both the State Representative, State Senator,
18	State Assembly Districts. If we could have the same
19	representative for all three areas, it would enhance the
20	value of the representation for our area.
21	And that's all I have for you today. Thank you very
22	much for your time. And good luck with the rest of your
23	input.
24	CHAIR SADHWANI: Thank you so much.
25	COMMENT MODERATOR: Thank you.



1	Right now we have $0-0-2$, and up next will be $0-1-0$.
2	0-0-2, I will be promoting you now. 0-0-2, your
3	speaker order number is number 4. If you'll please make
4	note of that for future reference. You can now enable
5	your audio and video in the lower left corner of your
6	screen. If you will please remind the mapper of what
7	area you would like to discuss today, the floor is yours.
8	MS. MICHELLE: Good morning. My name is Michelle,
9	and I'm calling from Irvine, California. You see Irvine
10	there in the central area. I have lived here in Irvine
11	for thirty-one years, in the same home, just off the 405
12	Freeway near Culver Boulevard. I raised my children
13	here, and I've been a member of Mariners Church, which is
14	on the Irvine/Newport border, extending closer there to
15	the coast and Laguna Beach. I'd like to talk about the
16	regional level and then the more local.
17	Irvine is literally in the center of the area known
18	as central Orange County. It's really the basis of where
19	we, you know, live most of our lives, right in the
20	center, and we have ties to the communities around the
21	region.
22	Even though Irvine doesn't touch the coast, we have
23	strong connections to our coastal communities like Laguna
24	and Newport. For example, Crystal Cove State Park is
25	sandwiched right between Laguna Beach, Newport, and



1 Irvine. It's a wonderful natural resource, enjoyed by 2 all three cities. I hike there all the time, and usually 3 I'm there early on a Saturday to make sure I get a 4 parking space. I'm happy to be here with you guys today. 5 On the other side of central Orange County to the northeast, I'm next to communities like Tustin and 6 7 Orange. They've become aligned with Irvine with shopping 8 and recreation areas and workplaces. When I moved here, 9 the Marine Air Station was dominant, based in Tustin 10 there. Now, those military hangars remain, but the air 11 station is gone and been replaced with a major shopping 12 district, my nearby Whole Foods, and lots of new housing. 13 On the other side of central Orange County, a few 14 minutes from where I live, you know, going now a little 15 bit more to the coast, where I live is UC Irvine. And 16 it's been a big part of our communities. It's exploded 17 in growth; just the last ten years enrollment has jumped, 18 you know, nearly 9,000 students. And so you can imagine, 19 the university is a big part of our local community, both 20 at the beach and around the campus. 21 So the communities of Laguna, Irvine, and Newport 22 have a lot in common. But these commonalities identify 23 as our central region. They do not -- those 24 commonalities don't stretch north along the coast, and 25 they don't stretch south. Irvine's core issues are not

2	Now, I want to shift to a little bit more local
3	level. You may know that Irvine is a master planned
4	community. It was designed that way with housing
5	villages to be distinct and also connected. We often
6	associate with these villages as much as we do our
7	cities.
8	MR. MANOFF: Thirty seconds.
9	MS. MICHELLE: I live in Woodbridge; nearby are
10	Westpark, Turtle Rock, University Park. Our schools are
11	named after these villages. And you know, these villages
12	really are
13	MR. MANOFF: Fifteen seconds.
14	MS. MICHELLE: our normal boundaries. So I urge
15	you to keep central Orange County communities together
16	for our commonalities. Thank you.
17	CHAIR SADHWANI: Thank you.
18	COMMENT MODERATOR: Thank you so much.
19	Right now we have $0-1-0$, and then up next we will
20	have 0-0-8. I would like to invite those who have joined
21	us to please use the Raise your Hand button at the bottom
22	of your screen, indicating you wish to comment.
23	Right now, we will go to $0-1-0$, I will be promoting
24	you now. $0-1-0$, your speaker order number is number 5.
25	If you'll please make note of that for future reference.



1	And if you will please let the mapper know what area you
2	would like to discuss today, the floor is yours.
3	MS. AZIZ: Hi, good morning. Thank you,
4	Commissioners. My name is Peter Aziz (ph.). I am here
5	advocating on behalf of the Arab American community,
6	specifically looking at the northwest Anaheim area and up
7	until, I would say, Chapman, just north of Chapman, down
8	Brookhurst; between the 5 and the 39.
9	This particular area is an undesignated business
10	corridor known as the Little Arabia District.
11	Unfortunately, due to the Census, our community does not
12	have accurate representation on who our population is.
13	We are not just a population of Arab Americans, but we
14	are adjacent to the Hispanic and Little Saigon area as
15	well. This particular area in Brookhurst is a business
16	corridor that we would like to continue to keep within
17	one district.
18	The 46th, I believe, District of the Congressional
19	Member, Lou Correa, in my opinion accurately demonstrates
20	the appropriate districting for this particular region.
21	However, the State Senate 29 and Assembly District 65, I
22	believe, unfortunately does not encompass this particular
23	area and corridor for the Arab American community
24	specific to our district.
25	Now many of the participants have mentioned a lot of



1 the issues concerning their communities that properly 2 reflect their community. Ours equally does not accurately represent our community, in the sense that a 3 4 lot of our nonprofits are having to pick up the tab 5 particular to the services demonstrated by this 6 community. 7 Again, we have a lot of places of worship that are overlapping, and a lot of nonprofits that work within 8 9 this particular region that provide a service for our 10 immigrant and migrant population. Unfortunately, as I 11 mention again, the Census does not provide an accurate 12 depiction on the Arab American community. So we do not 13 have appropriate data and numbers that reflect the amount 14 of population that either reside in this particular 15 community, nor travel to this community. 16 It is a central hub for many Arab Americans and 17 Middle Eastern diaspora; however, it is only reflective 18 of a business corridor that we would like to continue to 19 highlight, and I amplify, in the future become 20 opportunities for future districting. 21 So please consider this when mapping. This is an 22 important region. Politically, there is a lot of civic 23 engagement that is being done. And this is a community 24 that works adjacent to other communities like Little 25 Saigon and the Hispanic American community.

5	you would like to see kept together?

19	MR. AZIZ: And the corridor, it's right next to the
20	Disneyland Convention Center in Anaheim, I would say
21	right before Adventure City, off of Ball, which is where
22	it expands to; following down Brookhurst just before
23	Chapman Avenue, right before Garden Grove. And to the
24	further east, if you follow down West Ball Road, just
25	before the 5 and near Katella parallel.



1	This specific area is adjacent to the Anaheim Resort
2	Area. There is a number of businesses in this area that
3	are not just Arab American, as well as Little Saigon, as
4	well as Hispanic adjacent communities. There has been
5	specific studies by UC San Diego Center of Immigrant
6	Studies that we have been working with in the past year
7	to produce an appropriate survey and population data and
8	projections reflective of this community.
9	CHAIR SADHWANI: Thank you so much. I think we've
10	got it.
11	MR. AZIZ: Thank you.
12	CHAIR SADHWANI: Have a great day.
13	COMMENT MODERATOR: Right now we will have 0-0-8,
14	and then up next we will have 0-0-6.



1	MR. MANOFF: Thank you. Go ahead please.
2	MR. KRISS: Okay. Well, thank you. Thank you for
3	inviting me to join the meeting. My name is John Kriss.
4	I've been a resident of Seal Beach, California, since
5	1977. I live in the community of Surfside. And I'm the
6	Director of the Surfside Storm Water Protection Tax
7	District, one of twenty-seven tax districts in Orange
8	County. I am the President of that District at this
9	time.
10	I'm here to talk to you about a commonly shared
11	asset and major concern, the beach, which for the beach
12	communities is a treasure.
13	The Orange County beaches, we have a problem. And
14	it's a unique problem, and I don't say that just as a
15	matter of opinion; it's a study fact. Erosion has been a
16	major concern since the 1930s and 1940s. In 1960, the
17	concern was so big that the U.S. Congress directed the
18	U.S. Corps of Army Engineers to research the problem, see
19	if they could find the causes, and provide a solution, if
20	possible.
21	In 1962 U.S. Army Corps of Engineers came up with a
22	study, in which they said that the problem at the Orange
23	County beaches is totally unique, and it's unique because
24	the problem is caused one hundred percent by government
25	actions that have been taken in the past. The damming of

14 make up for the natural loss of 350,000 cubic yards	of
15 sand. In any event, they directed the Corps to do t	hat
16 every five years periodically indefinitely	
17 MR. MANOFF: Thirty seconds.	
18 MR. KRISS: because the problem would be here	
19 continuous and had to be continued indefinitely.	
20 We have been fighting this fight for twenty-fiv	е
21 years, since 1995, because the Army Corps of Enginee	rs
22 stepped away from the project

24 MR. KRISS: since it was no longer funded.	And
25 at that point, the project has pretty much ceased.	We



1	have had one or two projects performed.
2	What we need is a unified approach to this, a
3	unified message, a unified presentation. The Orange
4	County, City, beach cities
5	MR. MANOFF: Time.
6	COMMENT MODERATOR: Thank you so much. Right now,
7	we have 0-0-6, and up next we will have 0-0-7. I'd like
8	to invite 0-1-1 to use your Raise your Hand button at the

25	Orange County. I would like to see that kept together as

1 much as possible. We have a lot of shared concerns, 2 especially going on right now, as you heard it with an earlier caller, with beach erosion, bike paths, water 3 4 quality. We share a lot of the same concerns and values, 5 and we want to know if we can keep that together as much 6 as possible. 7 I'm a volunteer in Seal Beach, involved with different communities. I'm not going to say their names 8 9 because I'm not here speaking on behalf of any of them. 10 But as a volunteer, as long as you're involved in the 11 community, I know there is a lot of aspects, especially 12 in the north end of Orange County. 13 We want to keep those beaches together, because we have a lot of common issues and a lot of common concerns 14 15 from the beach erosions. And these beach erosions don't 16 just erode and stay in Seal Beach. It erodes the sand away in Seal Beach that goes down through Sunset, 17 18 Huntington, and Newport, even other parts of Orange 19 County. 20 So I want to know if we can keep those beaches 21 together in one Congressional Orange County District, if 22 possible. 2.3 CHAIR SADHWANI: All right. Thank you so much. 24 COMMENT MODERATOR: Right now we have 0-0-7, and 25 then up next will be 0-0-3.



MR. HO: Hi, can you hear me?
COMMENT MODERATOR: We sure can.
MR. HO: Yes, hi. My name is David Ho (ph.). I
have lived in Seal Beach for over ten years. More
specifically, I live a few hundred feet away from the
beach, in Old Towne Seal Beach.
First, let me tell you what I have learned about
Seal Beach during its Centennial celebration in 2015.
While Seal Beach is currently known affectionately as
Mayberry by the Sea, that was not always the case, when
Seal Beach was known as Joy Zone and Sin City due to its
gambling hall, prostitution brothel, and rum-running.
Fast forward to the present, Seal Beach serves a
community of interest from a few perspectives with Los
Alamitos, the unincorporated area of Rossmoor, and the
other communities along coastal Orange County all the way
to San Clemente. Some of these perspectives include
national security, education, and the environment.



1	As to national security, Seal Beach is home to the
2	Seal Beach Naval Weapons Station. Its neighbor to the
3	north, Los Alamitos, is home to the Joint Forces Training
4	Base.
5	As to public education, children in Seal Beach
6	attend schools in the Los Alamitos Unified School
7	District from K through 12, along with students in
8	Rossmoor and Los Alamitos.
9	As to the environment, coastal Orange County
10	including Seal Beach, face issues not faced by more-
11	inland communities. We need to be able to address the
12	issues faced by the coastal communities with one voice.
13	Some of these issues include flooding, beach erosion.
14	For example, in Seal Beach every November, Seal
15	Beach builds its berm of about a half a mile long, nine
16	feet high, to prevent flooding and more soil erosion.
17	Each April, they take it down. But sometimes the city
18	still gets flooded. You can ask the local residents who
19	live there or have businesses there.
20	And also, Seal Beach is also home to the Seal Beach
21	National Wildlife Refuge, which is within the Naval
22	Weapons Station. I have visited that on a tour, and I
23	have also visited the Bolsa Chica Ecological Reserve, and
24	I've seen the importance of preserving the wildlife at
25	the wildlife preserves.

1	That's all I have. Thank you.
2	CHAIR SADHWANI: Thank you so much.
3	COMMENT MODERATOR: Right now we have 0-0-3, and
4	then up next will be 0-1-1.
5	Right now, 0-0-3, I will be promoting you now. 0-0-
6	3, your speaker order number is number 9. If you'll
7	please make note of that for future reference. And if
8	you will please let the mapper know what area you would
9	like to discuss today, the floor is yours.
10	MR. MALEKI: Hello?
11	COMMENT MODERATOR: Hello. Go ahead.
12	MR. MALEKI: Hi. My name is Daryn Maleki (ph.).
13	I'm here to speak on behalf of small businesses in the
14	northwest Orange. The cities in that region include La
15	Habra, Buena Park, Cypress, Stanton, south and west
16	Fullerton, plus Anaheim, and La Palma.
17	With the exception of Anaheim and Stanton, all these
18	cities touch the L.A. County border, but they are very
19	different from L.A. cities.
20	L.A. County residents look to their county
21	government for healthcare, transportation, public safety,
22	and other means. The two counties deal with small
23	businesses and restaurant regulations very differently,
24	and we've seen that over the past year during this
25	pandemic. Naturally, Orange cities look to our county



1 government in Santa Ana and not downtown L.A.

2	The Orange County economy is also different from
3	L.A. County. The hospitality, tourism, food service are
4	all important in northwest Orange County. Because of the
5	Disney Resort, various entertainment businesses in Buena
6	Park like Knott's Berry Farm, Medieval Times Dinner &
7	Tournament, the Teatro Martini Comedy Show, the Pirates
8	Dinner Adventure Theater, employ thousands in this
9	district. Beach Boulevard connects the Buena Park
10	Entertainment District with the Disney Resort.
11	We are a community proud of immigrants, second-
12	generation immigrants, and as a matter of fact, thirty-
13	four percent of La Palma, thirty-seven percent of
14	Anaheim, thirty-seven percent of Buena Park, forty-four
15	percent of Stanton, twenty-seven percent of Cypress,
16	thirty percent of Fullerton, and twenty-nine percent of
17	La Habra residents are all foreign born. That sets us
18	apart from the OC coast and the foothills, as most of
19	their communities don't share that kind of history.
20	Most important, please don't take a small part of
21	Orange County and attach it to Los Angeles County like
22	the last Commission did, with part of Buena Park in the
23	State Senate. Those residents and small business owners
24	will not receive the same level of attention. And as a
25	small business owner I believe fully that keeping Orange

2	not attach it to L.A. Thank you.
3	CHAIR SADHWANI: Thank you.
4	COMMENT MODERATOR: Thank you so much.

13	MS. TRISTOVAR: Good morning. If I may please have
14	the map of the city of Irvine on the screen?
15	My name is Elisia Tristovar (ph.). I'm an over-
16	twenty-year resident of Irvine. I'm also as, I guess, a
17	contractor, working in the area; I'm a realtor. And on
18	an everyday basis I deal with local residents and see the
19	issues that are coming up.
20	What I would like to speak today to is to please
21	keep the integrity of the district and this community.
22	Even though Irvine grew over two times over the last
23	twenty years, and we are considered to be a very, very
24	diverse community, I just would like to stress that we
25	are one unique community. And there are many



1 conversations about owners, residents, and tenants in the 2 area.

3 Irvine can be considered as really just one unique
4 place where everything is integrated together. We have a
5 unique, diverse demographic landscape, and the overall
6 setup of the city with the residential, commercial, and
7 open spaces balance is really something that the whole
8 country is looking up to.

9 It would be very, very important to keep our 10 integrity together. Because what is happening in the 11 south is also an issue for the north of Irvine residents. 12 We have seen some local issues about rezoning, about 13 putting some properties in the open spaces coming up in 14 the past few years, and I cannot stress enough how 15 important it was that the whole community of the whole 16 city of Irvine came together to this.

And this will conclude my request to the Commission.Thank you very much.

5 0-1-2, I will be promoting you now. 0-1-2, your speaker order number is number 11. If you'll please make 6 7 note of that for future reference. You can now enable 8 your audio and video in the lower left corner of your 9 screen. If you will please remind the mapper of what area you would like to discuss today, the floor is yours. 10 11 MR. KUO: Good morning, Commissioners. If I could 12 ask the mapper to show us Irvine again. My name is 13 Anthony Kuo. I'm an elected member of the Irvine City 14 Council. And I also serve on the Board of Directors of 15 the Orange County Fire Authority, which is a joint powers 16 agency, representing a significant amount of Orange 17 County with regard to fire protection.

18 In the fall, the Silverado Fire roared through our 19 community, burning over 13,000 acres, threatening over 20 69,000 structures, and forcing the evacuation of 70,000 of my city's residents; it was about a third of the city, 21 22 as well as nearly 10,000 more residents from Lake Forest 23 and other neighborhood. Over 12,000 personnel were 24 assigned and fought the fire. The 241 Toll Road was shut 25 down. Residents were out of their homes for many days,



1 and the air quality was awful.

2	The 241 Toll Road was shut down because of the fire,
3	and the evacuated were out of their homes for days. And
4	the lucky ones breathed smoke for several days.
5	Wildfires are a deadly problem in Orange County cities
6	like Irvine, Lake Forrest, Rancho Santa Margarita, and
7	Anaheim Hills that back up to the Cleveland National
8	Forest.
9	It's imperative that our state legislative
10	representatives focus on this critical issue. Without
11	better preventative measures, good planning, and strong
12	firefighting capacities this will happen again and again.
13	In fact, the 2007 Santiago Fire burned over 28,000 acres
14	in some of the same areas. Climate change makes this
15	situation even more precarious.
16	Having a representative focus on this issue would
17	help Irvine, Lake Forest, Anaheim Hills, Rancho Santa
18	Margarita, and other Orange County cities address
19	firefighting concerns, forest management, evacuation
20	routes, and other aspects of dealing with this kind of
21	emergency.
22	And I'll be working to submit to your staff a map of
23	the fire stations in Irvine, which will have a radius of
24	about a five-minute response time, that helps show the
25	areas that each of our fire stations cover. Thank you.

1	CHAIR SADHWANI: Thank you.
2	COMMENT MODERATOR: Thank you so much.
3	Right now we have caller $8-3-9-2$, and up next will
4	be caller 5-5-2-1.
5	Caller 8-3-9-2, if you will please follow the
6	prompts to unmute. Caller with the last four digits 8-3-
7	9-2, if you'll please press star 6 on your telephone
8	keypad to unmute. Caller 8-3-9-2, you are unmuted. I
9	have a couple of brief instructions for you. Your
10	speaker order number will be number 12. If you'll please
11	make note of that for future reference. And if you will
12	please let the mapper know what area you would like to
13	discuss today, the floor is yours.
14	MS. CHRISTY: Fountain Valley, Westminster, and
15	Huntington Beach.
16	MR. MANOFF: Thank you. Go ahead please.
17	MS. CHRISTY: Hello?
18	MR. MANOFF: Yes, go ahead please. We can hear you.
19	MS. CHRISTY: Hi, my name is Christy (ph.) So the
20	2010 redistricting process (indiscernible) the Vietnamese
21	residents by splitting Westminster into two separate
22	congressional districts. This dilutes our voice at the
23	federal level.
24	Today, I am urging the Commission to keep
25	Westminster intact in one assembly, State, Senate and



1 Congressional Districts.

2	COMMENT MODERATOR: I believe, our caller is done
3	hung up? Okay? I apologize. Thank you so much. I
4	believe they're gone.
5	Caller 5-5-2-1, you'll be next. And then caller 6-
6	6-5-9, you will be up next in the queue.
7	Caller 5-5-2-1, if you will please follow the
8	prompts to unmute at this time. Caller 5-5-2-1, you are
9	unmuted. I have a couple of brief instructions for you.
10	Your speaker order number will be 13. If you'll please
11	make note of that for future reference. And if you will
12	please let the mapper know what area you would like to
13	discuss today, the floor is yours.
14	Hello? Can you hear me? Caller 5-5-2-1, can you
15	hear me? It sounds like there may be some reception
16	issues. Caller 5-5-2-1, can you hear me?
17	MS. MILEY: Hello? Can you hear me?
18	COMMENT MODERATOR: Yes, we can. Hello.
19	MS. MILEY: Hi. I want to talk about Fountain
20	Valley, Huntington Beach, and Westminster.
21	COMMENT MODERATOR: Perfect. Your speaker order
22	number is 13, if you can make note of that. And go
23	ahead, the floor is yours.
24	MS. MILEY: Yes. All right. Speaker number 13. My
25	name is Miley (ph.).

1	West Little Saigon is a natural economy whose cities
2	are all relying on each other for commerce and
3	prosperity. This makes Fountain Valley, Midway City,
4	Westminster, Huntington Beach crucial communities of
5	interest for each other.
6	Today, Garden Grove, Santa Ana, Midway City,
7	Fountain Valley, and Westminster are all split up between
8	three different congressional districts, CA-46, CA-47,
9	and CA-48. The fact that these places are divided
10	amongst three different congressional districts makes
11	little sense, considering how connected each of their
12	economies are to each other.
13	Westminster, Midway City, and Fountain Valley should
14	be grouped with Huntington Beach into one single
15	district. It is vital that the business community's
16	voice isn't spread too thin. The small businesses that
17	support the region deserve to have their voting power
18	consolidated and unified, not divided.
19	CHAIR SADHWANI: Thank you.
20	COMMENT MODERATOR: Thank you so much.
21	Right now we have caller 6-6-5-9, and then up next
22	we will have 0-1-5.
23	Caller 6-6-5-9, if you'll please follow the prompts
24	to unmute. Caller 6-6-5-9, you are unmuted. I have a
25	couple of brief instructions for you. Your speaker order

1	number will be 14. If you will please make note of that
2	for future reference. And if you will please let the
3	mapper know what area you would like to discuss, the
4	floor is yours.
5	MR. CHAN: Okay, thank you. Hi. So my name is
6	Henry Chan (ph.), and I'd like to discuss Westminster,
7	Fountain Valley, and Huntington Beach.
8	MR. MANOFF: Thank you, go ahead.
9	MR. CHAN: Okay. Under the current district lines
10	the Vietnamese population is divided into three
11	congressional districts. This division disempowers our
12	closeknit community and our leaders from defending our
13	many unique interests such as cultural, political,
14	economic, and religious.
15	The Redistricting Commission should consolidate the
16	Vietnamese population from three congressional districts
17	into two. In doing so, they will ensure that the
18	Vietnamese population will have their interests properly
19	represented in the Federal Government.
20	So for example, the city of Westminster, which has
21	the highest percentage of Vietnamese Americans, is
22	divided into two congressional districts. We urge the
23	Commission to keep all of Westminster in one
24	congressional district.
25	Thank you.

1	COMMENT MODERATOR: Thank you so much.
2	Right now we will have $0-1-5$. And I invite those in
3	the queue that have called in and have not given comment
4	today, to please press star 9 on their telephone keypad.
5	And I also invite 0-2-0, if you would like to give
6	comment during this session, to please use the Raise your
7	Hand button at the bottom of your screen.
8	And 0-1-5, I will be promoting you now. 0-1-5, your
9	speaker order number is number is 15. If you'll please
10	make note of that for future reference. You can now
11	enable your audio and video in the lower left corner of
12	your screen. If you will please remind the mapper of
13	what area you would like to discuss today, the floor is
14	yours.
15	MR. PEQUENO: Yes, I'd like to speak about Lake
16	Forest. Hello, I'm Robert Pequeno, and I serve on the
17	Lake Forest City Council.
18	Lake Forest is a city of about 85,000 residents on
19	the southside of Orange County. While the Commission
20	might be tempted to lump all of south Orange County
21	together, reality is, our community is very different
22	from a place like Laguna Beach or Newport Beach. Our
23	major transportation corridors run north/south; either
24	the 241 Toll Road or Interstate 5.
25	We look first to the mountains for recreation as



1	they are in our backyards, and then to the beach. We
2	share our concerns about wildfires with the communities
3	to the north of us, like Irvine, Anaheim Hills, and to
4	the south, like Rancho Santa Margarita. And we breathe
5	the same bad air and get stuck in the same roads when the
6	fires get out of control. We certainly share an intense
7	interest in policies that will better prevent future
8	fires.
9	In terms of community colleges, we look at
10	Saddleback and Mission Bay or UC Irvine rather than
11	Orange Coast College in Costa Mesa, which is a wonderful
12	school, but not as close to home.
13	Like Irvine, Tustin, and the City of Orange, we
14	enjoy a diverse population. Incomes in the community
15	that back up to the Cleveland National Forest tend to be
16	above average. Goggling some Census data, I see that
17	Tustin has a median household income of about 84,000.
18	Rancho Santa Margarita is 121,000, Lake Forest is
19	109,000, and Irvine's is 105,000.
20	In short, I encourage you to link Lake Forest to the
21	communities north and south of it, rather than connect it
22	with the coastal districts and coastal communities that
23	have different transportation patterns and economies that
24	are geared to tourism. Thank you.

17	All of west Little Saigon is physically connected by
18	the I-405 corridor. The 405 is currently undergoing a
19	major improvement project that will have huge
20	implications on transportation in the region. With some
21	of these renovations being up to a ten-year project, our
22	region needs a unified voice to ensure this work is not
23	only completed in a timely manner, but done in a way that
24	inflicts minimal disruption to a lot of the residents who
25	rely so heavily on it.

1 Today, despite relying on the same roads and 2 infrastructures, Fountain Valley, Midway City, and Westminster have sizeable Vietnamese populations in our 3 4 community of interest along Huntington Beach. In this 5 redistricting process, with respect to Westminster, Midway City, and Fountain Valley should be grouped with 6 7 Huntington Beach in one similar district. The Redistricting Commission must ensure that these 8 9 communities are united with one congressional district, not divided, which will ensure that our local leaders are 10 11 able to assess representation in Washington, D.C. 12 Thank you for your time. 13 CHAIR SADHWANI: Thank you for calling in. 14 COMMENT MODERATOR: Right now we have 0-2-0, I will 15 be promoting you now. 0-2-0, your speaker order number 16 is 17. If you'll please make note of that for future 17 reference. You can now enable to audio and video in the 18 lower left corner of your screen. 1 (ph.). I'm a former Rancho Santa Margarita Council 2 Member and Mayor, and I'm former Director of the 241 Toll Road Board. 3 4 For those of you that don't know the 241, it is a 5 toll road that runs from Rancho Santa Margarita and Coto de Caza, the Anaheim Hills, and also connects the 6 7 northeastern part of Irvine, a portion of Tustin, and the City of Orange, (indiscernible) foothills, and Rancho 8

9 Santa Margarita.

The 241 is a beautiful road that was intended to 10 11 connect these communities with a toll road from Riverside 12 County to south Orange County. It was intended to reduce 13 congestion on the I-5, where too many commuters and 14 truckers had preferred to sit in traffic and think tolls 15 are considered too high. The toll road is scheduled to 16 become state property when the bonds are paid off. But when that will be is unclear. 17

Having a single representative focus on solutions for the problems facing the 241 Toll Road would be very useful to all the communities. And finding a way to finish construction to territories south of Rancho Santa Margarita and Coto de Caza would stop traffic from being dumped into these communities, and take traffic off the I-5 as originally intended.

I understand, it may not be possible to have a



1	smaller district like an assembly seat, but population
2	equally is of paramount. Please try to keep in mind all
3	of these cities please try to keep in mind that all
4	these cities are the same districts, so that we can get a
5	focus on making this asset of a greater value to the
6	communities of Coto de Caza, Rancho Santa Margarita,
7	Irvine, City of Orange, and Anaheim Hills.

18	As someone who straddles two congressional
19	boundaries, I see the negative effects of not having a
20	common voice represent the beach communities of Orange
21	County. And Orange County ocean and coastline
22	conservation is of the highest priority and importance to
23	all residents, regardless of their political party.
24	The only way to truly protect these voices is to
25	ensure that they are united in one congressional



1	district, not split in two as is now the case.
2	California's 48th Congressional District should move
3	further south and encompass the cities of Dana Point, San
4	Juan Capistrano, and San Clemente for the beach
5	communities to get the most effective representation as
6	possible. There are three key reasons for this.
7	First and foremost is tourism. As the number one
8	industry in Orange County, the protection of our
9	beautiful coastline deserves one voice who will fight for
10	clean beaches and protect tourism jobs. In CD-38, travel
11	and tourism employs close to 29,000 people, and generates
12	close to 4.5 billion dollars in spending. This is vital.
13	The coastline-driven industry needs to be unified and
14	protected by members of Congress.
15	Also, Orange County beaches face serious erosion
16	issues with sand. Sand replenishment usually happens
17	every five to seven years, but lately hasn't occurred
18	since 2010. The impact of this delay is really could
19	seriously harm our tourism industry.
20	The second major reason is infrastructure. Coastal
21	Orange County communities and cities have infrastructure
22	and housing issues that are unique to the coast, due to
23	housing density issues as well as congestion issues.
24	Highway 1, which starts in Orange County, winds its ways
25	through all of these communities. It's neglected and has



1 specific issues that are currently not being looked at 2 due to the split congressional district. We need a 3 representative that understands these issues, and can 4 work with local and state leaders to keep our quality of 5 life high. Right now, being a member of Congressional District 6 7 49, I notice that our roads and infrastructure are not being focused on by my current representative, because 8 9 his main focus is Veterans Affairs, which is great. But 10 again, only three cities in Orange County are represented 11 by him in Orange County. His main focus is mainly in 12 north San Diego County. 13 The other infrastructure issue is John Wayne 14 Airport. It is a world class airport and really unique 15 to Orange County. 6	it's kind of a key thing of explaining to her why we
7	don't have a beach. I said well, we have to have
8	actually the Federal Government come in and dump sand,
9	and we have to talk to our congressman. And we had a
10	great congressman several years ago, who was Ken Calvert,
11	a great guy, but he was a Riverside guy, and you can only
12	do so much.
13	Getting back to a specific quality of life issue,
14	and it seems but it's important, it's just sand on the
15	beach. And I would like to have one representative who
16	is devoted to being mindful of the coast, being mindful
17	of the people who have made an effort to live by the
18	ocean, specifically by the beach, and enjoy it. It makes
19	sense.
20	The second lesson that I taught my kids, is

My name is John Chou (ph.), and I'm here to discuss Dana Point, California. Thank you 5 very much to Honorable Commissioners, and I know it's a 6 7 lot of hard work to sift through all the data testimony, 8 and I appreciate it very much.

9 In the past, Dana Point was in California 48, and Dana Point got redistricted because of California's 10 11 steady population increase over the years. But now that 12 the California population is decreasing, I believe that 13 it's quite reasonable and a good idea to at least 14 seriously consider redistricting Dana Point back to 15 California 48, especially because Newport Beach and Dana 16 Point share harbor-related concerns, and not only the 17 traditional beach issues and cliff, and bluff, and beach 18 erosion issues.

Second, redistricting Dana Point back to California 48 would certainly help with the harmonization of county, local ordinances, and with federal statutes. I think it's important for the community to have that harmonization, and that's difficult to do, or at least more challenging to do, if you have the beach communities, and importantly the harbor communities split



1	either between or amongst counties, different counties.
2	And then finally, it's very important for our
3	federal representative to have expertise in the concerns
4	that other members of the public have mentioned with
5	respect to beach communities, and as I've mentioned,
6	beach and harbor communities. Because there are many
7	federal agencies which could exert their jurisdiction,
8	and their priorities depend on congressional budget
9	allocation.
10	So for example, Congressman McCarthy in Bakersfield,
11	and Congresswoman Judy Chu in San Gabriel, they're both
12	very smart and experienced congresspeople, but to be
13	frank, in their constituency they just don't have the
14	same incentive to gain expertise on beach and harbor
15	issues, because that's not what affects them the most.
16	And they don't have the same expertise that somebody
17	such as Congresswoman Michelle Steel or Congressman Jimmy
18	Panetta up in beautiful Santa Cruz, that they would have,
19	and I think it's important for our federal
20	representatives to have that knowledge, to have that
21	expertise, and then more importantly can exert it
22	MR. MANOFF: Thirty seconds.
23	MR. CHOU: can exert it effectively during the
24	budget and allocation process.

13	Irvine Spectrum, and several other major shopping
14	centers.
15	The University Area and Crossroads are more
16	connected to Costa Mesa and Newport Beach in large part,
17	because of their proximity to John Wayne Airport.
18	Portola is dominated by single family homes, and is
19	above the I-5 Freeway. Portola is a bit more like north
20	Tustin and Lake Forest.
21	Irvine is a planned community, and these three
22	geographic areas reflect the thoughtful mix of both
23	commercial and residential development within.

11	Redistricting Commission doing the important work for our
12	state. I am Chris Wim (ph.). I'm a policy analyst for
13	the Anaheim Chamber of Commerce. And I'm going to be
14	talking about the area around Santa Ana, Orange, Anaheim,
15	Fullerton, and Buena Park. So it's going to be central
16	northern part of Orange County along the 5.
17	Not only do I work for the Anaheim Chamber, but I
18	was born and raised in Orange County, and I've lived in
19	Anaheim for over three decades. The Disneyland Resort,
20	Angels Baseball, and the Honda Center where the Ducks
21	play, are major employers in the Anaheim area. And we
22	have thousands of small businesses in the area that also
23	rely on the visitors to these venues as customers.
24	It will come as no surprise, that Anaheim's multi-
25	billion-dollar entertainment economy impacts more than



1	just Anaheim. The fact is, Buena Park, southern
2	Fullerton, even Cypress, and the western part of the city
3	of Orange and Santa Ana, all suffered higher than normal
4	COVID-related job losses. And that's because a
5	substantial number of residents of these cities are
6	employed in the hospitality, food services, arts and
7	entertainment, and other tourism jobs associated in our
8	city, as well as in Buena Park, which is linked to us by
9	Harbor Boulevard, Beach Boulevard, and the 5 Freeway.
10	Transportation is critical to both the customers and
11	employees who use the Freeways and public transportation
12	in our area to get to all of these venues. The 5 Freeway
13	is the single most critical mode of travel in our area.
14	So we urge the Redistricting Commission to consider the 5
15	Freeway corridor, which stretches from Santa Ana to
16	western Orange, to Anaheim, to Buena Park as one
17	community of interest. The Metrolink and the Amtrak
18	follow the same path through Orange County as well before
19	going on up to Los Angeles.
20	Now reducing congestion on the 5 Freeway is
21	critical, and data shows that residents know this. Due
22	to the cost savings they can achieve, as well as the
23	congestion on our area to begin with, the residents of
24	Anaheim, even Stanton, Buena Park, and Santa Ana are
25	shown to be three times more likely to carpool than



1	residents of farther away cities like Newport Beach or
2	Yorba Linda.
3	And finally, Beach Boulevard links Buena Park's
4	tourism attractions like Knott's Berry Farm, Medieval
5	Times Dinner and Entertainment, the Pirates Dinner
6	Adventure Dinner Theater, links those with Anaheim's
7	Disney Resort, Angels Stadium, and the Honda Center where
8	the Ducks play, but we also have numerous concerts as
9	well. And many people come to our area and visit the
10	attractions in both of these cities.
11	As we begin to reopen from COVID-19, as we hope to
12	move on as vaccination increases, and as these areas
13	slowly increase their vaccination rates, it is imperative
14	that our representatives begin to continue to deal with
15	our longer-term issues, dealing very specifically with
16	transportation, and whether that's
17	MR. MANOFF: Thirty seconds.

19	Metrolink, Amtrak, carpool, or bus routes, it's essential
20	that we have a representative who is focused on the
21	issues impacting northern and central Orange County, that

1	So I'd like to again thank the Redistricting

8	also share the 73 Toll Road. Traffic congestion is a
9	major concern in Costa Mesa and that portion of Irvine.
10	And the residents need a bold field to address that
11	collectively as a district to solve these kinds of
12	issues.
13	UC Irvine campus is also within the region that
14	encompasses it. They have tens of thousands of graduate
15	and undergraduate students that have graduated, and they
16	have made an enormous impact on the housing market in
17	both cities. And that's a major reason why they have an
18	exceedingly high number of renters in the area.
19	So only forty-eight percent of Irvine residents are
20	homeowners, and the percentage is a lot lower if you
21	exclude the area north of the I-5, which are largely
22	single family homes. Only thirty-eight percent of Costa
23	Mesa residents are homeowners, and that has a major
24	impact on the quality of life and economic stability and
25	future economic planning for residents in the area. That

Commissioner Yee, thank you so much.

2	COMMISSIONER YEE: And Commissioner Sinay also.
3	So I have only been to one Presidential Library, and
4	that is the Richard Nixon Library, which is also his
5	birthplace and also his gravesite, all together there in
6	Yorba Linda. And he was the first President I remember
7	growing up. I was a little young to understand what
8	Watergate was all about, but I do remember going through
9	that. And although he does leave a mixed legacy, history
10	is still assessing what it all amounted to. Still, first
11	native-born Californian to become President, and resting
12	in peace there right in Orange County.
13	CHAIR SADHWANI: That is so true. And I believe
14	after he left the White House, he returned to his home in
15	San Clemente, where he had a residence. I'm also aware
16	that President Nixon was an alumni of Whittier College,
17	which is not in Orange County, but in one of those
18	cities I suppose it would be a gateway city into
19	Orange County, in Los Angeles County.
20	So thank you so much for that tip. That's so true,
21	and so helpful to kind of remember the presidential
22	history that resides here in California.
23	Commission Sinay, I saw you had something to share
24	as well.
25	COMMISSIONER SINAY: Well, mine is more fun. But

when they were talking about Buena Park and Medieval Times -- I don't know if any of you have ever gone to Medieval Times, but it's definitely an experience. And I remember, we took our -- we've gone a few times. I was surprised how much more my niece and my daughter got into it than my nephew and my son.

But we went for my son's third birthday. And the reason it's so special is, the whole family was there, and they take a picture. And usually we're like, we don't need a picture. 1 they wanted to share about Orange County?

2 Yeah, Commissioner Akutagawa.

COMMISSIONER AKUTAGAWA: I don't know if this came 3 4 up, but since Commissioner Yee brought up 99 Ranch 5 Market, the question was brought up about where it started. And just a fun fact, it was -- the very first 6 7 store was in Westminster, California. It's no longer there, but they do have a number of stores in 10 states. 8 9 Apparently, I didn't realize that they had grown so much. 10 But they are at least quite present throughout southern 11 California, and I do believe in a number of places 12 throughout norther California as well, too. Just not in 13 Oakland, unfortunately.

I will also make a comment about Bueno Park. It was, like as a kid growing up in southern California, Bueno Park was very much a place that I knew well because it was, like an expectation. We would go to Knott's Berry Farm.

And I don't know -- now I know I'm really going to date myself. But I don't know if anybody remembers if you grew up in the area there was this, like -- I think I might have brought this up before, but this deer park where you can go in like, you know, it's kind of like an animal farm where you go pet the animals. It was just all deer. And I forgot what they called it.



1	But it was in Bueno Park, and it just, you know, as
2	they talked about the entertainment district, you know,
3	it is very much that around Bueno Park. And so, yes, a
4	lot of what people are saying about, the Beach Boulevard
5	being the kind of the connector between the entertainment
6	areas, makes a lot of sense. I drive that a lot.

4	definitely want to hear from you. We do enjoy it, and
5	it's very helpful and insightful for us as we go through
6	this ongoing process of redistricting. And your stories
7	and telling us about your communities is part of that
8	process.
9	All right. Oh, Commissioner Fernandez. Thank you.
10	COMMISSIONER FERNANDEZ: Commissioner Sinay reminded
11	me of the Medieval Times. We did go twice. And the
12	first time we went, I want to say my boys were probably
13	under ten. And I had no idea what it was about. We
14	just, you know, got tickets to go. And so we get there,
15	and they start serving us. And I'm, like where's the
16	utensils, you know, how are we supposed to eat this,
17	right? And I start looking around and I'm, like oh, I
18	get it.
19	So I have to admit, I was probably the worst one in
20	terms of getting into it. The worst with the, you know,
21	slamming on the desk and eating with your fingers. And
22	my boys kept looking over at me going, I think that it's
23	okay, we can eat with our fingers this time, right?
24	But it was so much fun, I have to tell you. It was
25	so much fun. And the jousting and the yelling. And

5	CO-CHAIR AKUTAGAWA: I actually went with I think
6	I was in college when I went. And it was with a group of
7	friends. Just to say, even if you're not a parent with
8	small children, you could still go. You know, it is
9	rather fun, and the whole eating with your hands and
10	everything that's going on. It was, you know, it was
11	such a different kind of experience, it was really just a
12	lot of fun to participate in that.
13	So I know we've talked a lot about the we've
14	heard a lot about the beaches as well, too. And it's
15	interesting, even though we all share a coastline for the
16	beach cities in Orange County, there are slight
17	differences along each of those beach cities in terms of
18	the coastline itself. You know, some are higher cliffs,
19	some are just like in Huntington Beach, definitely Seal
20	Beach well, I should say Sunset Beach and Huntington
21	Beach, much more easier to access areas to the beaches
22	versus, like along Laguna and also along Newport Beach,
23	some more cliffs and, you know, really beautiful places
24	to see.
25	Commissioner Sinay, did that jog a memory for you?

2	COMMISSIONER SINAY: Well, I have a lot. Yes, I did
3	live in Irvine when I was young, as I shared before. But
4	you just so a friend of mine, all the way from South
5	Bay, L.A., well, her dad actually her parents were
6	divorced. I think her dad lived even further north, in
7	the Valley, all places we've heard of during our listen
8	sessions.
9	But he had a his sailboat was parked outside of
1.0	

10 the Rusty Pelican in Newport Beach. And we used to just 11 go and hang out on the sailboat. And every once in a 12 while he would come down, and he would actually take us 13 out. But in high school, that was just really fun just 14 to hang out on a sailboat and -- I don't know.

15 But one time we went, and it was my two good 16 friends, and then the one whose dad owned it, and her 17 boyfriend. The four of us went, and we went in a Karmann 18 Ghia. So two people drove down in a Karmann Ghia, two of us drove down in, like, this car that's almost as small 19 20 as a Karmann Ghia. And she dropped her keys to the 21 boat -- oh, we went in, we got all of our stuff, and then 22 we said, hey, let's go to the beach. And as she is 23 locking up the sailboat, she drops her keys into the 24 water, and it didn't have a floatie on it. 25 So we had to -- and this is pre-cellphones



1	obviously, right? So we had to call our figure out
2	how many coins we could find to call our parents and tell
3	them, we're going to be late. Because we had to wait
4	until someone came down all the way from the Valley to
5	Newport to open up the sailboat. And then yeah, we
6	were looking for money so that we could figure out how to

6	UNIDENTIFIED SPEAKER: Yes, I'd like to discuss
7	Irvine, Tustin, Newport Beach, and Costa Mesa.
8	I completely agree with the speaker who spoke right
9	before the break that we had here. And these communities
10	really value their open space. They value the
11	affordability of housing, the quality of life, the
12	mobility of traffic in this region. I'm just extremely
13	passionate about some of these issues, and I think that
14	each of these cities have it as a priority for each of
15	these areas to succeed and exceed in those capacities.
16	And I think that having a leader, a representative
17	tackle those issues in Sacramento and Washington, D.C.
18	would be extremely advantageous to our state, our county,
19	and our region. And so that's why I think that that
20	community is very fitting.
21	And I just wanted to thank all of you for sharing
22	your time today, and sharing your thoughts and
23	experiences. This has been a great experience, and very
24	unique to see and hear what your ties to this region and
25	county are. So thank you.

1	COMMENT MODERATOR: And that was all of our callers
2	at this time, Chair.
3	CO-CHAIR AKUTAGAWA: All right. Thank you for
4	calling in.
5	And for anyone else who is listening in please, you
6	know, hopefully hearing some of the stories, and as this
7	last caller just mentioned, perhaps some of our stories
8	may inspire you to call in and tell us about your
9	community as well, too. As has been mentioned, the
10	traffic is quite extensive down here in Orange County as
11	well, too.
12	I grew up hearing often about the El Toro Y. If
13	anybody is familiar with the interchanges up where the 5
14	and the 405 meet, down by Irvine Spectrum and near
15	Tustin. Definitely, you know, a bottleneck area. And so
16	I feel like I think some people have mentioned about
17	the way we call, at least down here in southern
18	California, the ways in which we call our freeways,
19	"the".
20	And part of it is, I think, because for many of us
21	our lives are spent on these freeways. And that's one of
22	the ways in which we can, you know, just really, I guess
23	express ourselves about our commutes.
24	I know, when I describe my commute, when the
25	occasional times that I over this past year-and-a-half



1	that I've been driving up to my office. And I recently
2	drove up there and I was reminded why I just really hate
3	the traffic here.
4	But when I describe my commute, it's usually a
5	series of multiple freeway numbers that I have to explain
6	versus it's not just one, it is multiple freeways that
7	I take to get up to L.A. And part of it is, I've become
8	quite creative about how to get from one place to the
9	other, as have, I'm sure, anyone who is living near, you
10	know, urban areas, but particularly down here in the
11	L.A./San Diego Orange County/San Diego areas as well,
12	too.
13	But I'm just thinking about, you know, just some of
14	the communities. I know that we've talked about trying
15	to, hopefully at some point, be able to meet together in
16	person. My hope is that if we can meet here in Orange
17	County, I would love to be able to have the Commissioners
18	all take a tour of just the various communities that are
19	here, and seeing for yourself the not only the
20	different ethnic communities and the kind of geographical
21	regional communities even within this local Orange County
22	area that has been spoken about, but I feel like food is
23	a theme for all of us.
24	And so I know that when I talk to people about
25	coming and visiting Orange County, I usually just center




1 my recommendations about where can we go and get the best 2 kind of foods from the Filipino -- even though this is 3 technically L.A. County sometimes because of the borders, 4 Cerritos, there is Little India and, you know, a Filipino 5 community there. In Westminster, there is Little Saigon 6 that's been mentioned.

7 And then, in the Anaheim area there is the Little Arabia areas. There is definitely many places, Santa 8 9 Ana, but throughout Orange County, places to get some 10 fantastic Mexican food. And also, you're going to find 11 some other historic businesses as well, too. There are 12 some areas in which you'll get definitely fantastic, 13 especially in Irvine, Korean and Chinese foods. 14 You know, there is Fountain Valley, and throughout, 15 I would say, different parts of Orange County you will 16 definitely get some really good Japanese foods. And I'm 17 just also thinking about an Italian market that I know of 18 in Anaheim as well, too, that has some really fantastic

19 food there as well, too.

So hopefully, I'm making you all really hungry, and I'm sure there is going to be someone who is going to be inspired to call in. If anything, just to say, you forgot to mention this food or that restaurant. And so if that gets you to call in and, you know, give us your communities of interest testimony, I am happy to invite





1	you to do so. If you want to call in and make public
2	input, please do so.
3	We're at about 1:45, so we have about fifteen more
4	minutes.
5	Oh, Commissioner Sinay.
6	COMMISSIONER SINAY: I was just yeah, one of the
7	callers called in about how Tustin, you know, there used
8	to be a huge military base. And when you brought up El
9	Toro, that was another big base.
10	And our neighbors, when we lived in Irvine, he was
11	stationed in El Toro, and I remember the first time we
12	saw the Blue Angels with an invitation from him to go see
13	them. But it's interesting how much Orange County has
14	changed from active military bases, and what's being
15	created by those bases yeah, and being able to be so
16	close and see how huge some of those hangars are. And
17	how it's yeah, it's recreating the Tustin area, you
18	know, I guess it's the north Tustin area. But also the
19	El Toro area.
20	And there is a huge as you all know, I've worked
21	with the Veterans community in Orange County. And so
22	there are a lot of veterans in Orange County and a lot of
23	Reserve. And it would be great to hear from those folks
24	from the communities, just to understand, you know, how
25	they see the area and how districts can affect their



1 issues as well.

2	But yeah, I think it just reminded me when you said
3	El Toro, what a great memory of the Blue Angels. Now
4	I've gotten to see them in San Diego several times, in
5	San Francisco. But every time, I just think of El Toro
6	when I see them.


7 CO-CHAIR AKUTAGAWA: And actually, because of where we are, every once in a while we will get the flyover 8 9 from some of the jets, and so -- I guess because it's 10 only occasional, it's kind of fun to hear them -- I mean 11 literally just zip by. I live near Seal Beach, so you 12 know, I do pass by occasionally the Naval Weapons Station 13 as well, too. And you know, as you have said, it would 14 be great to hear from some of the veterans and even, you 15 know, anyone who is affiliated with any of the military 16 installations in that area.

Another caller had called in about Los Alamitos and 17 18 the base that's there. So I'm sure that there are a 19 number of veterans that also live in that neighboring 20 area, even though, I believe, I think that is still 21 considered Orange County. I think that's around the 22 lines where, you know, L.A. and Orange County become a 2.3 little blurred. But I do believe that Los Alamitos is 24 still considered part of Orange County, so that we have 25 that presence as well too.

Also what's been really interesting, and speaking
about some of the growth in Orange County, I think the
last time we talked about, you know, probably twenty-
five, thirty years ago we would have been able to drive
around and see the actual orange trees that made up
Orange County. And it was a wonderful scent in the air
when they were flowering and, you know, you could smell
those orange groves.
But there have also been callers that have called in
about the foothills as well, too. And those have been
some areas where we have seen a lot of growth in Orange
County as well, too. And connecting in closer to some of
the Riverside/San Bernadino county, you know communities
around there as well, too, as there has been greater
buildouts further inland as well, too.
So just really interesting to year, you know, what
people have been saying about the different communities
in the area. Laguna Woods, if you're not familiar, is
also a very large Leisure World community. And there is
also another Leisure World community up in Seal Beach as
well, too. So just kind of another fun fact there.
And then, of course, shopping.
COMMISSIONER SADHWANI: Yes, and Commissioner
Akutagawa, if I may. I shouldn't read things off the
internet, because especially as a professor that probably



1	goes against the code of ethics. But I'm just looking up
2	some fun facts about Orange County.
3	And you mentioned the Laguna Woods area. I used to
4	spend we used to go to Laguna Beach quite often.
5	Again, very different, like I think all the beach
6	communities while certainly having shared interests, they
7	all have a different feel to them. But I'm reading this
8	little fun fact that I no idea about. And again, this is
9	off the internet so I don't know if it's true or not.
10	But in 1933, an amateur archeologist who was only
11	seventeen years old, found in Laguna Beach a chipped
12	skull on the beach, and the skull was found was
13	considered to be over 17,000 years old. And at that
14	point in time that was the oldest remnant that had been
15	found in the western hemisphere. So a really
16	important it sounds like a really important historical
17	find, right there, in Laguna Beach.
18	So who would know, who would have thought that under
19	all the beautiful sand you might find a 17,000-year-old
20	skull. It doesn't sound like something I would
21	particularly want to do while I'm on the beach, but
22	really, you know, exciting to read that.
23	CO-CHAIR AKUTAGAWA: Okay. Well, we're winding
24	down, and at this point, I guess I do appreciate
25	everybody hanging in there. I guess, if you don't mind

24	COMMISSIONER SINAY: Its ghost.
25	CO-CHAIR AKUTAGAWA: I'm sorry?

1 COMMISSIONER SINAY: Its headless horseman ghost. 2 CO-CHAIR AKUTAGAWA: Really? I didn't know about 3 that. 4 COMMISSIONER SINAY: Oh, we camped there. Ι 5 remember going there with Campfire Girls. We camped there and they told us all about it right before they 6 7 sent us to our tents to sleep. CO-CHAIR AKUTAGAWA: I didn't realize that that was 8 9 part of their lure down there. All I know is, you know, 10 in all the years that I've lived in Orange County, and 11 also, you know, having, you know, been born and raised 12 here, I've never actually gone, you know, I've heard 13 about the swallows, you know, the migration of the 14 swallows to San Juan Capistrano. I have never though 15 actually made an effort to go down there to go see it. 16 And I am kind of curious now that we're focusing on 17 all these cities. I don't know if any of you have seen 18 it, done it. 19 And Commissioner Sinay, I think you said that they 20 fly up from Argentina, so --21 COMMISSIONER SINAY: I used to work for Partners of 22 the Americas, and we'd partner U.S. cities, and states, 23 and regions with Latin American countries' states and 24 regions. And we had partnered southern California and 25 Argentina because of the swallows. And the swallows did



1 the trip back and forth.

2	CO-CHAIR AKUTAGAWA: I don't know if this will
3	qualify as a fun fact or and I will say, my caveat is
4	that this isn't from the internet, but this is how rumors
5	do get started, I will admit to this. But I do believe
6	that when I think of places like Mission Viejo, and
7	(indiscernible) and some of these areas, you know,
8	southern California but specifically Orange County is
9	actually quite well known for their swimming programs.
10	And I do believe that Mission Viejo has a pretty
11	competitive swim club, and that they've actually sent
12	several Olympians from their clubs to, you know, swim on
13	behalf of the U.S. And I think several have actually
14	medaled in the Olympics. Since we're in that Olympic
15	moment, I thought I'd just mention that as well, too.
16	And actually this year, surfing is part of the
17	Olympics. So that's actually kind of interesting. I
18	haven't watched any of it. But it's interesting to hear
19	that surfing is also part of the Olympics this year. And
20	being from Surf City, U.S.A., it's something that I took
21	note of with interest.
22	COMMISSIONER SADHWANI: I'm curious, Commissioner
23	Akutagawa, if you know anything about, like is there a
24	competition between the surfers of which beach is a
25	better beach to surf on.

1 CO-CHAIR AKUTAGAWA: Yeah, I think -- I don't think 2 it's quite as bad as what you'll hear about, like in 3 Malibu and some of those other places where you've heard 4 rumors of you know, locals try to claim spaces for 5 themselves. And same, I think, also in the Rancho Palos 6 Verdes area.

7 I've heard rumors, but I'll be honest, I mean, I'm not a surfer myself but from what I understand, most 8 9 people are pretty welcoming. There's also a lot of 10 standup paddle, you know, enthusiasts in this area all 11 along the coast. My brother-in-law particular, he and my 12 niece, they compete in standup paddle competition. So 13 that's really quite popular, especially down towards 14 south county, like in Dana Point, San Clemente, around 15 that area, there is quite a bit of that as well going on, 16 so.

17 And then, if you come up to, like around the Sunset 18 Beach, Huntington Beach, and probably, you know, parts of 19 Newport Beach, some of the callers mentioned some of the 20 tourism activities that are going on. So I see a lot of 21 people trying out surfing and standup paddling, you know. 22 Kayaking is also another one that I see quite a bit of 23 things, you know, people would just taking an either a 24 one- or two-person boat out and just kayaking around the 25 If they're in the harbor or -- I think just even harbor.



1	down by the beach it's more just, you know, people who
2	are surfing.
3	Maybe another I'll just speak about this. So I'm
4	a dog person, so I am a I guess I call myself a fur
5	mom. And so down in Huntington Beach, there is a dog
6	beach, an unofficial it's kind of an
7	unofficial/official dog beach. So unofficially dogs are
8	not supposed to or officially dogs are not supposed to
9	be off-leash on the beach.
10	But unofficially, because you have to go down a
11	number of steps and stairs to get down to the beach from
12	up top where people would park, it's a somewhat semi-
13	protected area where dogs are allowed or dog owners have,
14	you know, taken their dogs off leash and allow them to
15	play around on the beach and on the water. So if you are
16	curious as to seeing dog beach over by the Huntington
17	Beach pier, there's some fun times to be seen there as
18	well, too.
19	Or if you drive down with your dogs, I think as with
20	anything, well-behaved pets are welcome. And so that's
21	another little fun fact around that area as well, too.
