5	CHAIR AKUTAGAWA (via Zoom): Okay. Thank you.
6	All right. Hi, everyone. Welcome to our August 19th
7	Business Meeting. I sometimes want to say, our Communities
8	of Input meeting, but that is not what we're here doing
9	today. This is our Business Meeting.
10	I just want to say welcome to everybody. We do
11	have several things on our Agenda today that we will be
12	discussing. And so I am going to start with Ravi. Would
13	you please take roll? MR. SINGH (via Zoom): Yes,
14	Chair.
15	Commissioner Andersen.
16	(No audible response.)
17	Commissioner Fernandez.
18	COMMISSIONER FERNANDEZ (Via Zoom): Presente.

SINGH: Commissioner Yee. 12 13 COMMISSIONER YEE (via Zoom): Here. 14 MR. SINGH: Commissioner Ahmad. 15 COMMISSIONER AHMAD (via Zoom): Here. 16 MR. SINGH: And Commissioner Akutagawa. 17 CHAIR AKUTAGAWA: Here. 18 MR. SINGH: You have a quorum, Chair. 19 CHAIR AKUTAGAWA: All right. Thank you very 20 much, Ravi. 21 All right. So just very briefly, I do want to 22 just announce that we are going to go into Closed Session 23 first. We're not going to take public comment just yet. 24 So I do want to just let everybody know that. When we

return -- and we expect to be in closed session until 4:00

- 1 o'clock. So it will be a fairly short closed session, at
- 2 which time when we come back we will then start with public
- 3 comment. Okay.
- 4 MR. MANOFF: Chair. Just checking --
- 5 COMMISSIONER LE MONS: Excuse me, Chair.
- 6 CHAIR AKUTAGAWA: Yes.
- 7 COMMISSIONER LE MONS: What I was going to say,
- 8 it's 4:00 o'clock now.
- 9 CHAIR AKUTAGAWA: Oh, I'm sorry. We'll be back
- 10 at 4:30. My apologies.
- MR. MANOFF: Oh.
- 12 (Off the Record at 4:03 p.m. until 5:05 p.m.)
- 13 CHAIR AKUTAGAWA: All right. Thank you very
- 14 much. Welcome back. Thank you. Californians waiting for
- 15 us, I just want to report back on our Closed Session. We
- 16 were discussing pending -- we were having a discussion
- 17 under the pending litigation exception, and no action was
- 18 taken.
- 19 So with that said, I do want to continue on with
- 20 our Agenda. I know that I promised that when we came back
- 21 we would take public comment, and I do believe we have some
- 22 people waiting to make public comment, and then at which
- 23 time we will then as expeditiously go through our Director
- 24 Reports before we get to our Subcommittee Committee
- 25 Updates.

- 1 And we are in particular going to be discussing
- 2 the \*3:05 population \*3:11.
- 3 All right. So Katy, I'm going to ask you to let
- 4 us -- let everybody know how to call in to make public
- 5 comment.
- 6 PUBLIC COMMENT MODERATOR (via Zoom): Yes, Chair.
- 7 In order to maximize transparency and public participation
- 8 in our process, the Commissioners will be taking public
- 9 comment by phone. To call in, dial the telephone number
- 10 provided on the livestream feed.
- It is 877-853-5247. When prompted, enter the
- 12 meeting ID number provided on the livestream feed. It is
- 13 87694754343 for this meeting. When prompted to enter a
- 14 participant ID simply press the pound key. Once you have
- 15 dialed in you will be placed in a queue.
- To indicate you wish to comment, please press \*9.
- 17 This will raise your hand for the Moderator. When it is
- 18 your turn to speak you will hear a message that says, the
- 19 host would like you to talk, and to press \*6 to speak.
- 20 If you would like to give your name, please state
- 21 and spell it for the record. You're not required to
- 22 provide your name to give public comment. Please make sure
- 23 to mute your computer or livestream audio to prevent any
- 24 feedback or distortion during your calls.
- Once you are waiting in the queue, be alert for

- 1 when it is your turn to speak, and please -- again, please
- 2 turn down the livestream volume. At this time we have
- 3 caller with the last four 1803, and then up next in the
- 4 queue will be caller 6252.
- 5 Caller 1803, if you will please follow the
- 6 prompts to unmute at this time. Caller 1803, the floor is
- 7 yours.
- 8 MS. ALLEN (via Zoom): All righty. Thank you so
- 9 much.
- 10 Good evening, Commissioners. I hope you all are
- 11 doing well. My name is Sky Allen. I work with Inland
- 12 Empire United. We are a collective impact people serving
- 13 Riverside and San Bernardino counties. And what the \*5:15
- 14 name the IE Redistricting Hub, a group of 2,000 community
- 15 organizations working to educate and mobilize our community
- 16 around the process.
- 17 Last year we helped \*5:25 people to apply for
- 18 this position from our region. We've spent all of this
- 19 year so far educating our friends and neighbors about what
- 20 redistricting is and mobilizing COI testimony for your
- 21 public input meetings.
- I actually submitted a letter to you a while back
- 23 in May, urging you to host additional public input
- 24 meetings. And though we added more meetings to your
- 25 calendar, I apologize for that, I hope that it -- has been

- 1 one that's made your process stronger in the long run.
- 2 More recently, we've been in deep discussion with
- 3 map-drawers to insure that any draft district maps that are
- 4 proposed to you later this year reflect our COIs, reflect
- 5 our communities' needs and priorities, because we
- 6 understand that though the 14 of you are well equipped with
- 7 issue experts and excellent research and data, you don't
- 8 know our cities or our communities like we do. You
- 9 couldn't possibly.
- 10 So we understand that we don't have the
- 11 authority, of course, to decide what the maps are going to
- 12 look like. To the extent that we can hash out tricky areas
- 13 internally and save you some trouble, I would think and
- 14 hope y'all can see that as an asset, as opposed to a
- 15 threat.
- I'm calling in tonight because the other week I
- 17 heard a comment, and \*6:28 you possibly don't feel that's
- 18 the case, I would urge you to reconsider your perspective.
- 19 Your job as an independent commission is to be independent
- 20 of the partisan bias of state legislatures, not independent
- 21 of community members or organizations.
- MR. MANOFF (via Zoom): Thirty seconds.
- MS. ALLEN: Advocacy around maps is of a piece
- 24 with advocacy around COIs, not designed to undermine your
- 25 process, but to the contrary, to add the nuance and

- 1 perspective necessary and appropriate to respecting their
- 2 communities \*6:53.
- 3 MR. MANOFF: Fifteen seconds.
- 4 MS. ALLEN: I hope y'all will come to affirm this
- 5 commission as one welcoming to community members and
- 6 organizations, and in so doing insure there is space for
- 7 the submission and presentation of district maps this fall.
- 8 Thank you so much for listening.
- 9 CHAIR AKUTAGAWA: Thank you, Ms. Allen.
- 10 PUBLIC COMMENT MODERATOR: All right. Now, we
- 11 will have caller 6252, and then after that will be caller
- 12 3818.
- 13 Caller 6252, if you will please follow the
- 14 prompts to unmute at this time. The floor is yours.
- MS. HUTCHISON (via Zoom): Thank you very much.
- 16 Good evening, Commissioners. This is Helen Hutchison, with
- 17 the League of Women Voters of California. I have two items
- 18 today I wanted to ask you -- to speak to you about. The
- 19 first is a brief one, one that asks you to consider taking
- 20 public input at the beginning of Agenda items, rather than
- 21 at the end.
- The public voice should be able to have the
- 23 opportunity to have an impact on your discussion, and so
- 24 we'd like to be able to do that. Additionally, we'd ask
- 25 that you consider taking public input a second time when

- 1 you're considering something that is really a significant
- 2 change from your -- the original recommendation.
- 3 The second item is about submission of maps from
- 4 individuals or groups. You've received and will continue
- 5 to receive input in a whole variety of ways, and I'm not
- 6 just talking about the physical ways people give you their
- 7 input, but also a variety of kinds of ideas.
- 8 And these are definitely going to include
- 9 suggestions for district maps. These maps could be single
- 10 districts, a regional set of districts or a full state map.
- 11 You've been focusing on communities of interest, and that's
- 12 great.
- They're the building blocks for everything, but
- 14 please don't limit yourself to thinking that's the only
- 15 kind of public input you should consider. You may find a
- 16 solution to a particularly tricky tradeoff in a proposed
- 17 map you receive, or something in the map may inspire some
- 18 new idea in your thinking.
- 19 So please consider and listen to all of the input
- 20 you receive in the spirit in which it's offered.
- MR. MANOFF: Thirty seconds.
- MS. HUTCHISON: Whether it's from an individual,
- 23 a group or a coalition of groups, we're all just trying to
- 24 get to the best set of maps for all of us. Submitting a
- 25 map to you is just one more way that communities can give

- 1 you --
- 2 MR. MANOFF: Fifteen seconds.
- 3 MS. HUTCHISON: -- that you can use in your final
- 4 mapping. Thank you very much.
- 5 CHAIR AKUTAGAWA: Thank you, Ms. Hutchinson
- 6 [sic].
- 7 PUBLIC COMMENT MODERATOR: All right. Now, we
- 8 have caller 3818. If you will please follow the prompts to
- 9 unmute at this time. And go ahead. The floor is yours.
- 10 MS. GARNER (via Zoom): Thank you. Good evening
- 11 Commissioners. This is Grace Garner, calling from the
- 12 Black Census and Redistricting Hub. We sent a letter along
- 13 with the Prison Policy Initiative to you regarding the
- 14 federal prison population allocation.
- I just wanted to call in to let you know that
- 16 we're watching, and that if you have any questions at all
- 17 for us we're happy to answer those, either now or during
- 18 that section. So thank you so much for your time and for
- 19 considering our letter.
- 20 CHAIR AKUTAGAWA: Thank you very much, Ms.
- 21 Garner. All right.
- 22 PUBLIC COMMENT MODERATOR: And that was all of
- 23 our --
- 24 CHAIR AKUTAGAWA: Katy. All right.
- 25 PUBLIC COMMENT MODERATOR: -- that was all of our

- 1 callers at this time.
- 2 CHAIR AKUTAGAWA: Awesome. Thank you very much.
- 3 All right. So we'll go ahead and we'll move onto our first
- 4 Agenda item. We do have Director --
- 5 COMMISSIONER PANE (via Zoom): Check. Check.
- 6 CHAIR AKUTAGAWA: Yes.
- 7 COMMISSIONER PANE: Chair, looked like
- 8 Commissioner Sadhwani hand a -- had her hand raised.
- 9 CHAIR AKUTAGAWA: Oh, I'm sorry. It was --
- 10 COMMISSIONER SADHWANI: Thank you so much,
- 11 Anthony. Just very briefly. I just wanted to respond to a
- 12 couple of the callers calling about district maps, and
- 13 point you to the documents that we've been providing from
- 14 the Line Drawer Subcommittee, that we are working on having
- 15 those sessions.
- 16 I don't have them in front of me. I believe that
- 17 we earmarked the days, and Commissioner Andersen, correct
- 18 me if I'm wrong, of October 21st, 22nd and 23rd to receive
- 19 those district maps. We are just working on what the
- 20 actual protocol will be for those meetings.
- 21 So I just wanted to let the folk -- let folks
- 22 know who are watching and called in, we hear you. We're
- 23 working on it and stay tuned for more information about how
- 24 those meetings will be run.
- 25 CHAIR AKUTAGAWA: Wonderful. Thank you for

- 1 clarifying that and adding that additional information.
- 2 It's helpful. Thank you, Commissioner Sadhwani.
- 3 All right. We'll go ahead and we'll continue on
- 4 to our Agenda, and I will try to make sure I do a better
- 5 job of scanning through the boxes to look for hands. We'll
- 6 go to the first -- next item on our Agenda, No. 3, Director
- 7 Reports, and I am going to ask Director -- Executive
- 8 Director Hernandez to start.
- 9 EXECUTIVE DIRECTOR HERNANDEZ (via Zoom): Thank
- 10 you, Chair, and good evening, Commissioners. I wanted to
- 11 let you know that my report will be brief, so we can move
- 12 things along.
- Under staffing personnel, our Outreach Director
- 14 will be presenting the three remaining staff that have not
- 15 been presented to the Commission. So that will happen
- 16 shortly.
- 17 And then moving onto the Protocols for Commission
- 18 Communications, I wanted to let you know that we have
- 19 signed the Information Security Agreement with the
- 20 Statewide Database, and we are informed this morning that
- 21 the transmission of information will begin on a regular
- 22 basis as of later today or has already begun.
- 23 So we're moving that along. Our database portion
- 24 of -- is -- our database team is moving things along
- 25 quickly, and you'll have some information later on this

- 1 evening about the Airtable.
- I also wanted to direct your attention to a
- 3 handout that we've posted for the meetings that include
- 4 input meetings, Commission meetings and Line Drawer
- 5 meetings through December. And so this is taking into
- 6 account the information that was provided by the Line
- 7 Drawer Subcommittee last week.
- 8 I've taken that information, incorporated into
- 9 the spreadsheet that I have posted for you to review.
- 10 There's a couple of things that you'll notice that have
- 11 changed, and I'll explain why they have changed. So I've
- 12 moved some of the meetings around a little bit because
- 13 there's still some ambiguity as to whether or not the
- 14 Emergency Executive Order for COVID-related -- suspending
- 15 the Bagley-Keene or making it, you know, more flexible, I
- 16 should say.
- 17 If that were to change and revert back to the
- 18 Bagley-Keene Requirements we would be in person once again
- 19 as of October. So with that I've indicated where we would
- 20 potentially have those meetings if we were to revert back
- 21 to that format.
- 22 So you'll see that beginning October 4th we would
- 23 have meetings in October in Sacramento for the three Line
- 24 Drawer meetings, and then I've moved the Commission meeting
- 25 to the 7th just so that -- for continuity purposes for

- 1 those that would be traveling.
- 2 Likewise, on the subsequent page the 20th,
- 3 October 20th, I've moved that one from the 18th so we
- 4 wouldn't have that much of a break, and allows those who
- 5 will be traveling to focus their attentions on all the
- 6 meetings versus traveling back and forth.
- 7 So I also wanted to mention that we still have in
- 8 September -- back to the first page -- September 9th and
- 9 10th, we had indicated COI input meetings if needed. That
- 10 is still open, and I've added a full CRC meeting for the
- 11 Line Drawers on the 11th from 9:30 to 4:30.
- 12 So those are some of the highlights of the
- 13 schedule. One of the questions that I would like to ask
- 14 the Commission, if it so chooses to have a statewide COI
- 15 Input Meeting, either on the 9th or the 10th, so that we
- 16 can do the scheduling as an option.
- I know we're kind of rounding everything up.
- 18 Eighth right now is the last meeting that we have scheduled
- 19 for the Southern California H through K, so that we can
- 20 insure that the language of Mandarin, Cantonese and
- 21 Japanese are available to individuals. But we have the 9th
- 22 and the 10th available. So I wanted to kind of put that
- 23 out there for you.
- 24 Are there any questions? Yes.
- 25 CHAIR AKUTAGAWA: I see Commissioner Fernandez.

- 1 COMMISSIONER FERNANDEZ: Yes. Thank you.
- 2 Thank you, Executive Director Hernandez. On the
- 3 meeting for the September 1st, if we could also please add
- 4 that we had Vietnamese and Spanish for that, as well as
- 5 Korean, for that meeting. I just want to make sure that we
- 6 don't lose the other two languages, so we're consistent.
- 7 And I hadn't -- and I would consider this a
- 8 schedule through the end of November, not necessarily
- 9 December, because there really isn't much in December and
- 10 we're going to be really busy in December. So I would just
- 11 voice it more of a schedule for the next couple of months.
- 12 And on the meeting on November 17th, I notice
- 13 that you only put a three-hour window for that where
- 14 normally we'd have a four-hour window. And I see why on
- 15 November 12th you did not add another meeting for the Line
- 16 Drawers, and I'm thinking it's because there was a split of
- 17 a holiday.
- 18 So I'm not sure if we need to make up that Line
- 19 Drawer date, maybe on the 8th or something. I'm not sure.
- 20 I would ask the Line Drawer Subcommittee to maybe look at
- 21 that. And I really don't like having a meeting the day
- 22 after Thanksgiving, just FYI.
- So, give me two days off, please. Thank you.
- 24 But that was it. I really do appreciate you doing this,
- 25 and moving some meetings around so that, you know, we don't

- 1 have gaps and we're not going back and forth. So thank you
- 2 so much.
- 3 CHAIR AKUTAGAWA: Okay. I do -- oh, Commissioner
- 4 Sadhwani.
- 5 COMMISSIONER SADHWANI: Yes. I just wanted to
- 6 note. I think -- and you know what, I did take a look at
- 7 this in advance and I didn't catch it then, and I'm
- 8 wondering if this is perhaps why folks are calling in. So
- 9 Alvaro, on October 21st, 22nd, 23rd, you have those down as
- 10 Line Drawing sessions.
- 11 The intention there is actually that those are
- 12 not Line Drawing sessions, but opportunities to receive
- 13 district maps. So hopefully, we can just make that change.
- 14 And then I think -- I just wanted to also raise, in the
- 15 last meeting I walked away with the understanding we had
- 16 had a conversation about the time line, I think as a part
- 17 of the Line Drawing Subcommittee.
- 18 So and we had tacitly agreed that we would
- 19 attempt to finish our draft maps no later than November
- 20 20th. We didn't make a motion. We didn't vote on that. I
- 21 just wanted to make sure that we're all still on the same
- 22 page for that, because as of right now one of the biggest
- 23 challenges, because we don't have a ruling from the Supreme
- 24 -- well, we haven't submitted a motion yet -- from the
- 25 Supreme Court, we don't know what our map adoption date is.

- 1 And so many pieces flow backwards from that date,
- 2 and I think, you know, when looking at this if you're
- 3 thinking there's ambiguity, that's on purpose, because we
- 4 don't know exactly what the date will be for draft maps in
- 5 which they have to be completed.
- 6 We can also complete them early, but I believe
- 7 and I just wanted to confirm that we would have draft maps
- 8 by November 20th.
- 9 CHAIR AKUTAGAWA: Yes. I do agree that -- or I
- 10 do recall that that was part of the conversation. I do
- 11 also see Commissioner Sinay and then I also have a comment
- 12 after that, too.
- 13 COMMISSIONER SINAY: Thank you, Chair. Yes. I -
- 14 my comment was going to be that we had agreed that we
- 15 were turning in the map, the draft maps early and that we
- 16 were going to block off Thanksgiving just that we all would
- 17 have kind of a break.
- 18 And so hearing that there's a meeting the Friday
- 19 after Thanksgiving kind of goes against what we had talked
- 20 about last time. So and then the other piece is, I know
- 21 that the Executive Director has brought up that we can have
- 22 one meeting.
- 23 My thought was to have two statewide meetings
- 24 with one having Spanish translation, just because we do
- 25 have some -- you know -- if we've already budgeted and

- 1 everything else, why not have the two meetings. And
- 2 there's some areas that are going to be tough to reach and
- 3 they might still be tough to reach because of the fires.
- 4 But if we already have budgeted and everything
- 5 set up, why not have both, with one having Spanish
- 6 translations.
- 7 CHAIR AKUTAGAWA: And just for clarification, are
- 8 you saying one of the -- for example, if there's three days
- 9 of Line Drawing that one of those might --
- 10 COMMISSIONER SINAY: No. No. No. The two input
- 11 meetings that were on the calendar the 9th and the 10th of
- 12 September. There's two --
- 13 CHAIR AKUTAGAWA: Oh, got it. Sorry.
- 14 COMMISSIONER SINAY: -- there's two still up
- 15 there. Sorry. I wasn't clear.
- 16 CHAIR AKUTAGAWA: Okay. So what you're
- 17 suggesting is that we -- either the 9th or the 10th, we use
- 18 those four additional COI Input Meetings and then make one
- 19 of them a full Spanish interpreted meeting.
- 20 COMMISSIONER SINAY: Right. And then -- so two
- 21 statewide -- both of them statewide, so everybody's
- 22 invited, and at one of them we have Spanish interpretation.
- 23 CHAIR AKUTAGAWA: Actually, I believe that we
- 24 would continue to provide Spanish interpretation at both,
- 25 as we've agreed upon for all the meetings.

- 1 COMMISSIONER SINAY: All right.
- 2 CHAIR AKUTAGAWA: So it wouldn't be one or the
- 3 other. They would both have Spanish interpretation.
- 4 COMMISSIONER SINAY: Okay. Thank you.
- 5 CHAIR AKUTAGAWA: Okay. My comment on the
- 6 Agenda. Alvaro, I just -- I think -- I appreciate what
- 7 you're doing in trying to balance everything. I will also
- 8 say just as the comments around having a Line Drawer
- 9 meeting the day after Thanksgiving, having a -- I guess
- 10 we'll have to figure out where we put the full CRC Meeting,
- 11 but trying to have a meeting the week of Thanksgiving on a
- 12 Tuesday after we spent two days in Sacramento and then to
- 13 have to come back again.
- 14 And then I'm just thinking also about the -- just
- 15 the nightmare of what travel could be during the week of
- 16 Thanksgiving if you're coming from Southern California up
- 17 to Northern California. So I do want to also point out
- 18 that, you know, if we can maybe look at a different for
- 19 that meeting and try to keep that whole week clear, that
- 20 would probably be ideal.
- Okay. Commissioner Fernandez and then
- 22 Commissioner Yee.
- 23 COMMISSIONER FERNANDEZ: Yes. Along those lines,
- 24 Chair Akutagawa, I'm thinking that maybe the meeting right
- 25 now set for November 17th and if needed, maybe make that

- 1 the full Commission meeting, and then it clears out the
- 2 meeting on the 23rd.
- And also, no meeting on that Saturday of
- 4 Thanksgiving either, please, 11/27.
- 5 CHAIR AKUTAGAWA: I think there's a lot of
- 6 agreement.
- 7 Commissioner Yee.
- 8 COMMISSIONER YEE: Yeah. I'm wondering how to
- 9 proceed with this planning, you know, while we're still
- 10 waiting to petition the Court and then hear back from the
- 11 Court and actually have definitive dates. You know,
- 12 listening to the Census Bureau, Legacy Format Data Release
- 13 Press Conference they emphasize, you know, this is the
- 14 appeal of 94-171 data.
- 15 They emphasize that clearly, and I think it's
- 16 entirely possible that the Court will hold us to a short,
- 17 the strictest to be a deadline, which would -- let's see --
- 18 so that would be plus 12 days. That would end up being
- 19 maps due -- draft maps due November 13th, as possible, I
- 20 think, by my reading, and how do we plan for that
- 21 possibility.
- I think it's actually a fairly -- it's not a
- 23 remote possibility. How do we plan for that while also
- 24 hoping for more time? I'm not quite sure how to approach
- 25 that.

- 1 CHAIR AKUTAGAWA: Sorry. Commissioner Sadhwani,
- 2 and then followed by Commissioner Andersen.
- 3 COMMISSIONER SADHWANI: Commissioner Andersen can
- 4 go first. Waving.
- 5 COMMISSIONER ANDERSEN: Thank you. Yeah. My
- 6 hand keeps on disappearing. So I think I need to use the
- 7 button. I do have actually quite a few different comments
- 8 about the changes here, and thank y'all for putting all
- 9 this together. But one which, it's the time.
- In the October you're kind of shifting, like you
- 11 want to have one meeting late and you've decided it'll be
- 12 the first one. Unfortunately, that's really going to goof
- 13 up the Line Drawing sequence. So if we really want to have
- 14 one, maybe be the last one, later in the day, not the first
- 15 one.
- But my other quick question is, I appreciate that
- 17 you're thinking we might have to be in person in October,
- 18 so therefore, move the meeting directly next to the Line
- 19 Drawing meetings. I'd like us to make sure we have on the
- 20 calendar, in case it's not in person, I would like to keep
- 21 it the days before, which would be, instead of on the 20th
- 22 of October, the 18th of October, because we just don't have
- 23 the bandwidth to do four full days in a row. It's a lot.
- I understand if we have to be in person. So that
- 25 would be -- that would affect the 18th and the 25th in

- 1 October. Then to address Commissioner Yee's point, there
- 2 are two different dates and one of which is -- should we
- 3 have no relief whatsoever and it doesn't matter, you still
- 4 have to stick with the 12 days, that's when it goes -- it
- 5 would not -- the 13th is correct, you have to be on or
- 6 before the 13th, but it being a Saturday we'd actually have
- 7 to post them on the 12th, which is why we did originally
- 8 have a CRC meeting on the 12th.
- 9 So I would recommend in that week of the November
- 10 we should put in three -- the Monday the 8th, 9th and 10th,
- 11 because originally we had 10, 11, 12 and then 9, 10, 11 and
- 12 then the 12th. So if we could have the meetings be Monday,
- 13 Tuesday, Wednesday, the 8, 9, 10, not Veterans' Day, and
- 14 then the full CRC meeting on the 12th, in the event that we
- 15 actually have to, you know, go on draft maps.
- 16 And then the other date would be the 19th. So
- 17 I'd kind of like to shift whatever it said about taking it
- 18 from the Saturday and moving that up, that set should move
- 19 up. And then like Commissioner Sadhwani, I totally agree
- 20 with what she was saying.
- 21 We need to kind of see what happens on our date,
- 22 final map date, before we can really fill in the rest of
- 23 those. So I'd like to tweak a little bit of these items,
- 24 timing, et cetera, but we'd -- I -- and we definitely want
- 25 to have that meeting on the 12th, just in case.

- 1 And we did -- we did indeed vote for -- we're
- 2 going to do our first draft map by the 20th, except that
- 3 would be again by the 19th. That's -- we all said we'd
- 4 like to do that on or before the -- you know -- that we all
- 5 kind of went -- we didn't vote, but we all kind of went,
- 6 we'd really like to do that.
- 7 And so I think those would be our days, meaning
- 8 through the 12th to the 19th, if possible, and depending on
- 9 the others.
- 10 CHAIR AKUTAGAWA: Executive Director Hernandez.
- 11 EXECUTIVE DIRECTOR HERNANDEZ: Thank you. So I
- 12 will go back to the drawing board on this, try again to
- 13 accommodate some of the changes. Just for your
- 14 information, the reason that I put, for example, the first
- 15 meeting in the set of -- or the series of meetings, I was
- 16 thinking of the travel, you know, allowing Commissioners to
- 17 travel in the morning for the meeting in the evening, and
- 18 then the subsequent meetings being in the morning, and
- 19 ending earlier, than later, for travel purposes, as well.
- 20 So that was a consideration, but it appears I
- 21 will need to go back and fine tune some of the dates. I've
- 22 heard that Friday, November 12th, is technically a holiday
- 23 for state employees, I believe. Is it not the case? Oh,
- 24 the 26th. I'm sorry. The 26th is a holiday for employees.
- 25 The 12th is the day after Veterans' Day, as

- 1 Commissioner Fernandez pointed out. There may be people
- 2 that are not available because they're taking an extended
- 3 weekend. So we'll have to play around with some of those
- 4 dates to make sure it fits everyone as much as possible.
- 5 So unless -- recommendations on dates, please
- 6 feel free to forward them, or send me an email on those. I
- 7 appreciate it. Thank you.
- 8 CHAIR AKUTAGAWA: Thank you, Executive Director
- 9 Hernandez.
- 10 We next have on our Agenda, we have our
- 11 Communications Director.
- 12 COMMUNICATIONS DIRECTOR CEJA: Thank you so much,
- 13 Chair. Hello Commissioners.
- I wanted to start off with the social media
- 15 analytics. We posted those online. We have a total of
- 16 1,024 total page likes on Facebook. I think the biggest
- 17 number there was our post-engagement at 403 for this past
- 18 week.
- 19 For Instagram, we have 237 followers. Our
- 20 account's reach increased by 45 percent. On Twitter, we
- 21 have a total of 1,640 followers, and that's up by 64. So
- 22 people are adding onto our social media channels. Our
- 23 LinkedIn is at 284 followers and our YouTube is at 66
- 24 subscribers, and has 2,172 views.
- I checked in on our database today and we're at

- 1 13,967 contacts. I just wanted to remind you that when we
- 2 started we were at about 3,000. So that's grown
- 3 exponentially, and will continue to grow once our
- 4 contractors come on board.
- 5 And jumping into that issue, we do have three
- 6 signed contracts for billboard and radio advertising. Raul
- 7 is working expeditiously to get the other ones going. So
- 8 as soon as those are signed then we can actually get
- 9 started on radio ads and billboards.
- 10 These contractors are eager to go, so one of them
- 11 is actually starting on Monday. We are getting the
- 12 language for the radio scripts approved. I got those
- 13 approved today, and then we're working on the graphics for
- 14 the billboards. We want to include one very basic design
- 15 to go statewide for the first month, and then the
- 16 communications team will be reaching out to each zone team
- 17 of Commissioners so that we can personalize the graphics
- 18 and messaging for billboards and radios for the next three
- 19 months after that.
- 20 But the very first month will be one basic
- 21 message going across the entire state, and then we'll have
- 22 an opportunity to tailor to your specific zones. We had a
- 23 big week last week with the announcement of the Census data
- 24 release.
- 25 Statewide there was 520 mentions of the Census

- 1 release. Forty-nine stories actually mentioned the
- 2 Commission. So we were pretty busy lining up interviews
- 3 and making sure that we were connecting Commissioners to
- 4 radio stations and newspapers.
- 5 We had Commissioner Sadhwani speak to L.A. Times,
- 6 Commissioner Sinay speak to KPBS. Commissioner Sinay spoke
- 7 to Telemundo 20 in San Diego. Commissioner Kennedy spoke
- 8 to KPCC. Commissioner Sadhwani spoke to Marketplace. She
- 9 also spoke to KCRW Press Play.
- 10 Commissioner Fernandez did an interview with
- 11 ABC10 from an oil change place in Sacramento. Commissioner
- 12 Kennedy spoke to NPR in Los Angeles. Commissioner Yee
- 13 spoke to KWED in San Francisco. I spoke to the Acorn
- 14 Newspapers. Commissioner Sadhwani spoke to NBC4, and last
- 15 night Commissioner Sinay was on with Univision.
- So we are getting a lot more attention. It's
- 17 picking up, which is great, comes in at a great time. We
- 18 do have our coordinator, who's been updating the website.
- 19 This was the first week where he actually took the reins.
- 20 So I'm pretty proud of the team. We're gelling and moving
- 21 forward.
- 22 So I expect to have a lot more media hits these
- 23 coming weeks, as I'm going to continue updating the media
- 24 list and just calling and seeing if we can do follow-up
- 25 studies.

- 1 CHAIR AKUTAGAWA: All right. Thank you very
- 2 much. Any questions?
- 3 All right. Not seeing any, I think we can move
- 4 on to our Outreach Director Report.
- 5 OUTREACH DIRECTOR KAPLAN: Sorry. I lost the
- 6 mute. Thank you, everyone. I -- we are -- because we're a
- 7 little behind schedule, the field staff that we're going to
- 8 join to introduce, I don't believe any of them are on
- 9 anymore. So I will do an introduction at the next
- 10 Commission meeting.
- I did upload a report for this week's -- for
- 12 today's meeting, which includes information for last week's
- 13 COI meetings and upcoming COI meetings in the next week.
- 14 So if there's any questions there, and then I just have a
- 15 few other highlights to mention, as well.
- 16 We did just receive an exciting update from the
- 17 Statewide Database this afternoon, but their access centers
- 18 are now open. We just got this news like right before the
- 19 meeting. So I'll be working with Fredy to get this
- 20 information on our website, and for the outreach staff to
- 21 distribute and other ways that we can promote this
- 22 information.
- 23 It is -- they are in six locations, Fresno, Long
- 24 Beach, Oakland, Sacramento, San Bernardino and San Diego,
- 25 and each center will have staff that can support members of

- 1 the public to develop community of interests or district-
- 2 based input to submit to the Commission, and to use the
- 3 redistricting software there.
- I also wanted to highlight, also just found out
- 5 this afternoon, the redistricting curriculum for 11th and
- 6 12th grade that Sacramento County Office of Education and
- 7 L.A. County Office of Education put together is now
- 8 finalized and LACO just distributed it yesterday.
- 9 So I'm in contact with Frank Peazy of SCOEE on
- 10 how else we can support in getting the word out in
- 11 coordination with Fredy and our COMs team, as well as
- 12 Outreach team. I also recently met with the California
- 13 Catholic Conference about statewide engagement, and they
- 14 will be able to distribute this to religious schools across
- 15 the state, as well.
- 16 So we're looking at other areas where we can get
- 17 the education curriculum, as well. And just connected to
- 18 education, we also had a great meeting with the U.C. Office
- 19 of the President, and they're really excited to engage
- 20 campuses and students across the state, and I will be
- 21 providing more update on this as we move forward.
- 22 So I don't know if there was any questions on
- 23 that or the report that's ported.
- 24 CHAIR AKUTAGAWA: Okay. I've not seen any
- 25 questions. Excellent. So let me -- oh.

- 1 OUTREACH DIRECTOR KAPLAN: No. I do see --
- 2 sorry. I do see Marlene is on now -- I see her -- who is
- 3 our field lead staff for the Central -- Central California.
- 4 So I just -- if there's a minute, I could introduce her
- 5 also.
- 6 Marlene, if you could turn on your camera and
- 7 introduce yourself to the Commission.
- 8 MS. DE LA GARZA: Oh, yeah, sure. Hi, everyone.
- 9 Hi. Thank you so much for this opportunity. My name is
- 10 Marlene De La Garza, and I am the field staff for Zones E,
- 11 F and G. Thank you.
- 12 CHAIR AKUTAGAWA: All right. Thank you very
- 13 much. It's nice to meet you, Marlene, and Commissioner
- 14 Andersen and I will look forward to working with you on
- 15 Zone G.
- Director Kaplan, is there anyone else that you
- 17 want to introduce or, otherwise, I know Commissioner
- 18 Fernandez has a comment that she'd like to make -- or
- 19 question. Sorry.
- 20 OUTREACH DIRECTOR KAPLAN: No. That's it for
- 21 today, just because of the timing shift. We'll have the
- 22 rest join, the other three, at an upcoming meeting.
- 23 CHAIR AKUTAGAWA: Okay. Excellent. Thank you.
- 24 Commissioner Fernandez.
- 25 COMMISSIONER FERNANDEZ: No. I just wanted to

- 1 say just thank you, and Marcy, to you and your staff,
- 2 you're doing absolutely wonderful. Thank you so much for
- 3 all the work. I know we send a lot of chats and a lot of
- 4 emails, but it's just awesome.
- 5 It's seamless. It looks really, really good when
- 6 we're on the -- doing our COI input meetings. So thank you
- 7 so much. Appreciate that. And then I also wanted a big
- 8 thank you to Fredy. I just to do a little back story on
- 9 this oil change, because I don't want people going away
- 10 with the wrong thinking, is Fredy called me and he said,
- 11 hey, there's someone in Sacramento that wants to do an
- 12 interview for the Census Data.
- I said, right now, I'm getting the oil changed on
- 14 my car. He said, perfect, they can come meet you. And so
- 15 I did a quick look to see what I was wearing. I'm like,
- 16 all right. Bring it on. So anyway, thank you, Fredy, for
- 17 getting the word out, and you know, right \*38:34 people
- 18 getting their oil changed and getting interviewed at the
- 19 Honda place. So thank you so much.
- 20 CHAIR AKUTAGAWA: That's why we are called the
- 21 Citizens' Commission. All right. Thank you very much. I
- 22 am not seeing any other hands. So let's move on to our
- 23 Chief Counsel's Report.
- 24 COMMISSIONER AHMAD: Thank you, Chair and
- 25 Commission. I don't have anything to report at this time.

- 1 So I'm happy to have any -- answer any questions the
- 2 Commission may have.
- 3 CHAIR AKUTAGAWA: All right. I'm not seeing any
- 4 hands raised for Chief Counsel. All right.
- 5 All right. Thank you, everyone. Let's go ahead,
- 6 let's go to public comments, since we are now finished with
- 7 Agenda Item No. 3, before we move onto our Committee and
- 8 Subcommittee updates.
- 9 Katy.
- 10 PUBLIC COMMENT MODERATOR: The Commission will
- 11 now be taking public comment on Agenda Item No. 3. To give
- 12 comment, please call 877-853-5247, enter the meeting ID
- 13 number, 87694754343 for this meeting. Once you have dialed
- 14 in, please press \*9 to enter the comment queue. The full
- 15 call in instructions are right at the beginning of the
- 16 meeting and are provided on the livestream landing page.
- 17 And we do not have anyone in the queue at this
- 18 time, Chair.
- 19 CHAIR AKUTAGAWA: If you'll just let us know once
- 20 it's finished streaming.
- 21 PUBLIC COMMENT MODERATOR: Yes
- 22 CHAIR AKUTAGAWA: And then while it does that
- 23 I'll just make a quick announcement. If anybody is
- 24 wondering, our break will take place at 6:30 p.m. So if
- 25 you've been hoping it's earlier, it is scheduled for 6:30

- 1 p.m.
- 2 PUBLIC COMMENT MODERATOR: Instructions are
- 3 completed on the stream, Chair.
- 4 CHAIR AKUTAGAWA: All right. Thank you very
- 5 much, Katy. I don't see anybody who's in queue. So all
- 6 right. We will go ahead and we will move onto our next
- 7 Agenda item, No. 4, Committee and Subcommittee Updates. So
- 8 we'll go ahead.
- 9 We'll start with Government Affairs, and Census
- 10 Subcommittee.
- 11 COMMISSIONER SADHWANI: Thank you. Since our
- 12 last meeting we have been working on a couple different
- 13 pieces we were tasked at the last meeting to continue to --
- 14 CHAIR AKUTAGAWA: Commissioner Sadhwani, we're
- 15 having a hard time hearing you.
- 16 COMMISSIONER SADHWANI: Oh. Can you hear me now?
- 17 CHAIR AKUTAGAWA: We need your podcast voice.
- 18 COMMISSIONER SADHWANI: Oh, yeah. Okay. Hang
- 19 on. Can you -- let me see. Make sure this isn't the echo.
- 20 Is that any better?
- 21 COMMISSIONER TOLEDO (via Zoom): That's good.
- COMMISSIONER SADHWANI: Okay. Great. Thank you.
- 23 So we were tasked with reaching out to the Little Hoover
- 24 Commission regarding their work with following up with the
- 25 Governor's Office, as well as thinking a little bit about

- 1 the legality of the federal prisons issue.
- I think what -- we're talking about federal
- 3 prisons issue later. So I think we should hold onto that.
- 4 Commissioner Toledo, do you want to give the update in
- 5 terms of the Little Hoover Commission --
- 6 COMMISSIONER TOLEDO: Sure. I'm happy to.
- 7 COMMISSIONER SADHWANI: -- the Governor's Office?
- 8 COMMISSIONER TOLEDO: Sure. Happy -- happy to.
- 9 COMMISSIONER SADHWANI: Great.
- 10 COMMISSIONER TOLEDO: So Anthony and I met with
- 11 the Executive Director of the Little Hoover Commission.
- 12 His name is Ethan Rarick, and he explained their current
- 13 efforts to modernize \*42:38, and some of the open meetings
- 14 requirements.
- 15 They did -- or he did clarify that the Little
- 16 Hoover Commission is shifting their advocacy focus to 2022,
- 17 for a 2023 implementation. And so they don't believe that
- 18 the Trailer Bill language will make it through the
- 19 legislature and get signed into law this year. And so
- 20 they're shifting their advocacy effort to get that done in
- 21 2022 for a 2023 implementation.
- He also clarified that they are not working on
- 23 advocacy to update the Executive Order, because that falls
- 24 outside of their purview. Their focus is really not
- 25 executive orders, and so that's not something that they're

- 1 working on, and they are -- or he is not aware of any
- 2 conversations about extending the current flexibilities
- 3 that are about to expire in September.
- And so with that we also -- as you know, we've
- 5 sent off a letter to the Governor's Office in support of
- 6 the Trailer Bill language, as well as the extension of the
- 7 current flexibilities. We've also contacted the Governor's
- 8 Office and did speak with some representatives there.
- 9 And they did express their desire to help us with
- 10 insuring that we can meet our mandate, given the pandemic.
- 11 And so we're hoping to get some favorable news sooner
- 12 rather than later. We're also in the process of drafting
- 13 an op-ed piece to advocate for the extension of -- to
- 14 advocate for some flexibilities and an extension of the
- 15 Executive Order that would allow us to be able to continue
- 16 to work in the format that we are doing, given the pandemic
- 17 and the continuing pandemic, and some of the issues that
- 18 some of our Commissioners are facing, and that the whole
- 19 community is facing, especially with larger gatherings.
- 20 And so we did ask Commissioner Vasquez to give us
- 21 -- provide some context and story to give the op-ed piece
- 22 some -- you know -- a story, right, because an op-ed piece
- 23 needs to have a story to go along with our advocacy
- 24 request. And so -- and I think she has a very -- or we
- 25 think she has a very strong story to tell, and that isn't

- 1 just important to us, but to other Bagley-Keene commissions
- 2 across the government process, and we need to be able to
- 3 continue our open meeting or meetings, and engage the
- 4 public in effective manners for us, in our case, through
- 5 the end of the year, but -- and into the finalization of
- 6 the maps, but for others it's going to be longer-term.
- 7 So that's where we're at, at this point, is
- 8 drafting the op-ed piece, continuing to work with the
- 9 Governor's Office and hoping to get -- at this point it
- 10 seems like we're leading, at this point, we're leading the
- 11 effort to try to get an extension of the Executive Order
- 12 for purposes of Bagley-Keene.
- 13 There may be other entities that are working on
- 14 it, and hopefully, they'll come forward as well, but at
- 15 this point it's us. And I mean, the other entities might
- 16 come to light once -- if and when -- and if we actually do
- 17 publish an op-ed, because that op-ed piece can be used both
- 18 in a letter format to the Governor's Office or in a more
- 19 public manner.
- It depends on how quickly we can get a response
- 21 back from the Governor's Office and some -- I mean, in this
- 22 case some action to guarantee that we'll be able to
- 23 continue on in a hybrid manner, hopefully. I know we all
- 24 want to meet in person and we all want to see how tall we
- 25 are, right.

- 1 And so but we also need to be able to do it
- 2 safely and in a way that everyone is comfortable and
- 3 continue to move this work forward. And it would be very
- 4 disruptive not to be able to do that, and I think that's
- 5 the piece that we're -- I mean, there is even the potential
- 6 threat that we -- that some Commissioners may not be able
- 7 to continue their work if we have to meet in person, right.
- 8 And so that would be incredibly disruptive to our
- 9 Commission and to the work of the people of California.
- 10 CHAIR AKUTAGAWA: Thank you very much,
- 11 Commissioner Toledo, especially because we are literally in
- 12 the home stretch now. So all right. Thank you very much.
- 13 Does anyone have any questions for the Government Affairs
- 14 Committee, Subcommittee? All right. Seeing no other
- 15 hands, right now we'll go onto Subcommittee 4B, which is
- 16 Finance and Administration.
- 17 Commissioner Fernandez or Fornaciari.
- 18 COMMISSIONER FERNANDEZ: We have nothing to
- 19 report at this point -- or nothing of significance. I
- 20 forget what the correct language is.
- 21 VICE-CHAIR FORNACIARI: Nope --
- 22 CHAIR AKUTAGAWA: Thank you very much.
- 23 Appreciate it.
- Okay. Let's go to Subcommittee 4C, the GANTT
- 25 Chart Committee, Commissioners Kennedy or Taylor.

- 1 COMMISSIONER KENNEDY: Chair, it looks like
- 2 Commissioner Fornaciari wanted to -- had his hand up.
- 3 CHAIR AKUTAGAWA: Oh, I'm sorry. Sorry. Okay.
- 4 VICE-CHAIR FORNACIARI: I was just going to say,
- 5 Commissioner Kennedy has a question.
- 6 CHAIR AKUTAGAWA: And Commissioner Kennedy, you
- 7 are up next, because you are the GANTT Chart, one of the
- 8 committee members. So it's -- take it away.
- 9 COMMISSIONER TOLEDO: Thank you. My question for
- 10 Finance and Admin, where are we on the travel policy? My
- 11 recollection is that it was going to go back for some
- 12 further work, but we're -- now that we're looking at
- 13 specific travel dates and potentially some difficult
- 14 combination and so forth, we really need policy to guide
- 15 us.
- So I just wanted to know where we were on the
- 17 work on the travel policy.
- 18 COMMISSIONER FERNANDEZ: So, so the last time we
- 19 brought it forward we -- the Commission did approve the
- 20 policy with some minor edits, and what Commissioner
- 21 Fornaciari and I are going back and we're looking at some
- 22 of the options and some of the language for that.
- I think it was the last four options. So we are
- 24 working on that, but in terms of the final policy we can
- 25 probably forward that to the Commissioners so that they

- 1 have that language.
- 2 VICE-CHAIR FORNACIARI: Yeah. The -- you know --
- 3 if you recall, we're working on some language on -- or
- 4 scenarios, the last few scenarios. We haven't quite
- 5 finished that, but as far as the travel for the -- the
- 6 approval for travel for these meetings, that was part of
- 7 the original approval.
- 8 But and I apologize. It's on me to do the final
- 9 editing and upload it to the policy document, and I haven't
- 10 done that yet. So I will get that done tomorrow.
- 11 CHAIR AKUTAGAWA: All right. Thank you very
- 12 much.
- 13 VICE-CHAIR FORNACIARI: Okay. Thanks
- 14 CHAIR AKUTAGAWA: Mr. Kennedy.
- 15 COMMISSIONER KENNEDY: So as -- on the GANTT
- 16 Chart we've made some progress and I've shared an updated
- 17 version with Commissioner Taylor and gotten some feedback
- 18 from him. I am still looking for a few dates on when
- 19 things actually happen, you know, when VRA Counsel Contract
- 20 actually started, those sorts of things.
- 21 So once I get those further details I'll be able
- 22 to finalize a draft for sharing with the full Commission.
- 23 Basically, you know, we are running significantly late on a
- 24 few things. You know, we -- it just makes the time tight
- 25 now. I don't think it endangers anything. It just means

- 1 that we'll have to keep the pace up. Thank you.
- 2 CHAIR AKUTAGAWA: All right. Thank you very
- 3 much. Any questions for the GANTT Chart Subcommittee?
- 4 Okay. Let's go onto Outreach and Engagement,
- 5 Subcommittee 4 D, Commissioner Fornaciari or Commissioner
- 6 Sinay.
- 7 VICE-CHAIR FORNACIARI: I missed the last meeting
- 8 on Friday. So I'm not sure -- so I don't have anything.
- 9 COMMISSIONER SINAY: Nothing to report.
- 10 VICE-CHAIR FORNACIARI: I don't know if Patricia
- 11 -- or Commissioner Sinay has anything to add.
- 12 COMMISSIONER SINAY: Nope. We're good right now.
- 13 VICE-CHAIR FORNACIARI: Okay.
- 14 CHAIR AKUTAGAWA: All right. Okay. Thank you.
- 15 Let's go on to No. 4E. This is the Materials Development
- 16 Committee, Commissioners Fernandez and Kennedy.
- 17 COMMISSIONER KENNEDY: We've been working with
- 18 the Communications Director on these draft radio scripts.
- 19 We've also prepared a -- kind of a template to -- that
- 20 could be shared with counties so that county redistricting
- 21 websites would include contact information on our website
- 22 address, and an indication of what body is responsible for
- 23 what aspect of redistricting, just because we -- you know -
- 24 our stated intent throughout has been to encourage
- 25 everyone to participate in all levels of redistricting.

- 1 But in order to do that they need easy access to
- 2 information on how to engage in the various levels of
- 3 redistricting. And now, the counties are putting up
- 4 websites that focus, you know, on their county processes,
- 5 but you know, some or many don't have information about the
- 6 statewide redistricting process.
- 7 So we thought that potentially developing a
- 8 template that we could share with them, they might find
- 9 useful and add information on how their citizens could also
- 10 engage in redistricting process with us, i.e., for U.S.
- 11 House seats, State Senate seats, State Assembly seats and
- 12 State Board of Equalization seats. Thank you.
- 13 CHAIR AKUTAGAWA: Commissioner Fernandez.
- 14 COMMISSIONER FERNANDEZ: Can I just --
- 15 CHAIR AKUTAGAWA: Yeah.
- 16 COMMISSIONER FERNANDEZ: Thank you. And then
- 17 just one more thing. I just wanted to get an update from
- 18 Executive Director Hernandez on the paper communities of
- 19 interest. I know that last time we received an update we
- 20 were looking at the postage and working on the copying
- 21 effort for the document.
- 22 CHAIR AKUTAGAWA: Yes. Commissioner -- or
- 23 Director Hernandez.
- 24 COMMISSIONER HERNANDEZ: Yes. So the latest is
- 25 we are working again with the Post Office. We had to make

- 1 some edits to the language versions, and they have to see
- 2 them once again to make sure that they fit their template
- 3 or their formatting that we have to adhere to. Once that
- 4 is cleared, we are ready to go with printing.
- 5 CHAIR AKUTAGAWA: All right. Great. Any
- 6 questions? Not seeing any, I'm going to move on to No. 4F,
- 7 Agenda Item 4F, Website Subcommittee. I believe that is
- 8 Commissioner Kennedy and Taylor.
- 9 COMMISSIONER KENNEDY: Nothing significant to
- 10 report at this point.
- 11 CHAIR AKUTAGAWA: Okay. Thank you very much.
- 12 Next subcommittee is Data Management
- 13 Subcommittee. I do believe we've been anxiously awaiting
- 14 to hear from this one about Airtable. Commissioners Ahmad
- 15 and Turner.
- 16 COMMISSIONER AHMAD: I can provide that update.
- 17 So we don't have anything significant from our end to
- 18 report, but we would like to get some understanding in how
- 19 y'all would want this type of information moving forward,
- 20 given that we have a full data management arm on the
- 21 Commission now.
- So if it's -- it would be helpful for us to
- 23 understand if you also want these updates from us or from
- 24 Alvaro and Tony, who are leading the Data Management piece.
- 25 Other than that, no new updates.

- 1 CHAIR AKUTAGAWA: Okay. Any questions, any
- 2 response to Commissioner Ahmad's question about how we want
- 3 to receive this information.
- 4 Commissioner Fernandez.
- 5 COMMISSIONER FERNANDEZ: I mean, to me it doesn't
- 6 -- I'm indifferent as to how we receive the information. I
- 7 would just like some information in terms of the status of
- 8 Airtable and at some point in time when we can actually
- 9 look at the data, that's my main concern.
- 10 It sounds like Commissioner Ahmad, which I
- 11 completely understand, may want to sunset the subcommittee.
- 12 So I get that. But if it's from admin, that's fine, or if
- 13 it's subcommittee, I just would like an update.
- 14 COMMISSIONER AHMAD: Cool. Then I will turn it
- 15 over to Alvaro.
- 16 COMMISSIONER HERNANDEZ: Thank you. So I don't
- 17 want to steal anyone's thunder, but we do have a
- 18 presentation for you by our Data Manager during the Line
- 19 Drawing portion of this Agenda. So I will -- you'll be
- 20 able to get more information about the Airtable, as well as
- 21 the data.
- CHAIR AKUTAGAWA: Okay. We're looking forward to
- 23 that presentation, then. Thank you.
- Let's move on to Agenda Item 4H, the COI Tool.
- 25 This is Commissioner Kennedy and I. So Commissioner

- 1 Kennedy.
- 2 COMMISSIONER KENNEDY: The main news is the
- 3 opening of the Access Centers. We need to make sure we
- 4 have all of the contact information for those so that their
- 5 \*57:39 can work on getting the news out.
- 6 CHAIR AKUTAGAWA: All right. Thank you very
- 7 much. Let's see. I want to be conscious about order here.
- 8 Next up on our Agenda is the Incarcerated
- 9 Populations conversation or discussion, and we do need to
- 10 hear from the subcommittee, which is Commissioners Kennedy
- 11 and Turner. However, I also want to note -- I think I'm
- 12 going to just --
- 13 Commissioner Kennedy, I know -- I don't think
- 14 Commissioner has returned -- oh, no. She did return.
- 15 Okay. We have 30 minutes to break. One option is, I'm
- 16 thinking that we could quickly see if Lessons Learned,
- 17 Cybersecurity and Legal Affairs Committee, if you all have
- 18 short or no reports to make, so that we could knock those
- 19 out. I'd like to ask about those.
- 20 COMMISSIONER KENNEDY: Nothing significant to
- 21 report from Lessons Learned yet.
- 22 CHAIR AKUTAGAWA: Cybersecurity. I think I saw
- 23 Commissioner Fornaciari shake his head no, and then Legal
- 24 Affairs, Commissioner Sadhwani, Toledo or Yee, do you have
- 25 something to report at this time? Okay. All right. So we

- 1 have just knocked that part out.
- 2 So let's go back to Incarcerated Populations.
- 3 Commissioners Kennedy and Turner, Incarcerated Populations,
- 4 Federal Facilities.
- 5 COMMISSIONER KENNEDY: Chair.
- 6 CHAIR AKUTAGAWA: Yes.
- 7 COMMISSIONER KENNEDY: Chair, it looked like
- 8 Commissioner Fernandez had a question.
- 9 CHAIR AKUTAGAWA: Oh, I'm sorry. Okay. Yes,
- 10 Commissioner --
- 11 COMMISSIONER FERNANDEZ: Thank you for that.
- 12 Thank you, Anthony. I appreciate that, and thank you,
- 13 Chair.
- Just quickly for the Lessons Learned, if we can
- 15 ask -- if we can add, we just recently had received the
- 16 Statewide Database Agreement, and if Lessons Learned, if we
- 17 can do that early on in the game instead of right before
- 18 we're going to receive the Census data.
- 19 So maybe put that in the queue earlier for the
- 20 next Commission. Thank you.
- 21 CHAIR AKUTAGAWA: Are you talking about having
- 22 the Lessons Learned conversation earlier, or are you
- 23 talking about --
- 24 COMMISSIONER FERNANDEZ: No. I'm just saying
- 25 adding it to the list for Lessons Learned so that the 2030

- 1 Commission can queue that at the beginning of the
- 2 Commission versus at the tail end to have an agreement.
- 3 The agreement should be well in advance of Line Drawing.
- 4 CHAIR AKUTAGAWA: Sounds good. All right. Thank
- 5 you very much.
- 6 All right. Commissioner Kennedy and Commissioner
- 7 Turner, I'm going to turn this over; your Subcommittee
- 8 Report on Incarcerated Populations, Agenda Item No. 41.
- 9 COMMISSIONER TURNER: Go ahead, Commissioner
- 10 Kennedy.
- 11 COMMISSIONER KENNEDY: Okay. Following up on the
- 12 last meeting, we did essentially reframe the request to
- 13 Bureau of Prisons. The initial request had gone to Senator
- 14 Padilla's office. Senator Padilla's office facilitated a
- 15 contact with someone in Legislative Affairs Office of
- 16 Bureau of Prisons, and ask that we continue the
- 17 conversation with that contact in Legislative Affairs at
- 18 Bureau of Prisons.
- 19 So the letter was reframed to go to Office of
- 20 Legislative Affairs of Bureau of Prisons. We received --
- 21 we basically stipulated the parameters that we will be
- 22 looking for in any data that we would receive from them to
- 23 be essentially identical to the parameters of the data that
- 24 Statewide Database has received from California Department
- 25 of Corrections and Rehabilitation.

- I had received acknowledgment that the letter has
- 2 been received in Washington and submitted to the higher ups
- 3 in the chain of command, and at this point we are awaiting
- 4 their reply.
- 5 CHAIR AKUTAGAWA: Okay. Commissioner Kennedy,
- 6 let's see. First, I -- well, I guess first I'll just
- 7 start. So my understanding is that a letter has been sent
- 8 to Senator Padilla's Office requesting the data, I believe
- 9 is what I heard.
- 10 COMMISSIONER KENNEDY: No. The letter to
- 11 Padilla's office went out months ago, and we did not hear
- 12 anything for a while. And then we heard that they had
- 13 managed to get a contact for us at the Bureau of Prisons.
- 14 CHAIR AKUTAGAWA: Oh, my apologies. So the
- 15 letter went to the Bureau of Prisons for the data?
- 16 COMMISSIONER KENNEDY: Correct.
- 17 CHAIR AKUTAGAWA: Okay. My understanding from
- 18 the previous meeting's conversation is that we have a
- 19 rather binary choice. It's either we exclude or we
- 20 include, as far as our mandate, but I could be wrong. My
- 21 understanding is that we cannot mandate or instruct the
- 22 Statewide Database, from the last conversation, about what
- 23 else to do with the data.
- I am also very conscious of the inputs that we
- 25 did receive from the Black Census and Redistricting Hub.

- 1 And so I guess it seems like we're at a place that we do
- 2 have to take some kind of action. And so instead of -- I
- 3 mean, I don't think we could just keep pushing along to the
- 4 next meeting.
- I mean, we've just received the Census data. So
- 6 I think we have to decide what is it that we're going to
- 7 have to do. My -- just from my understanding from the
- 8 previous conversations at last meeting, we do have what
- 9 appears to be a more binary choice.
- 10 But I know that we have heard differently from
- 11 other stakeholders. So I -- for me, I just want to put
- 12 that out there. So, Commissioner Kennedy.
- 13 COMMISSIONER KENNEDY: So if you will recall and
- 14 if the public will recall, you know, we -- recognizing the
- 15 time-bound nature of this, I did put a motion forward to
- 16 simply receive the data as provided by the Census Bureau
- 17 and go with that, understanding that that is not our
- 18 desired outcome, but within the time available, you know,
- 19 wanted to help move things along.
- 20 So that motion failed. You know, I'm happy to
- 21 make the motion again tonight, but also happy to hear from
- 22 other colleagues. Again, you know, we know that our
- 23 preferred outcome would be to receive data in a timely
- 24 manner at a sufficient level of quality and with clarity as
- 25 to our ability to seek the reallocation of individuals in

- 1 federal custody.
- 2 Part of the problem with this entire process has
- 3 been, it seems that the line between whether this is a
- 4 legal matter or a policy matter is a very fluid line, a
- 5 very fluid distinction. We've had some input in the sense
- 6 that this is really a legal question.
- We've had other input in the sense that this is
- 8 really a policy question for the Commission to decide, and
- 9 so it kind of leaves us in a very difficult situation. You
- 10 know, if it were clearly a legal question or clearly a
- 11 policy question it would be much easier to address.
- But we're in this situation where we had feedback
- 13 indicating that it is a legal question, feedback indicating
- 14 it is policy question and it just makes it very difficult
- 15 to make progress.
- 16 CHAIR AKUTAGAWA: Thank you for that recap,
- 17 Commissioner Kennedy. That was helpful. I do see
- 18 Commissioner Fornaciari.
- 19 VICE-CHAIR FORNACIARI: Yeah. Thanks,
- 20 Commissioner Kennedy, and I -- I mean, I just, I want to
- 21 echo some of your comments in my thoughts on this. You
- 22 know, I think we all want to do -- we all would love to
- 23 reallocate the prisons appropriate -- or the inmates
- 24 appropriately to their last known addresses, but time is
- 25 not on our side at this point.

- I just -- I can't imagine that time would -- that
- 2 we would have the time to get the data and reallocate the
- 3 data. I -- plus, I would -- in addition, I would imagine,
- 4 even if we got data that we could use, that reallocation
- 5 would have to come at the end, after the Statewide Database
- 6 has already done the work that they needed to do for the
- 7 state.
- 8 And so we would be, in addition, eating into our
- 9 Line Drawing time, which is unclear how much Line Drawing
- 10 time we have. And I believe -- you know -- my read on it
- 11 is, you know, with Commissioner Akutagawa, it's a binary
- 12 choice at this point.
- 13 And so neither option is -- I think is great, but
- 14 I think that's where we're at. And I think in addition to
- 15 that, we have all agreed that, you know, working forward
- 16 for the next Commission to have in place the capability to
- 17 do the reallocation is what we're committed to do.
- 18 So given all that and, you know, given, you know,
- 19 the motion from last week that didn't pass, I'm going to
- 20 make a different motion. I'm going to move that we do
- 21 what's recommended by the state, to do -- that we do what
- 22 is required by the local municipalities, and that is to not
- 23 count the prisons.
- 24 So my motion is to -- is that we not count the
- 25 prison -- the inmates in federal custody. And I'll just

- 1 point out that that's consistent with the Black
- 2 Redistricting Hub's letter that we got. I mean, they --
- 3 that's Option 3 that they gave us.
- But you know, they have very strong position on
- 5 this, that if we can't allocate the prisoners -- the
- 6 inmates in some way, that we exclude them. And so I'm --
- 7 that's the motion I'm going to make.
- 8 CHAIR AKUTAGAWA: Commissioner Turner, is comment
- 9 or a second?
- 10 COMMISSIONER TURNER: Both.
- 11 CHAIR AKUTAGAWA: Okay.
- 12 COMMISSIONER TURNER: I'd like to second the
- 13 motion, and I'd also like to say that this has been a very
- 14 difficult discussion and decision to come to, or even just
- 15 -- I've gone back and forth. I am excited for Californians
- 16 everywhere, particularly those that are incarcerated, that
- 17 we do have a plan moving forward to be insured for 2030
- 18 that we're not in the same position that we're in today.
- 19 Timing is an issue. Choices that we have,
- 20 information, data that we have is problematic, and I think
- 21 everyone did what they could to get the information that's
- 22 needed, including just still inquiring to see what
- 23 information can be received.
- 24 But for us, at the level of work that we need,
- 25 it's -- what we need really won't happen in a timely

- 1 manner. And so we're left with the choice, the binary
- 2 choice and we don't like either of them, necessarily, and
- 3 it gets down to then just kind of what side you weigh out
- 4 on.
- 5 And I do second the motion of having them
- 6 excluded from where they currently reside, having the
- 7 inmates excluded.
- 8 CHAIR AKUTAGAWA: Thank you very much,
- 9 Commissioner Turner.
- 10 Okay. I see Commissioner Sinay and then
- 11 Commissioner Fernandez and then Commissioner Kennedy.
- 12 COMMISSIONER SINAY: I just want to support what
- 13 Commissioner Turner said. I think this has been, you know,
- 14 just a tough conversation. The aspiration that we all
- 15 have, you know, we're not being able to meet it and so
- 16 we're hard on ourselves.
- But we -- I -- you know -- I want to commend
- 18 everybody for the efforts that were done, especially
- 19 Commissioner Kennedy and Commissioner Turner, you know, on
- 20 getting us this far. And I think what it tells me is that
- 21 2030 is going to be different and that's really exciting.
- I also want to remind everyone that we have made
- 23 inroads into facilities -- the state facilities to get
- 24 communities of interest maps from people who are
- 25 incarcerated. And so you know, we -- that is something new

- 1 and -- since that wasn't done last time.
- 2 And so, please, anyone who can help us get -- you
- 3 know -- share it with families, share -- we're really
- 4 looking forward to getting that input. So as much as we
- 5 feel like we're not hitting the full goals that we were
- 6 hoping, our aspirational goals, we have done leaps in 2020,
- 7 and I'm proud of all of us.
- 8 CHAIR AKUTAGAWA: Commissioner Fernandez.
- 9 COMMISSIONER FERNANDEZ: Yes. I was just going
- 10 to ask for some language maybe change, if it's acceptable.
- 11 I would like to note that it's incarcerated people in
- 12 federal facilities. I really try to stay away from inmates
- 13 or prisoner language. That's my only suggestion.
- 14 Hopefully, it'll be accepted by those that made the motion
- 15 and seconded.
- 16 CHAIR AKUTAGAWA: Thank you for the good
- 17 reminder, Commissioner Fernandez.
- 18 VICE-CHAIR FORNACIARI: I'd ask Alvaro to show
- 19 the language that Alvaro interpreted what I said, I think,
- 20 in a way I think's appropriate, and consistent with what
- 21 you said.
- 22 EXECUTIVE DIRECTOR HERNANDEZ: I certainly try.
- Here we go.
- 24 CHAIR AKUTAGAWA: Commissioner Fernandez, does --
- 25 does that reflect what you were hoping it would reflect?

- 1 COMMISSIONER FERNANDEZ: Yes, and California
- 2 Federal Prisons, can we just be a little bit more specific,
- 3 since there are federal facilities. Thank you.
- 4 CHAIR AKUTAGAWA: All right. So Commissioner
- 5 Kennedy, I have you next.
- 6 COMMISSIONER KENNEDY: Thank you, Chair. You
- 7 know, I just want to say that, you know, I have perhaps
- 8 been -- excuse me -- tilted at windmills in this effort,
- 9 trying to go where others said it was impossible to go.
- 10 You know, I'm happy that we do seem to have made more
- 11 progress than others thought possible.
- I will say that, you know, my -- I continue to be
- 13 guided by what is on page 3 of the Black Redistricting
- 14 Hub's letter listed as number one of two inextricably
- 15 connected and equally important principles. Number one,
- 16 that everyone is counted.
- 17 And so you know, I will continue to feel that the
- 18 best option available to us, not our ideal, not our
- 19 preferred option, but the option that implements principle
- 20 number one as laid out in that letter is that we take the
- 21 data as received from the Census Bureau, which has
- 22 individuals in federal custody counted at their place of
- 23 incarceration, and go with that data.
- 24 And again, this is not my preferred solution. I
- 25 had fought for a different solution, but given all of the

- 1 parameters and constraints and in line with what is set out
- 2 as principle number one in that letter, I will continue to
- 3 advocate that we count the people.
- 4 I just -- I find that not counting people wins
- 5 too much of Indians not taxed and three-fifths of a person.
- 6 So that is my rationing. Thank you.
- 7 CHAIR AKUTAGAWA: Thank you very much,
- 8 Commissioner Kennedy, and I think we all do very much
- 9 appreciate what you have done, and I think ideally, from
- 10 the conversations that we've all had, I think that is what
- 11 we would like to see happen.
- I want to make sure that we also insure that any
- 13 other Commissioners who want to speak up -- okay. I --
- 14 Commissioner Taylor, I believe -- Okay. Thank you. You
- 15 have your hand up.
- 16 COMMISSIONER TAYLOR: Yes. Thank you. And
- 17 excuse me for the poor Internet connection tonight. I just
- 18 want to quickly just concur with Commissioner Kennedy. I
- 19 just find that objective number one is to have everyone
- 20 counted, and if we look at the mathematics of it all, I
- 21 think over-represented is a lesser evil than not
- 22 represented at all or under-represented. Thank you.
- 23 CHAIR AKUTAGAWA: Thank you, Commissioner Taylor.
- 24 Commissioner Andersen.
- 25 COMMISSIONER ANDERSEN: Thank you, everyone, and

- 1 this is -- as Commissioner Turner eloquently said, this has
- 2 been a very, very difficult conversation, because we all
- 3 want -- you know -- this around. Remember, everyone, we're
- 4 actually reallocating all the state prisoners at this time.
- 5 That's not happened in 2010.
- 6 This is the first time. This is a huge deal,
- 7 which is great. We also wanted to do the federal
- 8 prisoners, and unfortunately, the data was like, well, nice
- 9 idea, too bad. And all of a sudden, right at the last
- 10 minute, oh, we have some data, but it's inconsistent. We
- 11 don't know what it is and it really is a problem.
- 12 So the issue with do we include everyone or
- 13 exclude everyone, the local redistricting may not. There
- 14 will be a separate database which has all the state
- 15 prisoners reallocated. And even if we say -- if we say,
- 16 hey, we're going to -- we are going to count federal
- 17 prisoners, that means our database will be different.
- 18 And that's -- I think I want everyone to know
- 19 that this is why it's a -- we are really grappling with an
- 20 issue here, because absolutely, as Commissioner Kennedy and
- 21 Commissioner Taylor have said, we want everyone to count.
- 22 However, despite what we want, that won't affect the local
- 23 redistricting, because that's the way the law is written
- 24 and it couldn't change.
- That's why 2030, wow, it's going to be different.

- 1 The legislature's actually asked, you know, for hey, let's
- 2 work on some -- the proper wording to go through some
- 3 legislation change. And I think with that in mind, the way
- 4 it was written, we need to exclude, which I hate doing, but
- 5 it would be a different data set.
- 6 And I have a problem with having two sets of data
- 7 just because of the issues there -- that involve. Like our
- 8 numbers would be slightly different than the county's and
- 9 the local. Now, I know that's not our job. It's a
- 10 different direction, but it is -- it's a little -- it's a
- 11 slight botheration, which is why I believe we've gone ahead
- 12 and said, hey, we need to exclude them.
- 13 And I just wanted to bring forward, this is not
- 14 what we want to do. This is what, as by law right now, I
- 15 believe the local can't consider them. And you know, I
- 16 understand the idea that we'd really like to, but I think
- 17 it does have a set of issues with it. Thank you.
- 18 CHAIR AKUTAGAWA: Okay. I am -- let's see. I'm
- 19 just making sure I'm not missing anybody. All right. I do
- 20 want to just echo everybody's comments. I think, as I
- 21 said, I think we all definitely want to insure that
- 22 everybody is counted, everybody is included, and at the
- 23 same time our options are not super great.
- I also want to acknowledge the Black Census and
- 25 Redistricting Hub. They did lay out some options, the

- 1 third one being, obviously, the least preferred, but if we
- 2 have to come down to making a choice, they also did
- 3 recommend that we exclude versus include. So I do want to
- 4 just -- for me -- just note that that's something that I
- 5 took away from their letter.
- 6 Commissioner Turner, did you --
- 7 COMMISSIONER TURNER: I just want to add in, in
- 8 addition, I believe also signed on was the Prison Policy
- 9 Initiative. That was part of that same letter.
- 10 CHAIR AKUTAGAWA: Yes. Thank you for
- 11 acknowledging them, as well, too. And then I also do want
- 12 to note that they did send in an additional comment that
- 13 was noted or added to the handouts for this meeting. So
- 14 there is some additional comments that were added in. So
- 15 okay.
- I know that we do need to -- I want to go to
- 17 public comment before we go to the vote.
- 18 So Katy. And this is on this Agenda item on this
- 19 particular vote.
- 20 VICE-CHAIR FORNACIARI: You mean action item.
- 21 CHAIR AKUTAGAWA: I'm sorry. The action --
- 22 (Three people speaking)
- 23 PUBLIC COMMENT MODERATOR: On the agenda?
- 24 CHAIR AKUTAGAWA: -- for the motion on the
- 25 Agenda, yes, on Incarcerated Populations in Federal

- 1 Facilities.
- 2 PUBLIC COMMENT MODERATOR: Got it. The
- 3 Commission will now take public comment on the motion on
- 4 the floor for Agenda Item 4I. To give comment please call
- 5 877-853-5247, enter the meeting ID number, 87694754343 for
- 6 this meeting. Once you have dialed in please press \*9 to
- 7 enter the comment queue.
- 8 The full call in instructions are read at the
- 9 beginning of the meeting and are provided in full on the
- 10 livestream landing page. And at this time we do not have
- 11 any callers, and we will let you know as soon as the
- 12 instructions are complete, Chair.
- 13 CHAIR AKUTAGAWA: Thank you, Katy.
- 14 PUBLIC COMMENT MODERATOR: And we do have a
- 15 caller at this time. Caller 3818, if you'll please follow
- 16 the prompts to unmute at this time. The floor is yours.
- MS. GARNER: Hello, Commission. This is Grace
- 18 Garner again, calling from the Black Census and
- 19 Redistricting Hub. I just wanted to clarify our position.
- 20 You know, we do list those two inextricably connected and
- 21 equally important principles that everyone is counted and
- 22 they are counted in the most equitable way possible.
- 23 And they can't really -- they can't be separated,
- 24 and that's why we favor Option 3 if you -- based on what
- 25 the two options are that you're looking at, when you

- 1 include people at the location of the facility you're
- 2 giving an oversized reach to those -- that community.
- 3 So we would prefer that it was excluded when
- 4 you're looking at those two options, because again, it's
- 5 everyone is counted in the most equitable way possible, and
- 6 those two cannot be separated. Thank you for much for your
- 7 work on this.
- 8 We understand that it is very difficult and we
- 9 really appreciate the attention that you've been giving to
- 10 the issue, and all of the work that's been done to get this
- 11 data for the next group. Thank you so much.
- 12 CHAIR AKUTAGAWA: Thank you very much, Ms.
- 13 Garner. We appreciate your help and your comments on this
- 14 issue.
- 15 PUBLIC COMMENT MODERATOR: That was all of our
- 16 callers at this time, Chair.
- 17 CHAIR AKUTAGAWA: Okay. Then I believe, seeing
- 18 no one else calling in, all right, I believe we are ready
- 19 to take the vote.
- 20 EXECUTIVE DIRECTOR HERNANDEZ: Yes, Chair. So
- 21 we'll begin the vote now.
- 22 Commissioner Ahmad.

- 16 COMMISSIONER LE MONS: Yes.
- 17 EXECUTIVE DIRECTOR HERNANDEZ: Commissioner
- 18 Sadhwani.
- 19 COMMISSIONER SADHWANI: Yes.
- 20 EXECUTIVE DIRECTOR HERNANDEZ: Commissioner
- 21 Sinay.
- 22 COMMISSIONER SINAY: Yes.
- 23 EXECUTIVE DIRECTOR HERNANDEZ: Commissioner
- 24 Taylor.
- 25 COMMISSIONER TAYLOR: No.

- 1 EXECUTIVE DIRECTOR HERNANDEZ: Commissioner
- 2 Toledo.
- 3 COMMISSIONER TOLEDO: Yes.
- 4 EXECUTIVE DIRECTOR HERNANDEZ: Commissioner
- 5 Turner.
- 6 COMMISSIONER TURNER: Yes.

- 13 a simple majority. So the motion passes.
- 14 CHAIR AKUTAGAWA: Okay. Thank you very much,
- 15 everyone. I just want to acknowledge first off the work
- 16 that Commissioner Kennedy and Turner did. I also know that
- 17 there were other, you know, very robust discussions that
- 18 took place last week amongst all of the Commissioners.
- 19 And I know that this is something that, you know,
- 20 ideally we -- again, we wanted something different. It's
- 21 not necessarily one that we make easily, but I do want to
- 22 thank everybody for all of your very considered and very
- 23 thoughtful discussion around this.
- 24 And so -- and I will also say that I'm glad that
- 25 we were able to make a decision, because I do believe we

- 1 needed to do just that. So thank you everyone for that.
- 2 With that, I know that we do need to take a break. And so
- 3 we will see everybody back at 6:46.
- 4 (Off the Record at 6:31 p.m., until 6:45 p.m.)
- 5 CHAIR AKUTAGAWA: All right. Thank you,
- 6 everyone. I hope you had a nice break, even if it was
- 7 brief feeling. All right. So what we're going to do is we
- 8 have completed all of the report outs on the committees and
- 9 subcommittees. We will take public comment on Agenda Item
- 10 No. 4.
- 11 And Katy, I'm going to ask you to make an
- 12 announcement about it.
- MR. MANOFF: I can help you with that, Chair.
- 14 CHAIR AKUTAGAWA: Oh, thank you, Kristian.
- 15 MR. MANOFF: You got it. The Commission will now
- 16 take public comment on Item No. 4. To give comment please
- 17 call 877-853-5247, and enter meeting ID number 87694754343
- 18 for this meeting. Once you've dialed in, please press \*9
- 19 to enter the comment queue.
- The full call in instructions are read at the
- 21 beginning of the meeting and are provided on the livestream
- 22 landing page. And we do not have any comments at this
- 23 time, Chair.
- 24 CHAIR AKUTAGAWA: All right. We'll give
- 25 everybody a moment to catch up and call in if they have any

- 1 questions.
- Welcome back to the camera, Commissioner Sinay.
- 3 COMMISSIONER SINAY: Thank you.
- 4 MR. MANOFF: Those instructions are complete on
- 5 the livestream, Chair.
- 6 CHAIR AKUTAGAWA: All right. Thank you so much,
- 7 Kristian.
- 8 Okay. Well, let's go ahead. Let's keep moving
- 9 on to our next Agenda Item, which is No. 5, Line Drawer
- 10 Committee, Commissioners Andersen and Sadhwani, and I do
- 11 believe this is where Executive Director Hernandez
- 12 mentioned our new data manager is also going to explain the
- 13 Airtable, I believe.
- So Commissioner Andersen or Sadhwani. On, no,
- 15 she's not back yet. Commissioner Andersen.
- 16 COMMISSIONER ANDERSEN: I was glad you were going
- 17 to have Commissioner Sadhwani do the intro here. So I will
- 18 jump in. Yes. Thank you to -- if you -- all the public
- 19 and the Commissioners. It does say Item 5, Review COI
- 20 Submission.
- 21 And we, of course, have been waiting for Airtable
- 22 to be able to do this. And so at this point, basically,
- 23 we're going to have our new data manager, Toni Antonova --
- 24 hopefully, I spelled that -- pronounced that correctly --
- 25 will actually give us a presentation on where we are and

- 1 what we have so far, and then we also will do a little bit
- 2 more in terms of how we're going to be looking at this from
- 3 the Line Drawing perspective.
- And I do want to say that we'll -- in terms of
- 5 reviewing the COI submissions, this will actually start up
- 6 next week, and with great detail. And so this is our
- 7 introduction, and at that point I'm just going to turn it
- 8 over to our wonderful data manager.
- 9 MS. ANTONOVA: Thank you for that introduction,
- 10 Commissioner Andersen. I am going to share my screen and
- 11 show a bit of a preview of what we have been working on, on
- 12 the Data Management Team. We have spent the last week
- 13 really working to get all of the public input into a --
- 14 into one central location and that the public can access,
- 15 and we are aiming to kind of finish this process by the end
- 16 of next week.
- We're building a tool that the public can
- 18 interact with and to explore the data that's coming in.
- 19 Let me know if you can't see my screen for some reason.
- 20 This is a preview of the tool that we have been working to
- 21 put together. We want to share, you know, all of the data
- 22 that has been coming in, in an accessible way.
- 23 So along with a view of the data and a table
- 24 Excel-like format that you'll see on the left, we're also
- 25 putting together a map that you can interact with and

- 1 explore and zoom in on different regions. And I'll kind of
- 2 show how that works here.
- 3 You can see that, you know, that this map will
- 4 show how many submissions are coming from different areas
- 5 of California, and you'll be able to play around with it,
- 6 zoom in on the region that you're interested in, actually
- 7 click on the record and see what the person has written,
- 8 and the map that they may have drawn or attached.
- 9 You know, this is -- oops. Sorry about this.
- 10 Please make this app bigger or full screen. Oh, there we
- 11 go. You know, I think for some this may be the main way
- 12 that they prefer to interact with the data, and it's pretty
- 13 intuitive and kind of fun to play around with.
- 14 For those that might want a bit more of an Excel
- 15 view and to dive into all of this [sic] missions and some
- of the metadata fields, we'll have this table on the right,
- 17 and you know, you can scroll through and see a summary of
- 18 the submission and a number of different fields, along with
- 19 the shape file, which is the -- basically, the map that the
- 20 person has inputted into Drawmycaliforniacommunity.org.
- 21 And this tool will allow people to, you know, do
- 22 a number of functionalities that you typically find in
- 23 Excel. You can filter on different fields. For example,
- 24 if you want to look at all of the letters that came in, you
- 25 can do that here, all of the emails and so on.

- 1 Public input that come in through live meetings
- 2 will also be here, and you can take a look at that, as
- 3 well. And yeah, that's the end of my update. I want to
- 4 keep it quick. I'm happy to answer any questions. For
- 5 context, the data that is here at the moment is not updated
- 6 as of a couple weeks ago, and that's what we are diligently
- 7 working on, to get access and put this on the website by
- 8 the end of next week. Thank you.
- 9 CHAIR AKUTAGAWA: Thank you, Toni. Okay.
- 10 Questions.
- 11 Commissioner Fernandez and then Commissioner Yee.
- 12 COMMISSIONER FERNANDEZ: Thank you so much, Toni.
- 13 This is wonderful. You went through the filtering really
- 14 quick. Like what area -- what are the different filter
- 15 options?
- 16 CHAIR AKUTAGAWA: You're on mute, Toni.
- MS. ANTONOVA: So the columns that we're going to
- 18 include in this phase of the data release, you'll actually
- 19 find them here in the filters, or actually, I can show them
- 20 here. So you can basically filter on anyone of these
- 21 columns.
- There's a submission date, the source of the
- 23 submission. So you know, that's whether it's an email, a
- 24 letter, whether it comes directly from
- 25 drawmycacommunity.org or a live meeting; a summary of the

- 1 submission.
- 2 Most of the time this is, you know, a direct,
- 3 like, copy paste of what the person has sent in.
- 4 Sometimes, it's a paraphrased summary, any attachments that
- 5 come with it and a PDF of the drawmycacommunity.org
- 6 submission, and so on. These last two fields are metadata
- 7 that help generate the map.
- 8 And you can filter on anyone of them. So you
- 9 know, I used the submission source, because that might be
- 10 easier to do. Another way to interact with the data is
- 11 actually to search right here. So you know, maybe you want
- 12 to look at input that mentions Fresno, you can do that
- 13 here.
- Maybe I'll exit out of this. You can see here, I
- 15 can go through those different inputs. You know, maybe you
- 16 want to look at input that mention water rights. You can
- 17 type that in here, as well. We are -- you know -- after
- 18 this release we're going to be working on a kind of second
- 19 phase release, and there, you know, we'll be discussing any
- 20 additional, maybe more exciting features that we can add to
- 21 this tool.
- 22 COMMISSIONER FERNANDEZ: Thank you, Toni.
- 23 CHAIR AKUTAGAWA: All right. Thank you very
- 24 much. I have Commissioner Yee, followed by Commissioner
- 25 Turner.

- 1 COMMISSIONER YEE: Thank you so much, Toni. Wow.
- 2 This is super exciting. I've started looking at Airtable.
- 3 I'm wondering also about the search ability, and so I'm
- 4 thinking, you know, when we actually get to redistricting,
- 5 you know, drawing maps in different specific places, how to
- 6 group the input.
- 7 So the example you have or had there, Kettleman
- 8 City. You know, you can search on Kettleman City. You can
- 9 search on Kings County and you can search on any of those
- 10 other towns around Kettleman City. That's a lot of, you
- 11 know, searching to keep in mind.
- 12 So I'm wondering how -- can you search by map,
- 13 for instance, you know, kind of the way Yelp works. Give
- 14 me all the input for the current map view. You know, I'm
- 15 just trying to think, when we actually start mapping, I
- 16 mean, that's kind of -- you know -- sets of data that we'll
- 17 want, I think, right.
- 18 So everything that had to do with the whole area
- 19 around Kettleman City, whether or not it mentions Kettleman
- 20 City, right. And so how do we search like that?
- 21 MS. ANTONOVA: I'm happy to kind of provide a
- 22 response. You know, in the second phase of this I'll be
- 23 working with the Line Drawing organizations to figure out
- 24 what -- you know -- what they need to do analysis best, and
- 25 to make it easier to ingest all the information in this

- 1 data.
- 2 During that period of time, you know, on -- we
- 3 will be annotating and tagging each one of these data
- 4 entries with information like, you know, what neighborhoods
- 5 are mentioned, what cities, counties and any -- you know --
- 6 even maybe distinctive landmarks, things like that.
- 7 And so once we get that process going that may be
- 8 -- you know -- pieces -- that may be something that we can
- 9 add to this public view, as well, and that's a work in
- 10 progress with the Line Drawers and the Line Drawing
- 11 organizations.
- 12 COMMISSIONER YEE: Thank you.
- 13 CHAIR AKUTAGAWA: All right. Thank you very
- 14 much. We have Commissioner Turner, followed by
- 15 Commissioner Sadhwani.
- 16 COMMISSIONER TURNER: Yeah. I want to say, I
- 17 just felt like there should have been like drum roll, et
- 18 cetera. Toni kind of talked about it in this is this and
- 19 this is that, but I'm like, woo-who. This is amazing
- 20 information, and I just wanted to say thank you so much.
- 21 I'm so excited to have you on board, Toni, and
- 22 the entire team, and this is such an easy system to look
- 23 and search and be able to find what was previously
- 24 submitted. And I love, Commissioner Yee, what you just
- 25 suggested, to be able to get a map view, as well.

- 1 But I just wanted to celebrate a minute the tool
- 2 that we're finally looking at. Thank you.
- 3 MS. ANTONOVA: Thank you.
- 4 CHAIR AKUTAGAWA: Yes, I echo that. Thank you,
- 5 Commissioner Turner, for pointing that out.
- 6 Commissioner Sadhwani, I have you next.
- 7 COMMISSIONER SADHWANI: Yes. Thank you. And you
- 8 know, I want to reiterate and echo Commissioner Turner's
- 9 like, woo-who, because this is -- we've been waiting for
- 10 this for a long time. And Toni, amazing. I mean, you've
- 11 been on board for, what, one week, 10 days, something like
- 12 that.
- 13 So incredible, incredible work. I apologize. I
- 14 wasn't back yet when Commissioner Andersen tipped off this
- 15 session, but I did also just want to interject here a
- 16 little bit, because I'm hearing in Commissioner Yee's
- 17 question, there's a technical aspect to it of how exactly
- 18 is this going to work.
- 19 But then there's also a time line aspect, and so
- 20 I wanted to just share a little bit about the time line
- 21 that we are anticipating over the next couple weeks and
- 22 months. Commissioner Andersen and I have been meeting with
- 23 Toni and the Data Management Team, as well as with the Line
- 24 Drawers.
- 25 The Line Drawers, of course, also need to make --

- 1 we need to make sure that they have access to all of the
- 2 information that we are receiving. And so we're really
- 3 trying to just make sure that this is a seamless process.
- 4 And then the other pieces, we -- because we've been waiting
- 5 for such a long time, we wanted to really map out how we as
- 6 Commissioners, as well as the public, will be receiving
- 7 this information and digesting it, right, and hopefully
- 8 digesting it.
- 9 There's a lot in there. We have been waiting for
- 10 the COI tool submissions for quite a while. And so I
- 11 wanted to just offer up what Commissioner Andersen and I
- 12 have kind of come up with as a sketch for moving forward
- 13 over the next couple weeks.
- We didn't -- we were literally laying this out
- 15 this morning once we saw what was available and what Toni
- 16 had gotten done since Tuesday, which was a whole lot. So
- 17 we didn't have a chance to write this up as a memo or
- 18 anything more formal, but I wanted to share with you kind
- 19 of our thinking, and also get feedback.
- 20 And so, you know, today is August 19th. Our next
- 21 agendized meeting is -- business meeting is August 31st.
- 22 And so our intention is that by August 27th, which is a
- 23 Friday of next week, the Data Management Team will have
- 24 completed uploading all of the -- and maybe it's not
- 25 exactly uploading -- inputting all of the information into

- 1 Airtable, as well as have that publicly available on our
- 2 website.
- 3 That is out goal. August 27th, of course, is a
- 4 Friday, which means clear some time in your weekends, my
- 5 friends, because we're hoping that on August 31st at our
- 6 meeting we would take our first kind of deep dive into some
- 7 of this data.
- 8 What we are anticipating, we've had a number of
- 9 conversations with the Line Drawers about how do we best do
- 10 this. We will give you a little bit of homework. So on
- 11 the 27th be prepared to get a little homework from us about
- 12 how the 31st will exactly run.
- But we wanted to jump right in and, you know,
- 14 take, of course, the easiest part of the State of
- 15 California, which is L.A. County, and begin to take a look
- 16 at L.A. County. We know that there's a whole lot of COI
- 17 submissions in L.A. County.
- 18 We know that there will in the long run be a lot
- 19 of ERA considerations in the county, as well. Moving
- 20 forward, we anticipate exploring the input in Airtable by
- 21 using the mappers regions, right. So the Q2 Haystack Team,
- 22 as you all know, have a number of different mappers.
- Jaime Clark, of course, is one of them, and we've
- 24 seen her often and she is most certainly a senior member of
- 25 that team. Jaime is assigned to Los Angeles, and that's a

- 1 part of why we thought it would make a lot of sense to
- 2 start there, in addition to, of course, L.A. has so many
- 3 other pieces.
- 4 Other mappers, Tamina, Willie and John, represent
- 5 more than one outreach zone, and so moving forward in our
- 6 future dates on September 7th and on September 11th, which
- 7 was a day that was added and is also a Saturday, we will
- 8 look at areas of California based on those mappers'
- 9 assignments. So that's multiple zones together.
- 10 Exactly which date -- which zones when is to be
- 11 determined, but that is kind of the direction that we're
- 12 thinking. And on August 31st we will start, actually, that
- 13 meeting with a training on how to use Airtable. And I
- 14 think, you know, we're hoping that everyone plays around
- 15 with it over the weekend next week, once it's live on the
- 16 27th.
- We want to make sure, also, that there's an
- 18 opportunity both for Commissioners and the public to get
- 19 the proper training on how to use this tool, how to access
- 20 the information. So we anticipate that the 31st will start
- 21 out with a training done, you know, starting off with Toni
- 22 and the Data Management Team, followed by kind of this --
- 23 the transition from Airtable Data Management to Mappers.
- And so I anticipate Jaime's also going to have a
- 25 little touch base on some of this training, as well. We're

- 1 still working out all of the kinks there, and then we would
- 2 kind of do a deep dive in L.A. County and review the
- 3 submissions that we have.
- 4 And Commissioner Andersen, please jump in,
- 5 because that's a lot of information, and I probably forgot
- 6 something.
- 7 COMMISSIONER ANDERSEN: No. Commissioner
- 8 Sadhwani did a great job, which is why I was going to have
- 9 her lead off. Just a couple of items. When you're looking
- 10 -- and Commissioner Yee, you're saying, well, how do we
- 11 look at this by area?
- 12 One of the easiest ways, you'll notice Airtable,
- 13 that is our PinMap. Now, this will ultimately be on our
- 14 website, a link to it will be on the website. So the
- 15 public can actually -- a PinMap. Oh, where are those --
- 16 you know -- all those reds dots and things, they represent
- 17 not just Communities of Interest that have come in through
- 18 the COI tool, but Communities of Interest that have come in
- 19 from all sources.
- 20 And in terms of where they're located, that's
- 21 actually by essentially the center of -- basically, the
- 22 very center of whatever the community of interest is. So
- 23 if it's city, it's probably like somewhere in the middle of
- 24 the city. If it's several counties, it's in a geographic
- 25 center of those several counties.

- 1 So that's just in the way -- in terms of our,
- 2 when you're looking at it, you know, quick way to search by
- 3 area is look at the map. Then you've already looked
- 4 through the dates and the full information will be there,
- 5 and we'll give you -- as of right now, it's only a certain
- 6 amount.
- And when you're saying, well, this view that
- 8 we're looking at now may or may not be exactly what the
- 9 public sees. In terms of other categories, other ways, our
- 10 little drop down of just looking at it by letter, email,
- 11 that sort of option, which are very readily available, and
- 12 then other searches, it probably might have a few more
- 13 things in it.
- 14 We want to work with the Line Drawers and have
- 15 Data Management work together on that to make it the most
- 16 useful, and without being too crowded. So that's basically
- 17 all I had to say on that. So this is sort of an intro, and
- 18 then any other questions, which I'm sure there will be
- 19 several of.
- 20 CHAIR AKUTAGAWA: We do have several questions.
- 21 We have Marcy first or Director Kaplan first, or Director
- 22 Kaplan first and then also Commissioner Sinay next after
- 23 her.
- 24 OUTREACH DIRECTOR KAPLAN: I just had a very
- 25 quick note, if we're able to time stamp the training that

- 1 Toni's going to do so that we can push it out with the
- 2 Outreach Team, also, because I imagine there's a lot of
- 3 people who will want to listen in. Thank you.
- 4 CHAIR AKUTAGAWA: Thank you. Great suggestion.
- 5 Commissioner Sinay.
- 6 COMMISSIONER SINAY: I'm really, really excited,
- 7 but I also want to bring in a piece of reality into all of
- 8 this. We have, if I heard correctly, 1400 Communities of
- 9 Interest, which sounds like a lot, but it really is a drop,
- 10 and it's not a drop in the bucket to what our goal was.
- 11 And this was one of my concerns, that if we focus
- 12 so early on doing Communities of Interest public meetings,
- 13 we were going to forget the tool and really pushing, you
- 14 know, using the tool. And it's my understanding is that
- 15 1400 is both what's come in through the COI, as well as
- 16 some of the input we have.
- 17 And so I think it is -- it's really critical, you
- 18 know, how good -- you know -- the database can only be as
- 19 robust as the data that gets put in it. And so I would
- 20 like to put out there, what are we going to do, you know.
- 21 You know, we're already jumping into Line Drawing, but we
- 22 still don't have all the COIs, you know, the diversity of
- 23 COIs that we need from all the different regions.
- 24 And that really needs to be a priority, and I
- 25 don't see us galvanizing around that and strategizing on

- 1 how we're going to do that.
- 2 CHAIR AKUTAGAWA: Thank you, Commissioner Sinay.
- 3 Any other hands? Commissioner Andersen.
- 4 COMMISSIONER ANDERSEN: I was just going to say
- 5 something about, it's a very good point, Commissioner
- 6 Sinay, and one of the reasons why the -- we're trying to
- 7 get the PinMap out early is it's graphic. People can say,
- $8\,$  oh, I don't see enough bubbles in my area. And hopefully -
- 9 and we can all see where we don't have a lot of input.
- Now, one thing that did happen, you know, a lot
- 11 of people, no matter what we were doing, until the Census
- 12 data came -- got -- came out they weren't paying attention.
- 13 And so I'm hoping that by seeing the PinMap shortly after
- 14 the Census data, you know, people are starting to pay
- 15 attention and they might say, oh, goodness gracious.
- 16 And then I think it was you actually suggested
- 17 that those last couple of days we might get a lot more
- 18 Community of Interest input on those September days. But
- 19 then, we will throughout the entire process of Line Drawing
- 20 be getting Communities of Interest as well as maps.
- 21 So I -- but you're right. In terms of, you know,
- 22 our advertising, everything will come in as far as our
- 23 outreach. But that is one of the reasons to have the
- 24 PinMap out there, and everyone will have a good look at
- 25 that.

- 1 CHAIR AKUTAGAWA: I see Commissioner Fornaciari
- 2 next.
- 3 VICE-CHAIR FORNACIARI: Yes. Sounds like a good
- 4 topic of conversation for our Outreach Committee Meeting
- 5 tomorrow, strategizing on how we're going to take a look at
- 6 this data and move forward to fill in those gaps. I do
- 7 think, though, also, that, you know, a lot of the input is
- 8 going to be coming -- a lot more input will be coming once
- 9 there are maps to react to.
- And so, you know, we'll be getting to see that
- 11 and input in different ways, right. I guess the reason I
- 12 raised my hand is, I have a question for the Line Drawing
- 13 Team about the -- kind of the workflow and the process
- 14 here. You know, so I see, you know, we have time set aside
- 15 to review the COI submissions, and then in later -- you
- 16 know -- in September debrief and provide direction to our
- 17 Line Drawing Team prior to the release of the official
- 18 redistricting data.
- 19 And is that -- is the idea there, the -- like the
- 20 15th, 17th and 18th of September is where we develop the
- 21 direction to the Line Drawers to develop the visualization
- 22 so we'll -- so we're going to -- so the big picture, if I
- 23 can -- this is the way I'm thinking of it. Tell me if I'm
- 24 wrong, right.
- We're going to look at all that input data we

- 1 have and we're going to try to digest that for a while, and
- 2 we're going to think a little bit more deeply with -- about
- 3 that input and, you know, hopefully we'll get some VRA
- 4 input at that time, too.
- 5 And then we sort of coalesce all that information
- 6 into direction for the Line Drawing Team, to come up with a
- 7 first set of visualizations that they will come up with on
- 8 -- by October 3rd, so we can begin to react to those and
- 9 work through those on the 4th, 5th and 6th.
- 10 And then after that, then we give them direction
- 11 on Iteration No. 2, and then on to Iteration No. 3 after
- 12 the 15th, I guess is -- am I getting it?
- 13 COMMISSIONER ANDERSEN: Absolutely. That's
- 14 exactly it.
- 15 COMMISSIONER SADHWANI: A+.
- 16 COMMISSIONER ANDERSEN: Yeah, that's exactly --
- 17 it's the 31st, the September 7th and September 11th will be
- 18 a review of what we have at -- what we have for different
- 19 areas. Then when we come back, then, on the 15th, 17th and
- 20 18th of September it will be -- okay. You've had a look.
- 21 This is -- the Line Drawers are also saying, you
- 22 know, we're seeing this, we see this, what do you want to
- 23 do Commission, and we'll be giving direction on some of
- 24 that, because we've had it -- we've already had a look, as
- 25 well as some VRA issues, which basically they'll be telling

- 1 us, well, that's nice, but there's going to be a VRA
- 2 consideration here.
- 3 So that's going to -- we'll get -- we'll be
- 4 giving direction input for them to give our -- do the first
- 5 set and then the first visualizations, and we start working
- 6 in October. That's perfect, your summary. Sorry. You're
- 7 on mute.
- 8 VICE-CHAIR FORNACIARI: I'm on mute. So we'll be
- 9 -- I'll be taking over as Chair and Commissioner Sadhwani
- 10 will be Vice Chair for these meetings come up. So we'll
- 11 have to get together, kind of figure out how we balance the
- 12 needs of the business meetings that are scheduled and the
- 13 means to do this and how we might manage that.
- I see maybe there's some tentative other meetings
- 15 we might want to insert in there, too. So we'll work
- 16 through that offline.
- 17 CHAIR AKUTAGAWA: And actually, for
- 18 clarification, Commissioner Sadhwani, I think you were
- 19 mentioning at the very beginning when some of the callers
- 20 called in about, you know, community members and
- 21 organizations being able to present district maps.
- What -- again, I just want to just bring this
- 23 together. So you're saying the 23rd, 29th and 30th are
- 24 those -- or are those time frames where you're envisioning
- 25 that that's when those district maps would be presented?

- 1 COMMISSIONER SADHWANI: The district maps, I
- 2 don't have the dates in front of me.
- 3 CHAIR AKUTAGAWA: It's -- yeah.
- 4 COMMISSIONER SADHWANI: It's October 23rd, I
- 5 think, something like that. It's like a Thursday, Friday,
- 6 Saturday.
- 7 COMMISSIONER ANDERSEN: Yeah. The 23rd's the
- 8 last one. It's the -- like 21, 22, 23.
- 9 COMMISSIONER SADHWANI: Yeah.
- 10 COMMISSIONER ANDERSEN: That, like we have the
- 11 three days. The first week of October is where we're doing
- 12 visualizations. The second week of October we're doing
- 13 visualizations. The third week of October will be for some
- 14 map input, and as far as, like, it could be an individual
- 15 district -- an individual with a district or an individual
- 16 with several districts, or it could be groups at the time,
- 17 as we're doing the visualizations, trying to come up with
- 18 our first draft maps.
- 19 And then the fourth week of October we'll be back
- 20 to visualizations, the 4th of October until we kind of go,
- 21 we're heading for a draft map.
- 22 COMMISSIONER SADHWANI: And if I may, just to
- 23 jump in, you know, to Commissioner Sinay's point and very
- 24 valid concern, this process is -- that we've sketched out
- 25 with the Line Drawers is very different from 2010. This

- 1 iterative visualizations and releasing like kind of what
- 2 we're thinking about and -- before we actually commit to
- 3 and vote on a draft, if I had to guess when those
- 4 visualizations go out, we're going to get a whole lot of
- 5 public comment, and you know, from every direction.
- 6 So I think that we will get there. I also think,
- 7 though, I'll just add, you know, in the next couple weeks,
- 8 August 31st, September 7th, September 11th, we're just
- 9 looking, right. We're just looking to see what we have,
- 10 and also what we don't have.
- 11 And I think that that can be a really helpful
- 12 time. We're not providing direction at that point. We're
- 13 not making any decisions. Much like the Community Interest
- 14 input meetings that we have, we should be looking at those
- 15 three days as an opportunity to hear communities by seeing
- 16 what has been submitted and really synthesizing it and
- 17 going through all of that.
- 18 And I do think that that -- I think while all of
- 19 this would have been great, like two months ago, you know,
- 20 I do think like hearing, you know, the time line that
- 21 Fredy's been talking about with the -- you know -- the
- 22 billboards that are going to be going out and additional
- 23 paid media, I do think that these conversations will help
- 24 us identify where we might need to do additional outreach.
- 25 And we're going to be like blasting out, you

- 1 know, hey, the Commission process is happening, so get
- 2 involved. So I leave it to the Outreach Subcommittee to
- 3 figure out exactly all of those details, but I think
- 4 there's a lot of things kind of coming together all at the
- 5 same time, and I'm hoping -- I'm positive -- I'm feeling
- 6 positive.
- 7 CHAIR AKUTAGAWA: And then so I do have one
- 8 additional clarification question. So it was -- so are we
- 9 talking about September 23, 29 and 30th as for sure
- 10 meetings that we should all be planning for?
- 11 COMMISSIONER SADHWANI: Those are listed as
- 12 business meetings. I think it depends on whether or not we
- 13 need them. We've listed I believe -- I apologize, I don't
- 14 have the calendar in front of me -- the 15th, those days
- 15 right in the middle of September as providing direction
- 16 prior to the release of Census data.
- 17 Those dates on 23, 29 and I think 31 -- 30, were
- 18 kind of slotted for VRA. We haven't received a firm
- 19 confirmation of the VRA time line yet. So we're kind of
- 20 holding those for that purpose.
- 21 CHAIR AKUTAGAWA: Okay. Thank you. I think I
- 22 was asking because of what Commissioner Fornaciari said
- 23 about finding that balance between all the things that
- 24 we're going to see, but also, what business we're going to
- 25 need to do, and will certain things need to get pushed off,

- 1 given just all that we're going to be discussing, as well,
- 2 too, so.
- 3 COMMISSIONER ANDERSEN: And also, one of those
- 4 days would be a review of our criteria, kind of -- like
- 5 back to kind of a quick review of all our training that we
- 6 did way back when in terms of how we -- you know -- kind of
- 7 all of the points we have to consider, one of those days.
- 8 But the days are September 23rd, and it's the
- 9 28th and 29th were those days. And so the Agendas have not
- 10 been set yet on that, but there's a few things we should do
- 11 before we just jump right in, so we're up to speed.
- 12 CHAIR AKUTAGAWA: Thank you. And I see
- 13 Commissioner Sinay with her hand up.
- 14 COMMISSIONER SINAY: Thank you. A couple of
- 15 things. I'm quessing from what you said, Commissioner
- 16 Andersen, that part of it will not only be discussing the
- 17 criterias [sic], you know, going back to our criterias, but
- 18 also discussing some of our values.
- I don't know what the right word is. I don't
- 20 want to use criterias, but things like, when do we split up
- 21 cities or not. There's a lot of big questions that we all
- 22 need to grapple with before we even start Line Drawing, and
- 23 I've been asking that a couple of times.
- 24 What other data will we be using besides Census
- 25 data to get clarity on communities and Communities of

- 1 Interest? There's a lot of great complimentary data like
- 2 point in time, public counts and things like that. So I
- 3 feel like there's a lot of pieces that we need to do before
- 4 we even start Line Drawing.
- 5 I'm a firm believer to set the stage before you
- 6 start playing, because it's hard -- you know -- I always
- 7 tell my clients, set your policies around who you will
- 8 receive money from and who you won't when doing fund-
- 9 raising, because it's hard to say no when the money's at
- 10 the table.
- And so, yeah, that's kind of why I was pushing us
- 12 to think a lot about this stuff earlier versus, okay, now
- 13 the data's here and we're going to -- I don't want us to
- 14 get distracted. Also, I hear what you're saying,
- 15 Commissioner Sadhwani, and yes, it's exciting that people
- 16 will be excited when they start seeing us Line Draw.
- But we've said from the very beginning that every
- 18 input is equal, and I don't want us to get caught up, and
- 19 that's another piece that I want us to discuss very clearly
- 20 before we start playing with the data and getting people
- 21 calling in is, how are we going to stay true to that
- 22 promise, that every input is equal, and not that the
- 23 loudest voice or the last voice is the one we listen to.
- 24 So I completely understand when the community
- 25 says, hey, this is a public opportunity. Everybody gets a

- 1 say, but everybody gets a say and everybody is equal. And
- 2 so we really need to talk about that and talk about our own
- 3 biases and how we're going to draw these lines before we
- 4 jump into playing with the data.
- 5 And so as much as I appreciate that everyone's
- 6 going to -- there's going to be a frenzy to get us
- 7 information when we make mistakes with a line, we have to
- 8 remember, if we have good -- I'm still a firm believer that
- 9 if we have good data, we have good, diverse Communities of
- 10 Interest, we will actually draw better lines from the
- 11 beginning, from the get-go than if we draw lines and we try
- 12 -- and then the community is pushing us in one way or the
- 13 other.
- And so I still go back to the -- you know -- I'll
- 15 be honest. Some of you may know this. I trolled Twitter
- 16 on the day after the -- all the Census data went out, and
- 17 anyone who talked about redistricting or Census data, I put
- 18 on there, if you're a Californian, please go to our tool
- 19 and submit a COI input.
- 20 You know, and I felt very lonely doing it,
- 21 because I wasn't seeing other people doing it, and we
- 22 didn't have a plan as a Commission, a communications plan
- 23 on how to do that. And I was like, I don't know if this is
- 24 appropriate or not, but hey, let me get -- you know -- if
- 25 people are reading this they'll find it interesting.

- 1 So I just want us not to just wait, but be
- 2 proactive all the way through and really remember that
- 3 we've said every input is equal, and really try to bring in
- 4 those different voices.
- 5 CHAIR AKUTAGAWA: Thank you, Commissioner Sinay.
- 6 And I do think that you do bring up a good point,
- 7 especially around talking in advance before we're
- 8 confronted with some of these harder decisions around, at
- 9 what point do we make these decisions.
- 10 And I know it's not going to always be quite so
- 11 cut and dried, and so -- but it does help to perhaps make
- 12 certain decisions a lot easier and go more quickly, because
- 13 we don't have to go around. However, there are going to be
- 14 decisions where we are going to want to dig in and we are
- 15 going to -- even though we had made some decisions about
- 16 how we're going to make decisions, we're still going to
- 17 probably want to dig into certain ones. And so I want to
- 18 just uplift what you just said, Commissioner Sinay.
- 19 Do we have any other comments, any other
- 20 questions for the Line Drawers? I just want to just also
- 21 acknowledge all of the work. I know that Commissioner
- 22 Sadhwani and Commissioner Andersen, you have been putting
- 23 in a lot of time.
- 24 You continue to put in a lot of time, and so I
- 25 just want to acknowledge all of the work that you're both

- 1 putting in, really, as now the portion of the work that
- 2 we're all here to do is really ramping up. And so I just
- 3 want to say thank you to the both of you for all that
- 4 you're doing, so. And I'm glad that you're both doing it.
- 5 Okay. Well, thank you very much. I am not
- 6 seeing any other hands raised or questions or comments. So
- 7 we do need to take public comment on this particular Agenda
- 8 Item No. 5, I believe we are at, before we move onto our
- 9 next Agenda item.
- 10 So Katy or Kristian.
- 11 PUBLIC COMMENT MODERATOR: Oh, I'm here. I was
- 12 just on the phone. The Commission will now be taking
- 13 public comment on Agenda Item No. 5. To give comment

- 3 CHAIR AKUTAGAWA: All right. Thank you very
- 4 much. Well, I will take the prerogative of the Chair,
- 5 then, as we're waiting. I will ask this question to the
- 6 question that Commissioner Sinay asked about how are we
- 7 going to make these kind of harder decisions.
- 8 Is that something -- can I ask, is that something
- 9 that the Line Drawer Committee would be taking on as part
- 10 of your process of the Line Drawing, that you would lead us
- 11 through a discussion around some of those things that
- 12 Commissioner Sinay brought up? I think I just wanted to
- 13 make sure we put some closure to that question. I realize
- 14 it's --
- MR. MANOFF: Those instructions are complete on
- 16 the livestream, Chair.
- 17 CHAIR AKUTAGAWA: Thank you so much, Kristian. I
- 18 quess we don't -- I don't see anybody lining up.
- 19 MR. MANOFF: There are no callers at this time.
- 20 CHAIR AKUTAGAWA: Okay. Thank you.
- 21 COMMISSIONER SADHWANI: I'm sorry, Chair. What
- 22 exactly --
- CHAIR AKUTAGAWA: So --
- 24 COMMISSIONER SADHWANI: -- what exactly is that
- 25 question?

- 1 CHAIR AKUTAGAWA: I believe I heard Commissioner
- 2 Sinay ask how are we going to make -- we're going to come
- 3 to places where there are going to be, again, difficult
- 4 decisions. Do we want to have discussions in advance? I
- 5 know it's not all going to be, you know, cut and dried, but
- 6 if in cases of -- I'll just say, for example, if there's an
- 7 instance in which we would say, if this, then that, this is
- $8\,$  when we would maybe make a decision that we would have to
- 9 split a city in half or we would need to -- I think --
- 10 Commissioner Sinay, am I understanding what I heard you say
- 11 correctly?
- Okay. Thank you. So that's what I meant by, how
- 13 do we want to go about that. Yes, Commissioner Sinay.
- 14 COMMISSIONER SINAY: Sorry about that,
- 15 Commissioner Akutagawa. I mean, one thought I had was if
- 16 we all went back kind of to our notes and just remember
- 17 what questions have arisen as people who are going to draw
- 18 lines. So the city question was the first one that hit me,
- 19 because one of our first meetings, Calabasas called us and
- 20 said, look, we're so tiny and you split us three ways, you
- 21 know.
- 22 So just thinking about some of those things that
- 23 kind of have come up. Having said that, yes, it can't be
- 24 in stone. We have the VRA. There's all these other
- 25 pieces, but just having some of those conversations.

- 1 CHAIR AKUTAGAWA: I see Commissioner Fernandez
- 2 and wastewater Turner. Sorry, Kristian. Were you -- okay.
- 3 Commissioner Fernandez.
- 4 COMMISSIONER FERNANDEZ: Yes. And another -- I
- 5 mean, to me, I just see it as like kind of setting up the
- 6 parameters, and the question, if you've been asked or
- 7 interviewed is, are you going to start from scratch or are
- 8 you going to use existing maps.
- 9 So something like those type of conversations.
- 10 It's like, you know, what's going to be our play book
- 11 moving forward. Sorry. Football reference. I love
- 12 football. Something like that.
- 13 CHAIR AKUTAGAWA: Thank you, Commissioner
- 14 Fernandez.
- I saw Commissioner Turner with her hand up, and
- 16 then Commissioner Andersen.
- 17 COMMISSIONER TURNER: Yeah. I was just going to
- 18 say, I really appreciate Commissioner Sinay for continuing
- 19 to lift that. I like the parameter-setting. I think that
- 20 there is a possibility that we can get so far into
- 21 conversation to determine what could be.
- 22 And another way to do it would also be just
- 23 keeping good notes as issues arise, and making our best
- 24 determination in setting a path and kind of a plan moving
- 25 forward that this is how we're going to continue to treat

- 1 this same circumstance.
- 2 Other than that, it feels like it can get really
- 3 hypothetical and we spend a lot of time on what may not
- 4 come up exactly in the same form.
- 5 CHAIR AKUTAGAWA: Thank you so much, Commissioner
- 6 Turner.
- 7 Commissioner Andersen and then Commissioner
- 8 Fornaciari.
- 9 COMMISSIONER ANDERSEN: Actually, Commissioner
- 10 Fornaciari had his hand up first, if he wants to go first.
- 11 CHAIR AKUTAGAWA: Okay. Commissioner Fornaciari.
- 12 VICE-CHAIR FORNACIARI: Yeah. I just -- I was
- 13 just going to give a couple of examples. I mean, last time
- 14 around they -- it was my understanding that, you know, they
- 15 had this share the pain thing or something that they did,
- 16 where if they split a city in one -- you know -- the
- 17 assembly district, they tried to keep it whole in a
- 18 senatorial district, and you know, I mean, looking at the
- 19 districts, how they came out, looking at the feedback we
- 20 got, I mean, it's -- you know -- is that something we want
- 21 to consider doing or not.
- I think the other thing that came to my mind was,
- 23 you know, we've had a lot of COI input on, I think that
- 24 other city should be with us. And then we have, I think my
- 25 city should be, you know, with -- you know. So how do we -

- 1 I mean, do we -- are we going to kind of discuss how we
- 2 balance those two different types of input?
- 3 CHAIR AKUTAGAWA: Thank you very much.
- 4 Commissioner Andersen.
- 5 COMMISSIONER ANDERSEN: Yeah. These are actually
- 6 -- Commissioner Sinay, thank you for bringing that forward.
- 7 This is kind of the stuff, what I was saying about going
- 8 over and reviewing criteria. This is kind of what I was
- 9 thinking, but not quite in that depth.
- 10 And I think, like as Commissioner Turner sort of
- 11 said, as we sort of start through, okay, these are the
- 12 rules, remember, this and that, I think some of those
- 13 conversations will indeed happen, because as we start to,
- 14 oh, yeah, how do you -- can really consider that, how do we
- 15 look at these things, and I really like the idea of, you
- 16 know, sort of the general rules, you know, parameters.
- We will be doing, as the Line Drawers are going
- 18 to be sort of pushing us to give them direction, I think
- 19 it'll be very obvious, some -- the harder questions. And
- 20 then, you know, I think, you know, as far as their first
- 21 visualization.
- 22 And then I think if we have those next kind of
- 23 three days to really contemplate what we sort of have done
- 24 a bit and then go, you know, so we could really be sort of
- 25 on the ground running, then, for October, I think might

- 1 really work.
- 2 You know, I certainly think Commissioner Sadhwani
- 3 and I can make a stab at what topics we need to include,
- 4 but I would look for other people to certainly -- you know
- 5 -- I don't know if we want to be the only ones to put some
- 6 of that on the table.
- 7 So I would recommend that -- trying to think what
- 8 other group would be sort of good at -- we might make a
- 9 quick drafts of -- actually, well, let's just put those --
- 10 put our ideas on the agenda building.
- 11 CHAIR AKUTAGAWA: All right. Thank you very --
- 12 COMMISSIONER SADHWANI: Perhaps --
- 13 CHAIR AKUTAGAWA: Oh, sorry. Commissioner
- 14 Sadhwani, please.
- 15 COMMISSIONER SADHWANI: Sorry about that. I just
- 16 jumped in without raising my hand. Perhaps, you know, I
- 17 really like this and yet at the same time I'm not entirely
- 18 certain what all of those parameters will or will not be.
- 19 I think the examples that Commissioner Fernandez offered
- 20 and Commissioner Fornaciari, also from 2010, that's really
- 21 helpful.
- I hadn't been thinking about that, per se.
- 23 Broader parameters of like, if x then y, I think that's a
- 24 little harder to set in stone, because I think every case
- 25 is going to be somewhat different. And so you know, I

- 1 agree with you, Commissioner Andersen, I would feel a
- 2 little uncomfortable drafting a play book that we would
- 3 then either adopt or not, just because -- I'm wondering if
- 4 maybe we can kind of insure that over the next several
- 5 weeks as we're reviewing the COIs if this can be on
- 6 everyone mind.
- 7 And by the time we get to September 15th and
- 8 we're giving direction to the Line Drawers, you know, as we
- 9 continue to -- if you feel passionately, like let's not
- 10 scrap all of the assembly and senate districts, right, as I
- 11 think Commissioner Fernandez, you were mentioned you've
- 12 been asked -- have been asked that numerous times.
- 13 Then let's talk about it on that day after we
- 14 have reviewed more of the COIs. I would be -- I would also
- 15 -- I wouldn't want to like set in stone something before
- 16 we've seen all of the submissions, because they're all
- 17 equal. Also, you know, I mean, in general, I think with
- 18 Congress we've lost a seat.
- 19 We do have to scrap them all, but Assembly and
- 20 Senate and Board of Equalization, right, the \*2:19:49. But
- 21 yeah, I think if we can continue to work collaboratively on
- 22 this and recognize that before October 4th, when we start
- 23 the Line Drawing process, that we want to have some guiding
- 24 principles, I think that would be really helpful.
- 25 And perhaps we can make sure to, as Commissioner

- 1 Turner mentioned, keep good notes on what those are
- 2 collaboratively.
- 3 CHAIR AKUTAGAWA: Yeah. Thank you so much,
- 4 Commissioner Sadhwani. I think maybe the spirt of it is
- 5 just some broader kind of frameworks that we can -- that
- 6 will -- that you know, won't see us going all over the
- 7 place, given all the data.
- 8 And I do agree. I think you bring up a great
- 9 point, you know. Let's look at the data, and that may help
- 10 to surface things that we hadn't thought about either, too.
- 11 But as we go forward over the next few weeks, you know,
- 12 some of these questions that maybe we're being asked in
- 13 these interviews or other things may pop up, and maybe we
- 14 can each keep a running list so that when it comes time for
- 15 the discussion they'll either have been crossed off because
- 16 they're irrelevant, or maybe they're just ones that we do
- 17 need to bring up and discuss as an entire Commission.
- 18 Does this fall within that kind of area of broad
- 19 guidelines that will help guide us, but not necessarily
- 20 bind us and, you know, box us in, so. Okay. Thank you for
- 21 this discussion. I just wanted to make sure we had some
- 22 closure on that part.
- 23 And I appreciate -- I believe that Commissioner
- 24 Sadhwani and Commissioner Andersen, you will be -- will you
- 25 will not be the sole source of all of it, because it does

- 1 fall under Line Drawer, you will be the lead guides on it,
- 2 I'll say. All right.
- 3 Okay. So with that I just want to say thank you.
- 4 We have not had any callers still call in while we were
- 5 having our discussion. I just want to make sure that I am
- 6 following our Agenda and not forgetting anything. I do
- 7 believe that we have come to the end of our Agenda, and I
- 8 don't see anyone else who --
- 9 Commissioner Andersen.
- 10 COMMISSIONER ANDERSEN: I do want to make sure
- 11 the public notices we have on the -- on our Agenda that we
- 12 have at the end, we have upcoming scheduled meetings and
- 13 that's -- we want to make a change on that. It's not --
- 14 actually, it's not quite correct.
- The full Commissions are August 31st, September
- 16 7. Actually, there will be September 11, but it's
- 17 September 15. It's not the 16th. It's the 17th and 18th.
- 18 It is September 23rd, then September 28 and 29, not
- 19 September 30. So I just wanted to bring that up and have
- 20 the public be aware, because it's sort of written and then
- 21 if they're looking at it -- and I know that that's going to
- 22 be -- our Executive Director Alvaro will -- I mean --
- 23 Hernandez will be, you know, putting the different things
- 24 on our meeting schedule online, as well.
- They all are online. But I just want to make

- 1 sure the public knows that. It's not the 16th. It's not
- 2 the 30th, but there is a September 11 and a September 17,
- 3 18.
- 4 CHAIR AKUTAGAWA: And also, just one more
- 5 reminder. We do have Communities of Interest input
- 6 meetings tomorrow, which is Zone G, which is the
- 7 communities mostly in the Eastern Sierras. And then we
- 8 also have a meeting on Saturday, which is the -- which is
- 9 Sacramento, as well as some of the other counties that
- 10 surround Sacramento, Yolo County, I think, El Dorado
- 11 County.
- 12 Unfortunately, or sadly, some of the areas that
- 13 are facing, you know, the big fires, too. So do want to
- 14 just note that we do have COI input meetings both tomorrow
- 15 and Saturday, as well, too.
- 16 So with that I just want to say thank you to
- 17 everybody. Thank you for your time. I know that -- woo-
- 18 who -- we are going to get 20 minutes back, and I just want
- 19 to thank everybody for all of your very thoughtful
- 20 conversation, discussion, consideration, deliberation, and
- 21 also all the hard work that our committees and
- 22 Commissioners are doing, so -- and also, very much so our
- 23 staff. I want to appreciate them, as well, too.
- 24 So thank you. Thank you to our -- also, our
- 25 video team. Thank you. We are adjourned.
