

August 9, 2021 – California Citizens Redistricting Commission COI Input Meeting and COI Tool Updates

COI Input Meeting Recap

CRC heard from 199 Californians in total at COI input meetings from 7/29/21 to 8/4/21.

7/29/21 -- Zone C: Alameda, Contra Costa, Marin, San Francisco, San Mateo, Santa Clara, Solano

- 18 speakers total
 - Majority of callers focused on Contra Costa County
 - A handful of callers discussed Alameda County
 - Some callers discussed Monterey County
 - 1 speaker discussed Solano County
 - 1 caller focused on San Francisco County
 - 2 callers discussed on both Solano County and San Francisco County
 - 1 caller described their community to be Contra Costa County to San Joaquin County
 - We had no callers from Marin, San Mateo or Santa Clara County
- Non-English COI: None

7/30/21 -- Zone H: Los Angeles County

- 52 speakers total
 - Majority of speakers focused on the Northern Los Angeles County -- Antelope Valley, Santa Clarita Valley, San Fernando
 - Many of the callers discussed Long Beach
 - Some callers discussed Westminster, Fountain Valley, Midway City
 - A couple of speakers highlighted the San Gabriel Valley
 - A couple of speakers focused on keeping beach communities together from El Segundo to Palos Verdes
 - 2 callers gave input on South Los Angeles
 - 1 caller discussed communities along the 210 fwy from Altadena to Claremont as their community
 - 1 caller highlighted Pomona
 - 1 speaker gave input on Los Feliz
 - 1 speaker discussed Compton
 - 2 callers provided input on Zone E: Simi Valley
- Non-English COI (Interpreter present):
 - Spanish: 2 speakers

7/31/21 -- Zone I: Riverside & San Bernardino

- 81 speakers total

- Speakers from Riverside County provided input on some of the following communities: Moreno Valley, Perris, City of Riverside, Lake Elsinore, Murrieta, Temecula, Coachella, San Jacinto, Hemet, Indio, Corona, Jurupa Valley, Banning, Beaumont, Palm Springs, Desert Springs, Morongo Basin, Murrieta, North Shore
- Speakers from San Bernardino County highlighted the following communities: Redlands, Rancho Cucamonga, Victorville, Fontana, Lucerne Valley, Apple Valley, Chino Hills, Rialto, Ontario
- 1 speaker gave public input on Zone H: Claremont to Altadena corridor
- Non-English COI (Interpreter Present):
 - Spanish: 1 speaker

8/4/21 -- Zone F: Fresno, Kern, Kings, Madera, Merced, San Joaquin, Stanislaus, Tulare

- 48 speakers total
 - majority of speakers gave input from Fresno
 - a dozen speakers shared about Kern
 - a handful of speakers discussed Tulare
 - a couple of speakers focused on Kings
 - other comments were from Madera, Merced, San Joaquin, and Stanislaus counties
